JOHN WATERS ON THE NEW 'HATE' BILL

'VACCINE' DEATHS SOAR

The devastating death toll from Covid vaccines is rising across Ireland as hospital emergency departments witness wide scale injuries and more health whistleblowers begin to emerge. After a lull in 2020, the biggest nursing union in the country, the INMO, has admitted that hospital overcrowding is currently at its worst since the so-called 'pandemic' began.

As the government, HSE and media struggle to keep a lid on the horrific accounts of sudden deaths, blood clotting, strokes, heart attacks, paralysis, eye damage and convulsions brought on by the experimental gene-changing injections, anecdotal evidence of fatalities and injuries is spreading throughout the country and convincing many Irish people to reject the shot.

Efforts by state authorities to silence families of victims and healthcare workers are also coming to light. Medics and healthcare workers who attempt to speak out about the risks of the vaccine say they are threatened, demoted, and told to go to stay silent or go on leave. They are also being told to stay away from work if they have not received the jab.

A consultant at St Vincent's Private Hospital in Dublin was told to go on leave and take a psychological assessment after he questioned the rollout of the vaccine.

The HPRA (Health Products Regulatory Authority) which is responsible for ensuring that vaccines in Ireland are safe has acknowledged more than 8000 reports of injuries and 56 deaths in the country so far.

However these figures are thought to be widely underestimated when compared to the current death toll in the EU which now stands at more



than 14,000 people and in excess of one million injuries. These are the official EMA (European Medicines Agency) figures. The actual number of vaccine deaths across Europe is thought to be much higher.

Several doctors in Ireland have died recently, just weeks after taking the vaccine. One well-known surgeon in good health passed away shortly after his second dose. Days earlier he had been running a busy clinic at his large hospital. Another doctor collapsed after the injection and said he knew the vaccine had caused it and that he regretted taking it.

Many other healthcare workers, frontline staff and retail workers who say they are being coerced to take it are now on sick leave. Beaumont Hospital - the country's main neurological centre - has seen growing dissent and anger among staff who are not willing to take

the vaccine but say they are being pressurised by management.

In one large Dublin supermarket, a dozen staff were unable to report to work, several claiming the vaccine had left them unwell. There are also growing reports of miscarriages among pregnant women. In one case, a young doctor lost one of her unborn twins.

The vaccines were granted emergency use by the EMA, which is led by Dublin pharmacist Emer Cooke, even though they do not prevent transmission of the SARS CoV2 COVID-19 virus.

The Pfizer trials will not be complete until January 2023. The same company has a notorious criminal record and was forced to pay the biggest fine in history (\$2.3bn) for lying about its drugs and bribing doctors to promote them.

Ms Cooke is one of several Irish

orchestrators of the global vaccine rollout. Her future hangs in the balance as Nuremberg-style trials for those involved in this crime against humanity become more likely with every passing day.

"Nothing like this has ever happened before in Ireland. It's absolutely horrific," said one HSE staff member.

"We're witnessing a genocide. It's patently clear. The number of injuries appearing and people dying days and weeks after the vaccine is horrific. And the authorities turn a blind eye. They are all in on it. Doctors, nurses, the Gardai, ambulance staff. They stay silent. They can never say they did not know. They know exactly what they are doing. One day, they will all go to jail for mass murder. Even the Nazis would be taken aback at this level of evil."

THERE WAS NO PANDEMIC

Newly released CSO (Central Statistics Office) figures show that deaths in 2020 were in line with other years, showing just a 2% increase compared to 2019.

Last year, 31,765 deaths were registered in Ireland, an increase of just 631 on 2019. The majority of deaths were caused by cancer with just 5% registered as COVID-19 although this figure is expected to be revised downwards significantly in the coming months given the large number of patients who died as a result of underlying conditions and not the virus.

Of the 1,672 Covid deaths, more than 80% were among elderly people aged over 75 and at normal life expectancy.

property – notably one's house and car – is transferred to the state.

The impoverished masses – whom they dub ‘the herd’ – will be nothing more than hapless tenants, tagged and tracked electronically, in a neo-feudal colonial society.

The New World Order involves a complete and utter rejection of Biblical values. As such it is the culmination of a dark rebellion which began a long time ago and which, in its final phase, will impact horrifically on the world as a whole.

Are We Being Misled By Design?

Throughout the last fifteen months we have had rolling death counts from the mainstream media warning us of a deadly plague. We are told that if we do not submit to tyranny and diktat, we are doomed. But why are the numbers seemingly so high? Is this part of an ongoing exercise to frighten and coerce the public into obeying ever more authoritarian measures?

There are many reasons why so-called covid deaths cannot be safely assumed to be so. The not fit for purpose PCR test being one, the vague symptoms (or lack of) another. But there are specific signs that the need for a high death count was known in advance. One indicator is that the way mortality statistics are recorded was changed.

In the USA the CDC published guidelines on March 24th 2020 changing the way cause of death is recorded, but only for covid. Pre-existing conditions were relegated to part II of the death certificate. Lack of oversight in the process meant Federal laws were violated which are supposed to ensure: ‘the integrity, objectivity, impartiality, utility and confidentiality of information collected for statistical purposes’. The result was unreliable data.

In the UK too, the rules changed. From the middle of 2019, the NHS began rolling out a new national system of medical examiners, apparently to ‘improve the quality of mortality data’. When covid arrived, along with it came new guidance for doctors completing death certificates. A medical examiner signing a death certificate no longer needs to have seen the patient at all. His ‘attendance’ could be virtual, even a mere telephone consultation. And covid was now an acceptable direct or underlying cause of death.

Then on March 26th 2020, the Chief Coroner for England and Wales issued new guidance stating that although covid-19 was a ‘notifiable disease’ under the Health Protection Notification Regulations (2010), for the purposes of the Coronavirus Act 2020 it wasn’t a notifiable disease, so no inquest was needed. To add to the confusion, death data has been pulled from four different sources, allowing a death to be counted multiple times, thereby massively inflating the daily death toll.

Meanwhile NHS England, NHS Improvement and NHSX (tech arm) were commissioned to develop a data platform to: ‘provide a single source of truth about the rapidly evolving situation; data will then be integrated, cleaned and harmonised in order to develop the single and reliable information that is needed to support decision-making’.

The ‘single source of truth’ meant that the CIA-backed company, Palantir was to provide the software data processing to shape health policy. Those in power claimed their hands were tied in handing over our health data, the excuse being the ‘unprecedented’ nature of the crisis. The deal was sealed in December 2020, with a Crown Commercial Service contract, but the truth is the NHS had been planning this since the previous summer. On 2nd July 2019, Louis Mosley, the boss of Palantir UK hosted a meal attended by David Prior, chair of NHS England. They discussed potential future uses of NHS data and emails between the pair, exposed by The Bureau of Investigative Journalism, confirm this.

Palantir has the ability to pull and link vast amounts of data across time and space. The choice of name is telling. In Tolkien’s Lord of the Rings, the ‘Palantiri’ were seeing stones which could communicate over vast distances. According to Gandalf it is beyond Sauron’s abilities to make the Palantiri lie or create false images. Instead though, he can show ‘selective images to foster a false impression in the viewer’.

A false impression is exactly what we got. We have an all-seeing, all-knowing corporation designed for spying and misrepresenting data to ‘help us understand the pandemic’. We know the regime’s Behavioural Insights team are working to create misleading thoughts in our minds, but what if AI is doing this too? No doubt with the ‘end justifying the means’. Coupled with the management of our health data handed to shady private corporations, including Microsoft, Amazon, Faculty and Google, there was a change in the software the ONS use for coding mortality data.

On 1st January 2020, the system used to code to the WHO global ICD 10 database was updated from IRIS 4.2.3 to MUSE 5.5. (Greek goddesses seem popular with global tech corps). Tests on MUSE system have revealed a 19.8 percent decrease in the category ‘Infections and Parasitic Diseases’ largely due to deaths that would previously have been recorded as Sepsis. ONS statistics on mortality from 2020 are affected, meaning deaths which before would have been labelled Sepsis could now go down as covid. Sepsis cases have been increasing since 2010. The Sepsis Trust have reported up to 52,000 UK Sepsis deaths annually. So how many cases were there in 2019/20 and 2020/21? FOI requests have been sent, but the ONS claim they do not have the data. Alongside

the remarkable disappearance of flu and pneumonia, perhaps Sepsis has morphed into covid.

Even after a death is coded in MUSE, ICD software itself can then reclassify it. For example both cancer and a positive covid test would be mentioned on the death certificate under MUSE. The data then goes through ICD coding where the underlying cancer cause will be ignored and bingo! Another death from covid. If we are not to get a false idea of mortality we need to understand how a software change can alter the cause of death from one year to the next. AI is now our global coroner.

There is little doubt that the authorities want us to believe the death rate from covid is far higher than in reality. I suggest they are doing this to create terror so they can bring in unconstitutional and oppressive measures in line with Agenda 21/30 and the bankster power grab whilst using us as guinea pigs for the experimental ‘vaccines’.

Masks Are Useless And No One Has To Wear One

Almost a year into the New Abnormal and its bedazzled masks are a constant visual reminder of the dystopia we all endure on a day-to-day basis.

A once peaceful trip to the shops is now replaced by a sea of masks, judging eyes and unwanted questioning. Although masks were first introduced on a voluntary basis and government officials had publicly explained the inefficacy of face coverings in stopping a virus, it wasn’t long before the rule was amended to no longer include choice after experts ‘shifted their thinking’. Hundreds of videos showing clear discrimination flooded the internet after many shop workers and security staff relished their new found power without any proper training in the interpretation of legislation - which isn’t all that surprising considering Chief of Police Dame Cressida Dick admitted that this rule would be unenforceable and instead encouraged the public to shame shoppers who dared to show their smiling faces in public. Pre-recorded government-compliant messaging is boomed over the tannoy of most shops telling us it is against the law to enter without a face covering or a medical exemption, but is that entirely true?

The legislation introduced for this rule is titled The Health Protection (Coronavirus, Wearing of face coverings in a relevant place) (England) Regulations 2020, this defines a face mask as a covering of any type which covers a person’s nose and mouth.

Section 4 of this Regulation is called ‘Reasonable Excuse’. It lists the reasons why a person may not follow this mask rule and includes medical, mental and health disabilities but also for those who may suffer ‘severe distress’ as a result of either putting on, wearing or removing a face covering. Additionally the government website also offers information on the use of exemption cards, stating that while some may feel more comfortable to carry proof of their exemption with them, it is not a legal requirement and you should not be required to produce one in order to access any service, public or private.

Over the last year scientists, professors and real journalists across the world have worked tirelessly to publish true and accurate information

surrounding not only the inefficacy of the face coverings but also the dangers of prolonged and inaccurate use by the general public.

On a personal tip, the level of enforcement does seem to vary depending on the area or the shop you happen to be in but if I should be asked whether I can put on a face mask my response is a polite “no, thank you”. 9 out of 10 times I find the worker, already overworked and underpaid, will just accept my response as simply as I presented it to them, for fear of making their day any more strenuous than it already is. If they question further I would yield to tell them that I am “exempt”. And should the shop worker be feeling over-zealous that day and choose to challenge me on the reason for my exemption I would politely remind them that I do not need to show proof of my exemption and that this should have been made clear to them during training. You can ask for a manager if the situation is not quickly resolved, and it’s a good idea to save the links for both the face covering legislation and the government guidance on exemption cards - should you need to request the assistance of a manager, these links will evidence your rightful claims.

That Nurse Who Does Ask Questions

I am a dual-qualified nurse currently walking around London wearing a sandwich board that says 'Nurses are scared to speak out'. Here is my story about why this feels necessary:

I am 34 years old and have been qualified for 12 years. My experience has predominantly been care of the elderly, specialising in improving communication and care, especially around end of life care.

I am a big believer in supporting individuals to make their own decisions, even if they feel unwise to us, and had great success with individuals maintaining a good quality of life through positive risk-taking. This supported individuals to continue to do the things they loved and enjoyed with support and not simply saying 'no it's too risky'. One example was supporting an individual with dementia to make her own cup of tea which sounds small but that developed into her interacting with staff during their breaks and coming out of her room and sharing stories of her life. I do not think this relationship would have developed if we had said 'no it is too risky'.

I am office-based but with my experience and knowledge I began to look at the evidence around mask wearing and the behaviour emerging that I saw and had happened to me where people appeared more aggressive and hostile towards each other, possibly due to being 'faceless'.

One day out I was pushed and shouted at by 2 different individuals and that was the day I decided I was no longer going to wear a mask to help others feel better, as it was changing people's behaviour in a negative way.

I kept busy during lockdowns and didn't pay too much attention to what was going on as I threw myself into work, giving me time to do lots of things I was previously unable to do.

I offered my services for free in my local health area and was not taken up. Of all the volunteers who wanted to give their time for free to do their part only a handful were taken up on their offer.

Something didn't seem right with the amount of advertising in supermarkets and over tannoy, the rules did not make any sense. One way systems where you were required to walk past many more people than you would normally, because there were arrows on the floor.

The messaging seemed heavily focused on fear and making people feel helpless. There was no messaging from what I have seen about common sense natural health and fitness. If the government were able to educate the public on health during lockdowns this could have supported the NHS to reduce the demand for other

services aside from covid patients.

I started to discuss this on social media and from what staff were reporting to me there was a 'culture of silence' developing and people felt unable to ask questions. As a nurse this is what we are trained to do – ask questions. Questions help inspire improvements.

There was no longer any debate – do this and if you have a question/opinion you are an idiot.

The endless reports of death counts – without context or perspective. What can we compare this to? How many people would usually be expected to die in a given day / week / month?

If you asked questions, you became tarred with the brush of being selfish, uncaring and 'how dare you, don't you know people are dying? Don't you know nurses are working really hard?!'

The questions were not acknowledged or considered and people were being shamed and then silenced.

I walked from Stoke-on-Trent to London (151 miles) over 10 days to raise awareness that it is okay to ask questions and they shouldn't cause conflict. That created a community of people who were sharing their experiences. I set off to hand deliver a letter to Boris Johnson - they didn't take it and I needed to post it - but that was okay as I had connected people together along the way and had supported individuals who felt unheard.

I continued to create content based on what people said they were having problems with.

I have attended and will continue to attend protests because I feel very strongly about pro choice, informed voluntary consent and I am completely against coercion, overt or covert.

I am currently walking London for 5 hours a day to raise awareness that some nurses are scared to speak out.

People ask me to share the stories of those who reach out to me. Currently I am one person doing the best that I can with the time that I have available and can not carry out interviews with each individual. People ask what nurses are scared of and why they are scared. People also say that I don't look scared to speak out as they see me with a sandwich board.

I address these points first and I am scared. I am concerned about the way I am portrayed in the media and the impact this will have on my ability to pay my bills and keep my registrations. This however feels like the most important thing to do and morally the right thing to do. Nurses are scared to lose their



jobs, they are scared that they will become scapegoats for the things they have witnessed. They have financial commitments just like everybody else and have worked hard to do the job they do and don't want to be forced out. The individual stories are not mine to tell, and I don't want to get them wrong. However, there are clear patterns emerging:

1. Heavy focus on audits rather than benefits to patient experience, no review dates or discussion on the impact these are having positively/negatively on both staff and patient wellbeing.
2. Working conditions – bullying, harassment, coercion, being ostracised or threat of job loss. If you ask questions, you become the problem.
3. Decline in quality of life and person-centred care. A focus around the hysteria and perceived risk of covid rather than discussing the actual risk to individuals and then planning their care accordingly. Patients missing appointments, needing surgery which, if they had attended appointments, could have been unnecessary. Individuals not being with families and loved ones during times of loss and grief but being invited the day after death

to collect the person's belongings. Each individual who has reached out to me has a very different injustice depending on their work environment.

I want to support nurses and inspire them to speak out in the best interests of their patients and work colleagues. For some reason it has been turned on us that we are the problem and there are many nurses and professionals out there who are lost, confused and alone, without support from colleagues, management, unions or the Nursing Midwifery Council.

I am asking for a meeting with The NMC to discuss the concerns with nurses and trying to clarify the myths and rumors that health and social care staff are concerned of and to have our questions answered. This is what I was trained to do. This to me is what being a nurse is about - doing what is right even if it is unpopular, seeking debate and evidence-based rationale, asking questions and putting the patient at the heart of care.

Alarming Rise In Alcohol Deaths

After 15 months of draconian measures imposed by the Johnson Regime, the wider consequences are beginning to surface in the form of figures sourced from the Office for National Statistics (ONS) and therefore undeniable, even to the mainstream media.

In 2020 the ONS registered 7,423 deaths from alcohol-related issues in England and Wales, this is defined as deaths directly caused by a misuse of alcohol. This figure is a 20% increase from the year preceding and is also the highest rate of alcohol deaths we have seen in England and Wales for 20 years.

Of those 7,423 deaths, 80% were from alcohol-related liver disease, 10% from mental or behavioural disorders linked to alcohol abuse and 6% from alcohol poisoning.

While government departments and services perform public displays of bewilderment, we need only look at the policies and procedures imposed on the British people over the last 14 months to begin to understand the reasons. Given that this massive increase in alcohol-related deaths began in March of 2020 (the same month the lockdown was imposed and off-licences were somehow considered 'essential businesses'), coupled with the apparent subversion of our National Health Service into a 'Covid-Only' Health System, it would not be far-fetched to deduce that these gross infringements on the lives and rights of everyone may have significantly contributed to the further deterioration of the nation's health and well-being.

Scientists Find Pollutants In Face Masks

Swansea University scientists have uncovered potentially dangerous chemical pollutants that are released from disposable face masks when submerged in water. The research reveals high levels of pollutants, including lead, antimony, and copper, within the silicon-based and plastic fibres of common disposable face masks.

Outlined in a recent paper, the tests carried out by the research team used a variety of masks – from standard plain face masks to novelty and festive masks for children – with many currently being sold in British retail outlets.

The rise in single-use masks, and the associated waste due to the alleged pandemic, has been documented as a new cause of pollution. The Swansea University College of Engineering have

conducted a study to investigate the presence of harmful toxic substances in the face coverings worn by the general public, including children, and purchased from UK retailers.

The study, led by Dr Sarper Sarp and supported by the Innovative Materials, Processing and Numerical Technologies (IMPACT) and the SPECIFIC Innovation & Knowledge Centre, found high levels of harmful pollutants, leachable heavy metals and micro-plastics, such as lead, copper and Polyethylene Glycol (PEG) in the face coverings they bought.

At a time when face coverings are legally mandated (though anyone is exempt) across the nation and introduced into our children's daily lives via their schools, the findings of

this study are ever-more alarming in that it raises some very important (yet scarcely welcomed) questions of what harm can be caused to the general public by the use of these masks? And, once disposed of, what impact will this have on our future generations?

Lizzie Prior, Great British Beach Clean Coordinator at the Marine Conservation Society said:

"The amount of PPE our volunteers found on beaches and inland this year is certainly of concern. Considering mask wearing was only made mandatory in shops in England in late July, little more than three months before the Great British Beach Clean, the sharp increase in PPE litter should be a word of warning for what could be a new form of litter polluting our beaches in the future."

The findings reveal significant levels of pollutants in all the masks

tested – with micro/nano particles and heavy metals released into the water during all tests. Researchers conclude this will also have a substantial environmental impact and, in addition, raise the question of the potential damage to public health – warning that repeated exposure could be hazardous as the substances found have known links to cell death, genotoxicity and cancer formation.

Dr. Sarp said: "It is, therefore, imperative that stricter regulations need to be enforced during manufacturing and disposal/recycling of Disposable Face Masks to minimise the environmental impact.

There is also a need to understand the impact of such particle-leaching on public health. One of the main concerns with these particles is that they were easily detached from face masks and leached into the water

with no agitation, which suggests that these particles are mechanically unstable and readily available to be detached into the mouth.

A full investigation is necessary to determine the quantities and potential impacts of these particles leaching into the environment and the levels being inhaled by users during normal breathing. This is a significant concern, especially for health care professionals, key workers and children who are required to wear masks for large proportions of the working or school day."

The research team includes Professor Trystan Watson, Dr Javier Delgado Gallardo and Dr Geraint Sullivan.

Is There Still Power in The Unions?

When I started working full-time in a bakery back in 1993, I was told that the first two things I should do on my first day were to find the staff canteen and ask to speak to the Union Shop Steward. Ten years later, I became a Shop Steward myself and eventually the Branch Secretary ('Convener' in old parlance). My mantra to the managers was: "As long as we have fair pay and fair play in a safe working environment, you'll rarely see us". When recruiting new members I used to stress to them the importance of collective power and the need to leave egos at the door, or risk the company dividing and ruling us. As a result there was a fairly solid 'kick one of us and we all cry' vibe in the factory.

Trade Unions can be a genuine, positive force when they do things properly. Many of the workers' rights that exist today have been hard won by Unions. Unionised workplaces tend to be safer and have better pay and conditions than non-Unionised workplaces. I've seen Unionised workforces use their collective strength to kick zero hours contracts into touch; the Bakers' Union strike at Hovis, Wigan back in 2013 being a prime example (1). There have also been big legal wins in recent years for Unison members working in the care sector (2). Membership benefits are also impressive, with legal cover, competitive insurance rates, education services, credit union schemes and benevolent funds available to members for only a couple of quid a week. I've benefitted

greatly from being a Union member and I always advise joining one.

However, there's something off-kilter about many of the Unions at the moment, which the government's response to 'covid' has revealed. When the first 'lockdown' started in March 2020, it turned out that many of those classed as 'essential workers' were extremely low paid and didn't even have company sick pay provision. I thought the Labour Movement would have been all over it, arguing that if this was a deadly virus, 'essential workers' should have more breaks, bonuses, shorter working days without loss of pay and sick pay for those forced to stay at home. Instead, I was dismayed to see (with honourable exceptions) some Union leaders foaming at the mouth for lockdowns, school closures, masks, 'social distancing' and furlough, whilst allowing companies to remove tables and chairs from canteens, separate workers from one another via plastic sheeting, temperature check and test people on their way into the workplace and sack workers who turned up for work with coughs and colds. Many Union Officials have had their access to sites restricted by company management and for the most part, it's gone completely unopposed, all in the name of 'keeping people safe', with no apparent consideration for the inevitable tsunami of job losses, attacks on working terms and conditions and health issues that have arisen from the measures taken.

I've seen Union leaders who labelled Boris Johnson's government as 'the most right-wing in history' back in 2019, taking to Twitter to complain that their restrictions haven't gone far enough during the 'pandemic'. Their opinions and actions appear to be shaped by the same mainstream media they claimed was 'biased' when Jeremy Corbyn was the Labour Party leader. Rather than seek consensus and mandates from their members, it seems that some Union leaders have simply used their organisations as a platform for their own politics, super-imposing their beliefs, fears and opinions on their respective memberships, rather than working hard to reflect the real concerns and aspirations of the people they're supposed to represent. Some of them now look to be acting as sales reps for big pharma, advertising and pushing the 'vaccine' on their members without so much as a risk assessment (3).

The TUC haven't helped matters either. For years now, their response to anything (particularly austerity during the David Cameron regime) has amounted to nothing more than slogans, marches and rallies. Oddly, rather than encourage a 'come one, come all' mentality, where workers from all backgrounds and walks of life come together in common endeavour and solidarity, the TUC appear to favour breaking Union members down into various identity groups (4), which only serves to open the door for divide and rule within the Trade Union Movement.

Trade Union membership has dropped considerably down the years

and this will likely get worse as businesses continue to struggle (if not go under) and companies are allowed to use 'covid' as a vehicle to ditch staff and move further into automation. Despite that as things currently stand, there are still several million Union members across the country and I can't help thinking that had they a few braver fire-brands among their leadership and more skilled orators with the old-school desire to challenge authority, fight for freedoms/liberties/rights and be willing to stick their heads above the parapet, a lot of what's taken place over the last year might have been hamstrung long ago.

As of writing this, there is a whiff of opposition to the idea of 'vaccine passports' (5), so there may yet still be time for Unions to get their mojo back, but the clock is ticking.

Banking, Or Organised Crime

Professor Richard Werner, an economist and academic, asked a London taxi driver one day, “who do you think creates and allocates the money supply in the UK?” The taxi driver rubbed his chin for a while then said, “the Bank of England.” Reasonable answer you might think. “But,” said Werner, “the Bank of England only supplies 3% of the money in this country. Who do you think creates and allocates the other 97%?” The taxi driver didn’t know. Do you?

The truth is shocking. 97% of our money supply is created and allocated by private banking corporations – profit-oriented enterprises. Banks can choose who to give it to and for what purpose. With such power banks can direct the economy of a nation for their own profit.

The popular misconception about banks, and one we were all taught in school, is that they invest money from people who want to use the bank as a store of wealth. The money is recycled in the short term for working capital, then some of the interest gained is given back to the saver. This ‘received knowledge’ is wildly inaccurate. Banks actually create new money by issuing credit - loans, overdrafts and mortgages. The revenue is created when you sign on

the dotted line of your loan contract, or when you use your credit card.

Your signature, your action, creates the ‘money’ there and then.

This is how any loan works: a bank makes a loan to A, say £10,000. This makes an asset for A, held in the bank’s book-keeping as an asset. But now A ‘owes’ to the bank, so this asset also becomes a ‘liability’ of the bank.

This double-entry book-keeping covers the fraud of creating money (if anyone else did this it would be fraud, but banks get away with it, because it’s officially-sanctioned, organised crime). Meanwhile A, not realising s/he has just created the money, thinks s/he now owes something to the bank.

On top of that the bank that just created £10,000, can now, because of Fractional Reserve Banking (a variable % of a bank’s money must be held in cash reserve) make another loan of up to £9000, to customer B from which they can also impose interest. Then they can loan up to 90% of new asset £9000 to C, and charge C interest. Interest upon interest, plus the ‘assets’ returned in cash over an agreed period time, all out of thin air.

Not only can the bank create

money, it can make more money out of what it creates, plus get back the money it created in the first place from the sweat equity of its customers, who have to work for several years to pay off the original ‘debt’ plus interest. It makes your head spin realising just how much money banks can make. From the original £10,000 (which didn’t exist) we have theoretically generated £27,000, plus 3 amounts of compounded interest.

There is a high level of deception that goes on in finance, obscuring the reality from people, which is dangerous. Some economists have likened the financial system to a giant vampire squid, constituting a huge challenge to our freedom. People don’t understand what is happening to their money. Josh Ryan Collins of the New Economics Foundation says of the UK: “This is a dysfunctional financial system. It is not working for society, or for the economy; it is a highly inefficient allocation of capital.”

It is when you look at the big picture - how this kind of banking contributes to increasing poverty - that the reality gets bleak. Britain has the largest share of private debt in the world. By 2007 the UK had become the most highly leveraged nation of any major economy. During the inevitable ‘credit crunch’

the government largely ignored private debt and focused on the far less significant public sector debt. They targetted public sector spending – and used it as an excuse for austerity policies that hit the most vulnerable members of society. Before 2008 food banks were unheard of. Today 1.3 million people are in need of them, mainly because of that other iniquitous austerity measure, ‘Universal Credit’.

The truth is public sector debt only accounted for around 10% of all debt, and this percentage is shrinking year on year. 90% of UK debt is in secured or unsecured loans, property and business loans, and speculative investments or ‘finance intermediation’. This percentage is still on the increase. Since the crash of 2008 nothing has really changed. We bailed out the banks, and after a bit of hand-wringing they went back to business as usual. And why not? The UK is also one of the most deregulated countries in the world in terms of finance.

Commercial banking is the cause of the boom and bust cycle. A huge percentage of loans are made not for projects that benefit society or increase wealth on the ground through job creation, but for assets like houses. When more money is created and enters the economy as mortgage loans, but

houses themselves do not increase in number to cover the demand, this pushes up prices, resulting in an asset bubble, which as we all know will eventually burst. Banks then refuse loans, house prices tumble, people lose their investment and banks take possession of the property. Most of bank lending is for assets; very little of it goes to sustainable projects that bring wealth to communities. This can and needs to change now. What we have is unsustainable and morally corrupt, but few realise this is the root of most of our problems.

A quote often attributed to the banking family of Rothschild says, “Give me control of a nation’s money supply, and I care not who makes the laws.” The saying is apocryphal. But William Pitt definitely made the following statement in 1791, at the inauguration of the first National Bank of the United States: “Let the American people go into their debt-funding schemes and banking systems, and from that hour their boasted independence will be a mere phantom.” Unfortunately Britain’s banks have followed this example, inveigling their customers into debt-slavery, while a small handful of corporate banking behemoths become wealthier than the wildest imaginings of Croesus.

Freedom Looks Like This

Iam still charged after another epic and unforgettable Saturday 24th April on the streets of London. Hundreds of thousands of lovers of freedom assembled from across Britain. Most had either been at the last Worldwide Freedom Rally on the 20th March or seen the fire in the eyes of friends who had. They were the ones who refused to live in fear, despite being surrounded by it in their communities. They’ve had enough of a game that started with ‘3 weeks to flatten the curve,’ something never intended by the instigators. They do not believe that Matt, Chris, Patrick and Boris have our best interests at heart. They want to retain ownership of their bodies and an immune system that has served us since man began.

The police had been risibly unable to deal with the previous mass rally, wandering around in small troops of 20 or so like a headless Roman platoon with orders not to kill,

surrounded on all sides by joyous and peaceful Celtic warriors. Would they be determined to prevent this event at all costs, stopping buses, suspicious train arrivals and closing Hyde Park? Or would British restraint apply – instead of the truncheons, water cannons and tear gas that our European neighbours employ? It did, with just a small scuffle at the very end, instigated by the police.

Aside from that, they were hardly to be seen on the day, rarely more than two at a time, unless standing outside Scotland Yard, Parliament and Number 10. There was no effort to impede the flow of a veritable multitude during the nine-mile circling of central London. The buzz of those present filled the air on a clear sun-drenched day. Many had been holding onto their sanity as most in their community succumbed to fear. For them, being

with this huge mass of like-minded souls provided one huge injection of strength, spirit and humanity.

Unlike nearly every other mass protest I have attended, this one had no identifiable leaders or management. Unlike others, there were no pre-printed posters or placards, and of the hundreds of home-made placards I saw, there were no two the same. There were no teams of characters handing out flyers. It was people’s freedom in action. It flowed.

There was no identifiable type; there never is at these rallies. It is heartening to know that the ability to see through the overwhelming fog of propaganda and mis-information is not restricted to any age, sex, class, colour or nationality. There has never been any blip in graphs or cases following these socially close and unmasked events, a phenomenon that itself may open more eyes - the thousands gathered do not get ill!

This is not about being ‘anti-vax’



or a ‘covid denier.’ Vaccinations, after the usual extensive testing, can play a valid part in health management. covid-19 whatever it is, has been a nasty disease for a tiny minority of vulnerable people. But health is a personal issue and personally, I will

not pass responsibility for my health to bodies that are largely funded by Big Pharma and the vaccine industry. We have different approaches to the subject and mine has served me well for over 50 years. It is good to know that I am not alone – far from it.

Scotland: A Year Of Lockdown Deaths & Avoidable Harm

The world median coronavirus infection fatality rate is 0.23% [1]. Death rates vary from country to country depending on many features including age - countries with older populations are likely to see many more deaths – and factors such as lower death rates in countries with previous immunity from exposure to other coronaviruses. A typical flu season might see a fatality rate of around 0.1% (1,000 deaths per million people) while a ‘bad’ flu season might be 0.2% to 0.3% (2,000 to 3,000 deaths per million people). Fatality on the cruise ship Diamond Princess was 1.3% [2] while the 1918 Spanish flu was estimated at between 1% and 6% [3].

National Records of Scotland (www.nrscotland.gov.uk) is the Scottish Government department responsible for collecting information, including data on deaths, about Scotland’s people. From the start of the pandemic to 28 March 2021 (week 12), there were 9,958 deaths where coronavirus (covid-19) was “mentioned on the death certificate” [4]. In a population of 5,463,300 people (which is the latest NRS population estimate as at mid-2019 [5]), deaths from covid-19 therefore equate to 0.18% of the population, and thus 99.8% of the population did not die.

Rounding Scotland’s population estimate to higher (6,000,000) and lower (5,000,000) round numbers to simulate boundaries to the population estimate, deaths are estimated at between 0.16% and 0.20%.

Arguably, the accumulating “rolled-up” 9,958 deaths straddles two flu seasons. Meanwhile, ‘regular’ flu has disappeared.

Covid-19 adversely affects older people. The worst affected were the very old, the average age of death from covid-19 being 82 years. Survival rates among the working population of Scotland (younger than 65 years) varies between 99.93% and 99.99%. Over the course of the pandemic it is estimated that 33% of deaths were in care homes, 60% were in hospitals and 6% were at home or non-institutional settings (as at 4 April 2021) [6].

There is controversy with coronavirus testing [7] and consequently death certificates might not be accurate. In NHS Lothian, for example, the total number of cycles that PCR is run for is 40 or 45 depending on the assay used [8]. To get a sense of the

impact of the pandemic in Scotland free from these controversies, one approach is to assess deaths from any cause over a long period.

To further place the 9,958 official ‘coronavirus death certificate’ deaths into context, in the same period (week 12, 2020 to week 12, 2021) there were 59,088 non-coronavirus deaths in Scotland, including 16,686 from cancer and 15,818 from cardiovascular disease (heart attacks and strokes).

Meanwhile, a recent Scottish Government Freedom of Information request [9] shows that deaths in Scotland for the period 3 March 2020 to 1 February 2021 where people have died solely from covid-19 with no other pre-existing medical condition was just 596 deaths.

Conclusion: The data is in and there is nothing to see. Even the official coronavirus death data, being those mentioning coronavirus on the death certificate, amounts to a bad flu that has historical equivalent peaks in maximum deaths. Indeed, Scotland’s standby Nightingale hospital, the Louisa Jordan, was not needed. There is no existential threat.

The only unanswered question, therefore, is: did lockdown help limit the death rate? Over 30 studies now suggest the answer is a resounding no [10a,b]. Moreover, Simon Wood, Professor of Computational Statistics, School of Mathematics, University of Edinburgh, suggests the R rate was below 1 before the first full lockdown, raising questions of “first whether full lockdown was necessary to bring infections under control, or whether more limited measures might have been effective, and second whether the several month duration of full lockdown was appropriate” [11].

According to a recent report, 379 Statutory Instruments have been introduced to micromanage every aspect of our lives and remove freedoms [13]. Emergency UK legislation, including the Coronavirus (Scotland) Act 2020, was introduced in April 2020 and has been extended twice. It is now set to expire on 30 September 2021, 78 weeks after we were told ‘three weeks to flatten the curve’.

A new approach is needed and lockdowns must never be repeated: The Health Advisory & Recovery Team (HART) (<https://www.hartgroup.org>) – a group of highly qualified UK doctors, scientists, economists and psychologists – points out that many international

studies show that lockdowns have proven to be a complete failure. HART group recommends 8 steps to move forward, including stopping mass testing of healthy people, stopping mask mandates and the reinstatement of the existing pandemic planning policies from 2019 [14].

There are other alliances and coalitions challenging the government’s response to the pandemic. Such alternate views rarely get mainstream news coverage or worse are censored or vilified for holding a different opinion. These include the UK Medical Freedom Alliance (<https://www.ukmedfreedom.org/about>), Doctors for Covid Ethics (<https://doctors4covidethics.medium.com/>) and the Covid19 Assembly (<https://www.covid19assembly.org/>). The latter includes Dr Martin Kulldorf, professor of medicine at Harvard University and Dr Clare Craig, NHS Consultant Pathologist; they want to audit every official covid-19 death in the UK.

Perhaps the best-known are the tens of thousands of epidemiologists and public health scientists as signatories to the Great Barrington Declaration (<https://gbdeclaration.org/>). The Spectator magazine [15] suggests there has been a well-orchestrated attempt to suppress and discredit the Great Barrington Declaration, pointing out that Devi Sridhar, a public health advisor to the Scottish government [and University of Edinburgh employee], denounced the declaration as not ‘scientific’. The Spectator goes on: “A bit rich considering Devi’s PhD is in social anthropology, whereas Sunetra Gupta, one of the GBD authors, is an international expert on infectious diseases.”

Lastly, church leaders are also now challenging the government; an open letter – with almost 1,500 signatories as at 21/4/2021 – was recently sent to Boris Johnson outlining serious concerns on vaccine passports [16].

In summary: the average age of death from covid-19 is 82 years old and the risk of death from covid-19 in Scotland is on average 0.18%. This is somewhat high and therefore a ‘bad’ flu season, but the peak is not without historical precedence and the virus has a predilection for old people (like flu does) and those with other health conditions. Survival rates among working-age Scots is 99.93% to 99.99%. Meanwhile, there are serious questions over lockdown efficacy, yet the harms of lockdowns are clearly staggering.

- Missed cancer screening appointments, impacting non-coronavirus physical health
- Cancellation of face-to-face GP consultations
- Increases in domestic abuse
- Increases in high risk alcohol consumption (see Royal College of Psychiatrists report [12])
- Increases in divisions between people (e.g., pro-versus anti-lockdown), harming social health
- Vastly extended NHS waiting lists for (non-coronavirus) treatments and tests
- A rise in mental health issues (driven by the government’s orchestrated media fear campaigns)
- Drastic interruptions to the entire education system with probable long-term harms to intellectual health
- Astronomical borrowing

Irish Traveller Wedding Held Despite Council and Police Pressure & Fines

A couple were undeterred from celebrating their special day despite severe warnings and pressure from local council officials and the Gardai (Irish Police) to cancel their wedding due to public health guidelines. Bride and Groom Willie Stokes and Shelby Kelly celebrated their wedding in style with family and friends at a large marquee reception in County Longford Ireland in May.

The 120-strong wedding party courageously defied an emergency court order that was issued earlier in the day to cancel the wedding and to remove a 2,000 sq.ft marquee. Local authority figures and armed Gardai liaised with members of the bridal party to stop the wedding from going ahead. Despite incurring penalties and court order injunctions, the happy partygoers rightfully poured into the

wedding tent after council officials and the Gardai left the scene.

The happy couple posted wedding pictures online and reported having “a great night” of celebrations. Other celebrators also posted joyous wedding pictures on social media with one partygoer mocking critics by saying they were only “jealous” of seeing people having fun. Family and friends supported the happy couple’s decision to go ahead with the wedding by saying “It is killing ye (to) see people getting back to normal”.

Since the wedding, the newlywed couple and other members of their family were all ordered to pay 3000 Euro compensation following a special court sitting in Longford town. Judge Keenan Johnston said the contempt and defiance of a court

order by attendees was akin to a “law of chaos” in view of current covid rules and a gross lack of respect to frontline workers. During the court hearing, the wedding celebrants issued wholehearted apologies regarding their actions.

As expected, government funded and out of touch Traveller Representative group Pavee Point patronised the wedding revellers. A spokesperson for the group reported, “It just shouldn’t have happened. The work that the HSE and Traveller organisations have done to educate Travellers, to see this is just very reckless and disappointing”.

In a sour world where fun and joyous occasions are cancelled and prohibited, it is wonderful to see peaceful disobedience in full display to celebrate one of life’s special moments.

Melbourne Locked Down Again

Australia is entering its 4th covid-inspired lockdown in Melbourne, the country’s second-largest city. The lockdown began Thursday May 27th and was set to remain in place for a week for Melbourne and the rest of Victoria state after a new cluster of cases was uncovered, yielding 26 new infections, including one person who was sent to intensive care, the AP reports.

Another 10,000 people have reportedly had some form of contact with those infected.

“Unless something changes, this will be increasingly uncontrollable,” Victoria Acting Premier James Merlino said.

Australia’s federal government declared Melourne a hot spot, allowing the city to tap additional federal resources.

PM Scott Morrison said 218 military personnel would be dispatched to Victoria to help administer vaccine doses to the population. Additional doses have been sent to Victoria, where only 3.9 million doses have been administered so far among a population of 26 million.

Health Minister Greg Hunt described the lockdown as “highly

regrettable, but necessary restrictions under the current circumstances.”

Under the terms of the strict lockdown, people will only be able to leave home to shop for food and essential items, provide or receive care, exercise, work or study if they are unable to do so from home, and to get vaccinated. Masks will be compulsory indoors and outdoors.

Cafes and restaurants will only be able to sell takeout, and schools will close once again, reverting to all-remote instruction for the duration of the lockdown. Professional sports events in Melbourne will continue, but crowds won’t be allowed.

Raising the sense of alarm, Australian authorities said the variant that caused the latest outbreak is the same one first identified in India, which has made its way across Europe and the US by now. Australia’s Chief Medical Officer Paul Kelly confirmed that it was the Indian variant designated as a ‘variant of concern’ by the WHO.

The new Melbourne cluster was allegedly found after a traveler from India became infected while in hotel quarantine in South Australia state earlier this month. The traveler was not diagnosed until he returned home from Adelaide to Melbourne.

Free Lottery Tickets, NFL & Baseball Games, Beer & Donuts Used As Vaccine Bribes In US

Several State lotteries, giant corporations and major sports leagues are effectively offering bribes to presumably ‘vaccine hesitant’ Americans as part of Biden’s goal to get 70% of the US adult population vaccinated with at least one shot by 4 July.

Ride-share giants Uber and Lyft will promote rides to and from tens of thousands of vaccination sites through their apps, the White House also said.

“People will be able to simply select a vaccination site near them, follow simple directions to redeem their ride, and then get a ride to take them to and from a nearby vaccination site free of charge.”

The new campaigns join a range of consumer-focused incentives unveiled in recent days, including a micro-brewery in Buffalo, New York offering beer to patrons who accept a vaccine shot.

McDonald’s will promote vaccine information on coffee cups and also said it will unveil a billboard in New York’s Times Square this month displaying vaccine information.

California joined the list of states

offering free lottery tickets to those who had taken the experimental shot. It already includes New York, Ohio, Maryland, Kentucky, Colorado and West Virginia. New York’s Mayor De Blasio is also offering willing participants tickets to a range of the city’s top destinations and experiences, which will be made available at a discount or for free, to those who’ve received the covid-19 vaccine.

Xavier Becerra, the health secretary, said in a statement the public-private partnerships “will help more people make informed decisions about their health and learn about steps they can take to protect themselves and their communities”.

Vaccination rates across the US have slowed as officials encounter vaccine-hesitant, free-thinking swathes of the population.

There is now an increasingly fervent public and private sector effort to meet drops in vaccine trial participation demand head-on. Unilever offered free ice cream, including popsicles and Klondike shakes, to health

workers and people getting vaccinated at several vaccination sites.

The doughnut chain Krispy Kreme is offering one free doughnut per day for the rest of 2021 to customers who present proof of being fully vaccinated.

The NFL announced during the Global Citizen’s VAX Live: The Concert to Reunite the World event that they would be giving away 50 tickets to Super Bowl LVI to vaccinated people who shared why it was important to get the shot.

According to a recent Kaiser Family Foundation survey, 47% of people who said they want to “wait and see” before being experimented on also said paid time off to get it would make them more likely to get the shot.

The question we would like to ask is, why is there such a need for this massive marketing campaign during what they keep claiming is a genuine pandemic that we must all be very afraid of at all times?

One can’t help question whether if we stopped listening to all the fearmongers, their attempts to provide a solution to a non-existent problem might also disappear.

Indian Crisis Likely Due To Vaccines, Not Covid

India is currently witnessing a covid-19 surge of unprecedented proportions, with an allegedly triple-mutant strain stretching the nation's healthcare infrastructure to the limits. The uncertainty hanging over the nation is compounded by viral despatches of dead bodies piling up in morgues; of people dropping dead in the streets; of despondent souls jumping off their balconies and of funeral pyres all over the country. There will be no public service-minded Big Tech censorship in this instance.

This is supposedly Wuhan 2.0. Any social media addict would be forgiven for thinking that India's population of 1.3 billion might suffer a dip before the year is out.

Amidst the toxic miasma of fear-mongering, coherent explanations over this surge are hard to come by. Therefore, one needs to resort to correlations and proxies in order to gauge causations and effects. For starters, one should compare the yearly death tolls (from all causes) before and after the advent of covid-19 in India, particularly for the year 2021. But relevant data will only be available a year from now. Many will die as a result of continued lockdowns which generally weaken the immune system. Essential medical procedures will be deferred as hospitals are compelled to focus on covid-19. Rising socioeconomic despair will naturally lead to a surge in suicides. In the end, not all coronavirus deaths can be directly attributed to the virus no matter how "experts" add them up.

Other correlations must also be explored in the Indian context. India was rather late in joining the mass vaccination bandwagon. Throughout 2020, its covid-19 mortality figures were moderate by world standards due to the efficacy of low-cost treatment protocols. Hydroxychloroquine (HCQ) was sanctioned for early stage treatment from March 2020 onwards while a few months later, India's most populous state of Uttar Pradesh (population 231 million) replaced HCQ with Ivermectin (an anti-parasitic drug).

The results were highly encouraging. As the TrialSiteNews (TSN) reported on Jan 9 2021:

"By the end of 2020, Uttar Pradesh — which distributed free Ivermectin for home care — had the second-lowest fatality rate in India at 0.26 per 100,000 residents in December. Only the state of Bihar, with 128 million residents, was lower, and it, too, recommends Ivermectin."

Despite having the coronavirus situation under control, New Delhi was under immense pressure from various international lobbies and their local proxies to roll out a mass

vaccination campaign. It can be argued that India's ongoing oxygen shortages are the direct result of prioritising foreign-curated experimental vaccines over local necessities.

While the initial mass vaccination launch was pencilled for Jan 16, the campaign effectively took off only in late February. With uncanny timing, the New York Times hailed India as an "unmatched vaccine manufacturing power" that could counter China in the area of vaccine diplomacy.

As the goal of vaccinating 300 million people by August 2021 neared the midway mark however, the number of covid-19 cases surged accordingly. The graph below

Is the IMA suggesting that new vaccine delivery systems, as lobbied by Big Tech, will solve this problem? Let us wait and see. Furthermore, is close proximity the prime culprit behind the super-surge in India? India is a nation where trains, busses and all forms of public spaces teem with human bodies. Yet, it did not lead to mass casualties in 2020 as many had feared.

One may scientifically argue that India's surge had nothing to do with

Dakota Governor Kristi Noem, a prominent opponent of mandatory masking, is using covid-19 restrictions elsewhere to lure businesses to her state. Other red states such as Florida and Arizona have moved to ban the so-called vaccine passports.

Rather coincidentally, the annual flu has virtually disappeared in the United States since the onset of the pandemic. It must be a modern medical miracle! How will India fare?

With the surge affecting the nation badly, the CEOs of Google, Microsoft and Apple, among others, have pledged heartfelt aid to India. With friends like these, one wonders why Indians cannot question the covid-19 narrative on Twitter, Facebook or YouTube without being summarily banned or censored. If India can concede the digital rights of its own citizens and the digital sovereignty of the nation to Big Tech, then how is it going to crowdsource solutions for covid-19? Or deal with any other future crisis for that matter? An Indian scientific paper which tentatively explored a laboratory origin for covid-19 can be summarily removed after concerted condemnation from Western academics but a similar claim made by the former head of the US Centers for Disease Control (CDC) appears relatively palatable. Isn't this a textbook example of neoliberal racism?

Indians should also question why Africa has not been badly affected thus far, despite a South African variant hovering in the region. This is a continent mired in conflicts, poverty, serious healthcare deficits and other Third World-related woes. It lacks world-class scientists and institutions which India admittedly has. Is it because Africa does not pose an economic threat to the Western oligarchy the way Asia does? Or maybe, mass vaccinations haven't yet taken off in Africa?

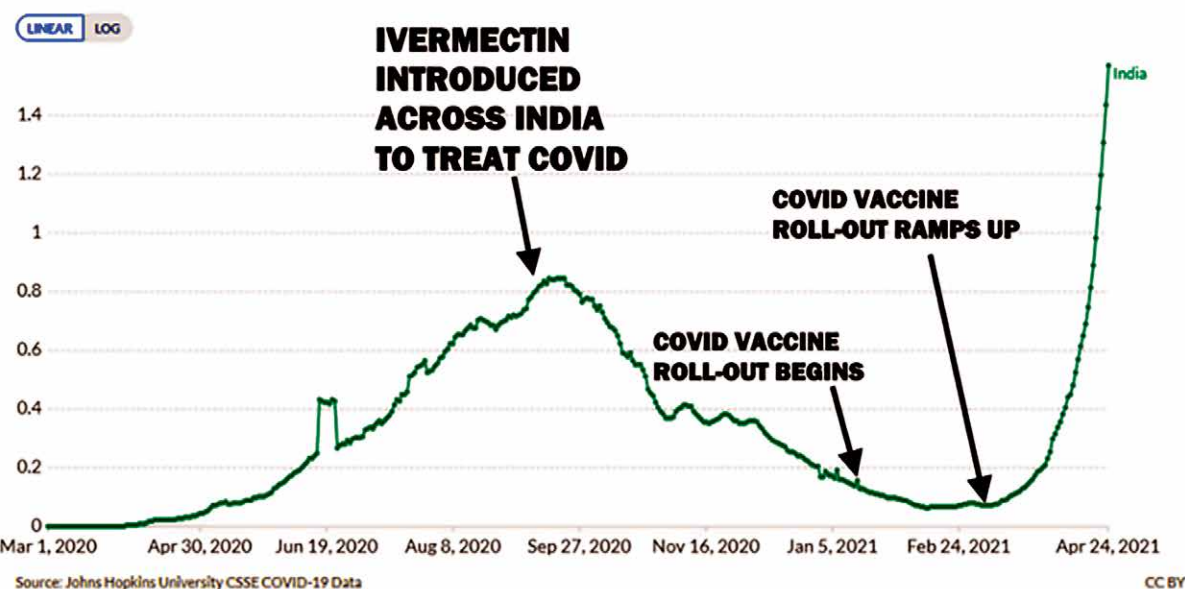
For the time being, India cannot reverse course on its vaccination drive and adopt measures similar to the one employed by the Eisenhower administration during the 1957-58 Asian Flu pandemic. The fear genie is already out of the bottle. Big Tech controls the digital narrative in India as it does elsewhere. Even if New Delhi manages to tame the 'covid-19 crisis' within the next few weeks or months, Big Tech will still be around to stifle India's destiny.

Ultimately, this game is much bigger than covid-19; it is about world domination through perennial mass-manufactured crises until a Great Reset is achieved.

broadly charts this anomaly.

Not only have India's covid-19 cases surged in tandem with increased vaccination, the trajectory of infections and inoculations can be neatly superimposed as the above graph suggests.

not have been able to impose and sustain their covid terror agenda - and much more - on their populations.

Project Veritas is a non-profit journalism enterprise set up in 2011 by James O’Keefe to support undercover reporting. It aims to create an army of guerrilla journalists – working on the inside – to investigate and expose corruption, dishonesty, waste, fraud, and other misconduct in public and private institutions in order to achieve a more ethical and transparent society.

Its biggest audience to date was for the 2019 video of ABC news anchor and US household name Amy Robach stating on tape to her studio crew that she had had the whole Epstein story years before but the network had suppressed it under pressure from the British Royal family. Rule #1 – Truth is paramount. Our reporting is fact-based with clear and irrefutable video and audio

content. Truth is paramount. We never deceive our audience. We do not distort the facts or the context. We do not “selectively edit”.

Rule #2 – We do not break the law. We maintain one-party consent when recording someone is inherently moral and ethical. We never record when there is zero-party consent. In areas where we are required to have consent from all parties, we seek legal guidance (abridged)

Rule #3 – During our investigations we do not disrupt the peace. We do not infringe on the 1st Amendment rights of others. (abridged)

Rule #4 –The undercover investigations we pursue are judged by us to be of “vital public interest” and “profound importance.” Undercover investigative reporting is necessary because, “...there’s no other way to get the story.” Whereas the Society of Professional Journalists allows for undercover techniques, if undercover techniques are necessary to expose issues of vital public importance, we believe they are not only allowed but required.

Rule #5 – We Protect the Innocent When Possible - Embarrassing private details are not to be investigated. We stay away from irrelevant, embarrassingly intimate details about private citizens’ personal lives. We look for individual wrong-doing and judge its public importance. The irrelevant religious or sexual dispositions of our targets are not to be investigated.

Rule #6 – Transparency. Our methods and tactics must be reasonable and defensible. We use the “Twelve Jurors on Our Shoulder” rule. The work has to be done with such a degree of integrity that it can withstand

scrutiny in both law and ethics. We are comfortable with transparency. We must be willing to be ready to disclose our methods upon publication.

Rule #7 – Verifying and Corroborate Stories – Evaluate impact on third parties and Newsworthiness of Statements Alone. We consistently consider the probable truth or falsity of statements, examine any reasons to doubt the veracity of underlying assertions and whether the assertions are newsworthy. When possible, we will confirm with our subjects that their statements captured on video are accurate and truthful (abridged)

Rule #8 – Raw Video. In certain circumstances we may release the “raw” video to the press and or the public. But as a rule, we do not.

Rule #9 – Subject Anonymity. We investigate and question sources before promising anonymity. Once we confirm, we will do everything in our power to protect the identity of our confidential sources.

Rule #10 – Being Accountable. Admit mistakes and correct them promptly.

Rule #11 – We do not manufacture content. We do not put words in our investigative subjects’ mouths. We do not lead the horse to water. Our purpose is to elicit truth.

Rule #12 – With Great Power comes Great Responsibility.

‘All Covid Vaccines Should Be Discontinued’

French drug evaluation center concludes: ‘All 4 covid vaccines should be discontinued’

The Centre Territorial d’Information Pharmaceutique d’Avis (CTIAP for its French acronym) concluded that none of the four vaccines implemented in France are safe or effective. They all received emergency use authorisation with insufficient clinical evidence and therefore demanded their immediate suspension.

CTIAP, which is linked to the Cholet public hospital in Western France, recently published a report showing that the vaccines used against covid underwent insufficient clinical testing. Also, the quality of the active substances, their ‘excipients—some of which are new,’ and the manufacturing processes are deficient.

Dr. Catherine Frade leads the research team, a renowned pharmacist who worked on public data reported by the European Medicines Agency (EMA) regarding injections from Pfizer, Moderna, AstraZeneca, and Janssen (Johnson & Johnson).

The first warning published in the report is that all these products have only temporary Marketing Authorisations (MA). Besides, they are all subject to further studies until 2024, making it almost impossible to complete them given the accelerated way vaccines are being distributed.

In this regard, CTIAP warns that all vaccines began to be marketed and actively applied in humans before the “quality testing of the active substance and the finished product” had taken place: All manufacturing laboratories have future deadlines to submit their studies in this regard. Even though they knew that by the time they submitted them, much of the world’s population

would already be vaccinated.

The report does not indicate that vaccines are outright dangerous, but current knowledge is not valid enough to demonstrate their effectiveness and/or safety.

The vaccines began to be manufactured and applied amid laboratory trials, which implies that an alteration in the results during the next few months could invalidate any previous trials because they are still in a period of research and adaptation.

The report draws an interesting parallel between vaccine production and automobile production. It asks whether we would imagine it feasible to start a production line for a new car and begin marketing it without

completing quality studies on each of its parts and engine, including safety-related components such as its brakes and electrical systems.

The logical answer is no, so why would we do so with vaccines, a substance intended to be inoculated directly into the body of every human being in the world?

The report concludes: “Prudence would surely dictate that, in all countries where these vaccines against covid-19 have been marketed, all batches thus ‘released’ should be withdrawn immediately and that any MA’s that have been granted should be suspended, or even cancelled, as a matter of urgency, until further notice.”

CDC Sued For Fraud By 7 Universities

CDC sued for massive fraud: Tests at 7 universities of ALL people examined showed that they did not have Covid, but just Influenza A or B – EU statistics: ‘Corona’ virtually disappeared, even under mortality.

HOW SAFE ARE VACCINES?

Most people who vaccinate their children do not realise the kind of ingredients contained in vaccines - even if they do know, they may not fully understand what that particular ingredient does or what it means.

Mercury

Mercury is 500 times more toxic than lead and is second only to Plutonium as the most toxic metal known to man. Injected mercury is different than ingested mercury. The American Academy of Pediatrics confirms aluminium affects the body negatively. Repeated exposure to aluminium can have damaging effects. If following the recommended schedule of the CDC, a child gets injected every couple of months with more aluminium. Studies with mice demonstrate a transient rise in aluminium levels in brain tissue. This means aluminium builds up in the brain and potentially other organs. Aluminium is widely associated with breast cancer. More recent research shows a link between aluminium and Alzheimer's Disease.

Animal Organ Tissue & Blood

Vaccine manufacturers have long used cell material from mammals to make vaccines now in use or to make experimental vaccines. There is an inherent risk of contamination with viruses and other microbes (or DNA from those microbes) that can escape detection during the vaccine development, testing, licensing, manufacturing and oversight process. Vaccines can contain pig blood, horse blood, rabbit brains, dog kidneys, cow hearts, monkey kidneys, chick embryos, calf serum, sheep blood and more, linked to childhood leukemia and diabetes.

Aborted Foetal Tissue

A number of vaccines—including varicella, rubella, hepatitis A, shingles, and rabies - are made using foetal embryo cells, and have been for decades. The reason given is that the viruses tend to grow better in these cells, and foetal cells can divide for a long time before dying. However, the use of actual human foetal cells poses the question of how the foetal DNA will interact with the virus and, eventually, the human into which it is injected. It remains unclear what kind of dangerous immune response this has been provoking, but according to the Sound Choice Pharmaceutical Institute, a biomedical research organisation, there have been distinct spikes in autism rates in the years when vaccines grown in human foetal cells were introduced. In my opinion, the moral implications here are huge.

Squalene

The World Health Organization (WHO) describes squalene as “a component of some adjuvants that is added to vaccines to enhance the immune response.” The WHO notes that most people who have received squalene-containing vaccines are in older age groups, and that we don't really know how this component might impact younger people. A 2000 study found that a single injection of squalene adjuvant produced arthritis in rats, and many believe squalene-containing anthrax vaccine to be the main culprit in triggering Gulf War Syndrome among American troops who served in the Persian Gulf War in the early 1990s.

Polysorbate 80

A preservative used in vaccines called Polysorbate 80 is so toxic that it should never touch your skin or be ingested. Studies with lab rats show this preservative has both carcinogenic and infertility effects. Yet this known carcinogenic ingredient is found both in Merck's cancer vaccine, Gardasil, and also used in chemotherapy given to cancer patients. The safety of using this chemical in vaccines has been poorly studied, and according to the Material Safety Data Sheet (MSDS) for Polysorbate 80, it may cause adverse reproductive effects and cancer based on animal testing data. The MSDS also indicates that no safety testing has been done in humans.

Monosodium Glutamate (MSG)

More commonly known as a food additive, MSG is also used as a stabilizer to help

vaccines remain unchanged when exposed to heat, light, acidity or humidity, according to the CDC. MSG consumption is notorious for causing headaches in some people. It can also cause fatigue, disorientation and heart palpitation, per the Mayo Clinic. MSG has been called an “excitotoxin,” which is a term used to describe a class of chemicals (usually amino acids) that over-stimulate neuron receptors in the brain, causing them to die.

DTaP, IPV, HBV and Hib*: (Diphtheria, tetanus, polio, hepatitis B and Haemophilus influenza type B) Given to infants 2 to 12 months with boosters less than a year later. *Contains* aluminum hydroxide, formaldehyde, and bovine cow serum.

Gardasil HPV: Human Papillomavirus Vaccine Made by Merck. Administered to children as young as 9 years of age for a rare sexually transmitted disease. *Contains* polysorbate 80, sodium chloride, aluminum, and a ‘denatured’ (fragmented and weakened) form of the virus.

Canadian Pastor Arrested For Worship

Officials in Calgary, Canada, said they arrested Artur Pawlowski, a street preacher who allegedly defied local lockdowns, over the weekend.

“Earlier today, police arrested two organizers of a church service who were in violation of a new court order obtained by Alberta Health Services (AHS) in relation to mandatory compliance of public health orders for gatherings,” said the Calgary Police Service in a statement on Saturday.

His brother, David Pawlowski, was also taken into police custody. Both were charged with allegedly organising an illegal in-person gathering as well as “requesting, inciting or inviting others” to join them, according to police.

The force said that Alberta’s provincial government obtained a bench order from a court that applies to “protests, demonstrations and rallies” that imposes “new restrictions on organisers of protests and demonstrations requiring compliance with public health orders including masking, physical distancing and attendance limits.”

“It is important to understand that law enforcement recognises people’s desire to participate in faith-based gatherings as well as the right to protest. However, as we find ourselves in the midst of a global pandemic, we all must comply with public health orders in order to ensure everyone’s safety and wellbeing,” the police service added.

Canadian Preacher Artur Pawlowski Arrested, Charged After Allegedly Defying Public Health Orders

A video uploaded on Twitter that appeared to show his arrest on a highway included Pawlowski’s voice: “If you are watching this video, it means that they have successfully arrested me.” It included a link to a crowdfunding website for his legal defence.

During the covid-19 scamdemic, the Pawlowski brothers have held gatherings and have denied officials’ entry into their church located in Dover, Calgary, according to reports.

Pawlowski drew headlines several weeks ago after he compared police with the Nazi Gestapo paramilitary forces and fascists.

“And they did it again! Today, the Gestapo Attacked our Church Again! History is being repeated in front of our eyes! Another sad day for Freedom and democracy!” Pawlowski wrote on April 24.

Before that, in a viral clip, he was seen in a video telling officers: “I



do not co-operate with Gestapo!”

“I’m not interested in any word that you have to say. I do not co-operate with Gestapo, I do not talk to the Nazis,” Pawlowski told officers on Easter Sunday weekend, adding, “Brown shirts of Adolf Hitler. You are Nazi, Gestapo, communist, fascists! I do not co-operate with Nazis!”

On April 3, Pawlowski was

fined \$1,200 for allegedly holding a public gathering of more than 15 people at his Street Church, in violation of covid-19 health orders.

“I grew up under a communist dictatorship behind the Iron Curtain, under the boot of the Soviets, and I’m telling you that’s no fun at all. It was a disaster,” he said in the interview. “So, it was like a

flashback when those police officers showed up at my church. Everything kind of came back to life from my childhood, and the only thing I could do is to fend off the wolves as a shepherd, and I used my voice to get rid of them,” Pawlowski added.

A Million Euros For Sample Of Covid-19

Many investigations and reports have been generated around the world concerning the disastrous covid-19 plandemic; however, for some people and institutions, it has not been satisfactorily proven that it is the cause that generates the deaths attributed to it.

The website adds: “The currently offered 1 million euros will be completely covered by Team Samuel Eckert. Thank you very much for your commitment! Get in touch.”

He had already collected about \$13,500, which will be returned to the contributors.

Eckert is one of many people who still doubt the veracity of the whole narrative surrounding the covid-19 virus and the strong push to vaccinate everyone on Earth.

He has also created channels on Telegram and other social networks, offering a forum for exchange for those who are like-minded. One of his Telegram accounts links 120,000 users.

Italian journalist Cesare Sacchetti, meanwhile, adds a bit more information about the requirements to be met by those aspiring to claim Eckert’s reward.

“German journalist Samuel Eckert is offering a reward of 1 million euros for those who provide irrefutable proof of the existence of covid-19,” he writes in one of his tweets.

He adds: “By proof, he means the isolation of the virus according to Koch’s postulates. To date, no one has been able to win Eckert’s challenge,”

reiterating that the virus does not meet the classical requirements established since 1905.

Robert Koch was a German physician who won the Nobel Prize in Physiology or Medicine in 1905 for his work on tuberculosis and established the postulates on the lethality of a virus, not its existence.

Many questions surround the pandemic and the repeated contradictions of the WHO, and the difficulties in studying the origin of the virus in the virology laboratory of Wuhan, China, do not contribute anything to help clear them up.

More and more questions arise, such as the one raised a few days ago in the lawsuit filed by the clinical scientist and immunologist-virologist of a Southern California laboratory, Dr. Derek Knauss,

and his colleagues from 7 universities against the Centers for Disease Control and Prevention (CDC) for massive fraud.

How One Radio Broadcast Caused Mass Panic In U.S.

Orson Welles caused a nationwide panic with his broadcast of 'War of the Worlds', a realistic radio dramatisation of a Martian invasion of Earth. Orson Welles was only 23 years old when his Mercury Theatre company decided to update H.G. Wells' 19th-century science fiction novel 'War of the Worlds' (1898) for national radio. Despite his age, Welles had been in radio for several years, most notably as the voice of 'The Shadow' in the hit mystery programme of the same name. 'War of the Worlds' was not planned as a radio hoax, and Welles supposedly had little idea of the havoc it would cause.

The show began on Sunday, 30th October 1938, at 8 p.m. A voice announced: "The Columbia Broadcasting System and its affiliated stations present Orson Welles and the Mercury Theatre on the air in 'War of the Worlds' by H.G. Wells.

Sunday evening in 1938 was prime-time in the golden age of radio, and millions of Americans had their radios turned on. But most of these Americans were listening to ventriloquist Edgar Bergen and his dummy 'Charlie McCarthy' on NBC and only turned to CBS at 8:12 p.m. after the comedy sketch ended and a little-known singer went on. By then, the story of the Martian invasion was well underway.

Welles introduced his radio play with a spoken introduction, followed by an announcer reading a weather report. Then, seemingly abandoning the storyline, the announcer took listeners to "the Meridian Room in the Hotel Park Plaza in downtown New York, where you will be entertained by the music of Ramon Raquello and his orchestra." Dance music played for some time, and then the scare began.

An announcer broke in to report that "Professor Farrell of the Mount Jennings Observatory" had detected explosions on the planet Mars. Then the dance music came back on, followed by another interruption in which listeners were informed that a large meteor had crashed into a farmer's field in Grovers Mills, New Jersey. Soon, an announcer was at the crash site describing a Martian emerging from a large metallic cylinder. "Good heavens," he declared, "something's wriggling out of the shadow like a gray snake. Now here's another and another one and another one.



They look like tentacles to me...I can see the thing's body now. It's large, large as a bear. It glistens like wet leather. But that face, it...it...ladies and gentlemen, it's indescribable. I can hardly force myself to keep looking at it, it's so awful. The eyes are black and gleam like a serpent. The mouth is kind of V-shaped with saliva dripping from its rimless lips that seem to quiver and pulsate."

The Martians mounted walking war machines and fired "heat-ray" weapons at the puny humans gathered around the crash site. They annihilated a force of 7,000 National Guardsmen, and after being attacked by artillery and bombers the Martians released a poisonous gas into the air. Soon "Martian cylinders" landed in Chicago and St. Louis.

The radio play was extremely realistic, with Welles employing sophisticated sound effects and his actors doing an excellent job

portraying terrified announcers and other characters. An announcer reported that widespread panic had broken out in the vicinity of the landing sites, with thousands desperately trying to flee.

In fact, that was not far from the truth. Perhaps as many as a million radio listeners believed that a real Martian invasion was underway. Panic broke out across the country. In New Jersey, terrified civilians jammed highways seeking to escape the unseen alien marauders.

People begged police for gas masks to save them from the toxic gas and asked electric companies to turn off the power so that the Martians wouldn't see their lights. One woman ran into an Indianapolis church where evening services were being held and yelled, "New York has been destroyed! It's the end of the world! Go home and prepare to die!" When news of the real-life panic

leaked into the CBS studio, Welles went on the air as himself to remind listeners that it was just fiction.

There were rumours that the show caused suicides, but none were ever confirmed. The Federal Communications Commission investigated the programme but found no law had been broken. Networks did agree to be more cautious in their programming in the future..

Orson Welles feared that the controversy generated by "War of the Worlds" would ruin his career. In fact, the publicity helped land him a contract with a Hollywood studio, and in 1941 he directed, wrote, produced, and starred in 'Citizen Kane' – a movie that many have called the greatest American film ever made.

Whether he intended to or not, Orson Welles' radio broadcast on Oct 30th 1938, announcing an invasion from Mars, caused mass hysteria across the United States as thousands flooded police stations, newspapers, radio stations and government bodies with panicked calls from people who genuinely believed Welles' dramatization of HG Wells' 'War of the worlds' was real.

This is the power of a mass broadcast system. By just using the audio of a wireless radio transmission, Welles convinced millions that earth was under attack, despite there being no evidence of it from the real world in front of them – either in their personal vicinity nor by contact from more distant networks of family and friends.

Now imagine what is possible with video as well as audio, and it was everywhere, on every channel, all day, every day.

The Israeli People's Committee, an independent investigative group that comprises medical, legal, and epidemiological expertise, has released a summary report on the experience of mass experimental vaccinations in Israel, which uses the Pfizer mRNA vaccine.

The data collected by the group paint a grim picture:

- The overall mortality in the January-February vaccination period was higher in 2021 than in any other year within the preceding decade. In the age group of 20–29 years, mortality in this time period exceeded that of the previous year by 32%.
- 288 deaths overall, mostly within the first 10 days after vaccination, were reported to the group. This number is more than **six times greater** than the 45 deaths officially admitted to by the Health ministry.
- The group gives the following estimates for the mortality among the vaccinated: overall, 1:5,000; age 20–49 years, 1:13,000; age 50–69 years, 1:6,000; age 70+, 1:1,600.
- Across lethal and non-lethal adverse events there was a relatively high rate of cardiac-related injuries, 26% of which occurred in young people below the age of 40, a high prevalence of massive vaginal bleeding, neurological, skeletal and skin damage, and events directly or indirectly related to coagulopathy (myocardial infarction, stroke, miscarriages, disruption of blood flow to the limbs and pulmonary embolism).

According to the authors, the compilation of the report was severely hampered by obstruction on the part of government authorities, involving in particular the shutting down of all monitoring and tracking systems for adverse events.

I've been writing about prescription drugs and vaccines for over half a century. My books on the subject have been translated into 25 languages and sold around the world. My first book, 'The Medicine Men', was an analysis of the relationship between doctors and drug companies. The book, published in 1975, was serialised in The Guardian newspaper and the subject of a 20 minute film on the BBC's main news programme of the time.

Over the years some of my campaigns have resulted in changes to government policy. And, in the past, I was regularly invited onto television to debate contentious issues. The BBC, Sky etc used to hire me as a presenter and expert. I doubt if there is a major media house which I haven't worked for. I once had five columns in national newspapers at the same time. Today, however, the truths I can tell are considered far too dangerous to be aired to a wide public. The refusal to allow debate or discussion isn't personal but is a result of their determination to suppress the truth and feed the public an unending diet of lies and misinformation.

Indeed, governments here and in the United States are working hard to ensure that the truth is suppressed and that I am demonised and discredited.

What used to be my Wikipedia page, but which is now a compendium of lies and libels, is controlled by the Central Intelligence Agency in the USA and the British Secret Intelligence Service. Describing me as a discredited conspiracy theorist and anti-vaxxer was done purely to

stop people listening to anything I say. It is worth noting that Larry Sanger, the co-founder of Wikipedia, recently described the self-styled, self-published fake encyclopaedia, as 'thoroughly corrupt', tarnished with 'behind the scenes control and payoffs'. Wikipedia is an encyclopaedia in the way that the BBC is an independent broadcaster.

Last month alone there were well over eight million worldwide visits to just one of my websites and, presumably as a result, there were over 1,700 serious attempts to hack into that site and take it down. Most of the hacking came from the United States.

The attacks and the abuse now come daily. The liars frequently claim that I have been discredited or struck off the medical register. Neither of these **libels** is true.

It annoys me when the British Government expresses dismay at the abuse on social media when I know that the British Government is the main source of the abuse I suffer.

The eagle-eyed might have noticed that I no longer put the letters FRSA after my name. The reason is simple. Last month I was expelled as a Fellow of the Royal Society of Arts because the society was unhappy with my opinions and offended that I had been attacked on the BBC's bent Panorama programme. Objecting to my factually accurate views seemed a little close to Stalin

for my taste and expelling me because I'd been attacked by the BBC looked like fining the victim of a mugging.

I am not, of course, the only health professional to have been attacked. Every honest health professional who has dared to question the lies being told has been vilified and lied about and their work unfairly discredited.

And it is this deliberate, cold-blooded, dishonest demonisation of those of us trying to share the truth which, in part at least, explains why we are struggling to defeat the fascists and tyrants who are determined to impose the global reset upon us – against our will.

The facts have been victims in this war – as they are in all forms of serious conflict.

But we don't actually need more facts that covid-19 is a fraud. We don't need more evidence that the mainstream media and the so-called fact checkers are bent.

We need to spread the truth outside those who already know that the covid-19 myth is based on fraudulent fake science. We need to accelerate the rate at which we share the truth with the unknowing.

Marches and twitter conversations can, I know, be comforting and reassuring. It's easy to feel alone in a world where the mainstream media is committed to promoting the dishonest pro-vaxx arguments.

But to win the war we have to reach outside, into the scary world where people believe what they've been told about masks and jabs. We will win by sharing the truth with as many people as possible.

People who believe that the experimental 'vaccine' works are, by definition, terminally trusting and gullible. They are buying a deliberately manufactured myth and a network of self-sustaining lies. They are the sort of trusting innocents who probably still believe that Father Christmas squeezes down chimneys once a year.

We need to share the facts which prove, without any question, that the experimental jabs have killed and maimed tens of thousands. To do this we simply share government figures from the US and the UK.

We need to share the evidence proving that although the virus is real it is no more deadly than the annual flu virus and that it was a hoax to claim that we are facing the greatest threat to human health since the Black Death.

As I've said for over a year, it isn't

the virus that is a hoax – the hoax lies in the way that the virus has been marketed, promoted and advertised.

We aren't going to win this war with marches, demonstrations, twitter spats or arguments about exosomes or germ theory.

We are going to win the war by reaching out to people outside the resistance movement. And we will do this by presenting the truth in a solid, reliable, entertaining and irrefutable way. We have to promote the truth so that we convert those who have been tricked, lied to and convinced by organisations such as the BBC.

The mainstream media won't allow us to debate these issues. We can't use Facebook or Twitter because these platforms are owned by the fascist cabal trying to take over the world. We are living in a totalitarian society where the truth is suppressed by the authorities.

I have believed for many months that we need to reach out by sharing our information in the only way we can: through distributing leaflets, by handing out copies of The Light Paper and by emailing copies of documents which prove the Government, the media doctors and the broadcasters are lying through their teeth.

It isn't difficult to do. There are leaflets and articles aplenty on www.vernoncoleman.org where everything is free to download and send.

And for addresses try using media.info – a website which contains the contact details of newspapers, magazines, radio and television.

We need an army of people prepared to do these things. Send out five emails a day and you can consider yourself a Major in the Resistance Army. Ten emails a day and you're a Colonel. Fifteen emails a day makes you a Brigadier. And if you send out twenty emails a day then you can call yourself General.

My suggestion? Send out the regularly updated article 'UPDATED – How Many people Are the Vaccines Killing?'

Send it to doctors, journalists and politicians.

Or send the video and transcript of 'Final, Irrefutable Proof that the covid-19 Pandemic Never Existed.'

Only by sharing the truth will we win this war.

Jam For Freedom

In the summer of 2019 I moved to London after almost 3 years of travelling to make a career for myself in the music industry. After a few months of busking in Leicester and Trafalgar Square I was making enough money per hour to quit my job. I saved all my tips and invested it in creating a 15-piece, high-end functions band...which was due to launch in March 2020.

The month when all venues were forced to close due to the 'covid' scandal. But instead of complaining, I created London's only outdoor jam event named the 'Outside Jam', hosting 21 jams over 6 months in summer 2020 (almost 1 a week). Audiences would tip us and this would be spread equally to the band - the only paid gigs all summer for most! However, in December the government decided everything had to close, and with the cold weather outside the game was up. Live music was officially over - or so I thought. That's when the idea struck me to reform the Outside Jam and relaunch it as the Jam for Freedom - a protest against the unscientific and destructive policies attacking our career and ambitions. And we would tour the ENTIRETY of the country with our live music, in defiance of the so called '10 mile' restriction!

Our first gig on January 23rd 2021 in my hometown of Watford was a great success, with 2 hours of live pro freedom tunes belted from the band and dancing from the public! It did however result in the arrest of supporter Andy for the crime of handing out our 'contaminated' leaflets and getting too close to people. He refused to leave the area which led to the unlawful arrest and his being held in custody overnight. Our drummer, Felipe, himself a migrant from Brazil who moved to the UK for its culture of freedom and live music, was ordered to leave the area and fined. I was also ordered to pack and leave for 'causing alarm and distress'.

But this didn't deter us. We headed home and formed a masterplan to raise enough money to get a motorhome to travel the UK and bring free live music to 21 different cities, and in February began doing local jams to raise the cash.

First up was Tower Bridge (where I took a live haircut whilst performing to show solidarity with the self-employed), Turnham Green (where we got an hour and a half of tunes in to a large crowd before police ordered us out) and then Wood Green where we made the high street smile before large crowds in the area led to more police orders to stop.

In just over 4 weeks from our first gig we managed to raise enough to

rent a motorhome for a 3 week tour. A large part came from a single private donor that loved what we were doing and had seen us play live twice.

We started our tour in Windsor, heading to Brighton and then detouring to Bishops Park in West London after being invited to a pro-freedom rally. We brought the equipment and fantastic musicians around us provided the backdrop to an incredible gig where around 200 people danced, hugged and sang. Midway through singing 'I Want to Break Free' I was arrested. My first ever arrest at 26! The people were angry. Shortly after, they detained Piers Corbyn as well and we made acquaintance in the back of the police van. I ended up spending a night in the cell and now have to attend a court date on June 10th to defend my 'crime' of helping mental health and protecting the sacred art of live music.

The day after my release I took the jam to Southend-On-Sea. Although the coppers did move us on from the high street, they also pulled us over to 'check I was insured'! Obviously I was. We then took the jam to a supporter's sofa where the remainder of the crowd joined in the fun. Unfortunately, due to the police's contacting the owner of the motorhome and revealing to him our 'illegal' activities and my arrest, we then unfortunately were forced to return it. But once again, this did not stop us. I continued to gig across

London, opening up for Piers Corbyn on his Mayoral campaign, Primrose Hill; playing to hundreds singing Hey Jude in Leicester Square for the end of the 20th March Freedom rally, and then to Walton-on-Thames, Surrey.

Approaching the end of March, we had built up enough publicity that we were pulling in enough donations to just about make it work. A kind donor offered us enough money to go toward a cheap people carrier! With that we were off on our second tour across the country where we went as far as Glasgow and played 17 jams through April.

At the end of the freedom rally on the 24th of April we played for a couple of hours to hundreds in Hyde Park. Clearly not pleased with our happiness, police recklessly marched in and damaged our equipment. Luckily no crowd members were hurt. Little did we know that a certain 3-time inductee to the rock and roll hall of fame, by the name of Eric Clapton, was watching this very gig live, mid-way through writing his new song 'Where Have All the Rebels Gone' in collaboration with Van Morrison. Well Eric, you've found them! Eric proceeded to donate £1000 to us, which brought us from broke to bouncing with glee! He has also lent us a bus to get around in! In response we were able to finance our May-June tour which will visit 26 areas throughout England, Wales and Scotland.

50 Members Of Common Law Court Submit Declaration Of Bias

The Declaration states that there is bias and business entanglement between Milton Keynes Council and Milton Keynes Court and therefore the Court is unable to maintain its impartiality, preventing independence and unable to serve justice. The Declaration states that the relationship between the corporations is in breach of both English Law and international treaties.

The Declaration contained evidence of the claim ranging from Halsbury's Law, the Bangalore Principles and Moto Proprio. The two organisations were instructed by the people to suspend any and all claims brought to Milton Keynes Magistrates Court by Milton Keynes Council until such times as full disclosure is made. The two businesses will be acting unlawfully if they fail to execute the instruction.

It is for this reason that 15 Lawful Counsellors from Common Law Court Four Counties recently attended a scheduled hearing on behalf of Paul Watson in the matter of council tax. Eight Police Constables were brought into the court but were immediately dismissed by the Lawful Counsellors as there was no breach of the peace and no crime. The case was adjourned by the judge as he refused to proceed.

The Magistrates Court have adjourned this landmark hearing until Tuesday 22nd June 2021 at Milton Keynes Magistrates Court at 10.am. Common Law Court Four Counties would like to engage the support of anyone who can attend from 9.30 a.m. on the morning of the case. There is a planned march from the Court to the local Council Offices on the same morning.

Preventers & Promoters Of Respiratory Diseases

How do prophylactics prevent disease and can you really catch covid-19 from 5G?

Prophylactics are either synthetic medicines, or medicinal plants, Omega 3 oils, probiotics and vitamins, likely to prevent people from contracting disease; they can also help to reduce disease severity. The emergence of severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) is postulated to be responsible for covid-19 disease, and much discussion has surrounded the use of prophylactics in its prevention. Can this disease really be prevented? Evidence suggests it can.

Ivermectin and hydroxychloroquine are synthetically-created medicines; both are celebrated anti-parasitic drugs with well-documented safety profiles and proven, highly potent, antiviral and anti-inflammatory properties. They are inexpensive and feature on the WHO list of essential medicines. Anti-viral pharmaceutical prophylactics have been used for decades to prevent and reduce disease severity. Whilst the U.S. FDA and UK MHRA have not yet approved ivermectin and hydroxychloroquine for prevention of, or treatment of covid-19 disease, studies suggest the individual use of these medicines may prevent and reduce disease severity. There are also a number of medical plants with anti-viral and anti-inflammatory properties in medical trials that almost match the effectiveness of their synthetic alternatives. Quercetin and quinine are two powerful natural alternatives. Vitamin D is also a celebrated prophylactic, well-known for preventing respiratory tract infections.

Promoters of disease are chemicals or environmental contaminants which may encourage serious illness. It has been postulated that 5G spreads covid-19. How can this possibly be? It sounds a ridiculous notion. So, let us discuss, disease preventers and promoters in a clear and simple way:

Vitamin D

People with higher baseline vitamin D are 60% less likely to die of covid-19, therefore it makes perfect sense to follow NHS advice and supplement with up to 4000 International Units (IU) per day. This is an easy way of reducing the

likelihood of contracting respiratory tract disease and of reducing its severity (Martineau 2017). And this makes it the super-hero in the fight against covid-19 disease. In a Spanish

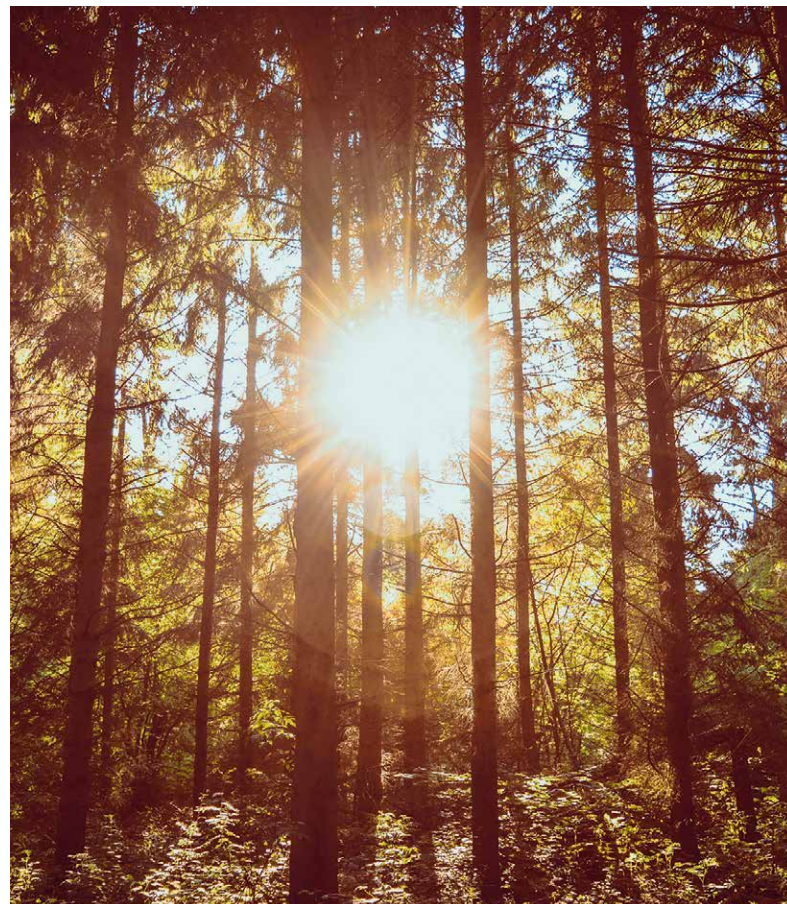

study, supplemental vitamin D3 reduced covid-19, ICU admissions by 82% and mortality by 64%. Many enthusiasts have been lobbying the UK government since early March 2020, calling for vitamin D supplementation for all, especially the most vulnerable, known to suffer innate vitamin D deficiency: black and ethnic minorities, older people, diabetics and those with obesity conditions. Reduction in deaths in Europe correlate with latitude, sun exposure and corresponding vitamin D levels, as in the Far East, where Cambodia and Laos have suffered only a handful of deaths. Vitamin D influences regulatory T-cell responses, essential for defence against bacterial infections. Optimising vitamin D absorption with a synergistic blend

of magnesium and vitamin K2 increases vitamin D uptake. Also, when you are insulin sensitive and eating a low-carb diet, you produce healthy ketone levels, which help inhibit cytokine hyper-inflammation, a primary cause of covid-19 deaths.

Quercetin and Quinine:

Studies confirm the role of many plants against respiratory viruses. Phytochemicals demonstrate activity against coronaviruses through viral entry inhibition, replication enzyme inhibition and blockage of viral release. Quercetin is a natural anti-histamine with anti-inflammatory properties; it also helps transport zinc into cells. Zinc is vital for healthy immune function and a combination of zinc and an ionophore was in 2010 shown to effectively block viral replication of SARS coronavirus in cell culture. Where hydroxychloroquine is unobtainable, quercetin or quinine (tonic water) may be a better substitute, as they also mimic hydroxychloroquine in

using zinc to inhibit viral replication.

Ivermectin

Evidence suggests Ivermectin can be useful at all stages of covid-19, especially as a prophylactic. In August 2020, Uttar Pradesh and Bihar distributed free Ivermectin and by the end of 2020, both states had the lowest death rates in India. A WHO-sponsored review suggests Ivermectin can reduce deaths by 83%. Dr. Andrew Hill of Liverpool University, describes Ivermectin as a potentially transformative treatment. In the U.S., Dr. Pierre Kory of the Covid-19 Critical Care Alliance suggests clinical studies show a large magnitude of benefits with Ivermectin, both as a prophylactic and treatment of all phases of covid-19 and keeps those with early symptoms from cytokine hyper-inflammation. While Ivermectin certainly appears to be useful, optimising your vitamin D levels should be your primary strategy.

Hydroxychloroquine:

Hydroxychloroquine helps shuttle zinc into human cells to block SARS-CoV-2 RNA-dependent RNA polymerase (the enzyme required for viral replication). Many doctors worldwide have reported great success with hydroxychloroquine and zinc in combined use, as a prophylactic. A medical review in the January 2021 issue of The American Journal of Medicine suggests, use of hydroxychloroquine and zinc reduced hospital entry. July 23, 2020, Dr. Harvey A. Risch, professor of epidemiology at Yale, suggested, the primary benefit of hydroxychloroquine comes from zinc, which inhibits viral replication.

Promoters of Disease

The connection between covid-19 and 5G is inconclusive. One theory suggests that 5G has promoted the emergence of covid-19. In Dr. Arthur Firstenberg's book, 'The Invisible Rainbow', a claim is made that as the world has become electrified, viral pandemics have followed, and suggests a correlation between the 1918 Spanish flu pandemic and roll-out of the first radio telegraphs. Dr. Thomas Cowan suggests 5G produces EMF-induced cellular toxicity. Poor

immune function, possibly caused by EMF in those with electro-sensitivity, combined with unhealthy living, may have enhanced infection. Two of the areas hardest hit by covid-19, Wuhan and Northern Italy, implemented 5G just before their outbreaks; perhaps lowering natural immune defence and promoting chronic inflammation; although those who died, mostly were older people with obesity and diabetes, with insulin resistance being the common factor. High blood sugar will create an open back-door osmosis opportunity, for viral entry into cells. Any correlation with 5G may be a red herring, hiding apparent innate vitamin D deficiency; and in the UK, a reported incident where a married couple ended up seriously hyper-inflamed with covid-19, two weeks after receiving their flu vaccine, like 5G, could be coincidental, but should be given our careful consideration.

Veggie Armageddon Pantry

The idea of an armageddon pantry is not to assume that the end is nigh and to panic buy us all out of wheatgrass; more of an invitation to just calmly acknowledge that we're in the middle of an almighty shitstorm that's likely to get a bit bumpier before the dust settles and to perhaps slowly add a few considered items to our weekly shop in preparation for the small possibility of temporary difficulties.

Many people I know, myself included, are thinking about empowering themselves with self-sufficiency, which tends to start with growing vegetables.

I'm notoriously bad at growing & foraging. I once had an allotment for a year and grew 2 pumpkins. The next year I went for 'crops in pots' and produced 4 x 2 inch carrots and a small bunch of new potatoes.

This year I went for a bag of dried beans & pulses and herein lies the inspiration for my armageddon survival pantry.

Here are my top 10...

1. Sprouted vegetables - not a lot of people know this, but if you sprout dried beans & pulses for long enough (until the sprouts are about 3-5mm or more), they become vegetables...I know. I fell off my chair when I found out.

There are so many pros and barely any cons. They last for for ever, so

you can buy them by the kilo if you like, they require no soil, no land, no dependency on British weather, no slug repellants, no cat repellants, no encyclopedias of which seeds 'get on' with others and which hate each other, and best of all they're fully grown and ready to eat in one week flat. What's not to love?!

Well, the down side is that they all taste pretty similar and will never make a decent soup. Remember though we're talking armageddon survival here, not MasterChef.

These are the main event in my pantry because vegetables ideally make up at least 50-80% of 2 meals a day. Sprouted ones are extra incredible too as they are raw and are packed full of vitamins, minerals and enzymes. If necessary (i.e. you're not sick to death of them), the beans & pulses can obviously be used as themselves too; just soak them for 8-12 hours before cooking. They can then be whizzed up into an endless array of houmous type creations, depending on what else you have available. If you're either desperate or highly conscientious, sprouted seeds can even be dehydrated and blitzed into a powder to encapsulate or sprinkle over everything else for added nutritional oomph.

2. Sauerkraut and/or kimchi. These are both packed full of

gut-boosting good bacteria, but I would opt for kimchi for this particular armageddon as it's so amazing for immunity with all the antioxidant rich spices and garlic. It's incredibly delicious and lasts for months, so a great way to use up someone else's spare cabbages and go all Amish for the winter (see kimchi recipe on my recipes page).

3. Rice - this is here as a padder-outer, mainly because I'm a mother of 3 children who would rather starve than eat most vegetables. It's cheap, lasts forever, everyone likes it, it goes with everything and you can make milk with it. Also handy for veggies or vegans, as combining a pulse with a grain (e.g. chickpeas & rice) will make a complete protein.
4. Sun-dried tomatoes. I know what you're thinking. Who the hell puts sun-dried tomatoes on an emergency food list? Well I do and I'll tell you why...they're unbelievably versatile; just soak them in boiling water & you have a salad accompaniment, whizz them up & you have a ready made stir-in sauce for just about anything, then add water & you have a make-shift stock for a whole load of other dishes to use like tinned chopped tomatoes. See? Genius.
5. Dried fruit - another staple mainly

to keep my children alive in a potential time of crisis, partly because it's a nutritional food that is enjoyed by all, but also because it's a great quick-fix for flailing blood sugar levels while dinner's cooking and so helps to stop them killing each other. It can also be rehydrated & used for smoothies & puddings.

6. Oats - I'm not the biggest fan of grains. Why? Well, you know people tend to say "don't feed bread to birds because it fills them up and stops them eating things they really need like seeds & berries?" That. Plus they're often high Glycemic Index, causing blood sugar instability & are generally a lot more of a burden on the body than we're led to believe. Much of this however is due to our over-zealous attachment to them; we just eat too many. I'm allowing them into my armageddon pantry though because of their versatility; they can obviously make porridge, flapjacks, biscuits etc, but also can be whizzed up into flour for cakes and a million other things, as well as making delicious milk. They're also super cheap and last for ages.
7. Concentrated greens such as chlorella, spirulina or wheatgrass. These are amazing. They help rid the body of heavy metals, which amongst other things make us more susceptible to radiation damage,

and are the most alkalising foods on Earth (our bodies ideally are slightly alkaline for optimum health). Chlorella is my favourite as it doesn't have a strong taste, so I can put it in my kids smoothies & get away with it, although it can be bought in capsules too. Bursting with vitamins & minerals, it's also a great source of omega 3.

8. Bee pollen. Due to its diverse and potent nutrient content, humans can survive on bee pollen alone...enough said.
9. Vitamin C. Needs no explanation; we're apparently in the middle of a pandemic. What does need an explanation is why some hospitals were raided by the FBI for treating covid patients with it back in March/ April last year and subsequently stopped from using it despite its apparent success - as you'd expect given its well-documented properties.
10. Chocolate. I just gave this article to my partner to read. I hadn't quite finished it, so I explained that obviously chocolate was going in at no. 10. He's known me for the best part of 20 years yet he still looked perplexed... "What, like just as a nice thing? In an armageddon pantry? Really?" Speechless.

30 Years Ago Doctors Told Me There Was No Cure

I have always been interested in natural health, but my journey into health mastery really began at the age of 32 when I was hit by an entirely unexpected health emergency. Following a course of antibiotics prescribed for a minor health condition, I suddenly found myself hospitalised and in a critical state after a major reaction to the drug.

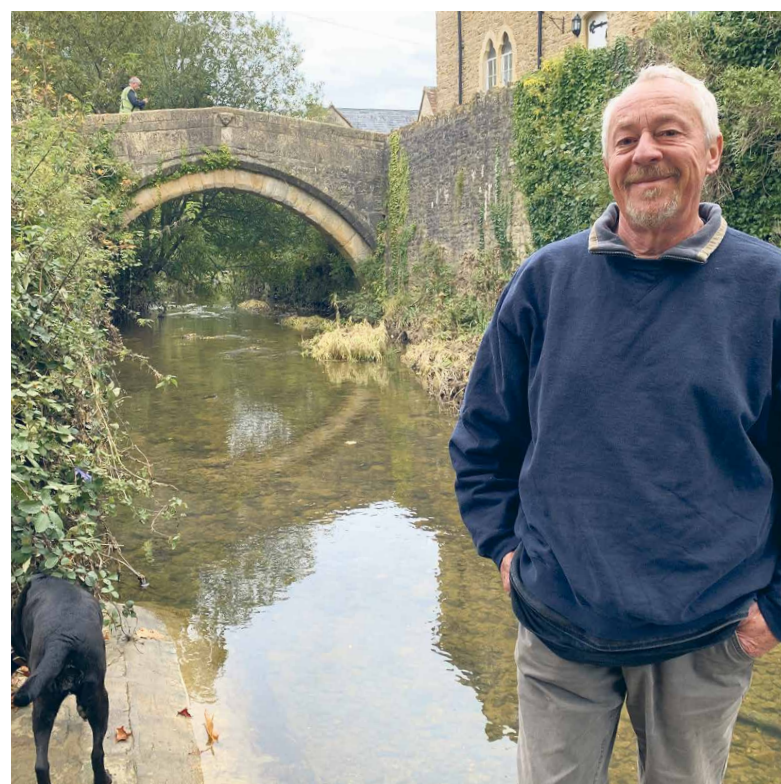

Debunking Smallpox: Vaccine Delusion?

We have grown up believing that smallpox is highly contagious, indiscriminate and deadly: that it killed many millions worldwide and that we were only saved from its ghastly ravages by the development of vaccinations; but this is simply not true and quite possibly the result of modern medical propaganda.

Vaccines didn't eradicate smallpox, they made it worse; it was already on the decline by the time vaccines were introduced in 1796 but then it began to rise again. The disease was at its peak during the 1700s, though it was often confused with other illnesses such as chicken pox, measles, shingles, scarlet fever and secondary syphilis.

In modern times, it is a somewhat mythical disease but in days gone by it was a lethal, everyday scourge that you were lucky to avoid. Anxiously accepted as a part of life, some chose to purposefully infect themselves to get it over with. This 'arm-to-arm' (or up the nose) transfer was called variolation and involved matter from an infected pustule being pricked into the skin of the recipient. It was a risky procedure because there was always a chance of catching some other hideous disease or dying.

In 1796, historical 'golden boy' Edward Jenner began experimenting on cows after hearing about a local farmer who had apparently gained smallpox immunity by inoculating himself with cowpox secretions. Jenner hypothesised that because cows didn't carry the same transmissible diseases as humans they would be safer to use as hosts. He swiftly began trialling the method.

James Phipps was one of the first to be immunised by Jenner as a young child; by the time he died he had been vaccinated over 20 times. He was 20. Jenner also tested the vaccine on his own son, who became crippled and died at 21. Both men died of tuberculosis, which some researchers attribute to the smallpox vaccine. (Eleanor McBean, *The Poisoned Needle*).

Though he was a keen pupil of esteemed surgeon John Hunter, Jenner sat no examinations and purchased a £15 medical degree from St. Andrew's University only after he had been practising for twenty years. His opponents considered him vain, petulant, crafty and greedy – 'a self-deluded quack who omitted vital information and denounced his findings only to reassert them when it suited him.' Nevertheless, he somehow managed to convince those in the right places and received

a £30,000 grant from parliament (roughly £3 million by today's standards) to continue his work.

The Vaccination Act of 1853 made it compulsory for all babies under the age of three months to be vaccinated in England. Before this, the two-year death rate from the disease was 2,000, whereas 18 years later, during the pandemic of 1871, it had reached 44,800. It is estimated that 90% of those who fell ill had been vaccinated.

Opposition grew towards vaccination as the situation got worse, not better. Anti-vaccination leagues and societies formed throughout the country with dedicated high-profile members. Local guardians defended the rights of citizens and communities stood together to fight government

tyranny. Protests took place and teams produced pamphlets and flyers with titles such as: 'Vaccination: its fallacies and evils', 'Vaccination, a Curse' and 'Horrors of Vaccination'.

Huge numbers of people across the land worried that the vaccine was unsafe and unproven. Parents were fined and thrown in prison for not immunising their children but their commitment to the cause didn't waver.

Through fierce, persistent and active opposition, parliament eventually passed an act in 1898 that removed penalties and allowed parents to choose whether to have their children vaccinated.

Alfred Russell Wallace, a naturalist and biologist, charted European deaths from smallpox and the vaccine and reported that: "the vaccine has actually increased susceptibility to the disease. The conclusion is in every case the same: that vaccination is a gigantic delusion; that it has never saved a single life; but that it has been the cause of so much disease, so many deaths, such a vast amount of utterly needless and altogether undeserved suffering, that it will be classed by the coming generation among the greatest errors of an ignorant and prejudiced age, and its penal enforcement the foulest blot on the generally beneficent course of legislation during our century."

The real problem with smallpox was filth and lack of hygiene. Sir Edwin Chadwick, a social reformer, toured populous working class areas

of England and produced the 1842 Sanitary Report, which compelled the councils to provide better facilities. He said: "Smallpox, typhus, and other fevers occur in common conditions of foul air, stagnant putrefaction, bad house drainage, sewers of deposit, excrement sodden sites, filthy street surfaces, impure water, and overcrowding, and the entire removal of such conditions is the effectual preventive of diseases."

The construction of London's sewers, which had begun in 1766, was completed by the mid-1860s and sanitation throughout the country, along with health, slowly improved with the introduction of the Public Health Act in 1875, which laid out detailed plans for more effective drainage, clearance of waste and rubbish, and regular maintenance of sewers.

Natural hygienist and physician, Dr. Russell T. Trall, considered smallpox "essentially...not a dangerous disease" and Joel Uritsky, MD, director of the National Immunization Program and Early Smallpox Response and Planning at the CDC stated more recently that "Smallpox has a slow transmission and is not highly contagious."

H Valentine Knaggs, a physician and naturopath, somewhat radically claimed that smallpox was a beneficent disease, a healing crisis. He said: "The body is ridding itself of toxins. Medical intervention interferes with the

process. Smallpox is an outbreak of carbuncles, simultaneously, all over the body. In a natural world, those who survived would be healthy, full of vitality and have great immunity from future disease."

Dr Vivian Vetrano, in her essay on smallpox, writes: "If hygienic care had been resorted to in the beginning of smallpox...no complications would have occurred and there would rarely be a genuine pustule." But way back when, patients were kept in bed, in warm rooms with dirty blankets and closed windows. Doctors applied gauze that had been soaked in corrosive mercuric chloride or carbolic acid and tightly bound the dressings; white blood cells were destroyed, the pus couldn't escape, toxicity increased and a second fever followed.

It would seem that medical intervention did not eradicate the disease but rather aggravated it. A doctor at the time remarked: "As it is palpable to all the world how fatal smallpox proves to many of all ages, so it is clear to me from all the observations that I can possibly make, that if no mischief be done, either by physician or nurse, it is the most safe and slight of all diseases."

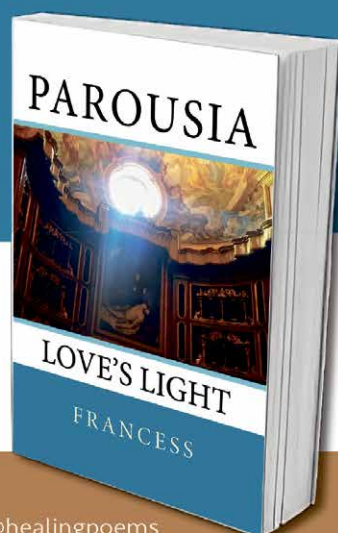

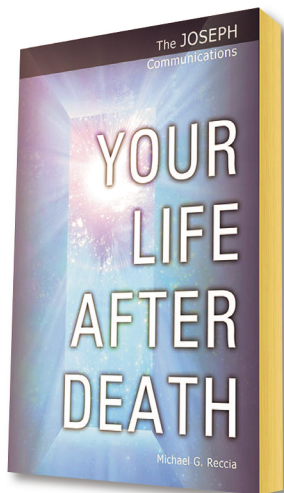

The Speech Haters

John Waters on the new Hate Crime bill, a charter for busybodies and ideological agitators to silence those who say things they disagree with

Over 20 years ago, I coined the term ‘Omnipotent Victim’ to describe an emerging phenomenon I had observed at work specifically in the operation of family law courts but also more generally in areas governed by the misleadingly innocuous-sounding concept of political correctness (PC). The idea was that, if someone qualified in one or more respects under a list of protected categories, it was impossible to win against them — no matter what the facts or circumstances — in any context in which State or media actors were involved.

Back then I predicted, the greatest tyranny would be the spectre of absolute power in the hands of the apparently defenceless victim: ‘We stand on the threshold of an era when, by virtue of being black, female, or the claimed sufferer of abuse or deprivation, the Omnipotent Victim will be set beyond

This country of ours is no sand bank, thrown up by some recent caprice of earth. It is an ancient land, honoured in its archives of civilisation, traceable into antiquity by its piety, its valour, and its sufferings. Every great European race has sent its stream to the river of Irish mind. Long wars, vast organisations, subtle codes, beacon crimes, leading virtues, and self-mighty men were here. If we live influenced by wind and sun and tree, and not by the passions and deeds of the past, we are a thrifless and a hopeless people.’

Omnipotent Victim, a programme for the marginalisation and silencing of the mainstream indigenous population, who will, if this Bill becomes law, become permanently prohibited — under pain of imprisonment — from defending their culture, their values, their children’s birthright, their country, their home.

Normally, laws come into being because of some need emanating from the population, but this is true in this instance in only the narrowest of sense. This law does not arise from any need of the Irish public, even widely defined, but out of the dim depths of political corruption and opportunism, being designed to protect from public comment or criticism the ideologies now festering in the undergrowth of our public life and in particular the unlawful and undemocratic practices that have arisen around mass migration into Ireland over the past two decades.

This Bill seems to be clumsily constructed, contradictory and vague, but this is an exercise in misdirection. It has the appearance of being thrown together, but it is actually cunningly contrived to achieve a nefarious purpose: the unleashing of a legal time bomb that may in due course prohibit just about everything worth saying. It has been drafted by the Department of Justice, clearly with the enthusiastic assistance of a vast array of NGOs, existing and continuing to operate off public funds allocated to the migrant sector.

It was signalled first a few years back by politicians persistently bemoaning the activities of the ‘far right’, a completely fictional entity invented by politicians



for the purposes of creating a bogeyman for the moment that is now upon us.

The objective of hate speech laws, declared the 2019 consultation document, is to ‘support a safe, fair and inclusive society’. But it does not appear to have been considered that a safe, fair and inclusive society might not be possible if people are forbidden to speak their minds. There is no attempt to define what ‘inclusive’ means. Does Irish society have an obligation to include anyone who arrives here, no matter the reason or pretext? It does not appear to have occurred to those involved that one way of making a society unsafe is to impose upon it hundreds of thousands of alien persons with no loyalty to the host people or their culture.

We were told that ‘tolerance and respect for the equal dignity for all human beings is fundamental to Ireland’s identity as a democratic, pluralistic society.’ But nobody had ever asked the Irish people how ‘pluralist’ they wished their society to become. And when did this become a matter of ‘identity’? Who decided this? What does it mean? Is it possible for a society imposing totalitarian controls on freedom of speech to remain ‘inclusive’, ‘fair’ or even particularly ‘pluralist’? Surely the fairest and most pluralist society is one in which everyone is able to say exactly what they think and believe?

The sole purpose of this ‘hate speech’ legislation is not to protect minority groups or ethnicities, but to insulate the government/political class from any criticism or questioning about its policies in certain areas, in particular — here — the policy of imposing on the Irish population countless unknown migrants with no love of or loyalty to Ireland.

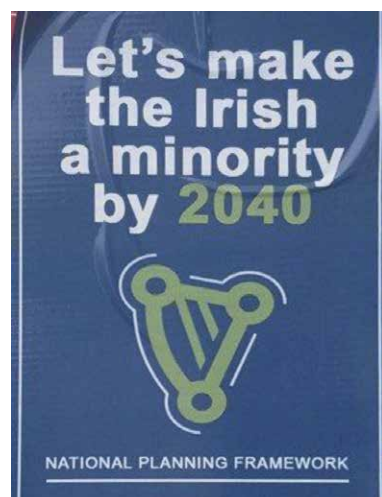
‘Hate speech laws’ are the enforcement arm of political correctness, which is the statute of Cultural Marxism. There are many problematic elements within this, but the most urgently so are the trans movement, which promises to do unspeakable harm — spiritual, mental and physical — to the coming generations of young people, and mass inward migration, which threatens to

destroy the sovereignty and capacity for self-realisation of the Irish people within a few decades unless something is done to bring these drifts to a halt.

To oppose mass, uncontrolled inward migration, unleashed by politicians who never sought a mandate for it, and imposed on existing communities who have spent sweat and blood in building up a safe home for their children, is not the same as opposing immigration. People have always come to Ireland and have invariably been welcomed. Neither ethnicity nor colour has been an issue for most people. We welcome people who come to our country in respect and hope, seeking to build a life for themselves

citing facts does not meet their need to create bogeymen - the ‘far right’, ‘white supremacists’, ‘racists’, all imported concepts which have no currency here other than a mendacious one. The ‘hate speech laws’ are their way of bringing things to a new and final level: If this Bill becomes law, there will in future be no means of resisting what is planned for our country; and then, in due course, all its people will have cause in time to mourn the inevitable consequences of that.

It has the potential to impose a terminal chill on public dissent or debate on just about anything of significance relating to the agendas currently



justice, morality, fairness and the law, and anyone she accuses will be automatically convicted. In this future, if you come into conflict with someone whom our various ideologies designate as victim, by virtue of sex, race or origin, you had better have your affairs in order in advance of the hearing. Victims are never guilty of anything, and those they accuse never innocent.’

This prediction achieves its fullest flowering in the just-published Criminal Justice (Hate Crime) Bill 2021, long heralded as the imminent introduction of ‘hate speech laws’.

It is not an exaggeration to say that this Bill is perhaps the most radical and the most momentous ever introduced into our country in this state of — whatever it might be called, that might once have been mistaken for freedom. This, finally, is the legal charter of the
