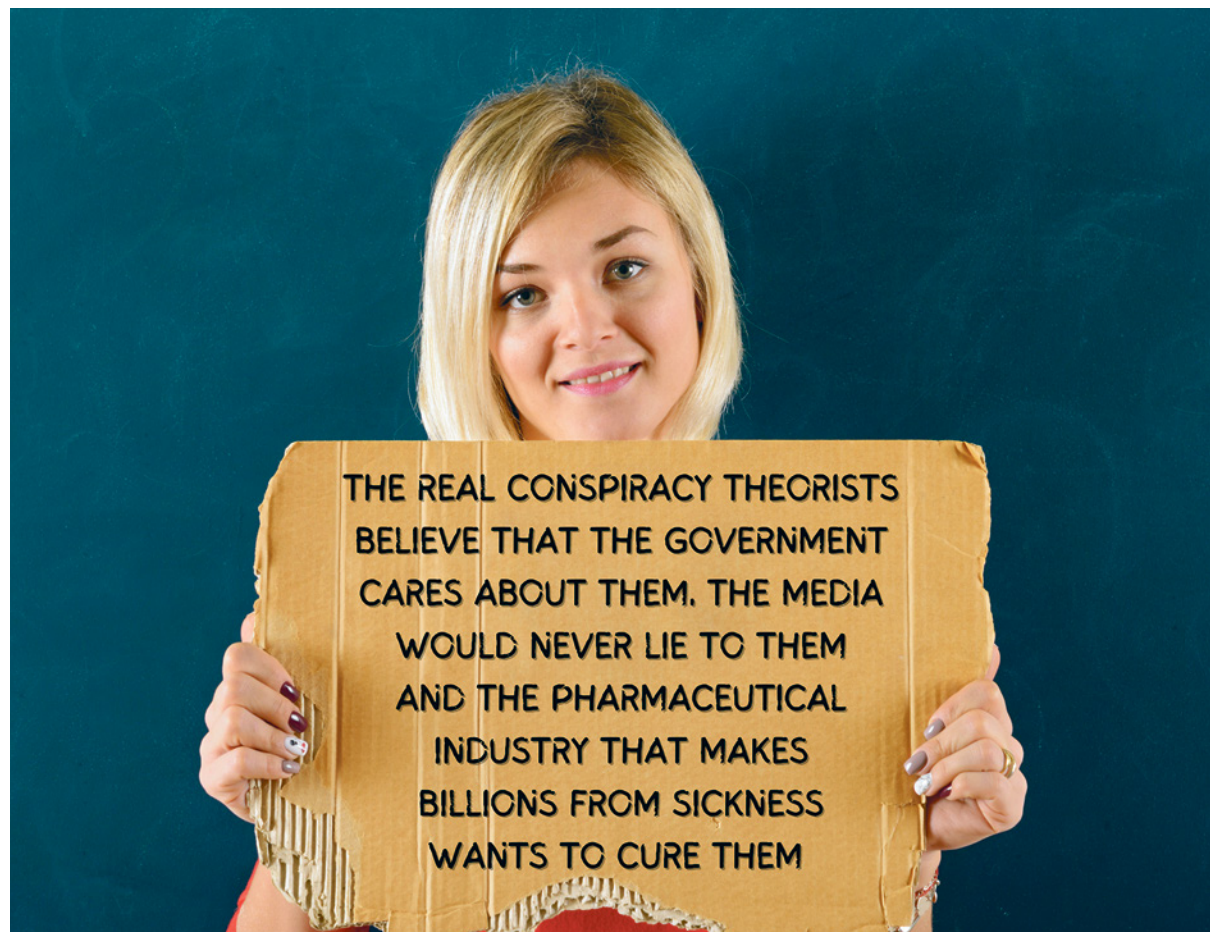

Pfizer's Mission To Murder

No wonder the criminal firm wanted to hide its vaccine trial results for 70 years

A DAMNING document was recently released as part of a court-ordered Pfizer data dump which the company wanted hidden until 2096. The Pregnancy and Lactation Cumulative Review was signed off on 20 April, 2021, around the same time there was a strong push by health authorities around the world, including the HSE, the US Centers for Disease Control and Prevention (CDC) and the UK's National Health Service (NHS), for pregnant and breastfeeding mothers to receive Covid vaccines.

The report is a cumulative review of relevant pregnancy and lactating cases reported in Pfizer's pharmacovigilance databases from the time of drug development through to 28 February 2021 and it contains disturbing data.

A total of 673 case reports were identified: 458 cases involved vaccine exposure during pregnancy (mother/foetus) and 215 cases involved exposure during breast feeding.

Out of the 458 pregnancy cases, 248 (more than half) reported adverse events.

Of the 458 cases involving vaccine exposure during pregnancy, 51 events were reported for miscarriage, abortion (1 event) and abortion missed (1 event).

According to Pfizer, 53 reports of spontaneous abortion were noted but four cases were excluded from the review because of suspected 'Covid' and 13 cases were further excluded because of the women's medical history - then there was 'one patient' who had a medical history of 'Covid' and was also excluded - this should leave 35 remaining cases but Pfizer erroneously writes 'the remaining 39 cases are summarised.'

Of the 39 cases that were reviewed, 38 were actually listed, another reporting error, perhaps? What immediately stands out (where gestational age was known) is that all the pregnant women in those cases experienced a miscarriage in their first trimester.

A further six disturbing cases out of the 458 involved babies being exposed to the vaccine transplacentally, leading to



premature delivery.

In two of the premature delivery cases, the babies died because of severe respiratory distress and pneumothorax - both the mothers received the Pfizer vaccine in their second trimester. In another shocking case, a baby developed foetal tachycardia (heart rate over 160 beats per minute) where 'the clinical outcome of the foetal tachycardia was unknown.'

This bombshell real-world evidence was known back in early 2021 by the FDA and Pfizer, just before the big push to get pregnant women vaccinated - and it showed significant safety risks to the foetus due to indirect (transplacental) exposure of the Pfizer vaccine, with spontaneous abortion (miscarriage) being one of the known outcomes.

When I analysed Pfizer's Cumulative Analysis of Post-Authorization Adverse Event Reports, released via court order at the end of 2021, similar alarming data was also observed.

Out of 270 pregnancy cases, no outcome was provided for 238 of them. Of the remaining 32 cases where the outcome was known: 23 were reported as spontaneous abortion (miscarriage), two as premature birth with neonatal death and two cases of spontaneous abortion with intrauterine death.

In the biased, retrospective study by Lipkind et al., which formed the 'evidence' for many leading health authorities, such as the CDC, to assure the public that 'Covid

vaccination during pregnancy is safe and effective,' only 1.7% of the roughly 10,000 women received the vaccine in their first trimester, compared to 61.8% who were vaccinated in their third trimester. This is a significant confounding factor because 80% of miscarriages occur in the first trimester. It can be said this bias was an effective way of skewing the study's results, making it appear that the mRNA vaccines were safer than they actually were.

The lactation cases: 41 (20%) of the 215 lactation cases reported adverse events in infants indirectly exposed to the vaccine via the transmammary route (through breast milk). An extensive list of horrific

adverse events were reported in breast feeding infants ranging from facial paralysis, lymphadenopathy and blurred vision.

Pfizer's report concludes that the cases reviewed are 'indicative of what is in the Pfizer safety database as of 28 February 2021. The sponsor (Pfizer/BioNTech) will continue to monitor and report on all pregnancy exposure and lactation cases.'

A study by Hanna et al., published in JAMA Pediatrics in September 2022, revealed that researchers found trace amounts of the Covid vaccine mRNA in the breast milk of lactating women as soon as one hour after vaccination.

They went on to state, "We speculate that, following the vaccine administration, lipid nanoparticles containing the vaccine mRNA are carried to mammary glands via hematogenous and/or lymphatic routes."

However, this vitally important information was already known for quite some time by Pfizer and BioNTech, since it was observed in real-world data from Pfizer's own review, signed off on 20 April 2021 and submitted to the Food and Drug Administration (FDA), where three days later, the CDC began recommending it for pregnant women. All of this was well known by the HSE in Ireland too who lied over and over about the safety of the vaccine.

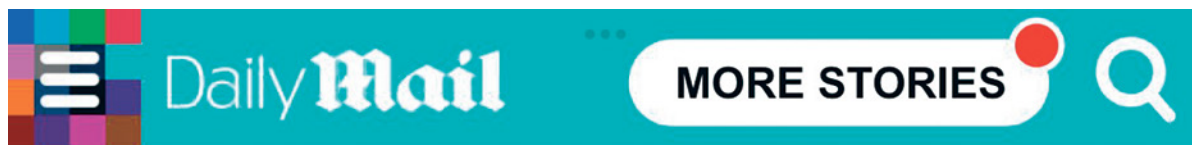

'The research, published in the journal Heliyon, comprises a review of 43 previously published

studies on exposure to CO₂, mask-wearing, and pregnancy.

'It notes that even short-term exposure to concentrations of CO₂ as low as 0.3% caused brain damage, increased anxiety, and impaired memory in both pregnant rats and young mice in one study.

'In another, when male mice were exposed to 2.5 percent CO₂ for four hours, testicular cells and sperm were destroyed. The equivalent amount for humans

would be 0.5 percent of CO₂ over the same time period.

'Yet another experiment discovered that stillbirth and birth defects occurred in pregnant rats that were exposed to just 3 percent CO₂, which would be equal to 0.8 percent for humans.

The study also points to research that found just five minutes of mask-wearing resulted in CO₂ levels increasing to between 1.4 percent and 3.2 percent.

While they note that the review provides 'circumstantial evidence' only, the researchers allude to a surge in stillbirths during the pandemic, saying that masks could have contributed.

'They also note that research indicates "reduced verbal, motor, and overall cognitive performance of two full standard deviations in scores in children born during the pandemic.'

This of course is classic gaslighting by the mainstream media who are trying to cover up the mass murder they have been involved in for the last three years with their political partners in crime.

They ignored and ridiculed all of the medical experts who spoke out against masks during the Covid scam and provided proof that they were dangerous, unhygienic and about as effective as using a wire fence to stop mosquitos.

have a smart meter. These networked measuring devices for electricity automatically transmit consumption to the electricity providers,” reported German Blackout News.

“According to the government, these systems should help to use energy efficiently and cost

effectively and relieve the electricity grid.”

Large supply bottlenecks and demand overloads loom along with rolling blackouts for the German people. With millions of heat pumps and electric cars coming on the market in the future, and coal

and gas plants being shut down, supplying Germany’s electricity needs will become a formidable challenge and rationing is inevitable.

The president of Germany’s Federal Network Agency, Klaus Müller, warned of potential overload problems and that power utilities

will need to be able to “temporarily reduce the amount of electricity drawn from the grid.”

Already plans for electricity rationing are to come into effect beginning 1 January 2024.

Experts have warned that problems may arise if many households charge their electric vehicles and run their heat pumps at the same time. It will not be possible for everyone to charge up their vehicles and run their heat pumps without causing grid overloads.

“In cases of overloads, the grid operator could remotely reduce the power of devices via smart meters to prevent power cuts,” reports Blackout News.

“The federal government announced that elaborate functions such as control and switching will gradually be enabled after a warm-up phase via application updates on the smart meter gateways in cooperation with the back-end systems.”

In other words, Big Brother is going to switch off your kettle whenever he feels like it. All ahead of us in Ireland. Be prepared!

Now is your chance to start investigating independent fuel sources and imagining how you would cope without any power from the grid. You might consider investing in a small generator, portable gas cookers, solar lights, a wood-burning stove and other means of keeping yourself warm and fed in the years ahead, which are going to be difficult as we approach 2030. The tyrants in Leinster House have every intention of forcing smart meters on the public.

Metal monstrosity planned for Mourne

RESIDENTS and walkers of the Mourne Mountains in Co. Down are up in arms over a proposed new £44 million visitor centre that would ferry the public to the renowned area in cable cars.

The Mourne Mountains Gateway Project would create a dramatic structure in the disused Thomas Quarry, which is currently about an hour-long hike from Newcastle’s Donard Park.

Computer images show how

unsightly gondolas would transport an estimated 365,000 visitors a year, in what is pitched as a tourism attraction equal to the Giant’s Causeway and Titanic Belfast.

With an estimated completion date of 2029, local politicians including Alliance MLA Patrick Brown, have dubbed the proposed structure an unviable “metal monstrosity”.

Dawson Stelfox, an architect who has climbed Mount Everest, also said he was unconvinced by



the plans so far. Posting on the Mourne Gateway Facebook page, he said: “Do they really think people will travel to the Mourne from all over the world for a five-minute ride to a glass box they are not allowed to escape from? Seems bizarre to me.”

The real agenda behind this is about controlling access to wild spaces - a process happening all across the island as part of UN Agenda 2030 be it in our towns, villages, beaches, bogs, mountains or valleys. Watch out for it!

WHEN we look upon the LGBT movement, we're not looking at what we think we're looking at. We may imagine it to be an unbelievable irritant, a bunch of quasi-fascist bullies, or a harmless but over-zealous bunch of people with little or nothing to do with their time.

To put it another way: How long, left to itself, would such a movement as the gay rights campaign have taken to establish itself, convince an adequate number of willing activists, collect sufficient funds to begin a campaign, and overcome the media's until recently congenital reluctance to get involved in partisan-sounding controversies?

Think of the fact that last month, An Garda Siochána launched a new 'Pride car' in, of all places, Cavan. A tweet from Garda Info announced: 'Based on our ongoing commitment to supporting minority communities, this initiative allows Community Gardaí to positively demonstrate our support of the LGBTQ+ community as they fulfil their daily engagements with community groups, sports clubs, schools etc.'

The tweets were illustrated by photographs of the 'Pride car' shown from various angles, all decked out in the rainbow colours.

The first tweet in reply, from someone called Paul, said: 'Don't forget to use this Pride car at your next recruitment day in a Mosque.'

Make sure to park it right outside the front door.'

Garda Info tellingly shot back, flashing the fangs of state power and coercion: 'Hi Paul, we will always accept criticism and constructive feedback but we do not tolerate derogatory remarks towards any individual or community. Our Garda National Diversity and Integration Unit work to support every community in Ireland, including the LGBTQ+ community.'

In fact, the Garda Diversity and Integration Unit works to support Cultural Marxist initiatives, and to silence anyone - like Paul - who is less than totally enthusiastic about these.

Such a unit as the Garda National Diversity and Integration Unit - partisan and politicised in ways that would have been



unimaginable even a decade ago - represents a contravention of every principle of neutral policing.

The 'LGBTQ+ community' is

a highly aggressive ideological movement that has captured every institution of Irish life, including - obviously, the police

force. Anyone who incurs LGBT disfavour will simultaneously incur the disfavour of the Garda National Diversity and Integration Unit, which will forswear to 'tolerate' any 'derogatory remarks' about groups under its wing.

Don't you ever wonder how 'gay' - a condition affecting less than two per cent of the population - came to be so total? Not only have these people altered the very meanings of archetypal human relationships under headings like parenthood and family, they have thrown a grenade into the centre of the definitions of the age-old concept of marriage. They have stolen the rainbow from the sky, ransacked books of myths and legends to usurp the meaning of iconic childhood concepts like the unicorn and the mermaid, and hijacked in its entirety the heavenly month of June. Do other categories

of activist not ask themselves what they might be doing wrong?

What activist group, promoting the demands of a minority, has in the past been able to command the entirety of the public realm for an entire month out of every year, to promote its grievances and stick its flag up everyone's nostrils?

It's not what it appears to be, or at least not what they say it is. It never was. If it had been, I might have, at some level, been able to accept the ransacking of our culture as the will of the people with a view to righting some historical wrong. But it wasn't and there was no historical wrong - not in the sense they mean when they make this generally unsubstantiated claim.

In the first place, we need to dispense with the idea that what is happening now - LGBT, Trans, Pride, Rainbow shtik - has anything to do with homosexuality per se. 'Gay' does not mean gay. 'Big Gay' is not gay. 'Pride' is not pride in being gay. The whole thing is a massive corporate bullying campaign with a precise, carefully designed purpose.

What we think we see is not what we are seeing. Yes, at some level, some elements of the 'gay community' (a made-up term)

are benefitting from what is happening. What interest groups could resist having all its dreams made come true by the people with the deepest pockets in the world? And, while it's happening, why not convince yourself its because of the rightness of your cause? It's just that those of us who have tried to advance other causes are here to tell them that it just doesn't happen like this. Many of those involved, through stupidity or learned myopia, undoubtedly think that what is happening is what they say is happening. But it isn't. In reality 'gay activists' are simply stooges for the wealthiest organised interests in the world seeking to effect the most fundamental change in our political system since the introduction of democracy, 2,500 years ago.

This is not about sexual orientation. This is about power and control, not by homosexuals but by those who, for the moment, choose to use them as cultural battering rams. This is the leveraging of gay victimhood as part of a softening-up process, which was one of the preliminary stages of a slow-motion coup, designed to alter the fundamentals of our culture so that we will be less adapted to resist what is coming.

And what is coming is fascism by its dictionary definition: a coalition of political and corporate power, globally organised and directed, preparing to replace the prevailing structure of government with a universal social control grid, digitally powered and data driven, operating via saturation surveillance and the money system to imprison the populations of the world in a dystopia that will leave the sci-fi writers of the past century shame-faced at their own lack of imagination.

The purpose was, and remains, to break down all societal mores, so that the public realm no longer offers any sense that it belongs to those who inhabit it, but is a place governed by alien values, which do not consider the welfare of people as may understand this themselves. And this is the deeper meaning of everything that has been happening of late - from lockdown to hate speech laws via the waves of mass inward migration in the face of widespread concern and objection. The reason the Government no longer appears to take heed of the view of the people is that democracy has already been dismantled; all that remains is to drive this message home.

We need to put out of our mind the notion that any of this was as

it appeared. It was not, as so may lazily believed, the eruption of a spontaneous homosexual spirit in the face of prolonged oppression and homophobic tyranny (mostly a fiction anyway) but the manifestation of near-absolute power acting through proxies and useful idiots whom, it was understood, could gain enormous cultural traction if adequately resourced, coached and supported.

In other words, what we were really dealing with here was not the pervert clowns doing appallingly unfunny routines on our TV screens, or even the half-crazed goons we encounter on the streets, but an impassive force of detached manipulators who care as little for the welfare of gays as they do for wider issues of freedom or democracy.

What we deal with is the weaponisation of gayness as an instrument of societal disintegration, with a view to - yes! - 'building back better'. What we are confronted by is a coalition of the most powerful corporate, economic, financial and cultural forces in the world, which has, sailing under the rainbow flag, effected a coup against the Free West, and works all the time now to replace democracy with a form of neo-feudal fascism.

But there is growing evidence of what the Americans call 'pushback' against the Trans agenda and the Drag Queen mission - when you think about it, a pincer movement that attacks, separately and simultaneously, the concepts of femaleness and maleness respectively. But you may notice that, despite the growing alarm and distaste of the public, the LBGT goons continue with their agenda - 'heads down and carry on', as though nothing was amiss, indeed, more precisely, as though the sole explanation for growing public discomfort was 'far right homophobia' and 'anti-gay backlash'.

The gay agenda may be running into public disfavour, but its passing from public tolerance or - at a stretch - affection, will not be the end of the matter. When that moment occurs, the put-upon people will meet with a response that, in their ignorance of what has really been happening, will strike them as disproportionate. They will meet with the untempered rage of the Pride Regime, not because the Regime has any care or affection for gay people, but because this will amount to an attempted rejection of the total agenda. And this is not permitted to anyone - gay, straight or confused.

Public resist climate hysteria

Despite relentless media propaganda, skepticism is growing

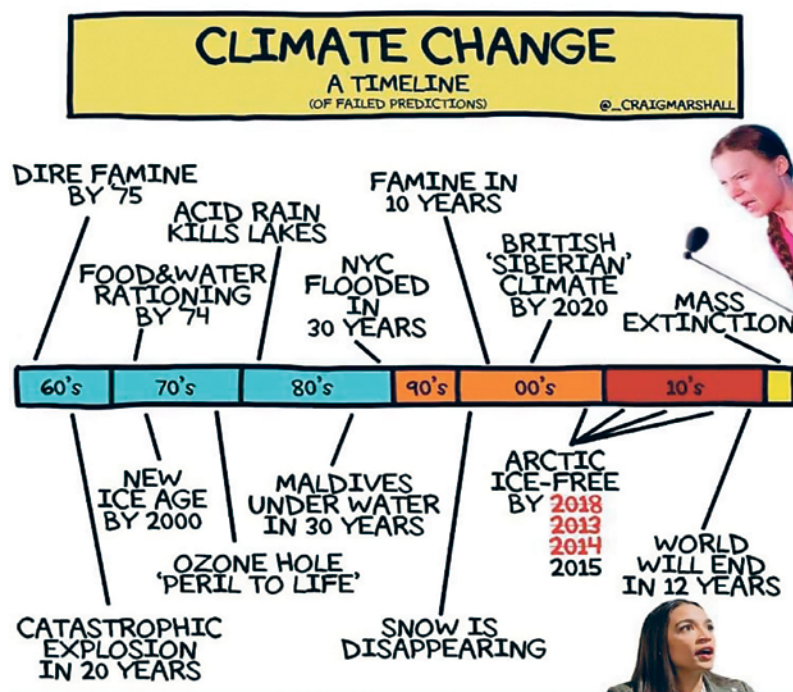


TWO recent polls have found that despite relentless propaganda promoting the man-made global warming narrative, climate change skepticism is growing globally.

A survey conducted by a group within the University of Chicago asked Americans whether humans were causing all or most of climate change.

Whereas 60 per cent held this belief five years ago, that figure has now slumped to 49 per cent.

A recent IPSOS poll which covered two-thirds of the world's population also found that nearly four people in every 10 believe climate change is mainly due to natural causes.



“Perhaps the most surprising statistic from the Energy Policy Institute at the University of Chicago (EPIC) survey is that 70% of Americans are unwilling to spend more than \$2.50 a week to combat climate change,” writes Chris Morrison.

“Nearly four in 10 Americans said they were unwilling to pay a couple of dimes. Despite decades of relentless green doomsday agitprop designed to corral populations into living under a collectivist Net Zero-ordered society, it appears that the vast majority of Americans are unwilling to pay even the chump change in their back pockets to stop the climate changing.”

Such skepticism is quite frankly astonishing given that the ‘official

narrative’ on man-made climate change has been vehemently amplified by every single major government entity, corporation, media outlet and cultural institution in existence.

The fact that ‘the regime’ is still struggling to convince huge numbers of people that climate change is both the fault of humans and representative of an existential threat represents a massive failure of re-education and brainwashing.

Social media giants are now increasingly characterising any skepticism of climate change as a forbidden opinion.

TikTok has become the latest platform to announce that any content challenging the sacred dogma of global warming will be ‘fact checked’ and removed.

Oxford Prof Slams Wind Scam

Yet another high-profile scientist refuses to kneel at the altar of wind ‘energy’

PROFESSOR Wade Allison from Oxford University says governments are ignoring overwhelming evidence of the inadequacy of wind power and resorting to bluster rather than reasoned analysis.

The prominent physicist has warned that the UK is facing the likelihood of a failure in the electricity supply and has called for a reset of national energy policy.

“Whichever way you look at it, wind power is inadequate. It is intermittent and unreliable; it is exposed and vulnerable; it is weak with a short life-span.”

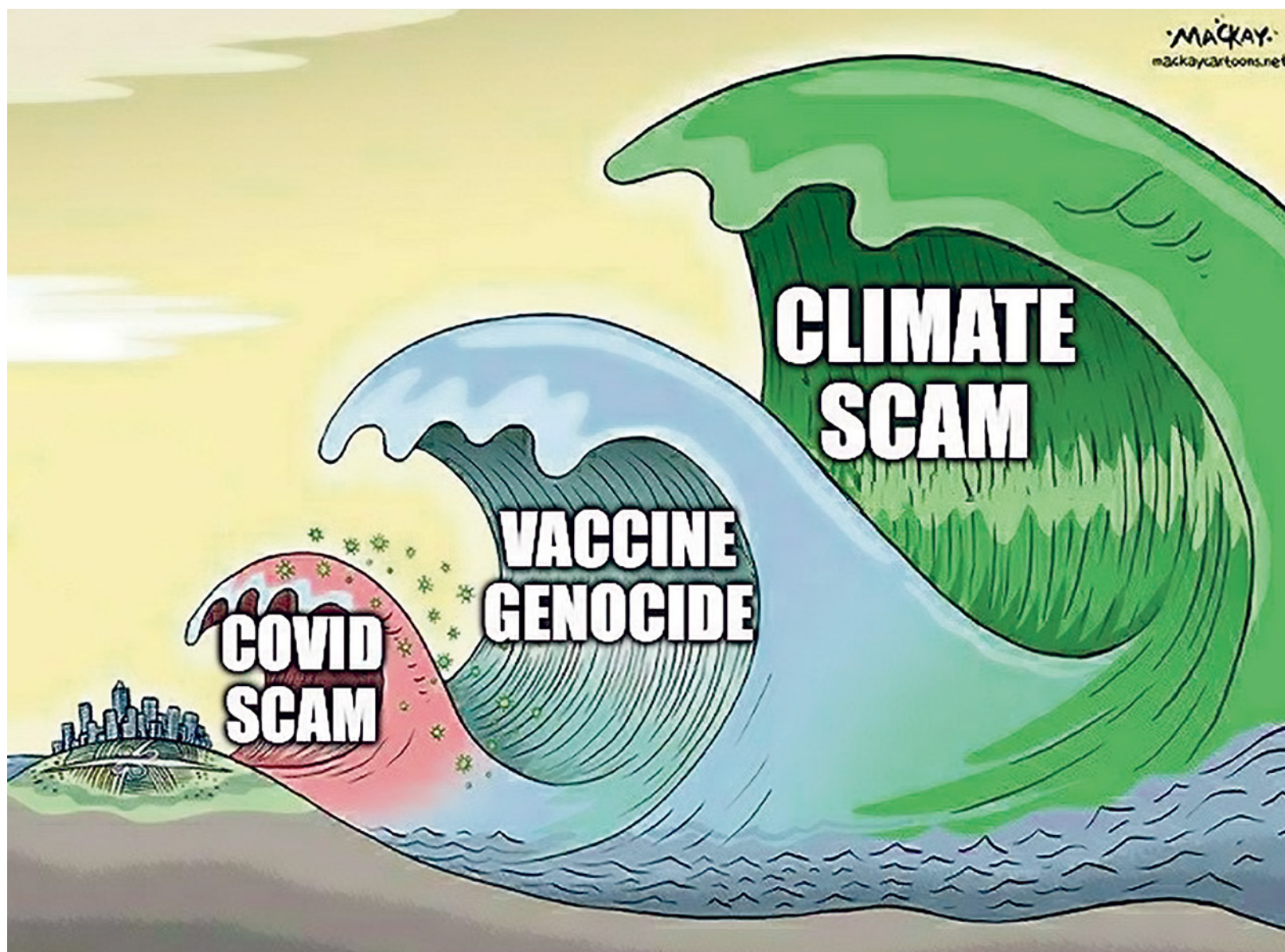
Professor Allison’s warning is set out in a new paper published in the Global Warming Policy Foundation called *The Inadequacy of Wind Power*.

‘The plan to dramatically cut the combustion of fossil fuels was accepted at the 2015 Paris Conference. The instinctive reaction around the world has been to revert to ‘renewables’, the sources of energy delivered intermittently by the power of the Sun. Unfortunately this power, attenuated by the huge distance that it must travel to reach the Earth, is extremely weak. That is why, before the advent of the Industrial Revolution, it was unable to provide the energy to sustain even a small global population with an acceptable standard of living.

Today, modern technology is deployed to harvest these weak sources of energy. Vast ‘farms’ that monopolise the natural environment are built, to the detriment of other creatures. Developments are made regardless of the damage wrought. Hydroelectric schemes, enormous turbines and square miles of solar panels are constructed, despite being unreliable and ineffective; even unnecessary.

In particular, the generation of electricity by wind tells a disappointing story. The political enthusiasm and investor hype are not supported by the evidence, even for offshore wind, which can be deployed out of sight of the infamous My Back Yard. What does such evidence actually say?

That the wind fluctuates is common knowledge. But these

fluctuations are grossly magnified to an extent that is not immediately obvious – and has nothing to do with the technology of the wind turbine. The energy of the wind is that of the moving air, and, as every student knows, such energy is $\frac{1}{2}Mv^2$, where M is the mass of air and v the speed. The mass of air reaching each square metre of the area swept by the turbine blade in a second is $M = \rho v$, where ρ is the density of air: about 1.2 kg per cubic metre. So, the maximum power that the turbine can deliver is $\frac{1}{2}\rho v^3$ watts per square metre.

If the wind speed is 10 metres per second (about 20 mph) the power is 600 watts per square metre at 100% efficiency. That means to deliver the same power as Hinkley Point C Nuclear Plant (3200 million watts) by wind would require 5.5 million square metres of turbine swept area – that should be quite unacceptable to those who care about birds and to other environmentalists. But the performance of wind is much worse than that, as a look at the simple formula shows. Because the power carried by the wind depends on the third power of the wind speed, if the wind drops to half speed, the power available drops by a factor of 8. Almost worse, if the wind speed doubles, the power delivered goes up 8 times, and as a result the turbine has to be turned off for its own protection. This is not related to the technology of the turbine, which can harvest no more than the power that reaches the

area swept by its blades.

The wind blows somewhat more steadily offshore than onshore, as every sailor knows. Nevertheless, the unreliability inherent in wind energy persists.

The bluster of windfarm politics, as pursued by the Government, ignores evidence, it seems. The industry is keen to promote onshore wind also. However there the fluctuations are greater than offshore and the political deterrence from My Back Yard is stronger. Consequently, the Government has promoted offshore projects. On 6 October 2020, Boris Johnson announced that ‘wind farms could power every home by 2030’. He continued to harangue the public in Churchillian tone ‘Your kettle, your washing machine, your cooker, your heating, your plug-in electric vehicle – the whole lot of them will get their juice cleanly and

without guilt from the breezes that blow around these islands.’

The significant word in the announcement was ‘could’. Evidently, offshore wind might provide such lighting in the UK – sometimes. But Great Britain needs reliable energy all the time.

Consumers should follow the example of Alice who, in negotiating terms with the White Queen, insisted on clarification of the day on which jam should be delivered.

Evidently, they should not look to wind power for reliable energy, but elsewhere.

With general energy shortages, the war in Europe, high prices and the likelihood of failures in electricity supply, many popular scientific presumptions underlying energy policy should be questioned. Wind power fails on every count.

Ex Pfizer chief: ‘There was no virus’

Former Pfizer VP Dr Mike Yeadon has reached the same conclusion of thousands of other scientists

I’VE grown increasingly frustrated about the way debate is controlled around the topic of origins of the alleged novel virus, SARS-CoV-2, and I have come to disbelieve it’s ever been in circulation, causing massive scale illness and death.

Concerningly, almost no-one will entertain this possibility, despite the fact that molecular biology is the easiest discipline in which to cheat. That’s because you really cannot do it without computers, and sequencing requires complex algorithms and, importantly, assumptions. Tweaking algorithms and assumptions, you can hugely alter the conclusions.

This raises the question of why there is such an emphasis on the media storm around Fauci, Wuhan and a possible lab escape. After all, the ‘perpetrators’ have significant control over the media. There’s no independent journalism at present. It is not as though they need to embarrass the establishment. I put it to readers that they’ve chosen to do so.

So who do I mean by ‘they’ and ‘the perpetrators’? There are a number of candidates competing for this position, with their drug company accomplices, several of whom are named in Paula Jardine’s excellent five-part series for TCW, Anatomy of the sinister Covid project. High on the list is the ‘enabling’ World Economic Forum and their many political acolytes including Justin Trudeau and Jacinda Ardern.

But that doesn’t answer the question why are they focusing on the genesis of the virus. In my view, they are doing their darnedest to make sure you regard this event exactly as they want you to. Specifically, that there was a novel virus.

I’m not alone in believing that myself at the beginning of the ‘pandemic’, but over time I’ve seen sufficient evidence to cast strong doubt on that idea. Additionally, when considered as part of a global coup d’état, I have put myself in the position of the most senior, hidden perpetrators. In a Q&A, they would learn that the effect of a released novel pathogen couldn’t be predicted accurately. It might burn out

rapidly. Or it might turn out to be quite a lot more lethal than they’d expected, demolishing advanced civilisations. Those top decision-makers would, I submit, conclude

that this natural risk is intolerable to them. They crave total control, and the wide range of possible outcomes from a deliberate release militates against this plan of

action: ‘No, we’re not going to do this. Come back with a plan with very much reduced uncertainty on outcomes.’

The alternative I think they’ve

used is to add one more lie to the tall stack of lies which has surrounded this entire affair. This lie is that there has ever been in circulation a novel respiratory virus which, crucially, caused massive-scale illness and deaths. In fact, there hasn’t.

Instead, we have been told there was this frightening, novel pathogen and ramped up the stress-inducing fear porn to 11, and held it there. This fits with cheating about genetic sequences, PCR test protocols (probes, primers, amplification and annealing conditions, cycles), ignoring contaminating genetic materials from not only human and claimed viral sources, but also bacterial and fungal sources. Why for example did they need to insert the sampling sticks right into our sinuses? Was it to maximise non-human genetic sequences?

Notice the soft evidence that our political and cultural leaders, including the late Queen, were happy to meet and greet one another without testing, masking or social distancing. They had no fear. In the scenario above, a few people would have known there was no new hazard in their environment. If there really was a lethal pathogen stalking the land, I don’t believe

they'd have had the courage or the need to act nonchalantly and risk exposure to the virus.

Most convincingly for me is the US all-cause mortality (ACM) data by state, sex, age and date of occurrence, as analysed by Denis Rancourt and colleagues. The pattern of increased ACM is inconsistent with the presence of a novel respiratory virus as the main cause.

If I'm correct that there was no novel virus, what a genius move it was to pretend there was! Now they want you only to consider how this 'killer virus' got into the human population. Was it a natural emergence (you know, a wild bat bit a pangolin and this ended up being sold at a wet market in Wuhan) or was it hubristically created by a Chinese researcher, enabled along the way by a researcher at the University of North Carolina funded by Fauci, together making an end run around a presidential pause on such work? Then there's the question as to whether the arrival of the virus in the general public was down to carelessness and a lab leak, or did someone deliberately spread it?

I also need to point out that the perpetrators have hermetic control of the mass media via a Big Tech and government stranglehold. That's why they've found it so easy to censor people like me. If a story appears on multiple TV networks, it's because they're either OK with it or it has been actively planted. It won't be genuine. They never tell the truth. I don't think they've told the truth since this coup began and probably much earlier. Most so-called journalists have lost sight of what truth ever was.

I believe that the perpetrators (who could be all or any of Gates, Fauci, Farrar, Vallance, CEPI, EcoHealth Alliance, DARPA and numerous others) planted the controversy about the origins of SARS-CoV-2 because a little embarrassment of the establishment was a small price to persuade most of us that there surely must be a novel virus when there isn't. (And they have got away with it to date.)

In closing, I'm not saying people weren't sick or that they didn't die. I'm arguing only about the causes of illnesses and

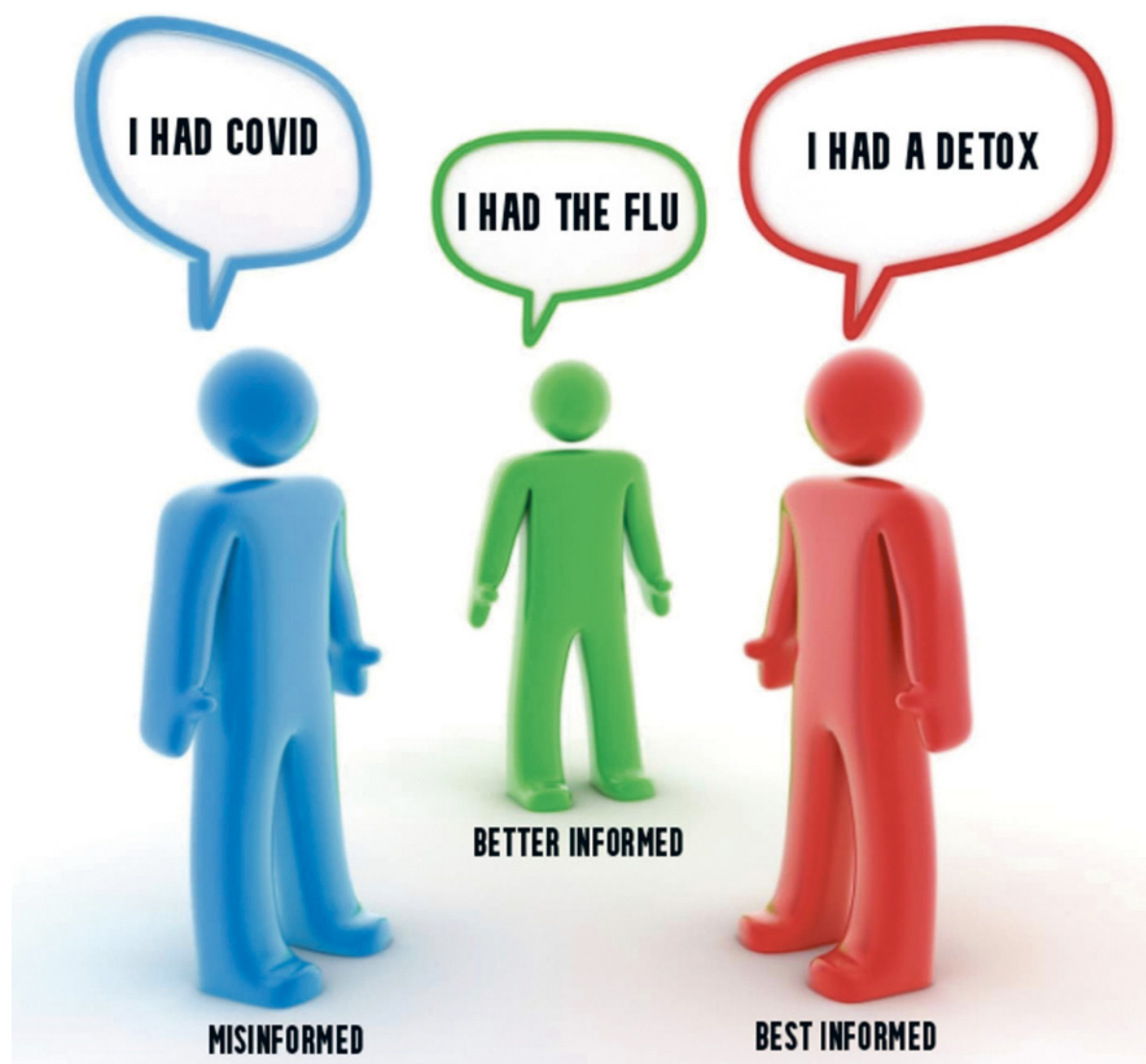

Here are some top tips from n

1 **Between 50 to 75 percent of your diet should consist of nature's food from the garden** - Vegetables (green, crunchy & organic if possible) should be the staple of your diet. If it grows in the garden, it's usually OK to eat with the exception of corn and potatoes. Potatoes are high glycemic foods and should be consumed sparingly. Sweet potatoes are a healthier choice when consumed in moderation. Fresh berries and fruits in moderation are good. If it won't spoil, nature didn't make it. Living foods contain enzymes. Cooking over 118 degrees destroys nutritional value and enzymes needed for digestion.

2 **Eat healthy fats & avoid grains**
Eat avocados, olives, eggs, coconut oil, butter, nuts and seeds. The ketogenic diet is good as well as the paleo diet. Gluten-free breads made from almond or coconut flour are OK. Ezekiel bread (from sprouted grains) is a healthier choice than regular wheat bread but still elevates blood-sugar levels and may contain gluten depending upon harvest dates. Gluten-free grains such as brown or black rice, quinoa or buckwheat may be used sparingly.

Dairy products can be mucus-forming. Try eliminating all dairy for a week and see if you feel better. Goat's milk is better than cow's milk. If you can't get milk from a farmer in its natural raw state, leave it alone. Homogenized and pasteurized dairy products are big culprits for respiratory illnesses and allergies, especially for children. They can cause arthritis too.

- Substitute your table salt with sea salt.
- Cook with ghee, coconut oil or butter. Eat olive oil raw.
- Eat meat in moderation. Fish (that have scales and fins), chicken, turkey, steak and beef from organic sources are best. Wild-caught Alaskan salmon is good (canned Alaskan salmon is OK).

- Organic eggs are good, they don't cause high cholesterol.
- Beans, lentils and peas are healthy but may be an issue for diabetics. Use sparingly.
- Raw honey, molasses and stevia are good sweeteners. Use stevia if you have blood sugar issues.

3 **Keep your pH (saliva) balanced**
Your body functions best when the pH of the saliva is 6.8 to 7.0. Eating raw fruits and vegetables will help you achieve this. All herbs are alkaline-forming foods. Freshly-squeezed lemon in your water is alkalizing. The body needs water, but we want healthy, chemical-free water. Most bottled water is acidic.

4 **Two to three bowel movements a day is healthy** - The body will become dis-eased if it doesn't eliminate wastes regularly. Prunes are natural laxatives. All fresh fruit helps the bowels move, especially when consumed in the morning for breakfast; however, if you have blood-sugar issues, skip most fruits, especially the sweet ones like bananas and watermelon.
Eating heavy cooked foods like biscuits, muffins, pancakes, French toast and milk with cereal causes the bowels to become sluggish. Cooked foods cause constipation. Chronic diarrhoea is often constipation in disguise. Aloe vera juice, cascara sagrada, senna, magnesium and psyllium husk powder are good natural laxatives.

5 **Avoid radiation**
Avoid microwave ovens and airport body scanners. Radiation causes cancer. Warning signs are there to protect us. Pregnant women are told to avoid X-rays because radiation can harm the foetus. What else do you think it may cause to delicate cells? Researchers believe that 50 percent of America's cancers are radiation-induced. Every time you go through an airport scanner, you are being exposed to radiation, increasing your risk of cancer and possibly causing infertility. Avoid these at all costs. Let them do a pat down instead.
Microwaves are radiation ovens that destroy nutritional value of food.

6 **Drink clean, purified water**
Avoid drinking tap water containing chlorine and fluoride. Natural spring water is good, if the spring is a clean source. A water purifier like the Berkey www.berkeyfilters.com is good. Reverse osmosis is good. Distilled water is good; add a pinch of sea salt to provide minerals. Plastic bottled water leaches chemicals (xenoestrogens) into the water and is usually acidic. Get a filtration system for your house. It will pay for itself in less than a year. A wise person drinks clean, chemical-free, healthy water.

7 **Limit your consumption of sugar & processed food**

11 Avoid drinking liquids with meals - Drinking water, juice or soft drinks with meals dilutes digestive juices. With the exception of a few sips here and there, wait 30 minutes before or after a meal to drink liquids. Chew each bite of food at least 30 times before swallowing. Chewing your food and mixing it with enzymes in your saliva is the first step in digestion.

12 Get enough sleep
Most people need eight hours every night. Some need 10 and others only need six. Give your body what it needs. We are all different. Children need 12 hours each night for their growing bodies. Remember, sleep is when your body heals, so don't cut yourself short. Most people catch colds after a lot of stress and not enough sleep. Get up when you are rested and go to bed when you are tired. The body rests best before midnight and this is also when hormones are manufactured. 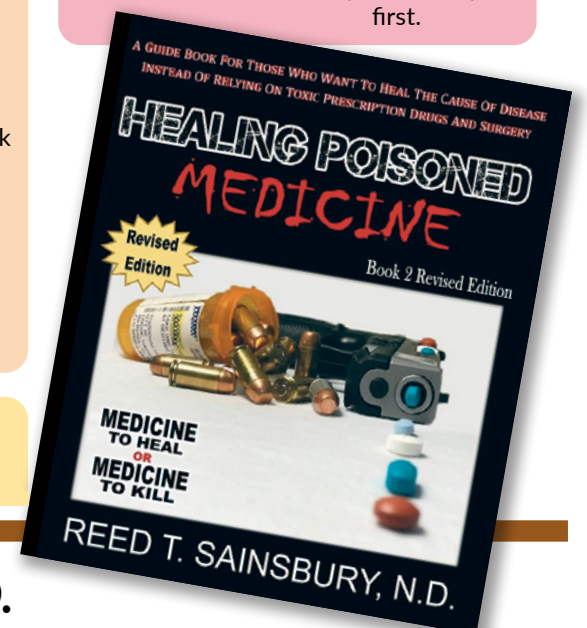
19 Use real butter, not margarine

UN is anti-Christian: Bishop

'Behind Agenda 2030 lies an attempt to change civilization, a New World order that will change the beliefs of individuals,' says Bishop Manuel Sánchez Monge.

IT'S not often that a serving bishop criticizes 'sustainable development' and its aims as codified by the United Nations in 2015 in their infamous Sustainable Development Goals (SDGs). But Bishop Manuel Sánchez Monge of Santander, Spain, has done just that in an op-ed published by the regional daily newspaper El diario Montañés under the title Agenda 2030 y el nuevo orden mundial (Agenda 2030 and the New World Order).

Sánchez Monge warns that the UN objectives are "a trap," emphasizing their anti-Christian character and their relativism, which can "modify the beliefs" of all and sundry.

Who would not like to see the reduction of poverty, or access to water for all, the bishop asked. The UN Agenda is based on the apparent virtue of the SDGs, but these are presented in an "ambiguous" way, he said.

Behind Agenda 2030 lies an attempt to change civilisation, a new world order that will change the beliefs of individuals. It is a globalist system – which has nothing to do with globalisation – aimed at establishing an unelected and undemocratic world government," he wrote.

The "family and religion" are seen as problematic, as are "the responsibility of spouses or generosity within marriage" and the rights of parents, the primary educators of their children.

Whether it is through the promotion of abortion, contraception, or "gender equality," secularism or statism, "it is the State that determines the way of life, thus generating a relativism that makes tolerance the moral value par excellence" under the UN plan, Sánchez Monge said.

The bishop added that even for reasons of convenience or "in order not to be excluded from the public debate," one cannot adhere to Agenda 2030: "Being called Christian carries with it demands that cannot be evaded," he warned.

His speech went on as follows:

It is a globalist system – which has nothing to do with globalisation – aimed at establishing an unelected and undemocratic world government. The document contains brilliant generalities to make people believe that if all power is given to the United Nations and Agenda 2030, everything will be fine. But no, the 2030 Agenda is a trap.

It sees the family as an environment conducive to discrimination and inequality. In the 2030 Agenda, family and religion are presented as elements of conflict. Religion and family are problems, not solutions. For example, having children, spousal responsibility or generosity in marriage are not part of this new common sense. Nor do they [the promoters of the SDGs] accept that education belongs to parents.

Then there are issues that are clearly unacceptable from the perspective of Catholic doctrine. Take the example of sexual and reproductive health. Abortion and the massive use of contraceptives are encouraged. There is another very serious aspect: so-called gender equality. Agenda 2030 uses the terminology of gender ideology and contemporary secularist and statist political correctness. The intention is to establish a new world order that excludes many institutions, especially those with a Christian foundation. It is the state that determines the way of life, thus generating a relativism that makes tolerance the moral value par excellence. Should we also be tolerant of evil? They [the SDGs] are freedom-killers and generate relativism. They assume that everything can and must be chosen; even gender is a matter of feeling.

There are Christian institutions



that accept the 2030 Agenda. They claim that they do so to avoid being excluded from the public debate, or to avoid self-marginalization. They want to obtain aid that would be denied them if they did not take it into account. But being called Christian carries with it demands that cannot be evaded.

Our societies today are polarized beyond return. There are two versions of the West that

are increasingly antagonistic. We are reaching a point where the different worldviews have so little in common that we can barely speak common languages.

If we lift up our eyes a little, we can also see that we are experiencing a revival. There is a resurgence of Christian families, as we can see in some places in France and Spain. The image of a married couple with three or more children offers a joyful

and loving vision of life. This is where the renewal lies. The Christian marriage of young people who live generously is the most directly visible contemporary form of Christian joy in life. Joy is the social sign of possessing something good. And those parents who go out into the street with more children than modern common sense would dictate have immense transformative power.

HOW do people recognize you? Is it by your clothes, by your spirit or your voice? How would you recognize Jesus?

“Did not our hearts burn within us as He talked to us on the road and explained the Scriptures to us ... Then they told their story of what had happened to them on the road and how they had recognized them in the breaking of the bread.” (Lk 24:13-35)

Our culture puts a lot of stock on looks. Image is perceived as the key that opens the door to success. Show gets more attention than substance. A major difference between our fallen human nature and Divine nature is that we judge by appearance while God judges by what’s in the heart.

So often, looks bear little resemblance to what’s in the mind or heart of a person. Jesus said, “It is not what goes into a person’s mouth that makes him or her unclean, but what comes out. Since what comes out, comes from the heart” (Mt 15:11-20).

A person can appear friendly on the outside while secretly trying to manipulate you for his or her own gain. Have you ever noticed after meeting someone it wasn’t the person’s looks that you remembered but rather his or her attitude? What you remember is what came from the person’s heart, good or bad. Our words and actions impact others more than our looks. That’s not to say we shouldn’t look our best. However, a person may have a well-dressed body but a heart full of trash and leave you wishing you had never met him or her. We remember the attitude more than the attire.

In the Gospel recently, we heard how Jesus joined two men leaving Jerusalem going home to Emmaus. Grieving the loss of Jesus, whose crucifixion they had witnessed, they were amazed that this stranger

who caught up with them seemed ignorant of the events in Jerusalem.

Although they were followers of Jesus for three years they didn’t recognise Him. His physical demeanour didn’t register with them. The Risen Jesus would no longer be recognised by His physical looks but by His words and actions. Faith is the response to a person whose words and deeds are consistent and trustworthy. Faith isn’t based on looks or appearance but on consistent fidelity to promises. It’s the response to a person known by what he or she says and does. Faith in God is the response to God who is faithful to all His promises.

Words prepare us for deeds. But deeds speak louder than words. Words become visible in action. God’s Word became visible in Jesus. Jesus interpreted the Scriptures (Old Testament) for the two men showing how the Messiah would die to redeem and ransom humans from their sinfulness, suffer and die by crucifixion, and then rise from the dead on the third day. They listened intently to Him. But it was when they invited Jesus to spend the night with them – an act of hospitality – that the clincher came. It was at the meal in their house when Jesus performed the four actions they had seen Him do on Holy Thursday night that their “Aha” moment came.

There Jesus took bread, said the blessing, broke the bread, and gave it to them. Then He vanished into thin air. “With that their eyes were opened and they recognised Him.”

God’s Word always comes before the Sacrament. This is true in the Holy Mass and in each of the Sacraments. The Word prepares and leads us to the Sacrament. The Word becomes visible in the Sacrament. The two disciples exclaimed, “Were not our hearts burning within us while He spoke to us on the way and opened the Scriptures to us?”

This Person was indeed Jesus who was true to His promises, doing now what He did on Holy Thursday. The breaking of the bread was the sign or action by which the Risen Jesus enabled His disciples to recognise His Real Presence. The two disciples went back to Jerusalem knowing that Jesus was alive and they “recounted what had taken place on the way and how He was made known to them in the breaking of bread.”



Many prophets had proclaimed God’s word about the coming of the Messiah, but only one Person had broken the bread and uttered the words, “This is my body.”

The prophets never experienced this but God spoke through them to prepare the way to visibly experience the Risen Lord.

Have you had an “Aha” moment when you heard God’s

Word and recognised Jesus in the “Breaking of Bread”?

The breaking of bread refers to the Sacrament of the Holy Eucharist. This is celebrated in the Holy Sacrifice of the Mass by the bishops, as successors of the Apostles and the priests, as collaborators with the bishops, empowered by Jesus in the Sacrament of Holy Orders. Thus Jesus made His Real Presence

Jesus tells us clearly that “without me you can do nothing” (Jn 15:5). He warns us, “Unless you eat my flesh and drink my blood you do not have life in you” (Jn 6:54-58). The Eucharist is the visible sign of the Risen Jesus still present in His Church giving us His Body and Blood so that we may have life that is eternal. I pray that you have this “Aha” moment. in your life every time you worship through participating in the Holy Mass.

THE WAR ON YOUR MIND

James Corbett of The Corbett Report on the only war that matters

WE are in the middle of a world-changing war. This is no ordinary war, however. Most of the victims of this warfare aren't even able to identify it as war, nor do they understand that they are combatants in it. It's called fifth-generation warfare.

I don't mean the war in Ukraine, the one that all the media are asking you to focus your attention on. No, the war I'm talking about is an even broader war. A war that is taking place everywhere on the globe, even as I speak, and that involves virtually everyone on the planet, young and old, male and female, military and civilian. It is the war of every government against its own population and every international institution against free humanity.

What is fifth-generation warfare, anyway? And what were the first four generations of warfare?

It's argued that the modern age of warfare began with the Treaty of Westphalia in 1648, which gave the state a monopoly on war.

From that point on, modern warfare went through three generations, namely:

- First-generation warfare: the tactics of line and column, developed in the era of the smoothbore musket.
- Second-generation warfare: the tactics of indirect fire and mass movement, developed in the era of the rifled musket, breechloaders, barbed wire and the machine gun.
- Third-generation warfare: the tactics of nonlinear movement, including manoeuvre and infiltration, developed in response to the increase in battlefield firepower in WWI.

This brought us to the late 20th century when the nation-state began to lose its monopoly on war and military combat returned to a

decentralised form.

In this era - the era of fourth-generation warfare - the line between "civilian" and "military" became blurred, armies tend to engage in counter-insurgency operations rather than military battles, and enemies are often motivated by ideology and religion, making psychological operations more important than ever.

But some argue we have now entered a new era of warfare, namely fifth-generation warfare, as defined in an Al Jazeera article as "the basic idea that in the modern era, wars are not fought by armies or guerrillas, but in the minds of common citizens."

Fifth-generation warfare is not waged against either standing armies of nation-states or guerrilla insurgents but against everyday citizens. It is not being fought in a battlefield somewhere, but in the mind.

Fifth-generation warfare is an all-out war that is being waged against all of us by our governments and the international organisations to which they belong.

It is being waged against each and every one of us right now, and it is a battle for full-spectrum dominance over every single aspect of your life: your movements and



interactions, your transactions, even your innermost thoughts and feelings and desires. Governments the world over are working with corporations to leverage technology to control you down to the genomic level, and they will not stop until each and every person who resists them is subdued or eliminated.

of this is that so few know that the war is even taking place, let alone that they are a combatant in it.

The best way to understand this war is to look at some of the ways it is being waged against us.

Information Warfare

This is an infowar and the powers-that-shouldn't-be are engaged in "a war for your mind."

warn about a pack of wolves on the loose in the province was forged by Canadian military personnel as part of a propaganda training mission that went off the rails.

"The letter told residents to be wary of wolves that had been reintroduced into the area by the provincial and federal governments and warned the animals were now roaming the Annapolis Valley. The letter, which later became public, sparked concern and questions among residents but was later branded as 'fake' by the Nova Scotia government which didn't know the military was behind the deception.

"The training also involved using a loudspeaker to generate wolf sounds, the Canadian Forces confirmed to this newspaper."

Guys, let let that sink in for a second. They created a fake letter from the government, put it out there saying that there's dangerous wolves, and they set up loud speakers in the area projecting out wolf noises!

This isn't just research, you know. This isn't just a training exercise. They're actively engaging in this psychological operation to scare people using loudspeakers.

This is unbelievable.

But it's not just out-and-out military operations by soldiers dressed up in camo fatigues that are part of this fifth-generation infowar. In the war on everyone,

the establishment uses every means at its disposal to manipulate the public's perception.

Thus, Richard Stengel, the former editor of Time is happy to chair a Council on Foreign Relations conversation in which he defends the US government's use of propaganda against its own citizens.

"Basically, every country creates their own narrative story. And, you know, my old job at the state department was what people used to joke as the chief propagandist job.

We haven't talked about propaganda. I'm not against propaganda. Every country does it and they have to do it to their own population and I don't necessarily think it's that awful."

Or take the UK government's Scientific Pandemic Influenza Group on Behaviours, which outright admits that they use psychological techniques to manipulate the public into fearing the scamdemic, a move that some of the panel members called "totalitarian" . . . and no one bats an eyelid.

Perhaps the most insidious part of the fifth-generation infowar is that it has become so normalised that everyone knows it is happening, but no-one thinks of it as warfare. Of course everything is "advertising" and "propaganda." And of course it's being used to manipulate our behaviour. That's just how the world works, isn't it?

But we ignore the real nature of the infowar at our own peril. After all, this is a war for your mind and the most contested battlespace in the world is the space between your ears. You might have thought I meant that metaphorically, but actually I mean it quite literally. Which brings us to . . .

Neurological Warfare

If you hear Dr. James Giordano speak without listening to what he's saying, you get the impression he is merely an articulate, well-informed scientist who is passionate about his research. When you do listen to what he's saying, however - or even just look at his PowerPoint slides, like the "NeuroS/T for NSID" slide - you realise that he is Dr Strangelove. Or, if not Dr Strangelove himself, then at least Dr Strangelove's spokesman.

But it's not nuclear armageddon that motivates Giordano, it's



what he calls “weapons of mass disruption”- the various technologies for neurological intervention that the US military and militaries around the world are developing.

These include the “drugs, bugs, toxins and devices” that can either enhance or disrupt the cognitive functions of their target, like the “high CNS (Central Nervous System) aggregation” nanoparticles that, according to Giordano, “clump in the brain or in the vasculature” and “create essentially what looks like a hemorrhagic diathesis.” As sci-fi as this sounds, he insists these nanoparticles (and many, many other horrific neurological weapons) are already being worked on:

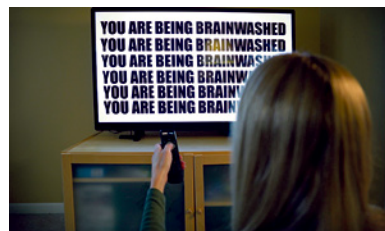
“The idea here is that I can get something called high CNS aggregation material that is essentially invisible to the naked eye and even to most scanners because it is so small that it selectively goes through most levels of filter porosity. These are then inhaled-either through the nasal mucosa or absorbed through the oral mucosa. They have high CNS affinity. They clump in the brain or in the vasculature and they create essentially what looks like a hemorrhagic diathesis; in other words, a hemorrhagic predisposition or a clot predisposition in the brain. What I’ve done is created a stroking agent and it’s very, very difficult to gain attribution to do that.

I can use that on a variety of levels, from the individual to the group. Highly disruptive. And, in fact, this is one of the things that has been entertained and examined to some extent by my colleagues in NATO and to those who are working on the worst use of neurobiological sciences to create

populational disruption. Very, very worried about the potential for these nano particulates to be CNS aggregating agents to cause neural disruption.”

We are at war with an enemy who is literally targeting our brains.

Avowed technocrat Elon Musk is trying to sell his Neuralink brain



chip technology to the hipster crowd as a cool and sexy way to upgrade your cognition . . . or so that the coming AI godhead will have mercy on us. Or something like that. Anyway, you should totally stick the Neuralink in your head at your earliest opportunity! And definitely don’t ask any questions about why so many of the macaque monkeys and other test animals that Neuralink was using as test animals in their “brain-machine interface” experiment have dropped dead.

To anyone not yet a victim of the information warfare operation designed to prepare humanity for the coming transhuman dystopia, all of this sounds insane. But for those who have fallen for the infowars psyop of the enemy, these types of mind-altering technologies are exactly as advertised: exciting opportunities to “upgrade” the feeble biological wetware we call our brain. But if you think you can avoid the biological aspect of the fifth-generation war by simply avoiding the brain chip, you’re out of luck. You’re also going to have to deal with . . .

Biological Warfare

This includes the mRNA and DNA and genetically-modified adenovirus vector “vaccines” that have been “normalised” over the past two years and which, as the miraculously “lucky” companies that bet it all on this technology like to brag, is re-programming the “software of life.”

- **The genetically-modified organisms - both gmo crops and gmo animals - that are now being unleashed upon the world in an uncontrolled experiment that puts our health and the very future of the biosphere in jeopardy.**
- **The push toward synthetic, lab-based “food” that is being funded by the usual eugenicist billionaires and which threatens to sever humanity from the natural abundance of the earth, make us dependent on an increasingly shrinking number of companies for our food supply, and, ultimately, to drive us toward a Soylent Green-style future.**

I’m sure you can fill in the blanks with myriad other examples of the attacks upon the world’s air, water and biome that constitute this unconstrained fifth-generation biological war being waged against us.

When and if you do put the pieces of this puzzle together and seek to warn people en masse that they are under attack, your ability to resist this agenda will be predicated on your ability to use your accumulated resources (your wealth) to foster communities of resistance.

Given the events of recent weeks, even the sleepest of the sleepy now realise that we are in a

period of economic warfare.

This is a battle being waged by every authoritarian power structure and every government against their own citizens for control of the most important resource of all: their wallets.

Yes, we are seeing the beginning of a truly world-historic moment: the death of the dollar reserve system, and the beginning of an entirely new monetary paradigm, the “Central Bank Digital Currency” system of programmable money that will be able to algorithmically control when, how and if you are allowed to transact in the economy at all.

Hopefully you get the point by now: There is a world war happening and it is a war on you.

Recognising this, the task we face seems nearly insurmountable. How are we to fight back in a war that the majority of people don’t even recognise is taking place?

Framed like this, our prospects do indeed appear hopeless. But therein lies the key: our perception that it is our duty to “fight back” against the enemy in their war on their battlefield on their terms of engagement is itself a narrative frame. And that narrative itself is

from those systems of control, and to start to reassert some kind of independence. That can be an extremely small thing like instead of buying groceries at the supermarket, buy them at a farmers’ market, or at least some of your groceries. Or perhaps you could grow them yourself in a vegetable garden. Something of that sort is a tiny thing on the individual level, but I think it’s the only thing in the long run that can lead to the type of society we want to bring to fruition. Again, I think it’s small things like that, if we start to apply ourselves with diligence and perseverance, that will eventually be able to overthrow this. But, unfortunately, as I say, we are on the cusp of this scientific revolution which makes scientific dictatorship possible, so unfortunately we don’t necessarily have generations of time.

We have a choice. Either we continue going into this technological, corporate matrix-which involves even things like buying the next generation of iPhone, which they’re already saying is going to have its own fingerprint scanning technology, and all of these corporate, military, Big Brother elements to it that



a weapon that is being wielded against us in the battle for our minds.

I think what’s needed is a more fundamental revolution: not of overthrowing a specific instantiation of this idea, but of overthrowing the idea altogether. And that can only come, I think, from building up an alternative system to which people actually want to apply themselves. I think we have to detach ourselves from this system that we’ve been woven into.

We have to look for any and every possible point at which we can start to detach ourselves

we’re willingly signing up to every day of our lives, and actually paying money for - or we start to create alternative structures which don’t rely on that system. It’s a choice that we have to make in our lives, I would say more quickly than has been apparent at any other time in human history.

We must stop playing their game. We must stop fighting their war. We must stop ceding our power, our authority, our time, our attention, our energy and our resources to engaging the enemy in their terms in their battlefield.

We must create our own parallel society on our own terms and soon.

We are saturated in lies. An astonishing number of people know they are lies and yet are unable to convince enough of the others to bring the truth over the line.

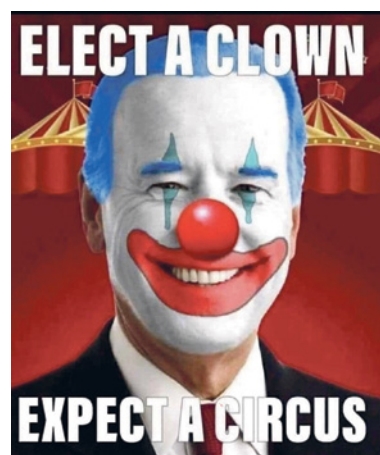

Jack and Bobby Kennedy stood for truth; Joe Biden and the current infestation of lowlifes stand for crime and lies. The Democratic Party is not democratic. It's a mistake too close to a joke to be real, and too surreal to be organic, except that, in the smoothness of its execution, it created its own measure. It is iconic, worthy of a great satirist. I cannot say how it might have been done, but a tech friend tells me they they have access to two levels of technology above what we are used to seeing.

The clues were there: Hunter, but no Jill. Only the truly criminal are prepared to go all the way, the ones with everything to lose if they lose. The saddest thing was the

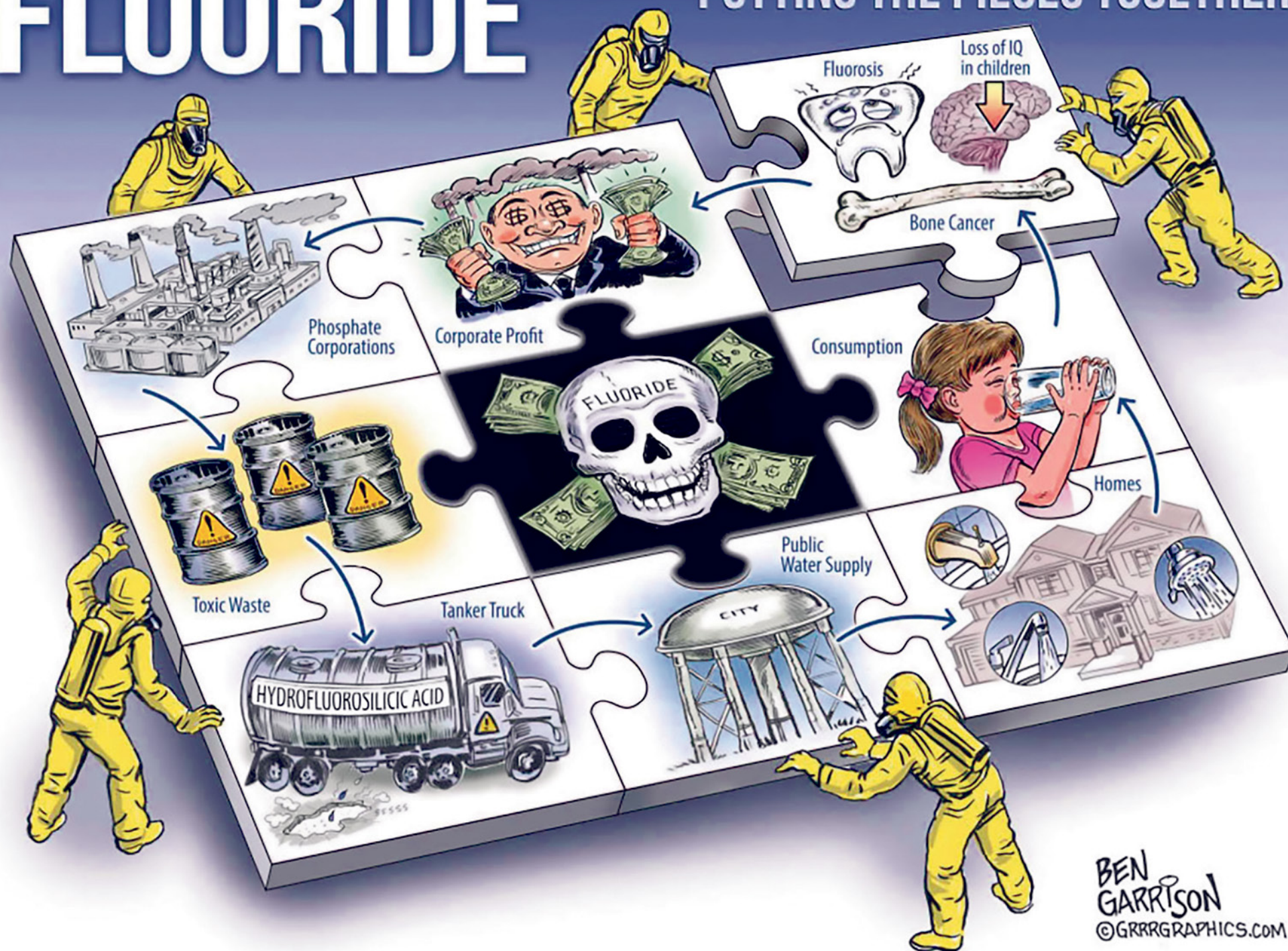
audience of rapt Paddys, those who stood there lapping it up, issuing sentimentalist cliches, clinging to this moment of lies as though their lives depended on it. And maybe their lives did depend upon it, for they most likely could not withstand five minutes of living in the truth if even half of what we believe about reality is true.

I wonder if such moments could have been possible had the motion picture never been invented. It is as though the very processes of inventing movie scenarios and making them into one of the pre-eminent iconic forms of our culture - and, then, the odd phenomenon of leaving one's home to go and sit in a cinema seat swallowing them down - have enabled their eventual spilling out into reality.

If so, there may be no end to this, because the world is coming down with unemployed screenwriters and the public is so inured to implausibility that there may be no outer limit to its capacity to suspend disbelief. Perhaps we should momentarily press the Pause button and hold a public competition to propose what might happen next . . . I say the 'real' Joe Biden escapes from the asylum, takes a taxi to the scene of the President's next public engagement, and confronts the interloper in his PJs.

Fluoride in water lowers IQ

FOR decades, independent scientists have claimed that fluoridation of the public water supply lowers IQ in children. A new report, which the US government attempted to suppress for more than a year, has now confirmed that link.

A lengthy court action has forced the government's NTP (National Toxicology Programme) to release the findings of a six-year systematic review to assess scientific studies on fluoride exposure and potential neurodevelopmental health effects in humans.

Of the 19 high-quality studies assessing the association between

fluoride and IQ in children, 18 reported an association between higher fluoride exposure and lower IQ in children. It stated:

‘The body of evidence from studies on adults is also limited and provides low confidence that fluoride exposure is associated with adverse effects on adult cognition. There is however a large body of evidence on IQ effects on children.’

Robert F Kennedy of Children's Health Defense said: ‘these findings fly in the face of the empty unscientific claims health officials have propagated for years, namely that water fluoridation is safe and beneficial. It's past time to eliminate this toxin from our water supply.

In 2016, a group of organizations and individuals petitioned the EPA to end fluoridation of drinking water in the US based on evidence of health risks, namely neurotoxicity. The EPA (Environmental Protection Agency) rejected the petition. In response, Food and Water Watch, Fluoride Action Network and others sued the EPA in 2017, seeking an end to water fluoridation.

The plaintiffs argued that water fluoridation violates the EPA's Toxic Substances Control Act and that fluoride is neurotoxic and lowers children's IQ. The EPA denied water fluoridation causes harm.

A seven-day trial took place in San Francisco in June 2020, but

the judge put the proceedings on hold pending the release of NTP's systematic review of research available on the neurotoxic effects of fluoride.

The report was delayed several times by government.

In December 2022, the plaintiffs filed several exhibits to the court, demonstrating the delay of the review.

‘This was a clear case of stonewalling,’ said Rick North of the Fluoride Action Network.

The case continues.

Ireland has one of the most heavily fluoridated public water supplies in Europe and is one of the

few countries in the world where it is mandatory by law.

Most citizens are completely unaware that the fluoride in their drinking water is the product of industrial waste and is affecting their children's neurological development.

Journalist Gemma O'Doherty has been highlighting the dangers for decades through her work but the Government has refused to end the practice despite calls from independent health experts. It helps to keep the masses stupefied and unlikely to rebel.

Charity begins at home

on why Christians are called to take a stand against mass immigration

LET'S start by asking a few simple questions that are bound to arise on this topic. In the Good Samaritan parable, and similar accounts in the Bible, we are clearly shown that God cherishes all members of the human race, irrespective of their nationality. Hence we should just copy that and be as welcoming and hospitable as possible to our new arrivals?

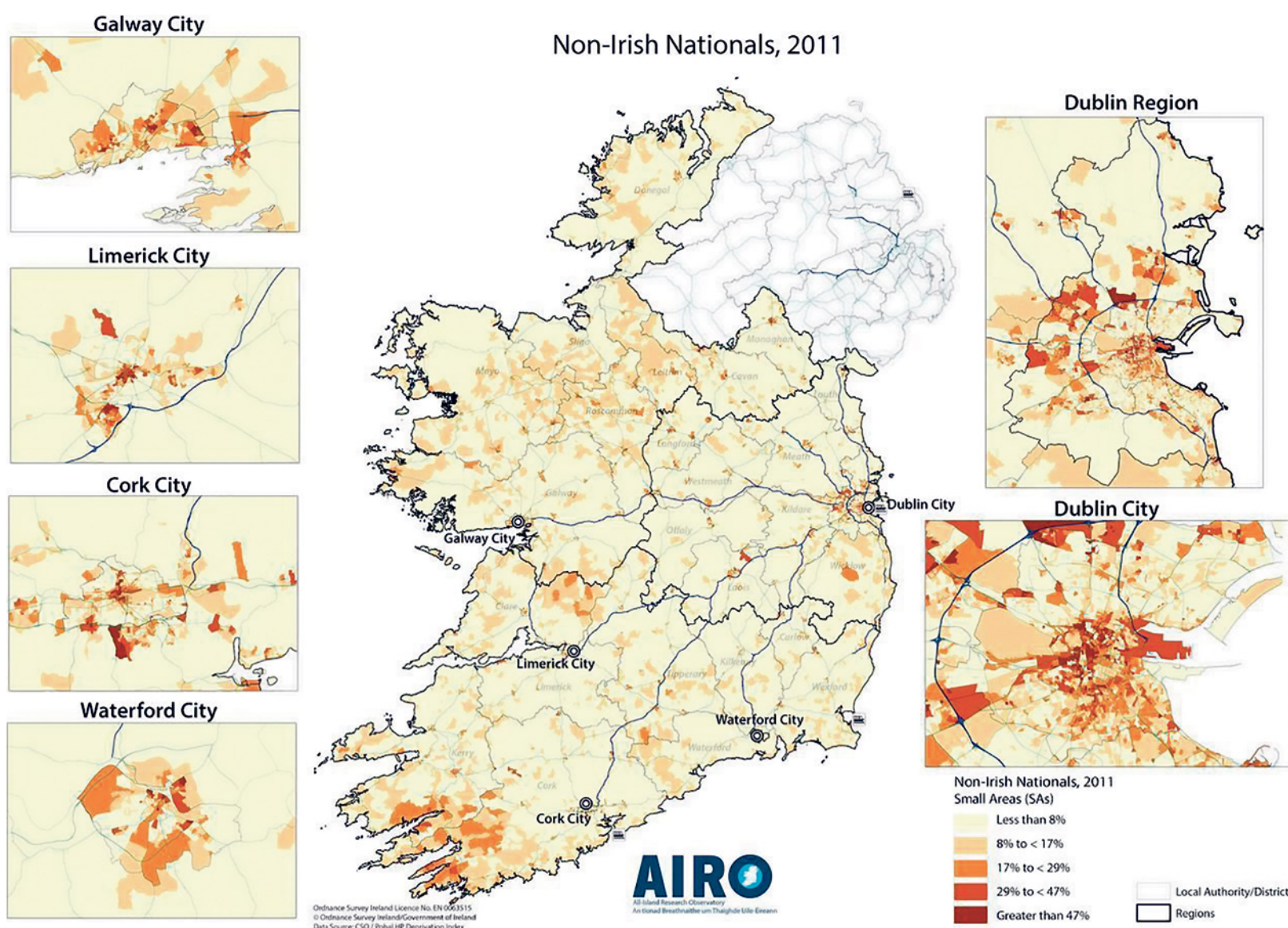
Normally yes, but surely a question does arise on simple numbers here.

The Good Samaritan was one person travelling on his own between two cities. He wasn't an army of himself. The story surely cannot be applied to a circumstance where 100,000s of people are pouring through the borders of a small country annually.

A recent survey of the Dublin housing market by Owen Reilly Estate Agency Services found that this year only 35% of houses will be purchased by Irish people, the rest by non nationals. Meanwhile, over 50% of those receiving government housing assistance (HAP) in counties like Laois and Longford are non-nationals.

With figures like that you need to refocus your Christian outlook to accounts of invasions rather than accounts of one stray traveller. On the question of countries, and races, it seems God supports nations that fight for their lands and borders, after all he gave the Israelite race the 'promised land' and supported them as they sought to defend it.

Another simple question often posed is that since human beings are all made in the image and

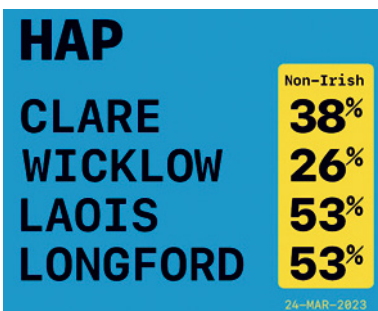


likeness of God (a core Christian belief) then any assistance given to these humans will store up credit for you in heaven.

Certainly it could, but a reply might be: if in helping migrants you are dis-helping natives, then obviously you cannot expect a net gain from heaven. If I help a migrant to get a house, at the expense of an Irish person, or indeed evicted an Irish person to do that, then I cannot call that robbing-Peter-to-pay-Paul scenario a Christian act.

But look around you. Is it really the case that migrants are taking up spare, already vacant resources, like in housing, healthcare and education? No, these facilities are typically full in Ireland and if migrants are pouring in to access them, they are pushing out the Irish to do so.

Finally, it may be right to ask if this mass immigration open-door policy that the Irish government



now favours is part of a deliberate strategy to undermine this country, because if so, surely we would need to oppose it.

Modern day powerbrokers, copying earlier Communist tactics, want to destroy identity and nationalist feeling in all countries in order to pave the way for a one-world government totalitarian administration. The tactic is to demean a country's history and culture, in order to break the deep affection between the ancient inhabitants and the country itself,

and so make world government easier.

For example I wonder if modern day Irish people could relate to these tactics used in Communist Russia, as related by Alexander Solzhenitsyn:

"History was changed – there was none! And the understanding of what a Russian is was changed – there was no such thing! And what was most painful. We Russians ourselves willingly walked along this suicidal path. The period of the 20's was considered the dawn of liberation. I recall from my school days that even the word 'Russian', such as 'I am a Russian' sounded like a call to counter-revolution... But everywhere was heard and printed the term 'Russopyati'."

[A curse word for 'Russian, the Russian national character and sense of solidarity then broke down under this pressure, which left them more vulnerable in the gulags]

"All nations in the Gulag crawled in order to survive and the lower to the ground they got, the better the chances of survival. But Russians in 'their own Russian' camps were the lowest order."

[Based on these experiences Solzhenitsyn felt that nationalism is very important for everybody:]

"Before the camps, I regarded the existence of nationality as something that shouldn't be noticed – nationality did not really exist, only humanity. But in the camps one learns if you belong to a successful nation you are protected and you survive. If you are part of universal humanity, too bad for you."

The point is that changing the racial mix is a very simple and effective way of destroying one's national identity. This sudden influx of immigrants is part of a long-term plan to undermine Ireland and therefore as Christians, we are called to oppose it.

Murder most foul

Patrick E Walsh on the raging yet silent vaccine genocide

I RECENTLY reported that the nine-month mortality figures for my home county of Kilkenny from the website rip.ie were up 27% for the period July 2022 to March 2023 on the three-year average figures to March 2021.

Sudden deaths are up 100% on the same period.

March 2021 is just before the Covid vaccination regime was rolled out on the Irish adult population so it's patently obvious where a lot of the blame for this carnage lies.

I've been reporting on these figures since November 2022 and as my original research has expanded from four months to nine, the scale of excess death is beyond dispute.

Kilkenny is a microcosm of Ireland regarding excess deaths which are exploding all around the country.

Russian mathematician Igor Chudov has done a lot of research into excess deaths and vaccination rates and come up with the following conclusion which I would urge people to investigate and not just accept my word on.

His statistical analysis, published on Substack, links the Covid vaccine to 49% of the excess mortality.

This would leave the government's draconian lockdown policies to pick up the tab for the rest.

This amounts to democide: mass murder of the people by the State.

People should focus on this when deciding whether to take the next booster. One thing is for sure you won't see it being discussed in the bought-and-paid-for mainstream media.

The Pharma-funded national media, in particular the Irish

Times, seem to have decided at this late stage that some serious ass-covering is needed to distract from their complicity in the Covid Scandemic, the greatest crime of all time.

Journaliar-in-chief, Paul Cullen, Irish Times Health Editor, wrote in March about the excess death rate of 24.4% for December 2022 when the average in Europe was 19%, which is shockingly high in itself.

'Excess deaths were recorded this winter over a period of at least six weeks, which many linked to a surge in flu and pneumonia cases...'

'The rise in the number of deaths beyond what is normally expected, affected all age groups...'

'As we have experienced a winter of high levels of influenza it would not be unexpected to see excess mortality...'

Who are 'the many' that have linked this to a surge in flu?

My default reaction to media using terms like 'the experts' and 'the many' is that if no-one is willing to put their name to this opinion then it is baseless speculation, pure and simple.

This is to obscure the truth of the matter, which is that we get flu every winter and this is built into the expected excess mortality figures.

It is disingenuous to suggest a 25% increase in excess mortality is due to something that occurs every year.

In Kilkenny, deaths in RIP.ie for December 2022 & January 2023 were 226, while they were 191 in 2020/21 and 140 for same months in 2019/20.

That's an increase of 18% on the so-called 'Great Pandemic' year and a staggering 61% increase on the year before Covid so don't talk to me about a flu and pneumonia surge being 'linked' to the problem.

By focusing on six weeks in December and January, they are implying that other than this period, there is nothing to worry about as regards excess deaths and since February 2023 is not mentioned then by default this was an aberration firmly fixed in the past.

The State's Chief Medical Officer Professor Breda Smyth was instructed by the Taoiseach in early February to investigate the cause of excess deaths in December and January.

It's now the end of April and we haven't heard a peep from her.

This is because when she finally does respond, the State wants this 'problem' to be firmly rooted in the

past in people's minds.

Don't be fooled by this tactic.

What is happening is not in any way in the past but is a clear and present danger to all who have taken the vaccine and boosters.

The high rate of sudden deaths in younger people is glossed over by saying that the rise 'affected all age groups'.

No reason offered or speculated.

Are they seriously suggesting that young Irish people are dying in excessive numbers because of the flu?

This is the Irish Times covering their backs so they can say they referred to it but do so without addressing the cause in an attempt to normalise young people dying.

Because to address this anomaly would mean considering 'the cause that dare not speak its name'...that is the vaccine which was rolled out to 95% of the adult population in 2021.

In recent times, I have noticed a new phrase appearing in the funeral notices on rip.ie.

Young and older people are dying 'after a short illness'.

Angus Dalglish, Professor of Oncology at St. George's Hospital in London, recently spoke about how several of his patients :

'have clearly relapsed following the booster vaccine...these relapses are quite aggressive and require systemic therapy. I am also aware of people in my circle who hadn't melanoma but have lumps after the booster...two leukaemia, lymphomas and a bad myeloma. I want to bring to everyone's attention that this does not look like a coincidence to me. We need to join forces to see is this a real effect and if it is, we must stop all boosters immediately'.

He doesn't say this lightly - he was previously pro-Covid vaccination.

'After a short illness' is the new 'sudden and unexpected'. Mortality rates are up over 20% while sudden and unexpected deaths are up 100% in this initial period.

'Correlation is not causation' vibrates across the airwaves.

We are about to find out what the mid-to-long term effects of the Covid 19 experimental jab are.

Anyone for another booster?

Extra Ecclesiam Nulla Salus

Dr E Michael Jones
on why there is no
salvation outside
of the Catholic
Church

ONE day after Ted Cruz and Josh Hawley grilled Merrick Garland in the US Senate, Bishop Robert Barron gave a speech at Notre Dame University in Indiana on the role which evangelisation played in the mission of America's most famous Catholic university. Evangelisation is good, His Excellency opined, but it is different from proselytisation, which is bad. Just what His Excellency meant by these terms became clear in an exchange on that topic with the conservative Jewish pundit Ben Shapiro. Cutting to the chase, Shapiro opened the discussion by posing what he termed “the most awkward of the awkward questions,” which is whether Bishop Barron felt that Ben was going to hell.

Shapiro: So let's begin with the most awkward of the awkward questions. I don't really care about this question but I get this question a lot. As a Jew, how does it feel that other religions don't think you're getting into heaven? So what's the Catholic view, I'm asking you on who gets into heaven and who doesn't? I spend a lot of my time promulgating what I think are Judeo-Christian virtues. So, what's the Catholic view of me? Am I basically screwed here?

Barron: “No, the Catholic view, go back to the Second Vatican Council. It says it very clearly. I mean Christ is the privileged road to salvation However, Vatican II clearly teaches that someone outside the explicit Christian faith can be saved. Now they're saved through the grace of Christ indirectly received. The grace is coming from Christ, but it might be received according to your conscience. So, if you're following your conscience sincerely or you think you're following the commands of the law sincerely, yeah, you can be saved. Now that doesn't mean complete



relativism. We still would say that the privileged route and the route that God has offered humanity, is the route of His Son. But, no, you can be saved. Vatican II says that even an atheist of good will can be saved by following his conscience because following his conscience, if he does, John Henry Newman says that conscience is the aboriginal vicar of Christ in the soul. It is in fact the voice of Christ. He is the logos made flesh. He is the divine reason made flesh. [By] following my conscience I'm following Him whether I know it explicitly or not. So even the atheist of good will, Vatican II teaches us, can be saved.”

Conspicuous by its absence from Barron's response was any mention of the sacrament of Baptism, which the Catholic Catechism defines as “necessary for salvation.” Instead of bloviating about Vatican II, Bishop Barron should have responded with a question of his own along the

lines of “Ben, are you baptised?” To which, Shapiro would have answered “No,” at which point Barron should have responded by saying that “If you refuse to be baptised, you cannot be saved.”

This is the essence of evangelisation, and there is no way around it. When Peter addressed the Jews after the Holy Spirit descended on the apostles after Pentecost, the first words out of his mouth in addressing the Jews was “You killed Christ.”

“Cut to the heart” by Peter's rebuke, the Jews asked “What must we do to be saved?” and Peter told them “You must be baptised.”

As some indication that the Gospel message can be preached effectively to the Jews, I got the following “letter of gratitude”:

Dear Dr. E Michael Jones,
Just over a year ago, I was a hapless Jewish bachelor living in my step-mother's basement. However, now, I am a well-to-do

married man, confirmed in the RCC (Roman Catholic Church). My conversion can be attributed in part to your assertion that the prescriptions of the Old Covenant can no longer be fulfilled, and yet, that they are fulfilled in the Eucharist as administered by ordained priests of the Holy Catholic Church. Your social commentary too, allowed me to make sense of world that as a dual US/Israeli citizen seemed to crumble before my eyes in the spring of 2020. My wife and I thank you for the benefit of your tireless evangelisation of the Jews. May we continue to labor as one in the rescue of all the “lost sheep of the House of Israel.”

Bruce Fingerhut, the publisher of St. Augustine's Press and a Jewish convert to Catholicism, used to say that the worst form

of anti-Semitism was exhibited by those who said that Jews did not have to convert to be saved. By proposing Christianity as the “privileged” way to salvation, Bishop Barron is implying that there are numerous salvific alternatives, implying that gaining eternal life is analogous to driving to Chicago, which can be reached by either the Indiana toll road or Rt. 94.

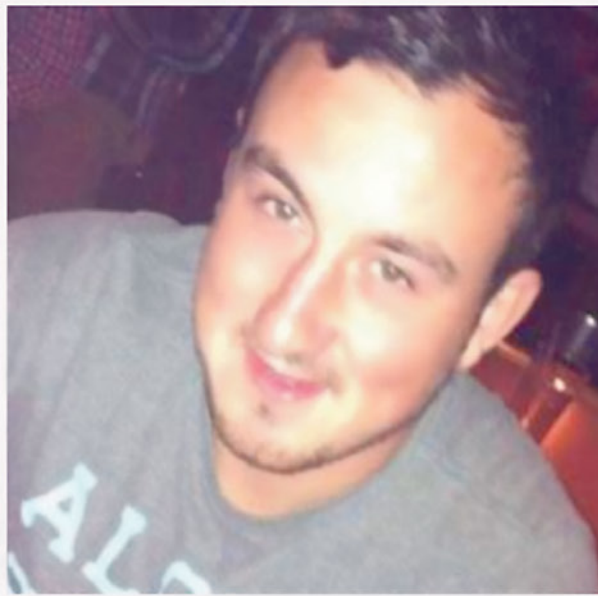

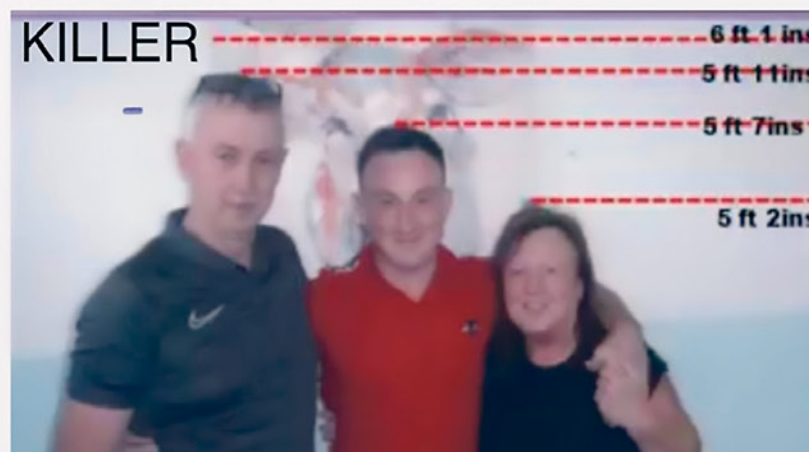
