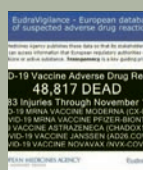

# Don't Stay Home

**THE first fallacy of the Covid scam was the idea that the Irish 'Government' (or any government) declared an 'emergency' because of the 'pandemic'. In fact, it was the other way around: they constructed an elaborate pretence about a massive collective health risk in order to justify the declaration of an 'emergency'. This is crucial to achieving any understanding of everything that has happened since.**

For reasons which will emerge in due course, the puppet governments of the West required to place their populations in a state of constant high alert, so as to be able to impose maximum control upon them at the drop of a truncheon.

The lockdowns, seen in this context, were 'rehearsals' for martial law, designed so that people would know what to expect and how to react when the curtain went up on the try totalitarian theatre. The message from the political establishment of the former nations of Europe, and the European Union, is that the era of freedom has ended, and the formerly sovereign people had better get used to it.

In the past three years, we have seen the rollout of illegal mandatory face masks, quarantine camps, health passes (apartheid), coercive injection with a substance that is not a vaccine but which kills people, and many other developments that the population

of twenty years ago would have deemed unthinkable. Now, we are being trained to think of them as the 'new normal'.

The latest innovation in this new tyrannical dispensation is the '15-minute neighbourhood', the sub-division of our cities into self-contained blocks which will be, in effect, open-air prison camps, designed to wean us off the habit of taking freedom-of-movement for granted. Initially, the concept will be sold as a remedy to 'climate change', and therefore primarily concerned with car travel. As with

everything else we have observed over the past three years, however, this conceit will soon be dropped and a spurious excuse will be found for making the new arrangement more or less total and permanent. Very soon, the 15-minute regime will make it almost impossible to justify having a motor vehicle at all. Then, as soon as enough people have given up on driving, the controls will ramp up to stop people moving around at all without express permission from the 'authorities'.

It goes without saying that any

proposal to divide our cities up into '15-minute neighbourhoods' would be utterly unconstitutional. Nobody asked for it and nobody was asked about it before it started to roll out - first in the UK, in Oxford and Canterbury, and soon in Paris, Milan and Melbourne. Dublin too is on the cards.

The 15-minute neighbourhood concept was developed by Sorbonne professor, Carlos Moreno, who thought a neighbourhood 'wasn't just about buildings but social networks too.' Who knew? By social networks,

it is to be presumed, is meant people sitting around talking over beverages of various kinds.

In Oxford, a consultation was conducted, allegedly to test public opinion on the proposal - 92 per cent rejected it, but the local authority said they were going ahead anyway. That was a real shock for everyone!

# The needle and the damage done

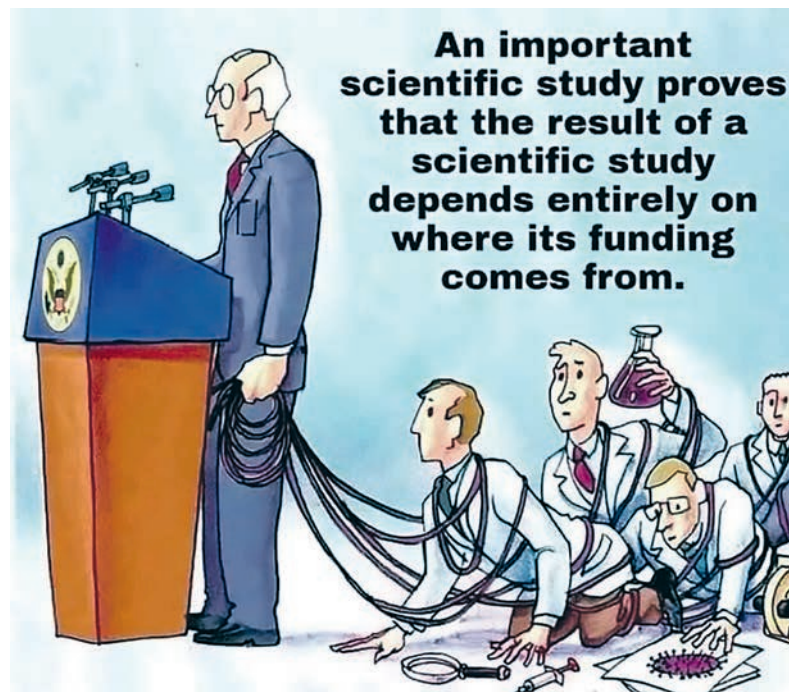
One in 27 will develop myocarditis or other associated injuries but every individual who got injected will suffer some degree of cardiac injury whether immediately felt or not, the research found.

In Germany, there has been a four-fold increase in sudden deaths since the vaccine was introduced in early 2021, according to the Association of Statutory Health Insurance Physicians (KBV).

Official figures from EuroMOMO, provided by European countries including France, Germany, Spain and Italy, show 690k excess deaths in Europe by week 46 of 2022. We know that Ireland's excess mortality has been soaring since the rollout reaching 16% during some months.

In Australia, there were only 1,303 excess deaths in 2020, but this increased by 747% to 11,042 deaths in 2021 following the

'vaccine'.

In 2020, during the so-called 'pandemic' Japan had fewer all-cause deaths than all the previous 9 years.

By the end of 2022, 83% of Japan's population was vaccinated. The country is now witnessing the highest number of excess deaths in 11 years. Meanwhile in the US, more than 25% of Americans now say they know somebody who died from the vaccine.

The latest Rasmussen national survey found that 49% of American adults believe that covid injection side effects are responsible for a significant number of unexplained deaths throughout the country. More than one in four says they were personally affected in some way by shot damage.

The Pharma-owned media in

Ireland continue to sweep the carnage under the carpet and harass those who expose it including the Irish Light. Journalists abandoned their post as defenders of the public interest a long time ago and are nothing more than bought-and-paid-for lackeys of drug companies and the HSE who pay their wages.

is the brainchild of the World Economic Forum (WEF), which has published a short, informal but informative video promoting the concept, billed as ‘part of the “C40 Cities” network for implementation of Agenda 2030.’

The concept is elaborated in the video as follows: ‘15-minute neighbourhood cities: Where everything you need is available within a 15-minute radius on foot or bike.’ This suggests a diameter of between one and two miles, the approximate mean distance coverable in half-an-hour, somewhere between foot and bicycle speed.

‘The aim,’ we are informed, ‘is to cut car use, resulting in fewer CO2 emissions. And cleaner air. Along with a more pleasant urban life.’ You will go nowhere and you will be happy!

In the 15-minute city, buildings will be required to multi-task. Schools might host different activities at the weekend, for example. ‘The concept aims to nurture local pride — amour des lieux — in urban dwellers.’ It is as if nobody had pride in their neighbourhood before the WEF took a hand; the reality is that diminishing civic spiritedness under the coming tyranny will have quite the opposite effect.

Then comes a whopper: ‘The pandemic has led many cities to rethink design, as people keep to their local area.’ A barefaced lie, as the cycle lane blitz was rolled out within days of the start of said ‘pandemic’.

None of this was by way of opportunistic response to the circumstances delivered by lockdown; again, the other way around: it was planned long in advance, the plans drawn up long before the first Covid cough was heard.

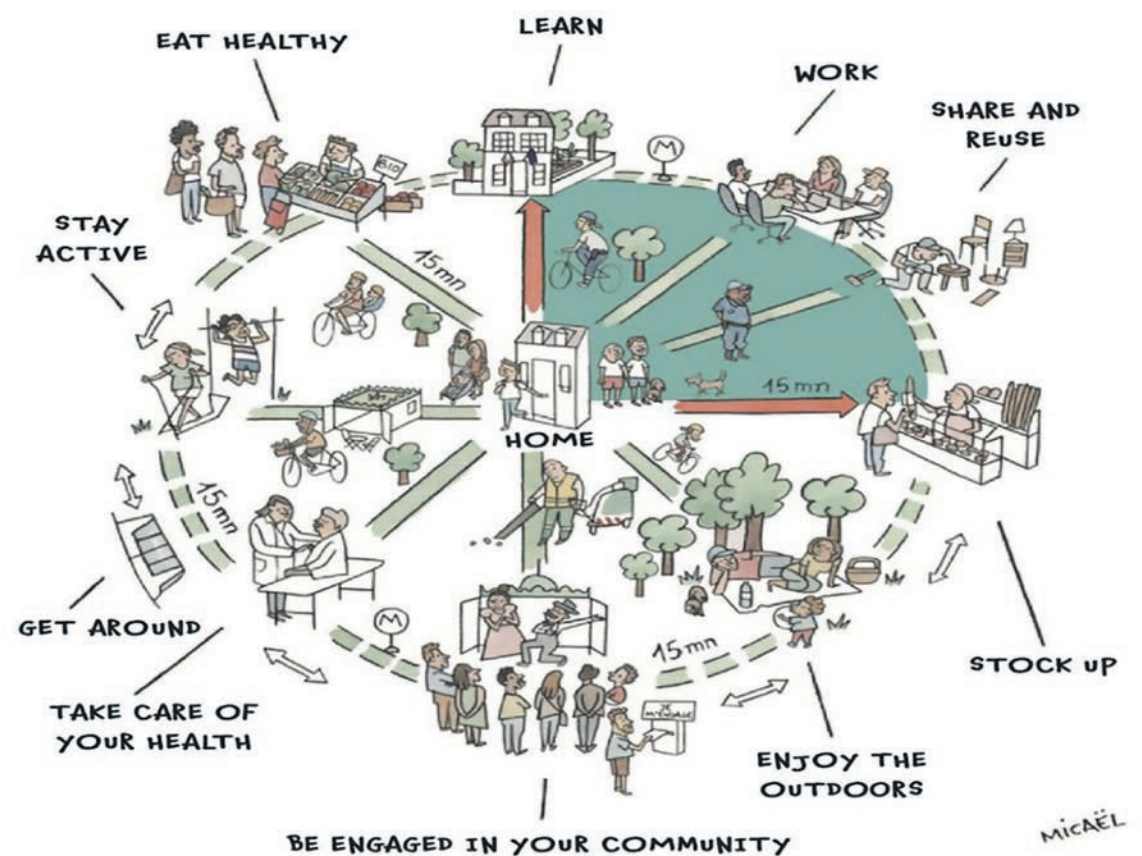
The long-term intention of the 15-minute neighbourhood is visible in ancillary aspects of the scheme. Already, the illuminated signs that have become redundant from the lockdown era have been co-opted to read ‘Shop Local’. Translation: ‘Expect to be staying mostly close to base!’ For years, the EU made it practically illegal to market Irish produce under the slogan ‘Buy Irish’, which they told us was an excessively insular form of thinking for the globalist age; now they go back to telling us what they forbade us from thinking decades ago! Why? Because the plan is so lock us down, using the well-tested frog-boiling method.

The WEF video informs: ‘Some critics say hyper-localism could

inhabit the “cluster-effect” [of businesses and services of the same kind that you often find in cities], often cited as the key to the success of cities, whereby specialists and their competitors work in close proximity, leading to faster innovation.’ Hyper-localism, eh? It already sounds neither short-term nor casual, but something that will happen all day, every day, and no excuses.

There is no mention in the video of the restrictions on car travel, whereby (at first) citizens will be 100 trips outside their neighbourhoods per year, i.e. two per week. They plan to reduce care use, not by improving public transport, but by making care use nigh on impossible, or at least impracticable, because citizens would risk huge fines just by living their lives the way they take for granted right now.

Of course, the concept is utterly impracticable. It is unclear, for example, if the plan is to divide cities into areas conforming to the 15-minute specification — ‘spatial blocks’ instead of cell blocks. Although this would be the simplest approach, it would raise all kinds of difficulties, such as what to do about people living on the fringe of a specific area — would they be entitled to travel in only one direction, to the other extremity of the neighbourhood, or would they be permitted to go 15-minutes in the other direction, into a separate neighbourhood? Could they drive a few hundred yards in the rain to visit a near neighbour or relative on the wrong side of the line? A more equitable proposal would be to treat every household as being at the centre of its own 15-minute radial area, but that raises the tricky problem of how to delineate the outer limits. Would this be achieved electronically, in each individual instance, so that the resident would receive a ping! — or an electric shock — when he had reached the boundary of his cell block? There is also the problem of what to do with people who work outside their neighbourhoods: would they be entitled to travel to work only twice a week? These arguments, of course, merely serve to illustrate the insanity of the whole thing, which means, of course, that the 15-minute city is actually logistically impossible: the one way they can make it ‘work’ is to give virtually everyone some kind of exemption. But, of course, we know what happens in such situations: As we saw during the Covid episode, the State simply blanks anyone who raises any issue of exemption, requiring them to obtain ‘proof’ or certification to demonstrate their entitlement



to such exemption, from some ‘expert’ or ‘specialist’, which naturally proves impossible to do, since all the ‘experts’ are threatened with cancellation if they issue such a document. The next step, as we know also, is to criminalise citizens if they seek to ignore this absurd situation by exercising their fundamental rights anyway.

Paris is next. The city’s mayor, Anne Hidalgo, wants every street in the city to have a cycle lane by 2024, and proposes removing 60,000 on-street parking spots, replacing them with ‘free space, allotments and playgrounds instead’. Paris has already banned cars on one Sunday every month, and along the River Seine. During the lockdown, the city created 50 kilometres of extra cycle lanes.

Milan is currently running a 150-minute localised experiment, and Melbourne is trying out 20-minute neighbourhoods.’

Given what we have seen of the escalating tyrannical nature of Western societies, what we need to ask ourselves here is what exactly might merit the kind of power to corral people in such strict and narrow confines as undoubtedly this project provides for.

The 15-minute neighbourhood will, automatically, destroy much of the freedom enjoyed by the human race since the motor car became ubiquitous about a century ago. But it will do more: it will announce to each and every citizen that freedom of movement is no longer a right, but a concession by the appropriate authorities. We need, then, to ask of ourselves a

very dark, troubling but necessary question: What else have they planned for us to make such control over our movements necessary? It is clear that measures like this are part of the superstructure of a martial law plan, designed to prevent citizens from travelling to protest or meet with like-minded people. This, surely, tells us that our jailers are anticipating that they will soon be required by their paymasters to implement some diabolical scheme — for perhaps the plundering of the property and resources of citizens, or some further excursion into extreme criminality or cruelty.

The answer, as always, is to withhold cooperation: Go where you please, when you please, as you always did.

# The Three Stooges

**So who in Ireland is most responsible for the vaccine genocide and how should they be punished? Nuremberg-style hangings are often promoted by the Zionist-controlled 'Truther Industrial Complex' but this is misconceived and based on a lie that those of us who have done the forbidden research now understand. What happened at Nuremberg was the antithesis of justice and the wrong people were executed.**

I'm not an advocate of capital punishment because all too often the innocent become the accused. But many say life in prison is not adequate for the crimes of Covid that have been committed which far surpass any of the atrocities carried out in human history up to now.

For those who have promoted the injectable bioweapon, natural justice will take charge and the diabolical figures in Leinster House, the HSE, Irish hospitals, the Gardai, the media and other State and Church institutions will soon crawl under their rocks unable to walk the streets without experiencing public opprobrium and wrath.

But it's important to identify the

hierarchy of culprits: those who are most to blame. That title must go to those whose primary purpose is to keep the government in check and ensure what they do is legal and lawful.

At the earliest stages of the Covid scam, John Waters and I went to the High Court furnished with evidence that a crime was being committed against the Irish people by the government in the form of unlawful Covid mandates and that it must be stopped.

Justice Charles Meenan - whose virologist uncle Patrick Meenan happened to establish the first Dublin office of the criminal World Health Organisation and developed the dangerous polio vaccine - abused and threatened us and did everything in his power to show his contempt for the Constitution by disregarding its most fundamental concepts.

He rejected our application for a Judicial Review to test the constitutionality of the destructive lockdown laws even though we warned him a vaccine genocide was going to follow.

At George Birmingham's Court of Appeal, the same resentment was displayed. Our experience at Chief Justice Donal O'Donnell's Supreme Court was not much different.

These three men had it in their power to stop the government in its

tracks and save lives but because they are spineless enemies of truth and justice, they pushed it forward on its lethal path, and as a result thousands are now dead, many of them very young. They simply must be held to account for this horrific crime.

We know that only puppets of the Davos elite get into the 'Dáil' because we don't have elections in Ireland but rather selections: they are handpicked stooges of the World Economic Forum blackmailed by dark secrets, financially compromised or manipulative fools. So how could those they pick to sit on the bench be any different?

Alongside the drug-pushing media and gardai, the Irish judiciary are the greatest enemy of the Irish people. They have failed utterly in their primary function to guard the people when the government oversteps its role. The only purpose of parliament and courts is to protect our freedom, private property and God-given rights, but this regime does the opposite of that, always prioritising its own selfish gain.

The most repugnant aspect of this is that our taxes are funding the destruction of our health, our standards of living and our children's futures. But those who stand by and tolerate it, as many have, must take some responsibility

for the dystopia that has emerged during these wretched times.

The tyrants in the Gardai, RTE and media who shamelessly forced the experimental injection on the public day in and day out for three years will face judgement too. Many in this evil club are experiencing karma as they suffer their own vaccine damage and see their colleagues drop dead around them. ## No Way Norway!

Norway is set to ban petrol cars by 2025 as part of the World Economic Forum agenda to impoverish its people and bring them back to serfdom.

Their timing is lousy as more and more evidence comes to light of the dangers of electric vehicles. Researchers at the University of Tennessee have found EVs have a greater impact on pollution than their fossil fuel counterparts. Professor Chris Cherry analysed the emissions and health impacts of five vehicle technologies in 34 Chinese cities, focusing on dangerous fine particles, and found electric cars cause much more overall harmful particulate matter pollution than gasoline ones.

Particulate matter includes acids, organic chemicals, metals, and soil or dust particles. It is also generated through the combustion of fossil fuels.

For EVs, combustion emissions occur where electricity is generated rather than where the vehicle is used. In China, 85 percent of electricity production is from fossil fuels, about 90 percent of that is from coal. The authors discovered that the power generated in China to operate EVs emits fine particles at a much higher rate than gasoline vehicles.

Cherry said: "An implicit assumption has been that air quality and health impacts are lower for EVs than for conventional vehicles, Our findings challenge that by comparing what is emitted by vehicle used to what people are actually exposed to. Prior studies have only examined environmental impacts by comparing greenhouse emissions."

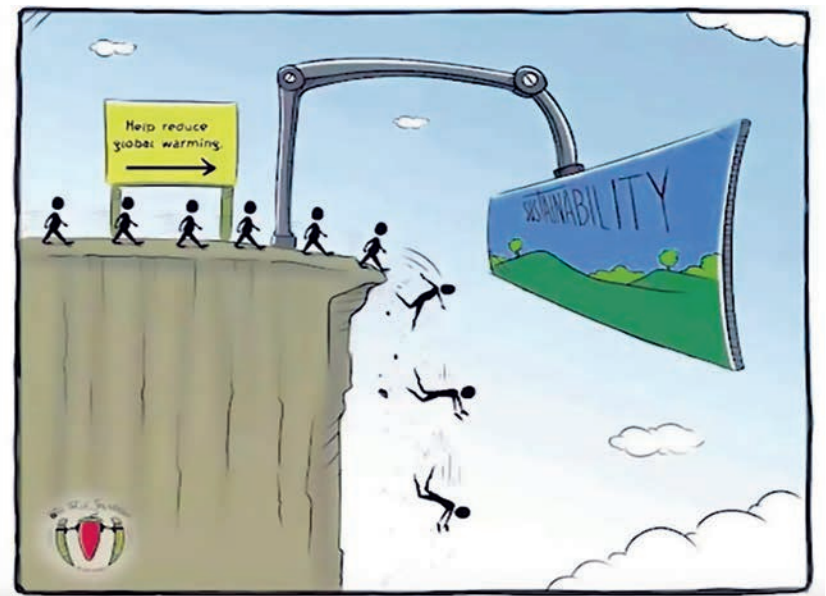
### Commie Canada

# How to have more rational conversations

Having successful conversations with people unaware of the issues we face today is complex and difficult, but can be done with practice and patience

## WHY do people shut down when asked a simple question, or lash out at a stated fact?

I spent over 20 years, prior to the first lockdown, studying perception, communication and behaviour. Yet nothing had prepared me for the level of influence that could be exerted over intelligent people who suddenly became completely irrational and abusive, doctors who dismissed valid questions, and a collective media that continues to demonise anyone daring to ask questions, or who refused to comply with rules and mandates.

Reaching people that have been conditioned with a false narrative is difficult, and at times can seem impossible. There are ways to reach people but it takes practice, understanding of the issues, as well as self-control, to even begin to have small successes at having rational conversations. It's an obstacle course we must navigate.

It is fair to say there are many pitfalls in having conversations with loved ones. Much of how to reach people begins with a number of things we must avoid; if these pitfalls are not navigated successfully, it really doesn't matter how many facts you have, or convincing an argument you present; you will likely be shut down with one of the many scripted responses, such as 'you're a conspiracy theorist' or 'have you joined a cult?'

What has happened when someone turns into King Kong and gets angry? Metaphorically speaking, we stepped on a landmine. Human beings have in-built (and cultivated) safety alarms, or cognitive dissonance, that to some extent help us function in the world.

While the behavioural sciences have in recent times made startling

discoveries about how we come to make decisions, and what drives our behaviour, these sciences are also now used by corporations and authorities in what is known as 'nudging' (influencing). For example, in repeated slogans such as 'hands, face, space'.

If these insights were understood by the public on the other hand, we could solve so many problems. This gives me great hope, and communicating these insights to help people understand their own and other's behaviours and beliefs is one of my missions in establishing reachingpeople.net.

### 'Science advances one funeral at a time' - Max Plank

Max's quote describes the resistance that we humans have when our beliefs are challenged. Usually the first information in sets the belief, so education and the media have a huge responsibility, and they have failed us so miserably, for so long.

First, however, we will have to let go of negative emotions we have towards unaware people. Trying to have a conversation in a heightened state - angry, anxious, etc. - will invariably not work. The anger, the injustice, the bitterness are all justified; but the problem is, in practical terms, they disconnect us from those we need to reach.

The greatest manipulation of

all is of our emotions, and by resolving negative ones, we do not let the perpetrators off the hook; we just stop experiencing those emotions. You don't want to feel bad when looking at a picture of a maniac such as Bill Gates. He isn't worth an ounce of energy.

So, finding a way to let go will really help conversations. Some of the ways I have found powerful are a) The Sedona Method; b) Emotional Freedom Technique (EFT or 'tapping'), and c) any process that assists in letting go of unresolved emotion.

Jerome Bruner showed that a fact presented in a story will land over 20 times more effectively than the fact presented in its raw form. We find that metaphor is also useful at reaching people, along with questions used artfully. See boxes on the right.

## Key concepts in successful communication

### 1 First impressions are everything

Most people make up their minds whether someone is a threat (physical or ego) within the first second. If we are seen as a threat, the other person will shut down immediately, likely attack us verbally, or exit the conversation quickly.

Seeing the unaware person as having wrong ideas, rather than see them in a derogatory light, will greatly help us not trigger this shutdown. If we unconsciously view people as stupid, we will treat them as such, and they will sense this and shut down. We have to be understanding that people have been subjected to the greatest psychological operation in history. Letting go of negative emotions we have towards unaware people is key.

### 2 Overcome division and find common ground

Studies clearly show if we see people as on the opposite side, we will mostly dismiss everything that person has to say. This is why media propaganda focuses on divisive group identities such as 'anti-vax', 'conspiracy theorist' and many others.

Overcoming this is critical. If we find a subject where we and the other person agree, we will have a great platform to introduce ideas they need to be aware of. A quick way to find common ground is to establish that you both want people to be healthy and happy. Example: 'we are effectively on the same side'.

### 3 Pace, pace, pace

One of the quickest ways to shut down someone to new ideas is to introduce too many subjects and complex problems too early. This is like a pushy salesman, or evangelical preacher - it shuts people down.

Share information at a pace that the other person can digest. Think about where they are and what they can acknowledge, such as corruption.

### 4 Share information in a way that the other person can hear

Much of the propaganda is aimed at reaching the unconscious mind. It is largely pointless to present a fact to someone in its raw form such as 'lockdowns don't work', if they believe the opposite. Starting with 'how effective were lockdowns?', then telling a story using metaphors or questions is a more powerful way to do so.

It is also worth avoiding asking the question "Why?" regarding the person's decisions. They get defensive, and will rationalise and justify. Asking questions to have them explain themselves, in a polite and gentle way, helps them understand their thinking, or lack of it. Be supportive as they hit discomfort in their minds. You're not trying to 'win', only help people realise where their beliefs come from. Asking questions about things such as 'are the public aware it doesn't stop transmission?' etc, when you have a good rapport going, can also be very effective.

# Pfizer's Long History Of Fraud

One of the most significant cultural transformations of the last two years has been the newfound glorification of the pharmaceutical industry

**AN industry plagued by decades of fraud, corruption, and criminality managed to quickly rebrand itself as the saviour of humanity during the Covid-19 crisis.**

But nothing inherently changed. Big Pharma still values shareholders' profits more than people's lives.

The regulatory agencies still operate as revolving doors to the pharmaceutical giants they are said to regulate.

Big Pharma still dominates lobbying efforts in the corridors of power and spends billions each year advertising pharmaceutical products.

Despite the notorious corrupt nature of the pharmaceutical industry, Pfizer's CEO Albert Bourla claimed during a November 2021 interview, that a small group of "medical professionals" who are intentionally circulating "misinformation" critical of the Pfizer vaccine narrative are "criminals".

Bourla seemed to have forgotten the history of his own fraudulent company.

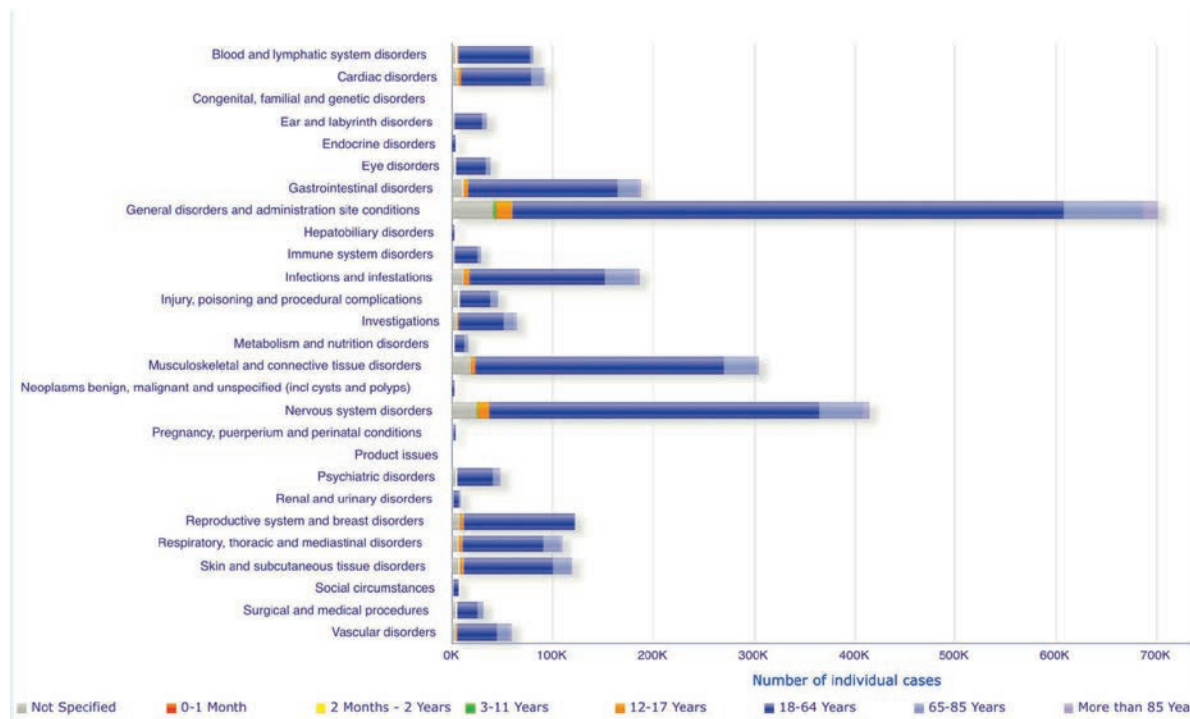
## Pfizer's Long History Of Criminal Behaviour

In 1992, Pfizer agreed to pay between \$165 million and \$215 million to settle lawsuits arising from the fracturing of its Bjork-Shiley Convexo-Concave heart valve, which at the time had resulted in nearly 300 deaths, and by 2012 had resulted in 663 deaths.

In 1994, Pfizer agreed to pay \$10.75 million to settle Justice Department claims that the company lied to get federal approval for a mechanical heart valve that has fractured, killing

hundreds of patients worldwide. Under the settlement, Pfizer also agreed to pay \$9.25 million in coming years to monitor patients who received the device or pay for its removal. The deal was criticized by consumer rights activists who urged Government officials to bring criminal charges and lobbied for a steeper civil penalty for the multibillion-dollar company that had covered

up safety concerns even as the device was killing patients.

In 1996, Pfizer administered an experimental drug during a clinical trial on 200 children in Nigeria but never told the parents that their children were the subjects of an experiment. Eleven of the children died and many others suffered side effects such as brain damage and organ

failure. A report by Nigeria's health ministry concluded, the experiment was "an illegal trial of an unregistered drug," a "clear case of exploitation of the ignorant," and a violation of Nigerian and international law. Pfizer did not obtain consent or inform the patients that they were the subjects of an experiment, not the recipients of an approved drug.

In 2002, Pfizer agreed to pay \$49 million to settle allegations that the drug company defrauded the federal government and 40 states by charging too much for its cholesterol treatment Lipitor. Lipitor had sales of \$6.45 billion in 2001.

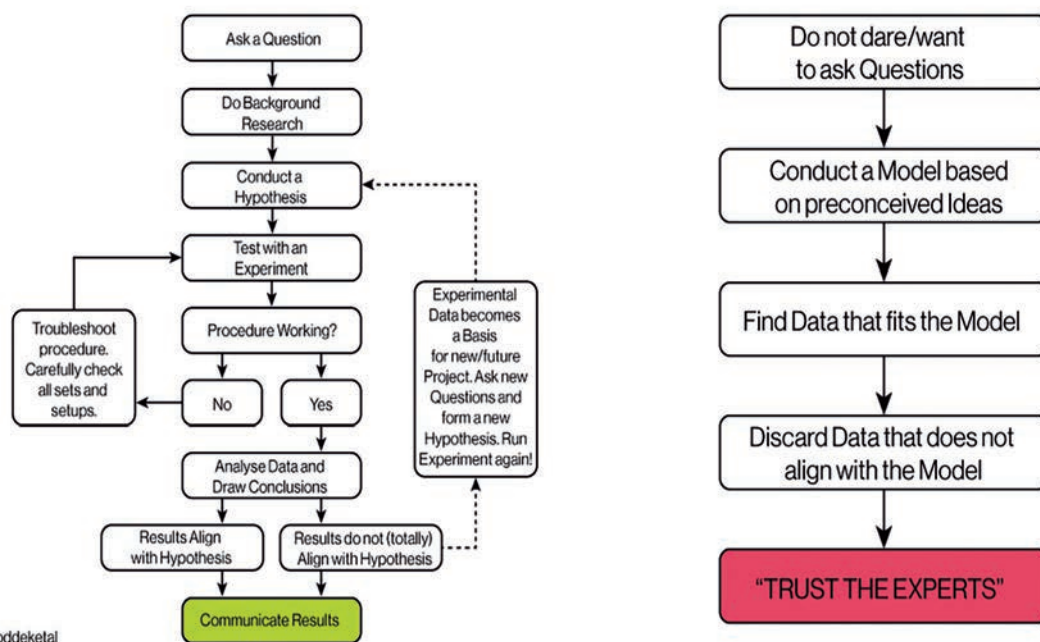
In 2004, Pfizer agreed to plead guilty to two felonies and paid \$430 million in penalties to settle charges that it fraudulently promoted the drug Neurontin for unapproved uses. Pfizer agreed that it aggressively marketed the epilepsy drug by illicit means for unrelated conditions including bipolar disorder, pain, migraine headaches, and drug and alcohol withdrawal. Pfizer's tactics included planting company operatives in the audience at medical education events and bribing doctors with luxury trips.

In 2008, the New York Times published an article entitled, "Experts Conclude Pfizer Manipulated Studies." Pfizer delayed the publication of negative studies, spun negative data to place it in a more positive light, and controlled the flow of clinical research data in order to promote its epilepsy drug Neurontin. Pfizer discontinued its marketing program for Neurontin in 2004 after the drug became available as a generic. That same year, the company paid \$430 million to settle federal criminal and civil claims that one of its subsidiaries had promoted the drug for unapproved uses.

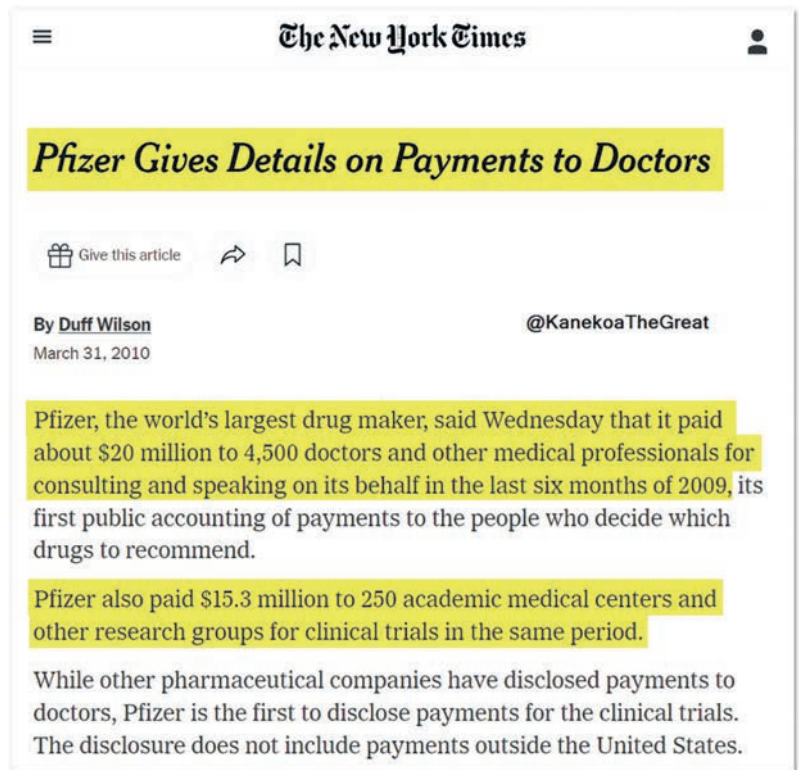
In 2009, Pfizer was fined \$2.3 billion, then the largest health care fraud settlement and the largest criminal fine ever imposed in the United States. Pfizer pled guilty to misbranding the painkiller Bextra with "the intent to defraud or mislead", promoting the drug to treat acute pain at dosages the FDA had previously deemed dangerously high. The government alleged that Pfizer had paid kickbacks to compliant doctors and also promoted three other drugs illegally: the antipsychotic Geodon, an antibiotic Zyvox, and the antiepileptic drug Lyrica.

In 2009, Pfizer paid \$750 million to settle 35,000 claims that its drug, Rezulin, was responsible for 63 deaths and dozens of liver

failures. Rezulin's withdrawal from the U.S. market on March 21, 2000, followed negotiations between the drug's manufacturer and the FDA. Senior FDA officials had long stood behind the drug despite a mounting death toll and Rezulin's absence of proven life-saving benefits. The position of the FDA officials stood in contrast to their counterparts in Britain, where Rezulin was removed effective Dec. 1, 1997.

In 2010, Pfizer was ordered to pay \$142.1 million in damages for violating federal anti-racketeering law by its fraudulent sale and marketing of Neurontin for uses not approved by the FDA. The jury found that Pfizer's marketing of 'Neurontin' violated both the Racketeer Influenced and Corrupt Organizations Act (RICO) and California's Unfair Competition Law.

In 2010, the New York Times published an article entitled, "Pfizer Gives Details on Payments to Doctors". Pfizer admitted that it paid about \$20 million to 4,500 doctors and other medical professionals for consulting and speaking on its behalf in the last six months of 2009. Pfizer also paid \$15.3 million to 250 academic medical centers and other research groups for clinical trials in the same period. The disclosures were required by an agreement that the company signed to settle a federal investigation into the illegal promotion of drugs for off-label uses.

In 2010, Blue Cross Blue Shield filed a lawsuit against Pfizer accusing the pharmaceutical giant of illegally bribing 5,000 doctors with lavish Caribbean vacations, golf games, massages, and other recreational activities in order to convince doctors to use Bextra for off-label use.

In 2010, leaked cables between Pfizer and US officials in Nigeria showed that Pfizer had hired investigators to unearth evidence of corruption against the Nigerian attorney general in order to blackmail him to drop legal action over the controversial 1996 Trovan trial involving children with meningitis. In 2009, Pfizer agreed to pay \$75 million to the families harmed during the 1996 drug trial, but the cables suggest that the US drug giant was looking for blackmail to get the Nigerian attorney general to drop the \$6 billion federal suit against Pfizer. The leaks showed that Pfizer's investigators were passing 'damaging' information to the local media and threatening the attorney general that much more damaging information would come out if he did not drop the suit. The \$6 billion lawsuit was dropped in 2009.

In 2012, the Securities and Exchange Commission charged Pfizer Inc. with violating the Foreign Corrupt Practices Act (FCPA) when its subsidiaries bribed doctors and other health care professionals employed by foreign governments in Bulgaria, China, Croatia, Czech

Republic, Italy, Kazakhstan, Russia, and Serbia in order to win business. According to the SEC, employees of Pfizer's subsidiaries authorized and made cash payments and provided other incentives to bribe government doctors to utilize Pfizer products.

In 2012, Pfizer had paid \$1.2 billion to settle claims by nearly 10,000 women that its hormone replacement therapy drug, Prempro, caused breast cancer. The Prempro settlements come after six years of trials, in which several plaintiffs were awarded tens of millions of dollars, including punitive damages for the drug maker's actions in withholding information about the risk of breast cancer from Prempro.

In 2013, Pfizer agreed to pay \$55 million to settle criminal charges of failing to warn patients and doctors about the risks of kidney disease, kidney injury, kidney failure, and acute interstitial nephritis caused by its proton pump inhibitor, Protonix.

In 2013, Pfizer set aside \$288 million to settle claims by 2,700 people that its drug, Chantix, caused suicidal thoughts and severe psychological disorders. The FDA determined that Chantix is probably associated with a higher risk of a heart attack.

In 2014, Pfizer paid \$35 million to settle a lawsuit accusing its subsidiary of promoting the kidney transplant drug,

Rapamune, for unapproved uses, including bribing doctors to prescribe it to patients. According to New York Attorney General Eric Schneiderman, who led the probe, Wyeth got doctors to push the drug for unapproved uses, relying on "misleading presentations of data."

In 2016, Pfizer was fined a record £84.2 million for overcharging the NHS for its anti-epilepsy drug, Phenytoin, by 2,600 percent (from £2.83 to £67.50 a capsule), increasing the cost to UK taxpayers from £2 million in 2012 to about £50 million in 2013.

but we're called anti-science, and want people to die. So, we ask ourselves, am I crazy? No, you're being gaslighted.

We see mobs of people looting stores, smashing windows, setting cars on fire and burning down buildings, but we're told that these demonstrations are mostly peaceful protests. And when we call this destruction of our cities 'riots', we're called racists. So, you ask yourself, am I a racist? No, you're being gaslighted.

We see the major problem destroying many inner cities is crime; murder, gang violence, drug dealing, drive-by shootings, armed robbery; but we're told that it is not crime, but the police that are the problem in the inner-cities. We see police giving migrants free passes while we are treated like second-class citizens. Our towns are being over-run with foreign criminals but we are accused of being white supremacists and racists. So, we ask ourselves, am I crazy? No, you're being gaslighted.

The United States of America accepts more immigrants than any other country in the world. The vast majority of the immigrants are non-Europeans, and these immigrants are enjoying freedom and economic opportunity not available to them in their country of origin. But we are told that the United States is the most racist and oppressive country on Earth, and if we disagree, we are called racist and xenophobic. So, we ask ourselves, am I crazy? No, you're being gaslighted.

Capitalist countries are the most prosperous in the world. The standard of living is the highest in capitalist countries. We see more poor people move up the economic ladder to the middle and even the wealthy class through their effort and ability in capitalist countries than any other economic system in the world; but we are told capitalism is an oppressive system designed to keep people down. So, we ask ourselves, am I crazy? No, you're being gaslighted.

Communist countries killed over 100 million people in the 20th century. Communist countries strip their citizens of basic human rights, dictate every aspect of their lives, treat their citizens as slaves, and drive their economies into the ground; but we are told that communism is the fairest, most equitable, most free, and most prosperous economic system in the world. So, we ask ourselves, am I crazy? No, you're being gaslighted.

Another egregious example of gaslighting is the concept of 'white fragility'. You spend your life trying to be a good person, trying to treat people fairly and with respect. But you are told you are a racist, not because of something you did or said, but solely because of the colour of your skin. You know instinctively that charging

someone with racism because of their skin colour is itself racist. You know that you are not racist, so you defend yourself and your character, but you are told that even your defence of yourself is proof of your racism. We see ourselves becoming a minority in our own homes, towns, nations. We know that this will change everything about our standard of living, our culture and the place that we have called home all of our lives. It is heartbreaking to watch and often we feel helpless about what we can do to stop it. So, we ask ourselves, am I crazy? No, you're being gaslighted.

Gaslighting has become one of the most pervasive and destructive tactics in politics and debate today. It is the exact opposite of what our political system was meant to be. It deals in lies and psychological coercion, not the discovery of truth or quality intellectual discourse. If you ever ask yourself if you're crazy, you are not. Crazy people aren't sane enough to ask themselves if they're crazy. So, trust yourself, believe what's in your heart and mind. Trust your eyes over what you are being told. Never listen to the people who tell you that you are crazy, because you are not; you're being gaslighted.

Sophocles said: 'What people believe prevails over the truth'. And that's what the media exploit every day. Hopefully you are smart enough to understand what is being done to you on a daily basis from many directions. Just think through what you are being told. Don't listen with a deaf ear, or see with a blind eye.

Climate alarmists and their media allies once again made a slew of claims about natural disasters being caused by manmade emissions in 2022. And once again, these claims clashed with reality and science.

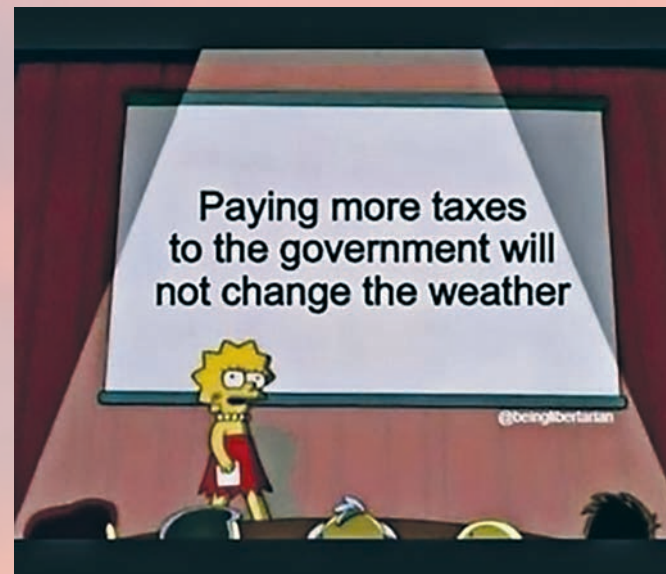

*This past year has seen a horrific flood that submerged one-third of Pakistan, one of the three costliest U.S. hurricanes on record, devastating droughts in Europe and China, a drought-triggered famine in Africa and deadly heat waves all over... Weather disasters, many but not all of them turbocharged by human-caused climate change, are happening so frequently that this year's onslaught, which 20 years ago would have smashed records by far, now in some financial measures seems a bit of a break from recent years.*

But are damages from those disasters really attributable to "climate change" or are climate activists and their media mouthpieces just trying to surf human tragedy to advance their very political cause?

The Associated Press, a long-time major newswire service, now accepts donations specifically to fund its climate coverage. In 2022, in fact, [the Associated Press admitted to receiving \\$8 million in donations to cover climate](#). The money came from very large foundations who have been pushing climate alarmism for decades, including the William and Flora Hewlett Foundation, the Howard Hughes Medical Institute, Quadrivium, the Rockefeller Foundation and the Walton Family Foundation.



Is this money funding actual journalism or just rank political activism? Here are 10 fact checks of climate disaster claims made by the Associated Press and other media outlets in 2022. We report. You decide.

## PAKISTAN FLOODS.

Monsoon season brought heavy flooding to Pakistan, resulting in over 1,700 deaths between June and October. [Media blamed climate change](#).

The Washington Post

**Fact Check.** The 2022 monsoon season was [within the range of natural variability and the wettest since 1961](#). If emissions are to blame, why was it so rainy then? Also average peak monsoonal rainfall actually has [declined](#) somewhat since the 1950s. [Ongoing deforestation](#) also may have made seasonal monsoon flooding worse.

## HURRICANE IAN.

Striking in September, Hurricane Ian was one of the top three most damaging storms to strike the US. [Media blamed climate change for the storm's rapid intensification](#).

NOAA

**Fact Check.** Hurricane Ian struck during hurricane season, after a historically quiet first few months of hurricane season and amid a season of less storm activity than predicted. Moreover, Atlantic basin hurricane activity is within natural variability, [according to NOAA](#).

## EUROPEAN DROUGHT.

Europe experienced its most severe drought in 500 years, [as reported by BBC News](#).

BBC NEWS

**Fact Check.** The [European megadrought of 1540](#) occurred before coal-fired power plants, SUVs and cheeseburgers. If emissions caused the drought, what caused it in 1540?

## CHINA DROUGHT.

China experienced "[record drought](#)" in 2022.

The New York Times

**Fact Check.** While the New York Times labeled China's drought as "record" as it was supposedly the most extreme drought since records began in 1865, [research](#) reports severe megadrought in China as far back as 1637, amid a period called the Little Ice Age.

**BUSTED!** Plastic bread bag, plastic water bottle, food in a plastic container, riding on a train powered by fossil fuels with electricity and A/C. Just another crisis actor!



# And: another year of turned out to be false

## FAMINE ON THE HORN OF AFRICA.

Drought and famine struck the Horn of Africa this year, threatening starvation for as many, for example, as 300,000 in Somalia. "Climate change underpins this continued lack of rainfall," the [media reported](#).

THE CONVERSATION

**Fact Check.** [There is no trend in rainfall in the Horn of Africa since 1990](#). So while the drought may be due to lack of rainfall, [droughts are natural and periodic in the region](#) and the lack of rainfall cannot be attributed to emissions. Famine in Somalia is more properly attributed to internal politics and conflict. While Somalia's neighbors, Ethiopia and Kenya, have also been affected by regionwide drought, political stability has nonetheless allowed crop production in those states to increase, while instability in Somalia has had the opposite result.

## UK HEAT WAVE.

Britain experienced several brief heatwaves in the summer, which were worsened by climate change, per the [New York Times](#).

The New York Times

**Fact Check.** Heat waves have dramatically declined in frequency and duration in the US over the past 90 years, per the [National Climate Assessment](#). So it is unlikely that emissions are increasing heat waves in Britain. Moreover, during the UK heatwaves, average global warming remained fairly constant at 0.2°C to 0.3°C (0.36°F to 0.54°F) over the 1979-2000 average global temperature, an amount of warming that is not even really measurable. So it may have been hot in the UK, but that was offset by cooling elsewhere. As [pointed out](#) by meteorologist Cliff Mass, heat waves may bring temperatures 30°-40°F above normal, but global warming is in the noise level at 1°-2°F.

## YELLOWSTONE RIVER FLOODING.

Few in the media went so far as to say last summer's Yellowstone River flooding was climate change, but they did the next best thing: "[Experts say Yellowstone Flooding is a sign of things to come](#)."

The New York Times

**Fact Check.** The New York Times correctly prefaced its version of the above-captioned statement with: "It is difficult to directly connect the damage in Yellowstone to a rapidly warming climate — rivers have flooded for millennia..." This year's flood was related to an [above-average snow pack that thawed just as massive rains came through](#). Cold weather + bad luck ≠ "climate change."



## LAKE MEAD.

Scientists blamed historically low water levels in Nevada's Lake Mead on climate change in the [Wall Street Journal](#).

THE WALL STREET JOURNAL

**Fact Check.** [Data show no trend](#) in natural water flows into Lake Mead since 1930. Since 2000, drawdowns of water from Lake Mead had been greater than natural inflows. The El Niño phenomenon, which is not emissions related, may also play a lesser role in Lake Mead water levels.

## WORLD CUP SKIING.

"[In this World Cup season, climate change is winning](#)," blared a Washington Post headline in November. Shorter winters were blamed for it being cold enough to hold only one of eight races as of mid-November.

The Washington Post

**Fact Check.** First, winter doesn't begin until December 21. Next, when World Cup skiing started in the 1960s, the season began in January. Now it begins in October, which is early- to mid-autumn. If the competition began in the winter everything would likely be okay because [wintertime snow cover in the Northern Hemisphere has been increasing since the 1960s](#).

**The Bottom Line:** There is not a single natural disaster, nor trend in any type of natural disaster that can be credibly linked with emissions or whatever gradual "climate change" may be occurring for whatever reason, including natural climate change. Attributing natural disaster damages to emissions and climate change is without a factual or scientific basis. [And that certainly goes for 2022.](#)

Regardless of one's view of what passes as "climate science," the good news is that even researchers who believe that "climate change" is a problem acknowledge that the number of weather-related [deaths](#) and the cost of weather-related [damage](#) are actually on the decline — despite ever-increasing emissions and whatever slight warming may be occurring.

# Could cyber attack bring in digital slavery?

Cashless society threat is a nightmare we must wake up to

**WILL a cyber attack lead to us waking up to a cashless society powered by Central Bank Digital Currencies (CBDCs) and a digital ID?**

This might sound like the plot of a dystopian science fiction movie – but it could be our reality and the climax of ‘the great reset’.

Let’s back up a bit here and set the scene. Fiat currencies (government-issued currency that is not backed by a commodity such as gold) start life with a backing to give them value.

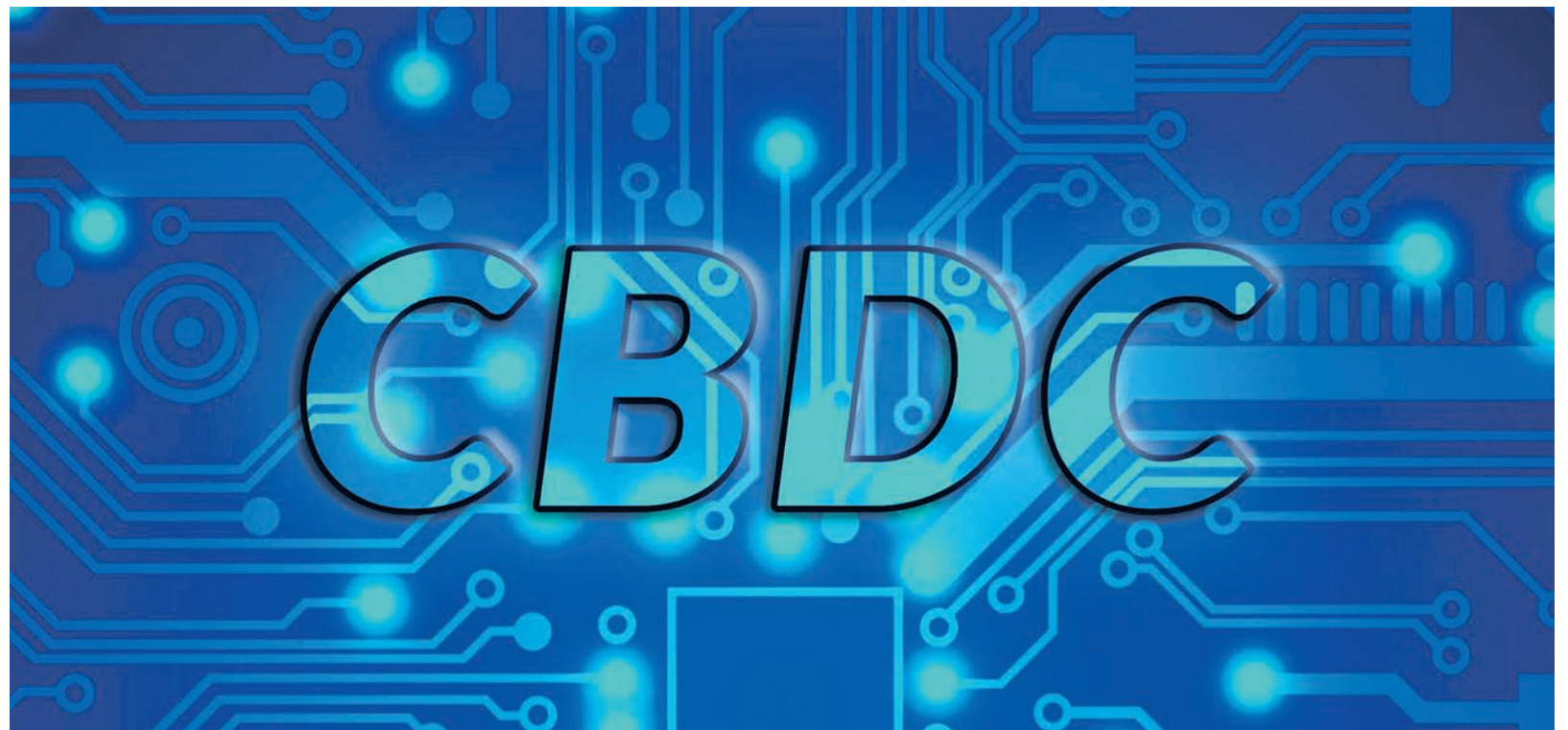
The dollar was backed by gold until President Richard Nixon took it off the gold standard in 1971. And the British pound was originally backed by 11b of sterling silver, hence pound sterling.

Fast forward to today, and these fiat currencies including the euro are backed by nothing more than a promise from the banks. They are designed to keep people poor via inflation. And they do so because central banks print money (create it out of thin air), slowly devaluing the currencies over time.

The primary reason they do this is to make their debt more serviceable. But what happens after years of monetary debasement? And what happens when central banks lose control of their 2% annual inflation target? The answer is simple: fiat currencies by design tend towards zero until they eventually reach zero (think Zimbabwe, Venezuela, and the Weimar Republic).

Today, we just so happen to be alive at the final stages of this fiat currency cycle. With the euro at 20-year lows, the yen at 24-year lows and the pound at 37-year lows, we are seeing the collapse of fiat before our eyes.

Worse still, with a backdrop of double-digit inflation, the Bank of England and the Bank of Japan continue to print exponentially more money to try to save their rapidly imploding bond markets, pensions and dying economies. History tells us that all currencies first collapse into the world reserve

currency (that would be the dollar this time around), before the world reserve collapses and the whole system requires resetting.

Usually a new country claims the world reserve status, backing the new reserve against gold to ensure value, stability and public trust, before the whole pony show starts over again. But what if this time, central banks decided to utilise technology to control this reset and implement a totalitarian takeover? That’s where the CBDCs and digital IDs come in.

CBDCs are digital fiat currencies issued by central banks. In practice, the daily user experience would be very similar to using a debit card or paying contactless with a smartphone. Beep the merchant terminal to pay and off you go.

But CBDCs have a sinister iteration that should make you want to resist them at all costs. First, CBDCs are a direct line from central bank to the people, with no requirement for any intermediary banks. CBDCs operate on a blockchain which is an immutable ledger, meaning the record of transactions can never be changed. By using CBDCs, a record of everything you ever purchased will

be kept forever.

Everywhere you went, every prescription, everything you ate, wore, or watched will be on a public blockchain forever. Worse still, CBDCs are programmable money. This means CBDCs can come with stipulations, e.g. you can only spend money if you have met injection requirements. They can be product-restricted, so that they only allow you to purchase pre-approved items. And they can even come with expiry dates e.g. spend within two weeks or two years, or lose it.

These are not speculations; these are part of the design, and stated inside the white papers for each of the CBDCs. As if that’s not bad enough, expect to pay negative interest rates (yes, really, they want you to pay the bank to keep your money there).

So how exactly are these to be rolled out? No one will accept CBDCs unless there is no other choice. Central banks will continue to debase their currencies until the cost of living increases so much that the public will beg the government for a solution. That solution will be a monetary reset, with the roll-out of CBDCs, heading towards a cashless society

and worst of all, digital ID and social credit scores. But all of this will leave the people angry at the government and central banks. And the intermediary banks will still be operational. Hence, the World Economic Forum tells us to ‘prepare for a cyber-pandemic’.

CBDCs are being tested right now; countries including Australia, India, Hong Kong, China, Japan, Korea and even the UK all have their CBDCs developed, tested and ready to go. The U.S. Federal Reserve launched its CBDC for testing last month.

Digital IDs are closer than most realise too. UK Prime Minister, Rishi Sunak, has ties to the WEF, and his father-in-law, Narayana Murthy, is the founder of software giant Infosys – which has developed a digital ID system similar to the one used in China.

Could a cyber-attack be used to bring in these new cashless systems? Could an internet blackout be the climax to this financial reset that sees us waking up to a new digital, cashless economy, full of totalitarian systems like CBDCs, digital IDs and social credit scores like they have in China? Watch this space!

You often see it in narcissistic relationships where a cheating spouse will point the finger at their innocent partner and wrongly accuse them of being the adulterer.

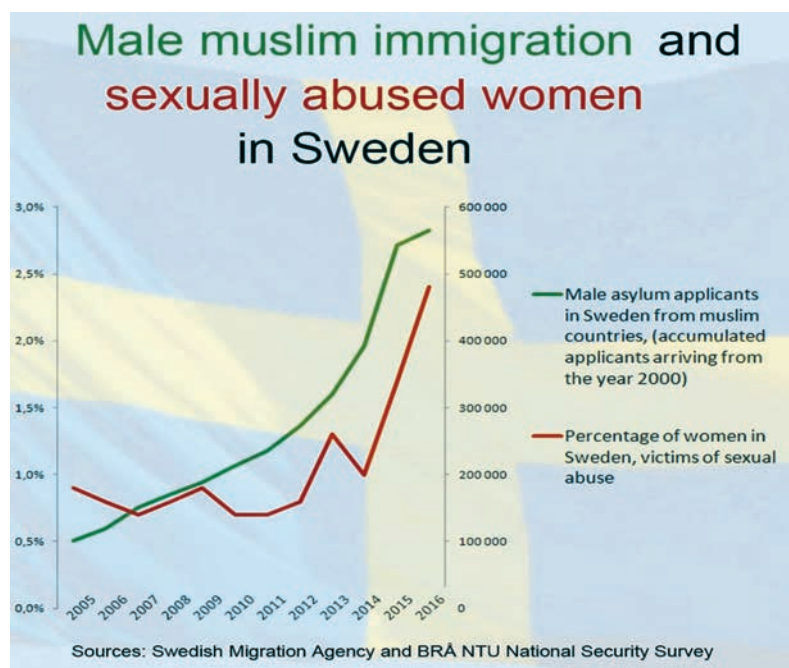

which Mikhail Gorbachev claimed would become the USSR of Europe. John Waters on the most pampered generation in Irish history

**There was a moment close to the beginning when the then emerging ‘millennial’ generation seemed like it might bring a waft of freshness. These early indications suggested the young were beginning to question and spurn the destructive ‘freedom’ ideologies of the 1960s and carve a new path of their own, drawing on the residual wisdoms of the ages and striking out in a new direction.**

Alas, it has come to nothing. Evincing a kneejerk — again, instilled — opposition to the dreaded capitalist ‘system’, they rush, against the tide of recent history, into the arms of Mr Marx, notwithstanding the fact that this

Our cultures, far from becoming more ‘progressive; are in a state of escalating regression, now entering its terminal phase. Some time in the past two decades, there has been an unnoticed moment of rupture in Western culture which has fragmented everything and turned everything either inside out or upside down, creating the impression that the works and struggles of the past were in the nature of some kind of recreational superfluity, the kinds of things that history is studded with for no good reason. Even those residual rumps of shrewd Irish people — and perhaps of peoples everywhere — have the idea that their country has simply gone crazy. Surveying the wreckage accumulating around us, one could scarcely argue with such a diagnosis.

Far from the open-minded republic of recent mythologising, Ireland is a post-colonial island that has yet to comprehend the nature and meaning of its history, still less to observe how various inherited complexes and pathologies play out in the present. The recently-descended — now almost total — dependence on ideologically motivated multinational operators like Apple, Facebook, Amazon and Google, together with an unfit-for-purpose media, have made Ireland a soft touch for the bootboys of radical agenda-setting, the ‘trophy country’ of Cultural Marxism in its push for global dominance. Ireland’s smallness, economic incoherence, and amenability to manipulation, as well as its historical status as a deeply Christian society, make it the perfect specimen on which the ideologues of the new totalitarianism can test their strategies and demonstrate their prowess. In particular, Ireland’s inspiring historical résumé of Christian thought and evangelism make it an enviable scalp for the gender and multicultural puppet-masters.

by no means confined to Ireland — though in Ireland, I would insist, it is more extreme than elsewhere. The point is not to see this chaos as a random, collectivised insanity: there are specific, localised reasons for it, though it has a growing pattern everywhere. Ireland undoubtedly has gone crazy, but as a way of dealing with some deeper incoherence that, being incapable of resolution in present circumstances, lends itself to chaos. This craziness, in short, is not a definition of the problem, but a late symptom of a deeper pathology, which has erupted in full-blown form in the Time of Covid.

Many of the symptoms are to be seen everywhere now. The most 'educated' generations ever are perhaps the most ignorant; the more communications we have, the less we are permitted

to say. The rush from seriousness has insinuated a layer of irony into everything, infecting public thought and conversation with a deadly lassitude. The fear of silence has accorded equal value to all words, reducing all statements to the same level of meaninglessness. Yet, virtually everyone remains silent about the most important things — silent as their countries are colonised, re-colonised, by stealth; silent as their freedoms are carted away to the breaker's yard. Somehow, we seem to glean a deranged kind of comfort from the fact that everyone, everywhere, is in the same boat, though of course by any reasonable assessment this ought to terrify us all the more. Throughout the Western world, the situation is more or less the same — youth succumbed to ideology and propaganda, fixated on sex and

technology, devoid of transcendent understandings and intent upon tearing down the cultural icons of Western civilisation and other inheritances from the past. And now, strapped into their snotrags, they cast baleful glances at those who decline to believe the lies of the smirking cynics who rule without leading. In this crypto-culture, Western civilisation is being stripped of its coherence and all the belief systems of the past are made to seem delusional. The result has all the outward appearances of a mass cultural suicide. Chaos reigns, but a chaos cunningly contrived and strategically ordered to lead us to the future that has been in preparation for far longer than the length of our lives to date.

# Renew your faith

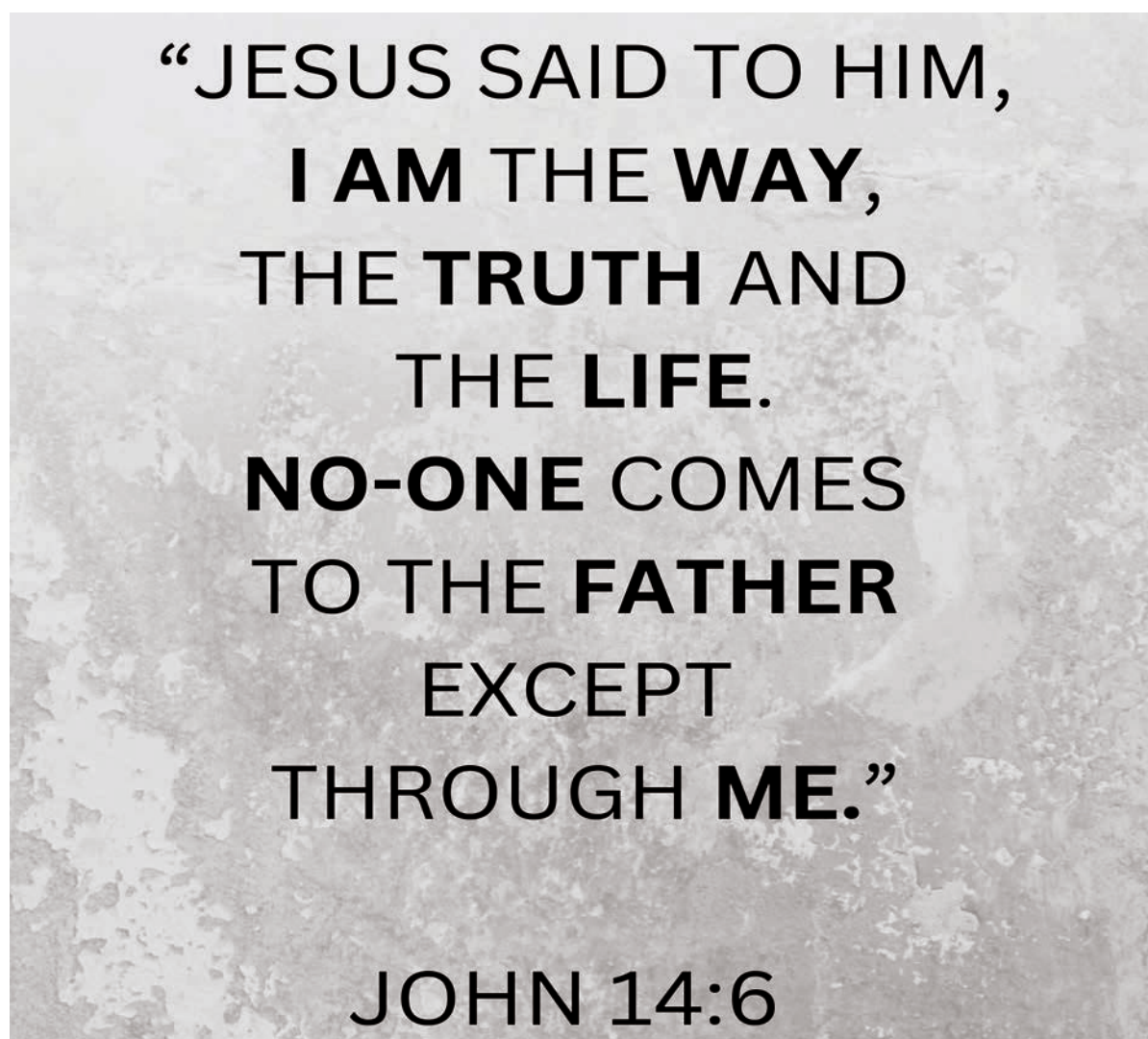
The Truth of Jesus Christ Is Our Only Salvation, writes Fr Sean Sheehy

Truth exposes the so-called "new normal" as defining what's abnormal.

For Christians, truth isn't just a philosophical concept or an abstract idea; rather it's a person, namely Jesus Christ. He revealed Himself as "the way, the truth and the life. No one comes to the Father except through me" (Jn 14:6).

Therefore, it follows that we can only find and experience the truth when we find and experience Jesus in our life. Our search for the truth isn't merely an intellectual endeavour, it's also and more importantly a personal experience of the Person of Jesus Christ accompanying us on our pilgrimage here on earth. For that experience to be ours we need to personally hear Jesus and meet Him where He said He would be, namely in His Church. He told His Apostles, with Peter as their head and upon whom He founded His Church, "Surely, I will be with you always until the end of time" (Mt 28:20). It's in His Church that we hear Jesus in the preaching of His word and meet Him in her Sacraments, which He gave her as the visible means through which He meets us as our Saviour, Teacher, Adopter, Nurturer, Sanctifier, the "Author



and Perfecter of our Faith" (Heb 12:2).

The Church began this new year of 2023 by celebrating the Solemnity of Mary, the Holy Mother of God. No one saw Jesus and met Him as Mary did. what's known as the Blessing of Aaron: "The Lord spoke to Moses and said, 'Say this to Aaron and his sons: 'This is how you are to bless the sons of Israel. You shall say to them: May the Lord bless you and keep you. May the Lord let His face shine on you and be gracious to you. May the Lord uncover His face to you and bring you peace''" (Num 6:22-27). Jesus fulfilled this blessing because He blesses and keeps all who are faithful to Him. He even reaches out to the lost so they might experience the truth of His blessing. As God's face in human form, Jesus showed us God in all His glory. He brought us the grace of repentance and forgiveness that results in a peace that the world cannot provide. Jesus fulfilled and continues to fulfil the hope of Psalmist and all believers: "May God still give us His blessing till the ends of the earth revere Him" (Ps 62: 2-8).

Imagine the new experiences which the shepherds had when they heard the angels. They found that it was real upon finding "Mary and Joseph, and the child lying in the manger" (Lk2:16-21). They told everyone about what they had heard and seen. "And the shepherds went back glorifying and praising God for all they had heard and seen; it was exactly as it had been told." Jesus indeed was the promised Messiah. Luke tells us that Mary "treasured all these things and pondered them in her heart." In faithful and loving obedience to the Law of the Lord, Mary and Joseph brought their little baby to be circumcised and "they gave Him the Name Jesus, the Name the angel had given Him before His conception." Through Mary, God has come among us in the Person of Jesus, Son of God and Son of Man. This is why Mary is called "Mother of God." Jesus on the cross made her the mother of all the faithful when he made her the mother of John.

Mary's faith shows us that God wants to work through us in bringing His blessing to the world. We do that by receiving Jesus to live within us as Mary did and which He made visibly possible in the Holy Eucharist. And as she gave birth to Him, so you and I are called to make His presence known to all we meet. Perhaps this can be the best and most productive resolution we can make as we enter this new year of new experiences. It may be our last year here on earth, so let's make the most of the opportunities we are given to imitate Mary and bring the Saviour of the world to all whose paths we cross and whose paths we need to cross. May you be an evangelist and a catechist in the ministry of saving souls especially in your own household, parish, and neighbourhood. As Mary shared her new experience with Elizabeth of carrying God in her womb, may you share your experience with Mary of bringing Jesus to others as their Lord and saviour who wants to bring everyone to His Father to adopt them and make them heirs to His Kingdom through the power of the Holy Spirit guiding His Church on earth. ## Switzerland to offer 'safe blood transfusions' from unvaccinated

**Switzerland will begin providing patients all over the world with safe blood transfusions from people who are unvaccinated. A group called Safe Blood Donation will be the first organization to provide the service. The group was founded in 2022 by Swiss naturopath George Della Pietra who aims to provide people all over the world with a way to receive life-saving blood transfusions from blood that is untainted from the toxic mRNA injections.**

Be it an emergency, a scheduled operation or because you need regular transfusions for other medical reasons. This is where Safe Blood Donation comes into play as an intermediary," a statement on

the organization's website says.

Naturalnews.com reports: The group will essentially act as a middleman to connect people all over the world with medical partners who are willing to accept blood donations and provide blood transfusions to people with health needs, but are hesitant to go to hospitals where they will almost certainly receive blood from vaccinated individuals.

Della Pietra created his organization due to the release of the mRNA COVID-19 vaccines causing disputes all over the world over blood treatments and transfusions. Specifically, people who are skeptical of the benefits that come with taking the experimental vaccines and doesn't want their body tainted by the unsafe products.

In Dec. 2022, a baby less than a year old was taken by the

government of New Zealand from his parents due to their refusal to allow blood tainted by the COVID-19 vaccines to be used during a life-saving surgery to repair the infant's heart defect.

Della Pietra has contacted hundreds of clinics all over Europe, all of which still don't allow people "the human right of free blood choice." Furthermore, dozens of clinics he contacted have all refused to become a partner of the new organization. Some of these clinics are sympathetic, but claimed they do not want to be mentioned for fear of reprisals from the mainstream medical community.

The founder further noted that his main goal is not to run Safe Blood Donation as a blood bank, noting that "this is not possible at the moment" due to legal concerns, but to act as a quick referral

service "to match blood donors and recipients" who are then sent to a medical partner's clinic where the safe, unvaccinated blood transfusion will be handled.

In return for providing people with this service, members are also urged to "make themselves available as blood donors" for other people looking for unvaccinated blood transfusions.

There is no blood bank with mRNA-free blood yet, but Safe Blood Donation declared that "we will not give up until we can offer a worldwide network of such clinics."

Della Pietra noted on his organization's website that as soon as Safe Blood Donation has enough medical partners who can handle the complex needs of its members who do not want vaccinated blood, as well as receive applications, accept blood donations and

perform blood transfusions, the organization will get to work immediately.

"Blood transfusions are carried out using blood preserves, which go through a complex process after the blood donation in which they are largely cleaned of foreign bodies," reads the Safe Blood Donation's website. "With the advent of the completely new mRNA vaccinations ... we have completely new challenges here, since not only the so-called spike proteins are neutralized to an unknown extent only."

People from at least 16 countries, including the U.S., Canada, Australia and several other nations in Western Europe, Asia and Africa, have already signed up either to donate unvaccinated blood or to receive blood transfusions from unvaccinated individuals.

Alcohol has killed more than all the wars in history

**THE word alcohol comes from the Arabic 'al-kuhl', which was the name of what was believed to be a body-eating spirit.**

The English 'ghoul' comes from the same word, or to be under the control of a demon or 'spirit', which is where the word to describe strong liquor is derived from.

Growing up in the 70s and 80s, I can clearly remember a culture of alcohol consumption that seemed to pervade every social occasion. As a child, no party big or small seemed complete without a teetering table heaving with an array of various cans and bottles waiting to be consumed. I'd look at these mysterious bottles and would wonder, could I too one day become a living legend for my drunken hijinks, just like the inebriated uncle, air-guitaring to Dire Straits with a tie wrapped around his head?

Both of my parents rarely ever drank at all, however the general attitude towards the occasional recreational alcohol binge was purported widely as one of harmless fun, and even a 'rite of passage' for all young men.

In that regard, nothing has changed at all in the last forty years. And neither have the disastrous consequences of such indifference to, and acceptance of, a substance that has killed and maimed more people than every war humanity has ever fought combined, at an average of three million people every single year. It is a shocking and sobering figure.

It is also estimated that 237 million men, and 46 million women worldwide suffer from various alcohol abuse disorders, with the highest concentration being in Europe.

Ireland has sadly acquired a reputation for being a nation of alcoholics. The degenerate lifestyle promoted by Leo Varadkar to young people has led to a culture of out-of-control binge drinking and the inevitable fallout that follows in terms of suicide, drug addiction, poor mental health and disastrous life choices.

Unsurprisingly, the lockdowns and the continuing psychological attacks on us all have exacerbated this situation further. Remember also, that while the state forced schools and businesses to close, prohibited the purchase of 'non-essential' items such as shoes and clothing, locked our parks, playgrounds and gyms, and arrested and fined us for walking down the street, the off-licences remained open and well-supplied.

A great many of us have known people that have slowly been destroyed by alcohol abuse, or indeed been the direct victim of it ourselves. I can remember in the early 90s, when consuming enormous quantities of beer in my local town was almost openly encouraged. And those rejecting it were seen as outsiders or somehow strange. I could never understand why

this was allowed to continue unchecked, even though it was well known that many young people had alcohol issues, which were wreaking havoc in their civilian lives.

Today, Ireland has one of the worst binge-drinking problems in the world, and we do not have to look far for evidence of it. Yet still, so little is done to recognise and tackle the issue of alcohol abuse even though the problem is staring us in the face.

Alcohol dependents will very often refuse to acknowledge the issue at all, but will instead manufacture excuses for their often extremely destructive behaviours, quickly blaming others around them without missing a beat.

This pattern of behaviour can be seen repeated with nearly all people afflicted with alcoholism. It is, by its very nature, a demonic possession - the true light of that person inside has been smothered while the demon is busy destroying everything they are, were, or could possibly be in the very cruelest of ways. I personally have watched this illness peel away the layers of a person one by one like an onion, until there was little left at all.

It's time to step up and fight back. Our children are everything, and to our community our very essence and future. We must educate them and ensure they all understand fully the very real dangers that alcohol abuse represents to them.

No longer should we accept that it is normal for our youth to be drawn into the lie that drinking alcohol is an appropriate and necessary part of growing up. We must expose and critically challenge alcohol peer pressures, advertisements and their mechanisms within our society, and the pervasive alcohol culture as a whole, which is always very happy to welcome new recruits.

Your greatest help in doing this will be your Christian faith. When you feel like turning to the bottle, turn to Jesus and think how blessed you are to have good health, clarity of thought and the will power to say no. Likewise, we must ask the ones we love how we may help them if we see there is a clear problem, without judging or being condescending.

# Why Essential Oils Heal and Drugs Don't

**If you tell most medical doctors that essential oils bring about healing with no negative side effects, they won't believe you. This is because in medical school, students are repeatedly told by their professors that all effective medicines have negative side effects, and if they don't then they can't be effective.**

When I was in medical school one professor emphasized this point in a colourful, graphic manner with specially prepared slides. In each slide specific drugs were depicted as evil looking demons or goblins.

As he presented each picture, he explained, "Although ugly and capable of doing harm, these 'demons' are also the bearers of some good. So long as the benefits outweigh the risks, we use them," he summarized. "We have no choice," he continued, "because if a drug has no dangers, then it can have no benefits. That's just the way it is. And that's why it is essential that only qualified physicians be allowed to prescribe medicines," he concluded.

Actually, the professor was telling the truth. Within the restricted practice of allopathy, the only real medicines are physician prescribed pharmaceuticals. Such medicines always do have negative side effects. All of them. No exceptions. Hence, doctors are trained to accept the bad with the good as the price of effective medicine.

## The Danger is in the Drug Itself

The dangers of prescription drugs are intrinsic to the drugs themselves, not in how they are administered. No matter how careful the physician in prescribing and how compliant the patient in following doctor's orders, even then deaths and damages occur.

In fact, according to the U.S. Centers for Disease Control, more than 100,000 Americans die every year, not from illegal drugs, not from drug overdoses, not from over-the-counter drugs, and not from drug abuses, but from properly prescribed, properly taken prescriptions.

In the US, more people die from doctor's prescriptions every ten days than were killed in the 9/11 terrorist attacks.

Why is this so? Why do allopathic drugs always have



undesirable effects (along with their apparent benefits) while one can find healing with natural products, such as essential oils, with no undesirable effects?

## Why Companies Deliberately Sell Dangerous Products

It is illegal to patent any natural product. The way to big profits in the medicine industry is to create an unnatural substance that never before existed in nature, then patent it, and obtain a monopoly. Hence, the molecules of pharmaceutical drugs are all strange to the human body. In all the history of humankind, such molecules were never encountered or taken into any human body. Hence, the body does not easily metabolize them.

God never made your body to accept and deal with these chemicals and antibiotics.

Non-toxic natural organic substances are usually easily eliminated by the body when their usefulness has run their course.

Up to a point, your body can even deal with and eliminate natural toxic substances. But when your body receives a synthetic substance, even one that may seem benign or inert (like plastic), your body does not know how to metabolize and eliminate it. If sent to the liver to break it down into disposable compounds, the liver says, "Hey. What is this? I don't know what to do with it. Here kidneys, you take it." Then the kidneys react saying, "Hey liver,

That's why you can find traces of prescription drugs in your body taken in childhood, decades ago.

On the other hand, natural molecules, such as those found in essential oils, are easily metabolized by the body. In fact, your body was created to handle them.

When an essential oil molecule finds the receptor sites it was designed to fit and conveys its information to the cell, or participates in other therapeutic functions, it then goes on its way to the liver and the kidneys and moves out of the body. Its benefits have been conveyed and its job is complete.

When you synthesize everything in a laboratory, you are in control. You can produce your medicines at will, in any quantity, whenever you choose. When you depend on nature to grow your product, God is in control. You are at the mercy of the seasons. You can only grow so much with a given year's crop. If a year's supply runs out before the next crop is ready for harvest, then you and your customers just have to wait. Meanwhile, you lose potential sales and profits.

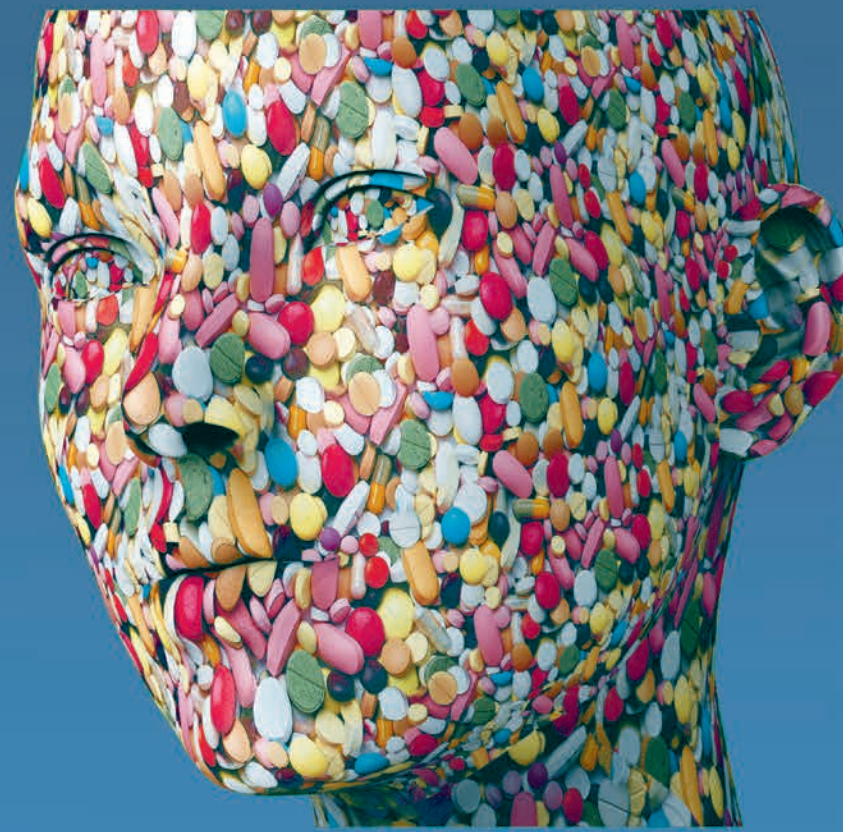

## Drugs Versus Oils

Drugs and oils work in opposite ways. Drugs toxify. Oils detoxify.

Drugs clog and confuse receptor sites. Oils clean receptor sites.

Oil molecules send information to cells and cleanse receptor sites so that they bring your body back to natural function. Oils are balancing to the body. Drugs are unbalancing to the body. Oils address the causes of disease at a cellular level by deleting misinformation and reprogramming correct information so that cells

function properly and in harmony with one another. With drugs, misinformation is fed into the cells so that some temporary relief may be obtained, but there is never any true healing. Drugs only trade one kind of disease for another.

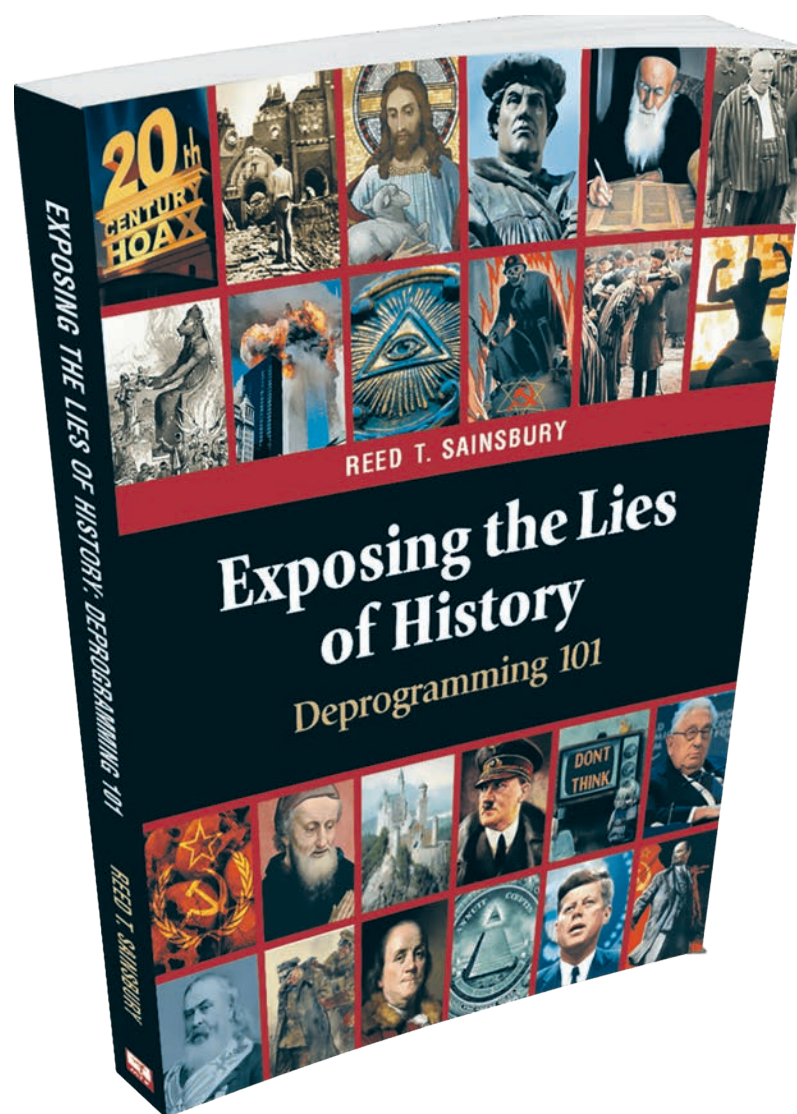
