THE YOUNG IRISH FACES THE MEDIA DOES NOT WANT YOU TO SEE

Media silent on huge death surge since vaccine

WE are in the midst of the biggest die-off in recorded human history. It has been in the planning for many decades by the controllers of this world, who are behind every war, famine, pandemic, genocide, financial collapse and most terrorist attacks and mass shootings. Every act of violence they commit against us - their 'useless eaters' - has a specific goal: to induce more fear, gain more control and kill as many souls as they can.

The evidence of this grand cull is undeniable now. Excess mortality, which barely flickered during 2020 - the year of the so-called pandemic - is surging, reaching frightening highs with every passing month.

In Ireland, sudden deaths of fit, young adults are skyrocketing. Many of them are super-healthy athletes. Search 'GAA and died suddenly' for 2021/2022 and a terrifying number of young faces will stare back at you: their whole lives ahead of them but quashed in the blink of an eye.

Nobody is allowed to ask why - an illustration of how morally bankrupt Irish society has become. Nobody protests. The rare family member who puts their head above the parapet is firmly shot down.


The Irish media has never had a more important task: to vigorously establish why so many young and healthy people are dropping dead. But instead they show contempt for these poor souls and attack anyone who might suggest the most obvious explanation for their sudden demise.

During the illegal lockdowns when the corrupt state revealed just how totalitarian it had become, the journaliars of Ireland stepped right into line like the paid-off lap dogs they are.

Day after day, they churned out a litany of lies, fear and deception to manipulate and blackmail the public into conforming with the Covid scam and throw away their forefathers' hard-won freedom.

The merest sniffle or cough in a cohort of people was a major cause for concern, renewed lockdowns and mask mandates. They demonised

those who had no symptoms at all but tested positive with the hopelessly flawed PCR test. Yet when the real pandemic began in 2021 with the rollout of the deadly mRNA shot, and we were faced with a tsunami of sudden deaths, strokes, clots and neurological disorders, they turned their backs and went silent.

Their toxic websites are filled with patronising tributes to the 'sudden dead' but as soon as somebody asks why so many youngsters are dying, they are lacerated in pharma-funded hit pieces. It's patently clear they have a lot to hide

The faces on our front page are just a small fraction of those young Irish who were struck by the plague of 'sudden death' in 2021/2022.

We have no definitive proof as to how they died because the media is covering that up and their families have largely chosen not to speak.

All we know is their death notices described their passings as sudden and unexpected.

Last month, the government's Central Statistics Office released its mortality rates for 2020 - almost two years too late. No doubt the State must have been embarrassed by what those figures would reveal. During the year of the 'most deadly virus is history' (medically defined as the common cold but let's not mention that inconvenient fact), death rates in Ireland barely increased. In other words, there was NO pandemic.

Where are all the headlines screaming it was all a false alarm, a

mistake, a grave error of judgement? You won't find one.

In 2020, there were 32,856 deaths in Ireland in 2020, of which 17,051 were males and 15,805 were females - completely in line with a normal year. The majority died not from the 'dreaded plague' that was supposedly stalking the land (despite the best efforts of rogue doctors and hospitals trying to falsely attribute all deaths to Covid) but mostly from cancer (30%) and circulatory issues (27%). A smaller proportion died as a result of respiratory illness - 10% and a separate category dedicated to Covid claims it accounted for 5.9% (1,928) of all deaths with almost 80% being aged over 75 - normal life expectancy. (See p5)

We can surmise that many of them fell into the class of people who died as a result of HSE neglect and dangerous government protocols such as sedative use, otherwise known as the 'Liverpool Care Pathway' or euthanasia.

Less than 2000 deaths is a far cry from the 85,000 figure Varadkar touted in March 2020 to drive the sleeping masses into a state of fear which would make them easy to control and order around.

Fast forward to our current death rates about which the media are maintaining a deafening silence. For most of 2022, there has been a dramatic surge in excess mortality with increases of 19.2% in April, and 16.4% and 16.8% in July and August - traditionally the quietest time of year for deaths.

Note how far ahead Ireland is of many other EU states in the Eurostat official figures (in the graphic on this page.) Could that have something to do with the vaccination rates in this country, which were among the highest in the world?

Why isn't the government who cares so much about your health not whispering a word about the fact that almost a quarter more people

are dying each month than typically do?

Why isn't the CSO issuing regular updates? Why aren't there hourly bulletins from the media on this shocking development? Why is nobody in the establishment asking what is the mysterious cause of all of this sudden death?

Because they know exactly what it is: the untested and dangerous injection they forced into the Irish people in a blackmailing operation that would make the mafia blush - combined with the devastating effects of mentally tortuous lockdowns on young people.

Where was their reporting last month when Pfizer admitted in the European Parliament that its vaccine was never tested for transmission prevention? Or the fact that, according to one study, one third of babies injected with the Covid shot needed immediate medical attention? Or that almost 50% of Australians said in a large poll that they regretted getting it? Or that damage to women's reproductive systems is nearly only happening in vaccinated women? Or that sudden deaths worldwide are happening to vaccinated people at a 50:1 odds ratio? Or that the Pfizer trial six month report showed no mortality benefit and that more people died who got the drug than the placebo? Or that Pfizer paid the biggest fine in criminal history: \$2.3bn (yes billion)? Or that the number 1 cause of death in Canada now is 'unexplained'? Or that a study in Thailand shows that 30% of young adults experienced cardiovascular injuries after the vaccine? Or that there are now more than 1,250 published papers linking the vaccine to significant adverse events.

The government and their media despise you. The health service would rather you were dead. It's time you walked away from their diabolical system of control and fear.




And to explain the true purpose of the dangerous experimental injections that have so far been given to an estimated 5.33 billion people (70 per cent of the human race), including children and infants.



CSO: There was no pandemic

THE State's official data collector, the CSO (Central Statistics Office), has now shown beyond all reasonable doubt that there was no pandemic in 2020. The great fraud that was carried out by the government and their lackeys in the HSE, Gardai, judiciary and RTE has been laid bare but not a whisper about it in the mainstream media - which is nothing more than a bought-off wing of the rotten regime.

If you take the time to visit the CSO website, you'll see that 2020 was a non-event as far as excess deaths were concerned, and that respiratory diseases actually fell that year compared to 2019.

Of the 32,856 people who died in Ireland in 2020, just 1,928 died of Covid - which has yet to be isolated, purified or even proven to exist under a microscope - and 1,278 of those were 80 years and older.


In other words, close to life expectancy, and in many cases, above it.

often by the adults in their lives. Many succumbed to this despicable intimidation.

As a result they are left with permanent injuries, a shattered immune system, and a shortened life expectancy.

All of these potential outcomes were presented to the High Court, Appeals Court and Supreme Court when John Waters and I asserted our Constitutional right to a legal challenge in April 2020.

IN a representative democracy, we are ruled by a government elected by the people. If we don't like the current administration, we have an opportunity to remove it at the polling booth.


The rhetoric may change, but in practice the differences between mainstream political parties are insignificant. Aside from electoral comings and goings, there is a long-term trend towards state interference in our daily lives. Despite any appearance of progress and prosperity, the people are more controlled than ever. But who is doing the controlling, and why?

Viewed from multiple perspectives, it becomes clear that governments are beholden to the global money system. Any national leaders who resist the globalist agenda are likely to be denounced as anti-democratic or 'far right' (e.g. Viktor Orban in Hungary and Jair Bolsonaro in Brazil); or they may be targeted for 'regime change' (after a long series of Middle-Eastern and Latin-American leaders, the pantomime ogre is now Vladimir Putin). Regime change operations in the 20th century included the destruction of Tsarist Russia by the Bolshevik Revolution, and of Imperial China under Mao Zedong.

The ravaging of Europe in two world wars spawned the supranational entities of the European Union and United Nations. The dismantling of Yugoslavia in the final decade of the millennium was a foretaste of a 'new world order'.

International bodies are conduits of financial power, some more obviously than others (e.g. the Bank of International Settlements, World Bank and International Monetary Fund). Similarly, non-governmental organisations are controlled by embedded money interests; for example, the World Wildlife Fund is backed by the Rockefeller Foundation, whose wealth derives from the hydrocarbon industry (i.e. oil)

Various Rockefeller-backed institutions are at the forefront of the fraudulent climate crisis narrative that vilifies the oil industry. This paradox requires a lot of unpacking,



but, in short, the 'net zero' imperative is not about reducing

pollution, but reducing population.

Why is public perception of power structures so far from the reality? Organisations spend vast sums on public relations, which is really manipulation. Propaganda has existed for as long as institutional hierarchy. The infiltration of the Church by freemasons has resulted in many lies being spouted from the pulpit.. However, exploiting mass media took shape as a science in the early 20th century, coinciding with the publication of the book *Propaganda* by Edward Bernays (Sigmund Freud's nephew) in 1928.

Since then, the sophistication and ubiquity of psychological manipulation techniques to manage the attitudes and behaviour of the masses has evolved to a level that is awe-inspiring and all-encompassing.

Propaganda is everywhere to see, for those who care to look. But the majority of the people are malleable to messaging by the powers-thatbe, oblivious to the motive of the

messenger. This reality has become clear to anyone who has explored how the world works, and whose discoveries are met with disbelief.

no-one can deny there is a pyramid of power far above the governments we elect to

represent us, and the courts which are supposed to maintain justice for all.

The question often asked is - why? To the average man and woman, the answer is simply not credible, because they cannot accept that something so diabolical can possibly exist outside the fiction of dystopian novels or films. If a lie is big enough, people will more easily believe it. Surely the demolition of the Twin Towers wasn't an inside job?

The output of Hollywood and mainstream media 'news' is controlled by the same network that controls all other levers of power. So while people watch Shakespeare or modern drama portraying the diabolical misdeeds of monarchs and cliché contemporary despots, most seem incapable of attributing the same characteristics to supposedly liberal leaders such as Justin Trudeau or Ursula von der Leyen.

A common flaw of lesser mortals is a belief that such men

and women have the same human cares and concerns as their own. They neither understand the psychopathy of power and the type of person drawn to it, nor do they relate the Machiavellian plots and manifestation of evil in the latest TV series or movies to real life. Truth is indeed stranger than fiction.

The internet is a double-edged sword. It is undoubtedly used as an instrument of control, but it also has exposed, to those sufficiently curious, the dark underbelly of power in the world. For now at least, researchers and analysts can obtain information and share their findings with others similarly motivated to understand power and its manifestations.

There is a growing awareness that in co-existence with a web of international policy shops, such as the Bilderberg Group and Trilateral Commission, are secret societies such as the Bavarian Illuminati, which have infiltrated Freemasonry and conduits of state, Church and corporate power. Thus, we find

However, even those at the apex should worry about losing control of the evolving 'machine'. The technology of artificial intelligence and digital control, taken to its logical conclusion, would result in the collective suicide of our species. More optimistically for humanity, the misapplied occult techniques and money matrix will culminate in the misanthropic structure's demise. Evil sows the seeds of its own destruction.


















Laundering with immunity

In the World Economic Forum's 'Identity in a Digital World: A new chapter in the social contract,' they have illustrated what the digital identity will look like in our everyday lives.



Fossil fuels are 'greenest form of energy'

A 35-YEAR veteran of the global warming debate says fossil fuels are the "greenest" of energy sources. In a recently published paper, Dr Indur Goklany notes that carbon dioxide emissions from industrial activity and transportation have increased plant growth and that fertilizers and pesticides derived from fossil fuels have boosted crop yields so that more food can be produced on less land.

"Contrary to the claims of proponents of the Green New Deal and Net Zero, fossil fuels are the greenest fuels," says Goklany. "First, uniquely among energy sources, fossil fuel use emits CO2, which is the ultimate source of the elemental building block, carbon, found in all carbon-based life virtually all life on Earth."


Referencing several studies, Goklany reports that up to 50 percent of global vegetated areas became greener between 1982-2009 and that 70 percent of the greening has been attributed to carbon dioxide emitted by the burning of fossil fuels.

Overall, Goklany credits 87 percent of the greening to fossil fuels. In addition to CO2 emissions, nitrogen deposition from fossil fuel-derived fertilizers and modest warming of the climate together account for another 17 percent of the greening, he says.

One researcher found that global leaf area had increased by 5.4 million square kilometers between 2000-2017, an area equivalent to the Amazon rain forest. Another reported global tree cover had grown by 2.24 million square kilometers from 1982-2016 through reforestation of former agricultural lands rendered surplus by improved farm productivity and of former

"Use of fossil fuel technologies has enabled human beings to spare 20.4 percent of global land area (GLA) for the rest of nature," said Goklany, the author of several books and a former U.S. delegate to the Intergovernmental Panel on Climate Change. "This exceeds both the habitat lost currently to cropland (12.2 percent of GLA) and the global cumulative area currently reserved or identified as conservation areas (estimated at 14.6 percent of GLA)."

In other words, the amount of land preserved from conversion to agriculture because of fossil fuel-related productivity increases is 25 percent larger than the North



American continent, said Goklany. Increased agricultural

productivity has allowed cropland in many areas to revert to forest or other non-agricultural use, he said. For example, between 1990 and 2020, forests in the U.S. and

Western Europe increased 2.4 percent and 10.1 percent despite population increases of 30 percent and 11 percent, respectively.

Making coal, oil and natural gas even greener is their relatively small footprint for power

production, says Goklany. To generate the same amount of electricity as fossil fuels, solar would need more than three times as much land; wind, five times as much; and hydropower, 25 times as much.

Media spew lies on emissions

The bank gives the customer the option to "pay a fee" to offset their carbon footprint, with the average listed as 1,280 kilograms, a long way from the 'sustainable' figure of 200 kilograms.

A person's carbon footprint is calculated and then an 'equivalent' metric is shown to make the customer feel guilty about it, such as "8 trees being cut".

"By combining our rich customer data and CoGo's industry-leading capability in measuring carbon outputs, we will be able to provide greater transparency for customers so that they can take actionable steps to reduce their environmental footprint," CommBank Group executive Angus Sullivan said in a statement.

The bank has promised to refine the calculation down to showing how much CO2 individual purchases are responsible for.

While initially presented as a handy way for someone to track their consumption habits and the supposed impact they have on the environment, some fear that such schemes could one day become

Such a proposal was presented in the science journal Nature by four environmental "experts" as a means of reducing global receiving an equal tradable carbon allowance that reduces over time in line with national [carbon] targets."

The sickness industry they call 'healthcare'


PREGNANCY should be a cause for anticipatory celebration, but it can also be worrying. Will a healthy child be born? And then, can the growing family thrive in these straitened times? An extra mouth to feed has long been a concern of the poor but the cost of living is affecting most people today. Lovely though they are, babies are expensive.

There is a deeper anxiety about having children, particularly among the ecologically conscious middle class, with the burden of 'social responsibility'. According to United Nations estimates, global population is fast approaching 8 billion. The phony climate crisis adds to existential stress and fuels the myth of overpopulation. The young, in particular, have been conditioned into thinking that we, merely by existing, are the problem.

The link between health and population control was a focus of the Rockefeller family, who used their oil wealth to transform medicine from an autonomous, individualistic profession to a tightly controlled allopathic industry. John D Rockefeller established the Rockefeller Institute for Medical Research in 1901. Empirical medical practice that relied on gifts of nature was outcasted in favour of highly profitable, aggressive surgery and petrochemically-based drugs.

The Rockefellers and other fabulously rich families adopted the false Malthusian proposition of overpopulation, and the notion of tainted stock subverting the Darwinian principle of survival of the fittest. From the early 20th century to the second world war, the eugenics movement was rampant in professional and intellectual spheres. It was toxified by association with National Socialist Germany, thereafter rebranded and given renewed vigour as Planned Parenthood and variations on this euphemistic

Using tax-exempt foundations, the Rockefeller dynasty endowed



universities, medical schools and hospitals, which came to rely on this generous funding, accepting Rockefeller nominees on their boards. Within decades, anyone questioning the allopathic orthodoxy was expelled from the system such that today, most doctors know very little of health other than applying a standard drug or procedure to 'cure; a specific condition. This is the war model of medicine decried by researchers and humanistic doctors such as Dawn Lester, David Parker, Sam Bailey and Tom Cowan.

Through ownership of hospitals, pharmaceutical companies and ancillary medical activities, these 'philanthropists' reap rewards in profits that make their endowments look miserly. Today's medical industry is less of a remedy than a facilitator of drug dependence. A visit to the doctor for a common medical complaint often results in a prescribed treatment causing side-effects requiring more prescriptions. An increasing number of people are now on expensive drugs for life. Ivan Illich and Vernon Coleman warned us of the iatrogenic harm of modern medicine in the 1970s, but they were ignored by the establishment.

Many patients can't afford these drugs but through governmentfunded programmes such as Medicare in the US and the HSE and NHS, the medical industry receives vast amounts of money without having to administer individual payments. The insurance model of healthcare is another means to fleece the human flock.

Margaret Thatcher, though she privatised utilities, dared not touch the NHS, which was perceived as a sacred cow. Tony Blair began privatisation of the NHS by stealth with changes to doctors' employment contracts soon after gaining power in 1997. These reforms turned doctors from employed physicians into business managers thereby aligning their financial interests with the medical industry. Prolonged sickness and disability are a perpetual source of income for GPs.

When Thatcher ignominiously left office in 1990, administration costs represented 3% of the total NHS budget. A leaked report in 2005 showed that, as a result of Blair's reforms, this rose to 14%. In the US bureaucracy accounted for 20% of the healthcare spend, but after 'Obamacare' was introduced in 2009, these costs skyrocketed. Where the US leads, the rest of the world follows and the UK is no exception. This is where the NHS is heading.

Although money is the primary

incentive for those delivering healthcare, other instrumentalist motives may be discerned. Control of the human herd has become fully visible since the Covid project began in 2020. Mass vaccination is potentially if not actually a means to reduce fertility while the billions who relented to the psychological warfare and received mRNA injections have taken a serious risk with their health and longevity. Already we can see that birth rates have fallen while mortality is consistently about 10-20% higher than expected.

As Dawn Lester asserts, 'you can no more catch a disease than you can catch a dirty neck'. Yes, people have taken ill but for many reasons. We have been targeted with toxins, electromatic frequencies and prolonged emotional stress, all of which can deplete vitality. The nutritional quality of our food has been progressively reduced making us much more susceptible to illness

In April 2020, under the cover of lockdown away from the "prying eyes" of relatives, there was a spike in deaths of the elderly through the administration of end-of-life drugs, starvation and "do not resuscitate" orders. Jacqui Deevoy has compiled an extensive dossier of a cull of the elderly. Meanwhile, those unlucky enough to be admitted to hospital and put in a "covid" ward were intubated and hooked on to dangerous ventilators.



The story of the electric Dust Cart was reported to me by my mechanic who is in the loop on these matters. He also told me that EV cars piling up in repair centres, deemed to be "unrepairable" - the cars are

NCT but halfway through, it ran out of power, so the test could not be completed. The car had to be pushed to the charging point to be fully charged, before finalising the test the next day. The owner of the car was less than impressed and more than a little embarrassed.

Most mechanics are not trained in electrics and specialise only in petrol and diesel cars. They can sort out the mechanical side when things go wrong, but won't touch the more complex, electrical side. EVs require a trained auto-electrician and they are not always easy to source.

The more electronic equipment is in the car, the more specialised the technician has to be. This is why EVs are currently a problem because there are not enough trained auto electricians and cars cannot be repaired because they have complex faults which mechanics simply do not have the expertise to repair.

So before you jump headfirst into buying one, make sure you do your homework. You're certainly not saving the environment or your pocket because the grants you might get are funded by higher taxes in the long run anyway.

In fact, electric dreams are being shattered every day with businesses seeing them as too high risk. Just imagine a HGV lorry full of frozen food and ice-cream on a hot summer's day driving on a local main road or motorway. The drain on the battery would be huge to keep its contents frozen on the journey. What if it runs out of charge?

How do you deal with a brokendown vehicle before it gets to its destination, totally out of power, the vehicle's contents slowly melting or congealing? A mobile dieselpowered charging unit would have to be available for such events. What an inconvenience!

EV vehicles also under perform when it comes to towing caravans

or livestock. They are just not able for the job. The wear and tear on their tyres is far greater too than conventional vehicles due to the weight of the battery. That in turn means even more pollution in producing tyres and extra pressure on forests, plants and animals for sourcing natural rubber.

As for battery airplanes, the climate brigate - whose leaders' favourite mode of transport is the private jet - can dream on. The usable range of a 19-seat plane goes from about 160 to 30 miles when replaced with electric while a larger craft is reduced to less than six miles. When it comes to airplanes, batteries are the killer: too heavy, too bulky. Today's batteries don't have the energy density necessary to power anything but the lightest planes. So electricity for bikes, golf carts and children's scooters perhaps, but as for planes and automobiles, economic sanity will win over political correctness in the long run.

New Zealand PM calls for global censorship

NEW ZEALAND Prime Minister Jacinda Ardern used a recent speech to the United Nations to call for censorship on a global scale.

She lashed out at 'disinformation' and called for a coalition to control speech. After nodding towards free speech, she proceeded to lay out a plan for its demise through government regulation:

"But what if that lie, told repeatedly, and across many platforms, prompts, inspires, or motivates others to take up arms? To threaten the security of others? To turn a blind eye to atrocities, or worse, to become complicit in them? What then? This is no longer a hypothetical. The weapons of war have changed; they are upon us and require the same level of action and activity that we put into the weapons of old."

To answer her question: 'how do you tackle climate change if people do not believe it exists' is that you convince people using the same free speech she wants to silence.

While referring to a censorship coalition as a 'light-touch approach to disinformation,' Ardern revealed how sweeping such a system would likely be. She defended the need for such draconian censorship on having to combat those who question climate change and the need to stop "hateful and dangerous rhetoric and ideology."

"After all, how do you successfully end a war if people are led to believe the reason for its existence is not only legal but noble? How do you tackle climate change if people do not believe it exists? How do you ensure the human rights of others are upheld, when they are subjected to hateful and dangerous rhetoric and ideology?"

That is the same rationale used by authoritarian countries like China to censor dissidents, minority groups, and political rivals. What is 'hateful' and 'dangerous' is a fluid concept that governments have historically used to silence critics or dissenters.

Court rules 'Kill the Boer' song is not hate speech

Lobbyists argue historic chant incites violence

A controversial South African song, Dubul' ibhunu, translated as 'Kill the Boer' or 'Shoot the Boer', has been deemed not to be hate speech by a Johannesburg High Court.

In June, the Afrikaaner rights organisation and lobby group AfriForum brought a hate speech court action case over the inflammatory 'liberation' song arguing that lyrics in the song were hateful and incited violence against white South Africans. The song is often heard at rallies for radical political party Economic Freedom Fighters (EFF). EFF was formed in 2013 by former African National Congress (ANC) member Julius Malema.

Judge Edwin Molahlehi sitting as an 'equality court' in the

High Court, ruled the song did not constitute as hate speech in a contentious court ruling. His judgement reported by the *Daily Maverick* in South Africa stated: "It does not constitute hate speech and deserves to be protected under the rubric of freedom of speech - it articulates the failure of the current government to address issues of economic empowerment and land division."

Ernst Roets, head of policy and action at AfriForum, said: "We work constantly with the victims of farm attacks, as well as the families of those killed in these gruesome crimes.

"We understand the pain and trauma these victims and survivors have to live with. We are therefore deeply disappointed with today's verdict. There is no place in society for songs that encourage the killing of people based on their identity.

"Today's ruling proved how the political order in South Africa is becoming radicalised. This case once again confirms that AfriForum
must now focus its attention on
strengthening and intensifying
our safety structures and security
training."

In a controversial statement after the court hearing, EFF said: "The case by the racists, which sought to erase the cultural element of the liberation struggle for South Africa, has fallen flat on its face. The landmark judgement must be welcomed by all progressive forces as a victory against racists."

New South African political party ActionSA established in 2020 by the former Mayor of Johannesburg, Herman Mashaba, responded to the court outcome by saying: "ActionSA condemns, in the strongest terms possible, those who are not committed to building a shared future for South Africa, and instead seek to promote violence and further divide us. We will continue to work to unite the good, hard-working, and lawabiding people of South Africa behind our objective to fix our beloved country.'

Phumlani Majozi, senior fellow

at African Liberty, said the court outcome was a kick in the face of positive progress in South Africa. Mr Majozi said: "Chanting 'Kill the Boer' will not do South Africa any good. What makes things worse is that the chant is by an organisation that sits in South Africa's legislature. That makes the whole situation even more dangerous.

"The EFF is not supposed to be in South Africa's legislature, it is an organisation that promotes violence, promotes racism, and is communist. The fact that South Africans sent this organisation to the legislature is one of South Africa's biggest blunders in the modern era."

AfriForum is currently in the process of appealing the verdict of the court ruling.

Nigeria bans foreign models and voiceovers in adverts

While many adverts in Ireland feature Nigerians nowadays for some reason, their home country is taking a very different approach.

Nigeria is unapologetically banning foreign models and voiceovers from advertisements, in a move to develop and promote indigenous talent.

The Advertising Regulatory Council of Nigeria (ARCON) has announced that "all advertisements, advertising, and marketing communications materials are to make use of only Nigerian models and voiceover artists.

"Ongoing campaigns are permitted to run out their terms, however, subsequent applications for revalidation for continued exposure of such materials will not be granted by the Advertising Standards Panel (ASP). Advertisers, advertisement agencies, media houses advertising community and the general public are hereby enjoined to take note."

Head of ARCON, Olalekan Fadolapo, said: "Advertising

should resonate with people. How do you think it will resonate if we keep using foreign artists?"

Steve Babaeko, president of the Association of Advertising

the Association of Advertising Agencies of Nigeria told the Times: "Ten to 20 years ago if you checked the commercials, I would say they were almost 50/50 in terms of foreign faces, and all the voiceovers were British accents."

He added: "People will tell you, 'There are about 200 million of us. Are you telling me you could not find indigenous models for these commercials?""

Babaeko believes the new law in the former British colony will act as a 'kind of renaissance' to ignite confidence in local artists and bolster the Nigerian economy.

British-Nigerian author Lotanna Igwe-Odunze reacted to the prioritisation of Nigerian talent by saying: "The government banned foreign models, not white models. White models are foreign to Nigeria, so of course, they are naturally banned. However, the ban bars anybody who simply isn't Nigerian. Huge difference."

One has to wonder what would happen if Nigerian models were banned in Ireland? 'Tolerant liberals' must be engaging in mental gymnastics regarding the 'Nigeria First' policy.

The ban is in line with the country's federal government policy to grow local talent and improve the economic growth of the country. Nigeria's ingenuity in focussing solely focus on creating new jobs for indigenous talent should be admired and applauded.

The ban came into effect on October 1, which happens to also be Nigerian Independence Day.

Motorists face surveillance nightmare

LEGISLATIVE frameworks are being introduced on both sides of the Atlantic to regulate the future of cars – specifically, the way private citizens will be able, or allowed to use them in the not-so-distant future.

In the US, the new rules shaping up around this are contained in the Infrastructure Investment and Jobs Act which enjoys bipartisan support and was passed last November.

Specifically, the Act's Section 24220 mandates that carmakers must start including remotely operated kill switches, while the Secretary of Transportation must establish the requirement by November 2024 at the latest.

This technology will allow either human or "AI" entities to control or stop ("limit or prevent") a car if it detects what's phrased as "an impairment" on the part of the driver.

Like in Europe, this means that the rationale given by lawmakers for such drastic regulation is the well-being and safety of people: stopping them from driving under the influence, or while experiencing another kind of impairment that represents a threat to public safety.

Naturally, they wouldn't explain it any other way – but critics see this as yet another step in imposing mass surveillance and control over people – in public places, in their own homes, thanks to a variety of "always watching and listening" devices, and soon enough, in their own cars as well.

It seems that the tactic is working since there hasn't been much opposition to the upcoming rules precisely because they are being sold to the public as a safety-enhancing measure and a way to prevent death and injury.

But there are fears that the scope and use of the technology and its unprecedented capabilities could easily be expanded, if those who control it decide so, at any point in time, and for whatever reason they see fit.

After all, bank accounts were invented to make people's lives better and easier; but as protesters in Canada found out earlier in the year, they also have the "off-label" use allowing the government to quash anti-government protests.

With Section 24220, the deadline for carmakers to start including the new "advanced impaired driving technology" in all newly made cars to be sold in the US market is 2027.

Those driving such cars will be under constant surveillance by sensors and cameras inside, and outside the vehicle. Section 24220



Al will control your car so the State can spy on you when driving

specifies that outside, performance will be monitored by sensors and cameras to assist with things like lane departure warning.

And there will be cameras and sensors inside the car as well, this time directed at the driver's head and eyes. More sensors will be installed to detect alcohol, and if it's present, the car will be stopped either by the driver, autonomously by the system, and even remotely.

Whatever data the cameras and sensors monitoring the head and eyes, and those detecting alcohol gather, will be used by the system to make a decision the vehicle needs to be stopped. The plan is to allow the driver to do this of their own accord, but if not, the autonomous feature kicks in and disables the car anyway.

Law enforcement agencies are the ones who will have control over the remotely operated kill switch they will be able to use to "brick" the vehicle.

Other than representing a potential vector for ushering in various levels of autocratic behavior by the government at some future stage, and in general rob people of their agency, there are other concerns around this type of technology and laws including fears that some form of it is already being used in

unregulated and secretive ways.


Paradoxically, considering that "remote control" of vehicles is explained as a safety-enhancing measure, these concerns have to do with the capability to purposefully endanger the safety of drivers.

A report from Countere mentions suspicions arising around the death of journalist Michael Hastings in 2013, who was killed in a crash after his car "suddenly accelerated to maximum speed." The deadly accident occurred as he was preparing a report profiling CIA director John Brennan for the Rolling Stone magazine.

Former US National Coordinator for Security, Infrastructure
Protection, and Counter-Terrorism
Richard A. Clarke later commented on the case to say the circumstances were "consistent with a car cyberattack," and that "there is reason to believe that intelligence agencies for major powers – including the United States – know how to remotely seize control of a car."

Drivers who want to steer clear of the upcoming changes affecting all cars are advised to go for classic vehicles without an Engine Control Unit (ECU).

French immigrants commit most violent crime

AFTER French President Emmanuel Macron acknowledged that half of all crimes in Paris were committed by foreigners, it has now been revealed that they also account for 70 per cent of all violent robberies.

During an appearance on France 2 television channel last month, Macron admitted, "Yes, when we look at crime in Paris, we cannot fail to see that at least half of the crime we observe come from people who are foreigners, either who are in an irregular situation or awaiting asylum."

This was subsequently confirmed by the Ministry of the Interior, which clarified that during the first six months of 2022, "48 percent of those questioned for acts of delinquency in Paris are foreigners."

"However, the Paris police headquarters also sent information that for the first six months of 2022, foreigners were vastly overrepresented in certain serious offences," reports Remix News.

"This group was responsible for

70.4 percent of violent robberies and 75.6 percent of simple thefts, according to data from the police headquarters and the ministerial statistical service for internal security"

This means that the foreign population of Paris, which stands at

15 per cent, is vastly overrepresented in committing 70 per cent of violent robberies.

However, Macron is still absurdly refusing to accept the direct link between immigration and insecurity, leading to him being mocked on Twitter by National Rally leader Marine Le Pen.

"To be able to say almost in the same sentence, as Emmanuel Macron did, that half of the crimes in Paris are committed by foreigners but there is no link between delinquency and immigration and we still have to do it!" she tweeted.

France, like Ireland, continues to massively struggle with integrating huge numbers of migrants and descendants of migrants who are prone to criminality and violence. Entire areas of major cities have been declared "lawless," and police are routinely attacked if they dare enter. Last year, a group of 93 former police officers warned that areas of the country have become "lost territory" thanks to illegal immigration and rampant criminality.

In May, the final of the

Champions League had to be delayed after people described as "local youths" stormed stadium security, vaulting fences and entering the ground without tickets as well as carrying out countless robberies and assaults on tourists visiting for the game who they saw as easy prey.

The media falsely blamed Liverpool fans for the chaos, when in reality footage and eyewitness testimony spoke to large numbers of migrants, some from crime gangs, deliberately targeting innocent supporters.

Concerns over migrant-linked crime in France were heightened recently after the gruesome murder of a 12-year-old girl called Lola in Paris. An Algerian migrant who was in the country illegally has been charged.

Official data shows that Macron's government has been totally inept at deporting illegal migrants, with only 0.2 per cent of Algerians given deportation orders actually being forced to leave France.

Facebook flops

ZUCKERBERG is learning a hard lesson about life: The bigger they are, the harder they fall. His swan dive into the Metaverse may eventually cost him his job and most of his wealth. As a Technocrat, he has never been in touch with authentic humanness; his success has mostly been luck, obedience to the global cabal, and not skill.

After Meta reported a decline in profits and revenue in its third quarter report for this year, Zuckerberg's wealth took a \$11 billion hit, according to Forbes and Bloomberg. In addition to a decline in profits and revenue, the company's virtual and augmented reality division has lost \$9.4 million this year, according to Forbes.

The abysmal performance comes at a time when other Big Tech companies like Google and Amazon are facing the end of their internet reign with profits and revenues plummeting as their users finally waken up to the fact that they have been concealing the truth from them for years, especially when it comes to vaccines and rigged elections.

Ireland's Chief Injustice

John Waters on the profound decay within the Irish judiciary as illustrated by Chief Justice Donal O'Donnell's recent foray into matters way beyond his brief.

IN their private lives, judges are as free as everyone else - no more and no less. But in their public manifestations, they are circumscribed in one particular context that others are unaffected by: They may not express partisan political opinions in public.

There are good reasons for this,

chiefly relating to the public's need to see judges as objective, but also arising from a legal doctrine known as the Separation of Powers, which governs the operation of the three strata of Ireland's Constitutional Government: executive, legislative and judicial. The point of this doctrine is to ensure that each of the three elements is prevented from inappropriately interfering in the functions of the others; thus, judges do not arbitrarily interfere in the decisions of the legislators; politicians do not publicly question the wisdom of judicial decisions, and judges do not get involved in politics or policy-making. In truth, this doctrine has become radically reduced in recent times, with judges chiefly using it to claim that they are prohibited from assessing the validity of particular pieces of legislation. This is a self-serving nonsense, since one of the chief functions of the courts is to ensure that laws passed by the Oireachtas are in accordance with the Constitution. Legislation passed by the Oireachtas may be scrutinised by the courts for its consistency with the Constitution. All actions of the Oireachtas and the executive which impinge on non-members are subject to judicial scrutiny. This, in fact, is the sole reason why the judiciary is included as one of the three elements of the Constitutional Government. In a sense, the term 'separation

of powers' is misleading, and is often misused by virtue of being presented as a doctrine of judicial 'hands off' with regard to the workings of the executive and Oireachtas.

At the same time as they seek to elide or shrink their constitutional responsibilities, it is noticeable that judges have recently been pushing the boundaries out in that other vital concept within the Separation of Powers doctrine: that they refrain from expressing views about politics that might come across as potentially prejudicial to their judicial functions. Again, this is a vital safeguard of our legal system, since it avoids any possibility that a judge may have to stand down from a particular

case on account of a previously expressed view that might cast doubt on his capacity for objectivity.

An example of this new, unsettling trend occurred recently, when the Republic's Chief Justice, Donal O'Donnell, delivered a speech to a conference at Dublin City University (DCU) on 'human rights and the rule of law amid a time of political instability across Europe', in which he expressed remarkably strong opinions on the current political situation in Europe. He spoke of his fears about the rise of 'aggressive nationalism' around Europe, alleging that 'we are facing - in ways some of us thought unimaginable' - 'threats and challenges' having 'more an echo of the mid-20th century than the bright, modern future we imagined'.

'It's a real and existential challenge to some of the values that we hold dear', he added.

In the first instance, it is

questionable whether a judge should be speaking at a conference concerning the political situation in Europe at all. Judges are the first, when it suits them, to tell us that they are not supposed to intrude on the territory of politicians. Yet, they are happy, when it suits them also, to not merely engage in such 'debate' but to do so in a manner indistinguishable from any conventional politician within the power structure of Europe at the present time.

If Mr Justice O'Donnell added any more calibrated or subtle elements to his arguments, these managed to escape the attention of those reporting on his remarks. Judging from what was reported, he does not appear to

have made specific reference to particular countries, politicians or movements, although it is clear that he was speaking of what journaliars call 'the rise of the far right' in Europe, as a result of enforced mass immigration into Europe and the growing establishment tyranny of recent years. In ludicrously comparing what is happening now with the rise of ['mid-20th century'] Nazism, he seemed to be blind to the reality that the most apposite points of comparison between that period and the present reside in the behaviours of mainstream politicians since the launch of the Covid subterfuge in March 2020.

To imply such a comparison between Adolf Hitler and, for

example, Hungarian President, Viktor Orbán, or Italian Prime Minister Giorgio Meloni, would be idiotic and actually defamatory, and yet such a comparison is part of what the Chief Justice appeared to have in mind, or at least would be a reasonable inference from reports of his DCU remarks.

What, precisely, did the Chief Justice have in mind in referring to 'the values we hold dear'? Was he referring to 'values' like genocide by quasi-coercive poison injection; upward wealth redistribution by lockdown; the incarceration of people in their houses like farm animals; the jailing of dissenters for declining to suffocate themselves with medically pointless face nappies; the ostracism of the elderly on their deathbeds from their beloved ones so that they die in emotional agony; a forever culture of 'Papers please!'?

Or, perhaps the Chief Justice had more in mind things like the arbitrary seizure of private property; the silencing of citizens by 'hate speech' legislation'; bodily mutilations in the name of 'choice'; post-birth 'abortions' (murders); and Drag Queen Story Hour? Is this the 'bright, modern future' that we imagined for ourselves and our children?

His remarks were also themselves arguably antidemocratic. He seemed indifferent to the likely consequences of his aiming a verbal scattergun at an



entire cross-section of politicians and political movements that have enjoyed enormous success across the European continent in recent times. For examople, Viktor Orbán's Fidesz party won 53% of the total vote in the Hungarian general election of April last. In the Swedish general election in September, the so-called 'far right' Sweden Democrats became the kingmakers of government, gaining 20.5% of the vote. In the four elections over the course of the past decade, the Sweden Democrats have gone from a marginal, ostracised party to the second largest party in Sweden. In September, too, Giorgia Meloni's Brothers of Italy attracted 26% of the total vote in the Italian general election, resulting in her investiture as her country's first female prime minister.


These appear to be the kind of things the Irish Chief Justice (one of the highest paid judicial positions in the world with a salary of €295,916) had in mind when he spoke of 'a real and existential challenge to some of the values that we hold dear'.

Seen in this way, his remarks amount to an extraordinarily prejudicial statement from the mouth of Ireland's most senior judge, and arguably the second most senior figure in the Constitutional Government of Ireland. On what basis does he so dismiss and disparage the electoral wishes of millions of his fellow Europeans, while still claiming the right to sit in public judgement on matters of often the most delicate character in Ireland's highest court?

And - perhaps more pertinently, given his judicial calling - on what evidence? On what basis does he seek to compare people like Orbán and Meloni to Hitler and Goebbels?

Well, he apparently confided to his audience that, a week before the conference, he heard a 'senior public official' from 'a very stable European state' launch 'an astonishing attack on the concept of judicial independence'. He elaborated that the official 'attacked the rights that were protected under documents like the Convention of Human Rights while in the presence of senior figures of the EU courts'.

He does not appear to have named the official in question or specified his or her office or position. He does not appear to have specified either the nature of the attack on judicial independence, or the particulars of which of the ECHR provisions were brought into question. Yet, this was the entirely of the evidence he advanced for his

extraordinary outburst.

Such a submission, presented to a court presided over by Chief Justice O'Donnell, would survive hanging in the air for approximately 15 second before

being consigned to the dustbin of jurisprudential history.

And yet, the Chief Justice felt entitled to extrapolate from this, apparently overheard casual comment of an unnamed official, that the outcomes of several recent democratic elections in Europe amount to a reprise of 20th-century Nazism. 'The problems we face

with populism, with aggressive nationalism,' he continued, 'cannot be isolated into some sort of isolation [sic] in one or two countries until we hope that the internal system will somehow fight off the infection. That is something that is happening throughout Europe, and the people of those countries look to the Court of Human Rights as a beacon.'

This is the kind of gibberish mouth by greenhorn graduates of the DCU 'journalism' course - in reality a school for Cultural Marxist agitators posturing as journalists in purchased media outlets. But the Chief Justice's use of the word 'infection' is more ominous still, summoning up some of the events he himself was trying to leverage to a quite different purpose.

The Chief Justice appeared to be especially concerned about some vague threat to judicial independence, but overlooked the possibility that an excellent way of helping to preserve judicial independence would be for judges to avoid making inflammatory ideological statements, or, failing that, to avoid in such statements seeming to adopt the same positions as the politicians in power that appointed them, and whom they're pledged under oath to oversee for legal compliance with democratic procedures, especially when such statements appear to legitimate the suppression of the democratise desiring of whole nations and the exclusion of the viewpoints of, in many instances, more than half of

the populations of those nations.

As a private citizen, Donal O'Donnell is quite free to mouth such inanities at dinner parties in Ballsbridge or Malahide. But while he bears the appellation 'Chief Justice' he possesses no entitlement to publicly disparage the voting choices of the electorates of other European countries. If he wishes to exercise such a 'freedom', he should first resign his position as Chief Justice.

A judge is not some anointed absolutist who, on appointment, becomes ordained with supreme and infallible powers of discernment and wisdom. A judge is, above all - in theory at least merely another frail human who, by virtue of being trained to the highest capacity of objectivity, becomes capable of not merely removing his own biases from the justice equations set before him, but of erasing all traces of such biases from his public persona. For a judge, therefore, to engage publicly in cheap political sloganeering is to bring the entire edifice of law and judicial independence into disrepute. Part of the reason we retain in our judicial system concepts like the Separation of Powers is to ensure that a judge is not compromised by prejudicial views he may already have placed in the public domain, thereby making it impossible either for justice to be done, or - just as grave - to be seen to be done.

Chief Justice O'Donnell, therefore, does not need to sit around waiting for 'aggressive nationalists' to assail judicial independence, for he has already done the job all by himself.

The Denial of Holocaust Denial

Charles Stanford examines the work of the world's foremost Holocaust revisionist Robert Faurisson who claimed the extermination of six million is nothing more than a Jewish myth

THE "Holocaust" remains the lone official religion of the entire West, a murderous religion if ever there was one and one that continues to fool millions of good souls in the crudest ways: the display of heaps of eyeglasses, hair, shoes or valises presented as "relics" of the "gassed", faked or deceptively exploited photographs, texts of innocuous papers altered or purposely misinterpreted, endless proliferation of monuments, ceremonies, shows, organised excursions to the holy sites of alleged Jewish martyrdom and great show trials with their calls for lynch-law.

The Holocaust is not only at the head of all taboo subjects, but is arguably a secular religion, concerning which no adverse comment at all is allowed. One can pour scorn on the Catholic Church and very little by way of criticism will be said. Mount an attack on Western civilisation generally and the cognoscenti will likely praise you. Try saying that the value of a society should be judged in terms of how it treats the most vulnerable, those in the womb and the elderly and infirm, and you will be floored by the abortion crowd and supporters of euthanasia.

However, if you dare to say a single word casting the slightest doubt on any aspect of the Holocaust story, you will be immediately castigated as an irreparable anti-Semite and subjected in many countries to criminal sanctions, loss of employment, and social scorn.

Writing about the Jews, both in relation to the Holocaust and other matters, has often been a problematic task. For example, when the names of those two great characters, Hilaire Belloc and G. K. Chesterton, are mentioned these days, it is always accompanied by a reference to their supposed "anti-Semitism.'

Sadly, it is also the case that the crucial distinction to be




Professor Robert Faurisson: Persecuted and prosecuted for exposing the lie

made in relation to the Jews on the part of a Christian is often misunderstood. Anti-Semitism is a racial concept, in the sense of hatred of the Jews because of immutable and ineradicable racial characteristics. This is utterly wrong and something that has always been repudiated by the Church. However, it is necessary for a Christian, in view of the belief of that faith in the divinity of Jesus Christ, to be anti-Jewish in the sense of opposing beliefs and actions of Jews which operate as a consequence of the Jewish rejection of Christ. Many Jews try sincerely to live up to the moral law.

Nevertheless, it is the case that the Jews rejected Logos, the reason for the universe and its redemption, and so rejected Christ, the Supernatural Messiah, in order to support anti-Christian revolutionary movements. gentleman who had to put up with both verbal and physical attacks on many occasions. In addition, the legal provisions in his home country of France meant that Professor Faurisson was subjected to heavy financial penalties for his views, despite the detailed evidence

he gave supporting them. In spite of all of this, he retained his good humour and essential moderation.

The essence of his case is still best expressed in two statements

A. His famous 60-word summary of his thesis: "The alleged

Hitlerite gas chambers and the alleged genocide of Jews form one and the same historical lie, which allowed a gigantic political and financial swindle whose main beneficiaries are the state of Israel and international Zionism and

- whose main victims are the German people - but not their leaders - and the Palestinian people in their entirety."
- B. His question to Michael Berenbaum, the then director of the U.S. Holocaust Memorial Museum: "I asked him why I had not found in his Museum an answer to my challenge: 'Show me or draw me a Nazi gas chamber!' Finally he - a rabbi and Jewish theologian said that 'the decision has been made not to give any physical representation of the Nazi gas chambers.' For me, it is like the Pope deciding that there would not be any more physical representation of the crucifixion of Jesus Christ: no more Cross in the Vatican."

Professor Faurisson put forward his argument as follows:

It is accurate to say that
National Socialist Germany built
concentration camps; it did so after,
and at the same time as, a good
number of other countries, all of
which were convinced that their
camps would be more humane than
prison. Hitler saw in them what
Napoleon III had thought he saw
in the creation of penal colonies:
progress for humanity. But it is
false to hold that Germany ever
established "extermination camps"
(an expression forged by Allied
propaganda).

It is accurate to say that the Germans used disinfection gas chambers operating notably with an insecticide called Zyklon B (the active ingredient of which was hydrogen cyanide) to safeguard, by disinfestation, the health of large numbers of civilians, troops, prisoners, and internees. But they never used Zyklon B to kill anyone, let alone to put to death throngs of human beings at once. In the light of the draconian precautions absolutely necessary for the use of hydrogen cyanide gas, the gassing of inmates as allegedly carried out at Auschwitz and at other camps would have been fundamentally impossible.

It is accurate to say that some German concentration camps had crematories to incinerate corpses. But their purpose was to combat epidemics, not to incinerate, as some have asserted, living human beings along with corpses. After the war, the photographs purportedly exposing "Nazi atrocities" showed us camp inmates who were either sick, dying or dead, but not killed.

The most notable examples of this took place at Bergen-Belsen and at Dachau in 1945.

What with the Allies' blockade and their "area" bombing of Germany, and the apocalypse

experienced by the latter towards the end of a nearly six-year long conflict, famine and epidemics, notably of typhus, had ravaged the country and, in particular, the camps in the western regions, overwhelmed by the arrivals en

masse of detainees evacuated from the camps in the East, and thus severely lacking in food, medicine and the Zyklon-B needed for protection against typhus.

So, if by the word "Holocaust" you mean that Nazi Germany

(1) had a policy of physically exterminating the Jews, (2) used execution gas chambers to that purpose, and (3) that the overall result of this policy, taking in deaths by natural causes within or without concentration camps, was

a total of 6 million dead, I say that there was no "Holocaust". But, if by the word "Holocaust" you mean that the Jewish communities of Europe suffered considerable hardship and loss of life during the second world war, I lament such If you dare to say a single word casting the slightest doubt on any aspect of the Holocaust story, you will be immediately castigated as an irreparable anti-Semite and subjected in many countries to criminal sanctions, loss of employment, and social scorn

sufferings.

It is accurate to say that many Jews experienced the hardships of war, of internment, deportation, the detention camps, the concentration camps, the forced labor camps, the ghettos; that there were, for various reasons, summary executions of Jews, that they were the victims of reprisals and even massacres (for there are no wars without massacres). The truth is that Hitler treated the Jews as his declared enemies, that he wanted to drive them out of Europe. The fate of the Jews was atrocious and, as I say, I lament such sufferings (though they did not - and by far - amount to 6 million dead), just as I lament those endured through-out that horrible conflict by Christians, atheists, Buddhists, Shintoists, and all others: perhaps as many as 40 million people were killed. The allied bombing raids on Dresden (February 1945) amounted to a real "Holocaust" (the incineration of an entire city would seem to bear a closer correspondence to the traditional, liturgical sense of the word that we are discussing here).

[The word "Holocaust" comes from the Greek word for "sacrifice by fire" (holos = entirely; kaein = to burn). Another term, which is less commonly used, but which is preferred by Jews, is "Shoa" (Hebrew for "catastrophe")]. Then there is the Katyn forest and the Gulag. The most dreadful deportations were those of the 12-15 million German civilians (from East Prussia, Pomerania, Silesia, Czechoslovakia, Poland, Hungary, Romania, and Yugoslavia), chased from their homes in Central and Eastern Europe in 1945-1946. Consider the fate of the German children killed or wounded by phosphorous bombs or of those slaughtered at the time of their "transfer" from East to West. Then, the handing over of millions of Europeans to the Soviet moloch, the bloodiest purge ever to sweep the continent: was all of that really too small a matter for review by an international tribunal? During this past century, no military force has killed as many children - in Europe, Japan, Korea, Vietnam, Iraq, and Central America - as the U.S. Air Force. And yet no international authority has held it to account for these slaughters.

And yet - all these horrors are hardly even noticed when there is talk of WW II atrocities. When people talk of THE unique crime of the century - a crime which staggers the imagination - we immediately sense that we are about to hear - once again - of the German genocide of the Jews.

There is only group with victim status: the Six Million. There is only one scene of any crime: Auschwitz. There is only one group of unique criminals: the Nazis.

There is only one new, horrifying weapon: the "gas chambers". These concepts are deeply anchored in the subconsciousness of all of humanity; they are drummed into our brains, on television, radio, and the press almost daily; they appear in all the history books, at least in the Western world".

Auschwitz

When you go to Auschwitz and see the ridiculous room next to the place with the ovens, and they dare to say that this was an enormous gas chamber, excuse me, but you can only laugh at it. First, there are three openings. You have two doors and an opening. So, two wooden doors. Poor little doors opening inwards. Which means, into the place where hundreds or even thousands of people at that time are supposed to have been gassed. One of those little doors even has glass panes. You understand that if you had had such numbers in this place, or even one man, the pane would have been broken and the gas would have escaped to the SS hospital which was something like 20 meters away from there.

One of the openings leads into the room of the crematoria. But hydrocyanic acid is an explosive gas. So you must not use it close to such a room. And here, you do not find the slightest mechanism to were born in Auschwitz.

There was absolutely no policy for a physical destruction of the European Jews. No order, no plan, no budget, no instructions and no weapons.

expel, to neutralize all this gas. It is really shameful to say that, and I must add that I was the first man to publish in my books plans of this place. They waited there for cremation. It is a place where you store bodies, dead bodies.

There would be no people from Auschwitz and from so many other camps. There would not be, notably, the children who

At the Nuremberg trial we were told that six million Jews had been killed. This figure is preposterous. In 1979 it was accepted by historians that this figure was symbolic, which means false. See all those organizations of survivors!

The Auschwitz Death Books contain the death certificates of some 65,000 individuals, of whom about 29,000 were listed as Jews. There were more Catholic deaths (just under 30,000) than Jewish deaths recorded.

Many times myself I have met Jews saying: "Now, how can you say that there were no gas chambers? I was myself in Auschwitz. I am a living witness." Every time I have looked those people in the eye and said: "Now, you claim that you are a witness:

please describe to me the gas chamber that you saw. Please describe to me the gassing." The answer is: "Now, how can you expect me to have witnessed a gassing? If I had witnessed a gassing I wouldn't be here, alive, to talk to you." They mean, I would have been killed. Now, this is a strange answer. Because first those people presented themselves as witnesses of gassings. And then according to what they say, there could not be any witnesses. They are wrong. If in Auschwitz you have had those fantastic chemical slaughter houses, functioning day and night for years and years killing 100,000 or millions of people, you would have had many, many witnesses.

You must know that Auschwitz was a camp where you had many civilians coming from outside and working in the camp. We have very many documents about Auschwitz. I say millions of documents about those camps. And we have not the slightest proof, material proof, that there were any gas chambers. So, if you do not have, as we have seen, an order, a plan, a budget, instructions, no weapon and so on, and if you have no witnesses, then what is it that you have?







In *image 3* above, the strange object shaped like a cross is from



