# Heart disease in children explodes since vaccine

## Sudden deaths of children soar as media stay silent

**THE greatest crime ever committed by an Irish government - and there have been many - will not be concealed from the Irish people for much longer. As hard as the HSE tries to cover up the horrifying impact of the covid vaccine on Irish children, there is no containing the staggering toll of sudden deaths in young people.**

Almost daily, the faces of sporty teenagers and newborn infants appear on the pages of RIP.ie: perfectly healthy children struck down by a fatal heart attack, stroke or sudden unexplained death.

There has also been a sharp rise in cases of sudden and severe hepatitis (inflammation of the liver) in children under 10, which has been seen in at least 20 countries including Ireland.

Why are so many healthy children dying? What has changed in their lives to cause it? We all know the answer but many still do not have the courage to say it out loud because they know they too may meet the same fate.

American cardiologist Dr Peter McCullough spoke recently about the astonishing lack of concern and outrage expressed by family members when young people die after the vaccine. He put it down to the mass psychosis that has gripped our nation since the advent of covid, explaining that these people are in a zombie-like state where they are emotionally inert to the death of a loved one because it has been caused by a hypodermic needle.

It's a classic case of cognitive



dissonance and denial often witnessed in parents whose perfectly healthy toddler becomes violently autistic in the aftermath of the MMR vaccine. They know what changed their child overnight but cannot state it publicly because they are the ones responsible.

And so it is with the covid vaccine:

how many children whose lives have been wiped out were urged to take it by their reckless parents? They will have to live with that for the rest of their lives. If only they knew the peace and strength they would feel if they could find the courage to speak out and save other young lives. At least their child's

death would not have been in vain.

But soon the dam of silence will burst because the injury levels are too alarming to ignore.

In the US, the number of injuries and deaths recorded in the government database of Vaccine Adverse Events Reporting System (VAERS) following

covid vaccines has soared above 1.2 million cases.

This represents an increase of 3008% compared to the previous 30 years of vaccine use.

In the world of sport, there has been at least 930 post-vaccine heart attacks and more than 620 deaths.

As of March 24, 2022, VAERS had received 2,323 reports of heart inflammation among people ages 30 years and younger who received the vaccine.

Youngsters involved in the GAA - which took a draconian approach to vaccination - have been dying at a terrifying rate.

RTE and the rest of the mainstream media, which could not exist without Big Pharma/HSE funding, should be interrogating the sporting organisation as to why so many of its young members are dropping dead. But instead they close ranks refusing to even acknowledge the sheer numbers who are dying and try to normalise sudden death, heart disease and strokes in children or cynically imply that the child committed suicide.

It is a crime which will seal their demise when the public finally learn the truth about how they were duped into taking this lethal experimental drug.

Even the manufacturers admit in the small print that their vaccines have side effects.

# The healthiest people in the world are dropping dead

## Athlete fatalities are soaring

**IN March, Australian world number one tennis player Ash Barty retired at age 25. Previously, she withdrew from two US tournaments due to health concerns.**

World number two golfer and 2020 Olympic gold medalist, Nelly Korda (23), announced that she was diagnosed with blood clots and was recovering at her home in Florida.

In February, 17-year-old Danish golf prodigy Viggo Sorensen, winner of the Emirates Golf Federation Order of Merit, suffered a sudden cardiac arrest and died.

In late March, Danish handball player Mikkel Hansen (34), one of the best handball players in the world, suffered phlebitis (vein inflammation) and pulmonary embolism, ending his season.

In February, French number one tennis player Gael Monfils (35, ATP#22) suffered an adverse reaction to his booster

vaccination and had to withdraw from the Davis Cup.

French tennis player Jeremy Chardy (34, former top 30) had to suspend his season after a vaccine reaction in the summer of 2021. Chardy returned to practice in January, saying he "regretted getting vaccinated".

In mid-April, 27-year-old Italian professional swimmer, Mariasofia Paparo, suffered a cardiac arrest or a heart attack and died. The Italian "Super Green Pass" required proof of vaccination.

Former Manchester City and FC Barcelona striker Sergio Aguero (33) suffered a vaccine heart injury in 2021. In February 2022, he revealed that he had to end his career: "If I try to run, I lose breath. I just feel like my heart doesn't work properly."

In late March, Newcastle United goalkeeper Martin Dubravka (33) was forced to withdraw from Slovakia's international team after being diagnosed with a heart condition.

Since late 2021, several German soccer players, including Bayern Munich's Alphonso Davies (21), suffered heart inflammation and had to rest for several



weeks or months.

In March, Belgian cyclist Cedric Baekeland (28) died of a heart attack during a training camp in Mallorca; Scottish cyclist John Paul (also 28) also died of a heart attack; Italian top cyclist Sonny Colbrelli (31) suffered a cardiac arrest after crossing the finish line during the Volta a Catalunya

cycling race. In February, Belgian cyclist Tim Declercq (32), called "the tractor", suffered post-vaccination pericarditis.

In Switzerland, marathon champion Fabienne Schlumpf (31) suffered myocarditis after her booster vaccination; Olympic sprinter Sarah Atcho (26) suffered pericarditis after her booster; and soccer

player Michael Perrier suffered a cardiac arrest and had to end his career.

In mid-March, West Indies' cricket player Shamilia Connell (29) collapsed during a World Cup game. Also in mid-March, European Rugby League administrator Tiziano Franchini (44) died from a suspected heart attack. Former wrestling world champion "Triple H" (52) was vaccinated in April 2021 and suffered heart failure in September, but it was reported that this was due to either a "genetic heart issue" or "viral pneumonia"; in March 2022, he announced his retirement.

In late March, a total of 15 tennis players had to retire from the Miami Open, including tournament favorites Paula Badosa and Jannik Skinner. Some of these players reported breathing or performance problems. In mid-March, only 59 of 154 cyclists finished the Paris-Nice cycling race. While this had various causes, it was reported that "the state of health of the peloton is not good".

Instead of penalising them for their dangerous products, the government have granted them legal immunity to protect themselves against future action by injured parties. This in itself should be enough to raise alarm bells. Most parents wouldn't buy a child's bike without a guarantee yet so many are willing to put a syringe into their arms which has multiple side effects including death and has full immunity from legal recourse.

Official data published from the US Center for Disease Control has revealed that 106 children have died following vaccination. The deaths have been reported among 12,548 serious adverse events among children ranging from hospitalisation to permanent disability.

As of April 22nd 2022, there have

been 48,033 adverse reactions to the Covid-19 injections among children, of which 12,548 were considered serious resulting in hospitalisation, permanent disability or death. Sadly, 106 children have lost their lives.

This does not however paint the full picture, because the CDC estimated just 1 to 10% of adverse reactions are actually reported to VAERS. Therefore, it's possible that over 10,600 children have sadly lost their lives due to Covid-19 vaccination.

There has been a 86% rise in deaths among male children compared to the same period in 2020 with one week seeing an increase as high as 600%.

The British Office for National Statistics has revealed that children are up to 52 times more likely to die following the vaccine than those who have not had it.

The body in Ireland charged with protecting the public from untested drugs - the Health Products Regulatory Authority (HPRA) headed by Dr Lorraine Nolan has recklessly allowed the vaccine to be given to children despite being fully aware of its dangers.

Its website openly admits that myocarditis and pericarditis are potential side effects, especially among young males, yet they continue to promote it.

Myocarditis is inflammation of the heart muscle, whereas pericarditis is inflammation of the protective sacs surrounding the heart. Both are extremely serious conditions due to the vital role the heart plays in keeping a person alive, and the fact that the heart muscle cannot regenerate. Serious myocarditis can lead to cardiac arrest and knock years off a person's life.

The fact that myocarditis is a confirmed side effect of the Covid-19 vaccines; especially among younger males, and there is a significant increase in the number of male children dying since they were offered the Covid-19 vaccine is clearly a direct consequence of administering this experimental gene therapy to children.

The data is there for all to see.

## Dozens of global food plants destroyed by mysterious fires

**FOOD shortages have been exacerbated by a string of fires, plane crashes and explosions at nearly two dozen food processing facilities across Canada and the US.**

This year so far, at least 22 plants in America have burnt down. But the bizarre fires have also struck other parts of the world.

In April, in the Dutch town of Heusden, 43,000 chickens died in a massive fire that destroyed four chicken houses on a farm.

A massive blaze near Bessbrook in Northern Ireland farm killed hundreds of pigs in November 2021.

In October 2021, a large fire at a Fermanagh poultry farm in Northern

Ireland killed 16,000 birds.

Last September, the Offaly yoghurt plant Glenisk suffered a devastating fire in which “basically everything” was lost.

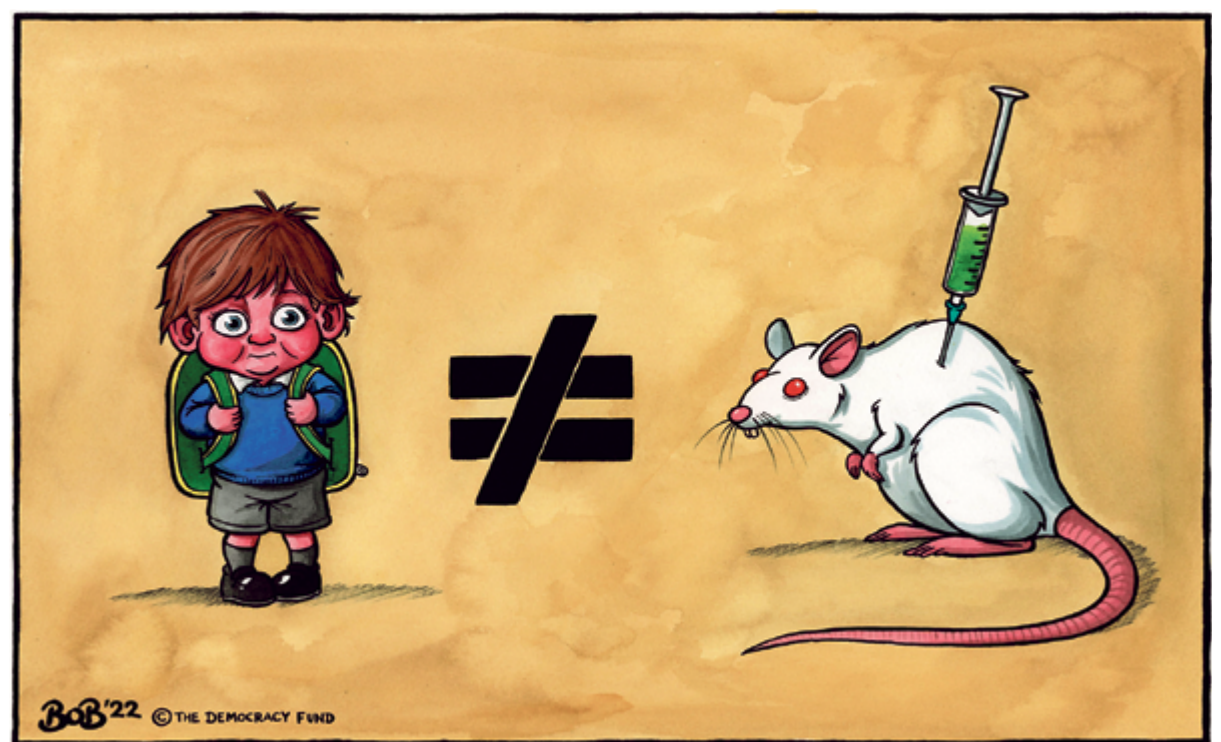
In March, a fire at a poultry farm in India killed 3,500 chickens, destroying the entire farm.

Another poultry farm in India was also hit by fire in March killing 8,500 chicks.

In July 2021, a deadly fire at a Bangladesh food processing factory kills at least 52 people.

Another fire at a poultry house in East Yorkshire, England in July 2021 killed 50,000 chickens.

In April 2021, over 55,000 pigs were killed after a fire broke out at a German pig farm.





# Climate engineering: We're being sprayed

Look up!  
What's that  
in our skies?

For at least 15 years, covert weather modification activities have been taking place with ever-increasing scale and frequency

**LIFE on Earth exists in a complex and fragile state of mutually-dependent dynamic equilibria between and among biota (plant and animal life) and the physical environment. Any disturbance is apt to upset this delicate balance with potentially devastating consequences for numerous species, including mankind.**

Geoengineering may be defined as 'the deliberate large-scale manipulation of the environment including weather and climate manipulation'.

The basis for geoengineering stems from cloud seeding experiments in 1946-47. It was discovered that adding dry ice (frozen CO<sub>2</sub>) or silver iodide to clouds could aid in the nucleation of rain or snow. Development of the technology to control weather for use as a weapon of war began with that discovery and has proceeded in secret ever since.

From 1967 to 1972, Operation Popeye involved cloud seeding with the intention of extending the monsoon season over the Ho Chi Minh Trail to impede transport of troops and supplies during the Vietnam War. But causing clouds to dump rain or snow more or less at will was just the first step.

The military wanted to fully control the weather as a weapon of war, as was later described in the 1996 U.S. Air Force document: *Weather as a Force Multiplier: Owning the Weather in 2025*. In retrospect, that

document should have been cause for alarm. Since the end of World War II, the U.S. military has been single-minded in its scientific pursuits with no sense of responsibility for the wellbeing of either civilian populations or the environment.

After learning how to make clouds produce rain or snow more or less on demand, the next technological step was to learn how to inhibit rainfall to bring drought and starvation to a perceived enemy nation.

For at least thirty years, experiments were conducted in the lower atmosphere (troposphere) that involved jets spraying undisclosed substances which left particulate trails across the sky that were witnessed by millions. These trails at first superficially resemble contrails, which are ice crystals formed from aircraft exhaust. Contrails are formed, however, only in very humid environments, with temperatures low enough to sustain the saturation vapour pressure with respect to ice, and with sufficient moisture content in the exhaust gases. Contrails rapidly become invisible by evaporation, whereas particulate trails spread out to sometimes briefly form artificial cirrus-like clouds before further spreading to form a white haze in the sky.

For at least fifteen years covert weather/climate modification activities have been taking place with ever-increasing scale and frequency that involve spraying pollutant particles into the troposphere. The scientific community has been grossly remiss in ignoring the now near-daily, near-universal spraying of particulate-pollution matter into the troposphere, which evidence indicates is coal fly ash, a substance containing toxins injurious to virtually all biota, including us.

Not only does the spraying contaminate the environment, but the aerial placement of this particulate-

pollution causes warming and alters weather patterns, which can cause damage or injury to human health and even loss of life, disrupt food production, and create a pestilent-ridden, unhealthy environment on a worldwide scale.

Yet the consequences of this weather/climate modification

geoengineering activity have not been taken into account by any of the climate change models evaluated by the United Nations Intergovernmental Panel on Climate Change (IPCC), a fact that calls into question not only the findings of that organisation, but its moral authority as well.

I hold that scientists, because of their abilities and training, have the responsibility to benefit mankind and advance civilisation. I therefore chose to apply scientific methods to ascertain the nature of the main substance being sprayed into the troposphere and discovered three independent lines of evidence that

the tropospheric geoengineering particulate-pollution consists mainly of coal combustion fly ash.

When coal is burned by electric power utilities, the heavy ash settles and the fly ash goes up the smokestacks, where in Western nations it is electrostatically trapped and sequestered, as this ash-portion contains most of the toxic heavy metals that were incorporated in the coal.

When sprayed into the troposphere, coal fly ash inhibits rain or snow fall, absorbs atmospheric moisture, enhances the electrical conductivity of atmospheric moisture, warms the atmosphere, and blocks radiation from the surface into the upper atmosphere.

When the coal fly ash, with its typically dark grey colour settles to Earth, it absorbs sunlight and changes the albedo of snow and ice which aids in its melting. In other words, in addition to causing drought, when sprayed into the troposphere on a near-worldwide, near-daily basis as at present, the aerosolised coal fly ash warms the Earth, causing deliberate anthropogenic global warming of a different type than that allegedly caused by greenhouse gases.

Jet aircraft that spray coal fly ash into the troposphere are part of a covert program and operate from undisclosed airbases. On or about February 14, 2016, an aircraft presumably operating out of Selfridge Air National Guard Base in Michigan (USA) momentarily released a small portion of its payload, which reportedly fell on residential properties in Harrison Township, Michigan (USA).

The material was sampled and analysed by officials from the Michigan Department of Environmental Quality. The results of those analyses provide evidence of a deliberate operation to melt ice and snow, which is consistent with the

hypothesis that aerosolised coal fly ash is being used to enhance 'global warming'.

Interestingly, one component of the airdrop material, inferred here from analytical results, is coal fly ash. Scientists who study glaciers should be mindful of the evidence presented here, and should look for instances where such matter, referred to as synthetic cryoconite, or proto-cryoconite, might have been dropped.

The coal fly ash component of the airdrop material further pollutes the environment with toxic heavy metals. Considerable time, effort and expense was required to develop the air-drop material, that I refer to as synthetic cryoconite, or protocryoconite, and to develop and test the technology to disperse that material from the air in a systematic and effective manner; consequently, it seems unlikely that this was simply a local operation. If so, this investigation reinforces the presumed intent of daily aerosol particulate spraying in the troposphere, observed worldwide, which has the consequence of causing 'global warming'.

Scientists worldwide should call for, and indeed demand, a full and open investigation into these covert geoengineering activities whose potential impacts on Earth's climate system, the integrity of Earth's biota, and on human health may prove to be extremely hazardous.

# ESG - socialism disguised as free market capitalism

AS a State Treasurer, I operate at the intersection of politics and capital markets, squarely where ESG resides. Many are afraid to speak out about it, but people need to understand the threat that it poses to our system, one based on free-market capitalism and constitutional principles.

ESG uses economic force to drive a political agenda through corporate America. As Larry Fink, CEO of BlackRock, the largest investment manager in the world, so succinctly stated: “You have to force behaviours, and at BlackRock, we’re forcing behaviours.”

BlackRock manages \$10 trillion of other people’s money. Other investment managers have trillions more. Unelected by anyone, they are using the might of other people’s capital to drive a far-left agenda. Arguably, no one outside the federal government has more power, and few people outside the industry know what’s going on.

There’s a small tech company in my state of Utah that employs fewer than 75 people. A Silicon Valley tech titan was a client. Call it Twoogle. Last year, Twoogle explained to the company that if they wanted to continue to do business with Twoogle, they would need to implement a whole range of policies.

For example, the Utah company would have to provide six months of full pay and benefits for maternity and paternity leave. The company responded that Utah’s fertility rates are higher than other states, and offering the benefit to all employees would imperil the company financially. Since fewer than five employees served the Twoogle account, they asked if they could implement the policy for just those employees.

Twoogle said no, they must implement the benefit regardless of the financial impact.

That every employee knew what benefits the company offered before they agreed to work there was beside the point. The tech company was forced to drop Twoogle as a client - a serious blow.

And what about Twoogle? Presumably, they engaged the company because they had the best product at the best price. They, too, will pay a price for their policies when they move to the next-best provider. How is this good for Twoogle’s shareholders?

This is just one small example of how ESG plays out across our economy. Multiply it by a million.



## ESG: Environmental, Social and (Corporate) Governance

ESG is a political scoring system for investors, with companies like S&P Global issuing ESG scores on corporations. It sounds great, right? In reality, ESG is dictatorship in capitalist clothing. Our banks, investment managers and corporations are all promoting ESG, cleverly lending ESG the veneer of free-market capitalism. But it is not capitalism.

Capitalism is freedom in an economic context. ESG is a system of force. ESG substitutes our pluralistic institutions for conformity to centralised power, one that makes up the rules as it goes. If you don’t believe me, think about the indeterminate nature of ESG. There are two layers of subjectivity: the determination of the ESG factors themselves and the answers to those factors. If you ask people what the factors should be, you will get different answers depending on their shade of politics.

Even if people agree on the factors, the answers as to what constitutes a ‘good’ or a ‘bad’ score for a particular factor also depends on whom you ask. Is British Petroleum bad because it sells oil or good because of its focus on developing alternatives?

This is an inherently political exercise, and ESG cedes power to the entities determining those two central questions. Government bureaucrats

appear to be colluding with investment behemoths like BlackRock to make the agenda, and they use the threat of regulation and the power of our investment money to bully corporate America into carrying it out.

What would prevent new factors from being used as a weapon against the other side? For example, what if the government, under different party control, suddenly decided to use capital to favour donations to pro-life groups? I would oppose this on the same grounds. We need to keep our capital markets and businesses politically neutral.

Pension allocators, most of whom are government employees, are also in on the game. As one insider put it, they are “effectively creating law and enforcing it without voter input, debate, or even knowledge. Given their size, their standards flow downstream, changing everything.”

Why, you may ask, is any of this a problem for the average person? Well, why are gas prices so high?

In the past, capital would have flowed to traditional energy companies to fund profitable projects. With oil prices so high, there are plenty of projects to choose from. But these projects find themselves on the wrong side of this administration’s regulators and the ESG mob, so they don’t get funded. The result is less supply and higher prices.

The misallocation of capital leads to vital industries dying on the vine. This is not merely inflationary, but also a national security threat. We see

this playing out in Europe right now, their own early version of ESG having largely banished much-needed fossil fuels. When Russia invaded Ukraine, their moral assessment of fossil fuels and firearms flipped. There’s no consistency with ESG.

When power is centralised, society suffers. Pluralistic institutions like free capital markets protect us from the tyranny of elite power.

On the other side of the ledger, ESG leads to asset bubbles in favored industries. The resulting bursts harm us all, as we saw in 2008 when the federal government forced banks to provide mortgages to high-risk borrowers in the name of social justice. The resulting defaults nearly brought down our economy.

ESG also leads to just plain bad investing, where high ESG scores trump mundane concerns like balance sheets and income statements. Solyndra, anyone?

If you’re in a large pension plan, these mistakes are being made right now in your portfolio. You will see it in the form of lower returns, which we are witnessing in ESG funds this year. When entire industries — fossil fuels, tobacco, defence, etc. — are excluded from your portfolio, returns will naturally suffer.

A City of London fund manager told *The Light*: “The ESG scores are created by the Index providers, and MSCI is the most dominant in this space. Index Funds (run by the likes of BlackRock, Vanguard, etc) are all transitioning away from

typical passively managed funds to semi-passive funds utilising the ESG scoring system. They also use the Carbon Intensity score (CI) so that firms with high carbon emissions are omitted from the process. Generally speaking, asset managers utilise a quantitative approach whereby they will maximise the ESG score and minimise the CI score.

“This has ramifications because it means that firms are no longer looking to maximise returns for investors, but rather invest in companies that are politically correct. As Marlo Oaks eloquently puts it, ‘the political weaponisation of the corporate world.’”

There is no real transparency in how the scores are created, and given that asset managers tend to rely on these scores rather than their own in-house research, it is essentially ceding central control of a large part of the investment decision-making process to MSCI. Who at MSCI are making these decisions and what criteria are they using to determine whether a corporation is good or bad? Anyone with an ounce of common sense would realise that this is highly subjective and open to corruption (‘I’ll give you a backhander if you give me a better score’).

The performance of these ESG funds have underperformed the broader index (e.g. FTSE All-Share). Given that ESG funds command higher fees (around 0.1%) compared to a typical passively managed fund (0.02%), then everyone is laughing, except for the people who are actually invested in the funds.

Every single person who owns financial investments (actively or passively managed funds) needs to contact their manager and demand that they are not invested in ESG products. This is especially important for people who own pension funds because a large portion of their pension will now be allocated to these type of funds (the pension fund manager would have rubber stamped it with the investment manager without your consent). It is also important to note that that ESG is expanding into the fixed income space (corporate bonds) and not just confined to equities.

If enough people put pressure on their investment/pension managers, then maybe we have a chance of ending this.

# 5G ‘an experiment on the population’

Insurers fearful over potential claims for harm

**NO ONE can say 5G is safe and yet local councils are rolling out 5G throughout the UK and without public consultation or consent, while the UK Government recently launched the £1 billion shared rural network deal to build 5G throughout the countryside.**

This will relax planning laws for existing masts to upgrade to 5G and allow the increase in height of masts up to 25 metres, with new masts to be built to a maximum of 30 metres, along with a host of smaller masts up to six metres in height above buildings.

Councils are also encouraged to allow curbside infrastructure, such as antenna attached to lamp posts and bus shelters - and all without prior approval - to accelerate network upgrades with an aim to provide 5G coverage for the majority of the UK population by 2030.

The first study on the health effects of 5G by Professor Lennart Hardell and Mona Nilsson was published by the Swedish Radiation Protection Foundation on February 22, 2022. The study recorded a massive increase in radiation exposure levels resulting in immediate microwave sickness symptoms for residents living below the antenna.

Symptoms included fatigue, difficulty sleeping, nosebleeds, tinnitus, dizziness, skin problems, concentration problems, irritability, impaired short-term memory, confusion, depression, and heart palpitations.

The first cease and desist order was issued in April 2022 by the Board of Health, Pittsfield, MA. against a Verizon cell tower. Residents surrounding the tower suffered ill health shortly after the tower was activated in 2020.

Here in the UK, a landmark legal ruling in November 2021 took place at the Planning Court, Queen’s Bench Division, High Court of Justice, London, with campaigners successfully claiming against Brighton and Hove Council with Hutchison 3G as the interested party.

The Honourable Mr Justice Holgate overturned the local authority approval for the 5G mast to be sited close to a primary school. The ruling found that

the council “failed to address the health impacts” of the mast. The council was ordered to pay the claimants’ costs of £13,340. This finding has significant implications for all councils dealing with 5G applications - it means there is a legal responsibility to investigate effects on health.

Thousands of antennas and phone masts are still being deployed in heavily populated areas to advance ‘the internet of things’, allowing thousands of devices to connect to the network with a drive towards smart cities. The only safety compliance necessary, according to the UK government, is a statement that self-certifies that the International Commission on Non-Ionizing Radiation Protection (ICNIRP) guidelines are met.

The UK ICNIRP guidelines are based on the same principle as the U.S. standards and only protect against short-term heating effects of radiation and not the long-term biological effects. On August 13 last year in the U.S., Robert F Kennedy’s Children’s Health Defense (CHD) and the Environmental Health Trust successfully sued the Federal Communications Commission in an historic lawsuit against the FCC for ignoring 11,000 pages of scientific and medical evidence showing biological effects below the current guidelines, so we can no longer rely on industry assurances of safety.

Bioeffects have clearly been established to occur with very low exposure (non-thermal levels) to electromagnetic fields and radiofrequency radiation according to many doctors and scientists. The BioInitiative Working Group reviewed thousands of peer-reviewed scientific papers. This group of experts calls for the precautionary approach and urgent action due to chronic EMF-related diseases that are a potential risk for everyone.

These diseases include adverse effects on the central nervous system, cancer, both initiating and promoting effects, impairments of certain brain functions, loss of memory and cognitive function, infertility, and immune dysfunction.

Radiofrequency signals were classified as a possible human carcinogen in 2011 by the World Health Organisation International Agency for Research on Cancer. Evidence of increased cancer risks

has since been strengthened by further human studies, as well as toxicology studies in animals, which demonstrated clear evidence of tumours from the U.S. National Toxicology Program and the Italian Ramazzini Institute study.

The Science and Technology Options Assessment Committee of the European Parliament published a review in June 2021: “Health impact of 5G. Current state of knowledge of 5G-related carcinogenic and reproductive/developmental hazards as they emerge from epidemiological studies and in vivo experimental studies.”

The review of research calls for a halt to the expansion of 5G and should be a clear warning for policy makers to put the brakes on. No adequate studies

are available on 5G in the higher frequency range (24 to 100 Ghz). Therefore, the review describes 5G as ‘an experiment on the population’.

It’s worth noting that the \$21 billion reinsurance company Swiss Re Group, which is one of the world’s leading reinsurance providers, rated 5G as a ‘high impact’ liability risk, citing concerns about its biological effects, and potential claims for health impairments. Despite this, the government is racing ahead with 5G rollout and the involuntary irradiation of the whole UK population.

Local councillors may not be aware that they could potentially be held liable for any harms caused by the policies they enact according to a UK lawyer, and should therefore check

whether the council’s public liability insurance provides cover for adverse health effects caused by 5G.

# Blowing apart the climate agenda

PIERS CORBYN:  
CO2 levels being used as a weapon of control

**IN recent times the public consciousness has been flooded with myriad climate crisis information and a vague sense of impending doom from 'rising CO2 levels'.**

Controlled opposition groups such as Extinction Rebellion and Just Stop Oil continue to engage in divisive actions in order to sour public opinion and ripen them up to support more draconian laws, a strategy employed by the government in order to generate public consensus for the tightening of rules should a real uprising occur.

It can be hard for the majority of us to make sense of what is really going on in regard to climate change. At the base of it all is the government's drive for 'net zero' amid reports of CO2 damaging the climate, rising sea levels and alarming weather events, and there are attempts around the world to curtail us and make us poorer to pay for the measures. Not many readers will trust anything the government reports nowadays, so who better to ask for some scientific insight than a highly qualified meteorologist, physicist and seasoned campaigner, Corbyn?

When I meet with him he had just recently been thrown out of the Bloomberg Sustainability Business Summit in London, despite being a registered delegate. They accused him of having covid-19 without any proof and forcibly ejected him before Sadiq Khan took to the stage. Corbyn tells *The Light* he is used to attempts to silence him, but that this time was particularly aggressive. I tend to be of the opinion that if authorities are using that much effort to shut you down, there must be some truth in what you are saying.

What are the lies of the climate crisis? Piers elaborates: "In a nutshell the CO2 'climate emergency' story says that the trace gas CO2 (0.04% of air) is the main 'control knob' of weather extremes and climate, and that man's CO2 – 4% of 0.04% of the atmosphere – is a major dangerous factor in this. Therefore, the story

concludes, you must be taxed and controlled. Very convenient! The measures suggested will do nothing for the environment, in fact things that will help nature such as not cutting down trees are not even considered. The cost of everything is being pushed onto individuals, as well as an unnecessary guilt."

Here's Corbyn with a science lesson for us: "For the CO2 narrative to be true requires man's (4%) CO2 to control the rest of (96%) CO2 and for CO2 to be the main controller of temperature and climate. Both claims fail against science."

What about all the scientists who agree with climate change theory? "Well it is said to be 97% of scientists, but this was actually a survey of how many papers mentioned CO2, and when this figure was analysed by Dr Legates\*, it was found that only 0.3% actually supported the theory that is being used to make vast changes to our lives now.

"In the long run, CO2 levels are an effect, not a cause, of changes in temperatures. Sea temperatures rule CO2 as the oceans hold 50 times more CO2 than the atmosphere. If the sea warms, CO2 is released (like warming a glass of fizzy drink) and if it cools

it absorbs CO2 from the air. This happens on a daily/weekly/monthly/yearly basis and on average, CO2 in the whole atmosphere stays around for a few years before going back into the upper levels of the ocean or into the soil; CO2 levels in these relatively small changes lag behind temperature changes. On longer time scales, extra CO2 emitted from the sea surface gets swallowed up into the cold deep ocean by currents and emerges 500-800 years later in the air over the Pacific after a long deep sea trek. So, the amount of CO2 in the atmosphere, over the long run, is an effect, not a cause, of temperatures and lags behind the climate by about 500-800 years."

Interesting points that are more than worthy of further research and rumination. Many will ask why exactly this dramatic storyline is taking place.

Corbyn: "Corrupt scientists and fake data are being used. Power is being sought through control mechanisms. The World Economic Forum has been building up to this for a long time. There are four legs and a tail to the New World Order. The pandemic; the climate con which becomes almost religious and so can justify almost anything. The third and fourth legs are physical attacks, being the jabbing and the 5G. The tail is the digital identification system. We must break each one of these legs by resisting; for example, to resist digital ID we must keep cash."

No one wants to feel powerless in the face of such might being used to mislead us and deny our freedoms. So Corbyn explains: "We are all local leaders. We must build our own leaders up rather than rely on existing politicians or structures. We cannot continue to propagate the idea of main political parties having a monopoly of power. The state will resist, but in the process of this conflict new things will emerge from action on the ground.

"We are not like-minded people joining together, we are like-purposed people seeking to stop this agenda. Never forget that mass understanding of the big picture is how we will defeat the New World Order."

## BBC: Ministry of truth

**B**RITAIN  
**C**OMPLETELY

**OVER the past 40 years, the BBC has transformed itself from the most trusted news source in the world into the British Brainwashing Corporation. It has a clear left-wing agenda which it pushes remorselessly while still proclaiming its lack of bias.**

Its coverage of Brexit was a disgrace: a report, entitled 'Brussels Broadcasting Corporation?' published by think tank Civitas, in conjunction with News-Watch, monitored thousands of hours of television and radio shows, including the flagship Radio 4 programme *Today*. Of 4,275 guests on *Today* who discussed the EU between 2005 and 2015, only 132 (or 3.2%) were Brexiteers. The BBC became the propaganda arm of the EU.

In 2019, the BBC spearheaded the creation of the Trusted News Initiative (TNI), together with news and media organisations including Google, Facebook, Twitter, the *Financial Times* and the *New York Times*. The TNI was ostensibly established to protect audiences from 'disinformation which threatens human life or disrupts democracy during elections'. The participants would make interventions 'to address misinformation across the media landscape'.

On the face of it, these were noble intentions, but since the fake pandemic these interventions have mutated from exposure of fake news to repression of free speech. The truth has become whatever the BBC says it is, and so it censors information it finds unpalatable, all the while continuing to proclaim its lack of bias.

There is now total censorship of all information that deviates from the agenda of the public health agencies. For example, Anthony Fauci, chief medical adviser to the U.S. President, concluded that there was no evidence to support the claim that ivermectin was effective against covid-19. But, as documented on [ivmmeta.com](http://ivmmeta.com), there are over 70 studies pointing to ivermectin's efficacy at reducing mortality and hospitalisation.

These include 31 randomised controlled trials, 7 meta-analyses, 32 observational controlled trials, multiple country case studies, expert opinion and patient testimony, all in favour of the medication. The BBC ignored this and has campaigned to undermine the

use of ivermectin saying that there is 'insufficient evidence' to recommend it.

The TNI's official line is that the project would not prevent "legitimate concerns" about vaccines being aired, but would attempt to stop "harmful disinformation myths". However in practice, the legitimate concerns of respected doctors, scientists and researchers are not permitted to be aired. When a founder of the mRNA technology, Dr Robert Malone, is censored and his videos removed, the TNI organisations are doing exactly what they said they would not do. What distinguishes the BBC from the other TNI organisations is that I and all other licence payers are forced to finance its deceit under threat of a criminal record.

So what's to be done? I have taken to complaining to the BBC whenever I notice prejudice in its reporting, either in what it says or what it omits. For example, in the summer of 2021, I participated in one of many Freedom Marches through central London together with hundreds of thousands of others. There was not a mention of this in that evening's BBC television news which did, however, cover a much smaller pro-Palestinian rally on the same day (a cause the BBC favours). In responding to my complaint about this, the BBC's defence was that it did not have time in its bulletins to report on all news stories of the day. I pointed out that in the early evening bulletin that day it had found time to report that Tom Cruise had donated one of his jumpers to a charitable cause. In response to this they could only repeat their 'lack of time' excuse.

I do not fool myself that my complaints will achieve anything apart from venting my frustration and anger at an organisation I used to admire. And, of course, the BBC will not admit it is wrong. But if, instead of one complaint, every lie, distortion and blatant omission generates a thousand, then, at the very least, this will cause the BBC considerable inconvenience. They aim to respond to complaints within a fortnight so it would force them to hire additional staff to deal with the volume of complaints, which would also appear in the official figures on customer dissatisfaction.

# Psychological manipulation of health staff by ‘charity’

**A FORMER government advisor has given a terrifying insight into how a pandemic of bullying and fear has taken hold in the health service resulting in catastrophic failures, manipulation of staff and alarming patient abuse.**

Debbie Evans, who worked at the Department of Health, began to investigate the activities of a charity called Common Purpose, which had come onto our radar here at UK Column.

We were interested in exploring how this so-called charity became involved in selecting future health service managers and witnessed firsthand the manipulation of people and their values, which were morphed into a specific sector of the health service called NHS Leaders. These supposedly were fast-tracked people who were going to lead the NHS into even better healthcare.

As these leaders with their newly acquired values were unleashed, the management style in the NHS became increasingly domineering and bullying. The ideas became less and less about the care and treatment of people who were ill or injured, and it became much more about the importance of profits and money within the NHS. It was apparent that the psychology of people was being manipulated.

The UK Column website has an article entitled *Towards a Million Change Agents*. That was a paper written by an NHS Common Purpose-trained individual who said that in order to reach a future utopia, the NHS was going to need a million change agents.

They mean people who are going to disrupt the performance of the NHS in order to get it to transition, to transform into what was supposed to be a world class health provision.

These people were installing themselves in UK cities, effectively taking control of politics within those cities. Within a few years, that organisation was operating overseas in countries like Germany, Holland, India and Australia, where they were recruiting people to bring them within an agenda of change agents, to change the way we think and conduct our business in society.

This organisation was started in about 1985 when the chief executive

Julia Middleton said she learned some amazing things about how to change society in the U.S. Common Purpose was funded by major banks that were never disclosed but a leak showed Deutsche Bank was one of them. This was a key example of an organisation

you couldn't track. You couldn't see the documents, you couldn't see the people, and you couldn't see that it was unleashing a plan to change our society without the average member of the public understanding this.

An example of applied psychology during the covid crisis is that mantras were introduced in the NHS. Nurses and doctors started to follow them instead of medical decisions. A highly qualified doctor told us that when an unvaccinated covid patient came in, the mantra was: 'Covid unvaccinated death pathway, covid unvaccinated death pathway'.

These mantras have been driven through the NHS to the extent that doctors told us they cannot discuss genuine government figures on vaccine adverse reactions because the person simply turns away, refuses

to talk to them or becomes very aggressive. They are witnessing cognitive dissonance in individuals, which is the result of their mental values being reframed.

We are certainly seeing the application of psychology in many



areas in the NHS, and its overall effect is a degradation of healthcare treatment to the extent that people are being killed, when they could have survived quite happily had they been given the right treatment.

What we've got unleashed on us now is a subliminal attack on our minds. And until we bring the full light to this, it's going to be very, very difficult for us to take the lid off what these people are doing through their covid and vaccination attack on people. Each of the pharmaceutical companies has access to this psychological weapon. Each of the law firms and NGOs.

Everywhere we see charities, industry and public bodies working with the British government, we know that the use of the psychology is shared between them.

A well-qualified psychologist said to me: "People who are intelligent and have highly questioning minds can be more susceptible to the use of hypnosis, reframing, and applied psychology than somebody who is less intelligent and has less of an enquiring mind."

It is very wrong if anybody thinks, 'Well, I'm a bright person, I'm intelligent, I'm highly qualified. This wouldn't affect me'. On the contrary, you may be more vulnerable. There are NHS professionals that I'm speaking to that are completely confused. They're having a cascade of information every single day. Things are changing. They don't know why.

"I am seeing NHS professionals doing things that would be completely alien to them: 'I'm giving respiratory depressants to respiratory patients'. It's just alien to what we have been taught. So, people are frightened. What we are seeing is a political system integrated with huge commercial companies, pharmaceutical companies unleashing an agenda which has been to test vaccines on a population without any care for the damage and the dying."

People who have been subjected to this form of reframing or mind manipulation are victims, and therefore need to be treated in a very gentle and reassuring way.

Because if we come at them in a blunt way to try and make them see the truth, the result is that either they

become very hostile – with cognitive dissonance – or possibly they're going to become mentally unwell as a result of the immense assault on their value system.

It is very significant that in all the documentation about the British Government's use of applied psychology to get its political agenda enacted, there is absolutely no assessment of what the adverse effects of such psychology may be on people who perhaps have underlying mental health issues, anxiety, or depression.

Indeed, where people have got undiagnosed mental health conditions - so they're not even aware that they've got a problem - when somebody is using this psychology on them, you can do immense damage. And I believe it is no coincidence that the official statistics in UK now show that the lockdown policy has caused a huge surge in suicides and mental illness, and particularly tragically, amongst young people.

But again, we can demonstrate that the UK government is hiding or manipulating the data sets that show this, or they're using applied psychology in the way they present those data sets to the public in order to further mislead us.

# Vaccine harassment is backfiring

**A FRIEND recently texted me in some distress; she and her husband were being pestered and harassed by the NHS over vaccines. She has a pile of NHS appointment letters, ranging from covid booster reminders for her husband to scheduling flu vaccinations for her children, and her youngest's pre-school booster.**

Her phone pings almost daily with NHS alerts and reminders. "We are reasonable people, but we feel pursued in a way that has damaged our confidence in the credibility of medical services", she told *The Light*.

She also recounts how some friends have been similarly pestered, writing of her disgust at the use of the so-called family services to act as the salespeople for pharmaceutical and state interests – with health visitors routinely alerting the NHS about children not being up-to-date with their vaccinations.

Are these happenings straws in the wind of a wider change in society, with Big Pharma and the state having drastically overreached themselves with the experimental gene therapy injection masquerading as a vaccine? With more families now being healthily sceptical about the efficacy of vaccines more generally, we can

expect such panicked NHS bullying tactics to escalate.

An enormous pile of literature exists that comprehensively deconstructs the junk, zombie science underpinning vaccine-centred public health discourse. No wonder Robert Kennedy Jr. said the following in a recent interview with journalist Tucker Carlson: "None of the 72 vaccines that are currently mandated for our [U.S.] children has been safety tested against a placebo in pre-clinical trials." Certainly, anyone who has read Kennedy's spellbinding book *The Real Anthony Fauci* must end up with the view that genuine scientific truth just doesn't matter any more, as an all-powerful Big Pharma, along with its Big Tech side-kicks, has completely captured modern culture, science and politics.

There are signs that public opinion

is indeed shifting on the vaccines question. That figure is down from 59 per cent supporting such a requirement in 2015. And even more tellingly, 28

per cent of adults now think Iowa should have no law on childhood vaccinations – up from just 16 per cent in 2015.

If these are indeed straws in the wind presaging a major cultural shift in vaccine-confidence levels across the world, it's looking as if the covid jab may well prove to have been a massive own goal for Big Pharma – and a nightmare for the World Economic Forum and Bill

Gates, determined as they are to vax the world's population continually.

Perhaps, for once, Gates recently spouted some sense, when he said in November 2021 in a Bloomberg Forum, speaking of the covid jab: "Statistically we didn't do as well as I would have expected... [You could almost say that] the politicisation of taking vaccines... has been a step backwards. I hope vaccine acceptance for other diseases like measles is not reduced by this" – with the fringe minority of anti-vaxxers that existed before the covid vaccine having been transformed into what Gates himself now terms a 'meaningful minority'.

Del Bigtree, speaking on March 24 said, "they have failed in the greatest possible way: they took what was about a 90 per cent vaccine confidence in the USA and have reduced it to below 50 per cent." Despite the CDC's official recommendation for all Americans to get the third booster jab, only 28 per cent have taken it, as of March 2022. So Gates' meaningful minority has become a clear majority – at least in the USA. Keep up the great work, Mr Gates.

As the mass-vax junk-science ideology continues to unravel and disintegrate, just watch the NHS vaxxer pressure and harassment escalate. Those who embrace natural immunity and bodily autonomy, and who eschew a fear-saturated approach to nature, must and will stand strong against it.

# Robbing Paddy to house Petruso

John Waters on why we must resist the Regime's plans to remove our right to private property

**THE government's latest attack on the God-given freedoms of the Irish people involves a threat to seize their private property rights, the ultimate objective of Communism.**

Spearheaded by the contrived Ukraine 'refugee crisis,' they seek to justify this theft using the mysterious 'housing emergency' that has persisted in Ireland for a decade and has been caused by the massive levels of immigration orchestrated surreptitiously by the State.

In all that time, four successive governments have implacably ignored the plight of thousands of Irish citizens unable to acquire homes of their own.

On the one hand, the utterly corrupt FF/FG/Green Regime, which exists purely to carry out the instructions of the external New World Order combine who seek to dispossess the earth's population of freedoms, belongings and way of life, has said that it plans to hold a referendum later this year on the right to private property.

On the other, it's sending out its skills to loudly claim that the existing constitutional position allows it to seize people's homes, houses and other property by force, as per the statement of the Minister for 'Justice,' Helen McEntee shortly after Easter.

But, if they are already permitted to do this why is there any need for a referendum?

The public should be in no doubt that, like the referendums of 2012, 2015 and 2018, this one will be an outright mockery of the democratic process, accompanied by grotesque abuses of the electoral process and the rules concerning balance and fairness in media coverage.

The half-million unaccounted-for votes that were found to be on the electoral register in early 2016 have still not been investigated, and nor has any more recent accounting provided a more reassuring picture. Indeed, it is likely that the register has since been augmented with possibly hundreds of thousands of illegally declared new 'citizens' — recently arrived migrants — with no legitimate claim to a say in the running of Irish affairs. These abuses will inevitably be aided by the usual torrents of propaganda and abuse of process by the bought-and-paid-for media, in the manner of the Covid deception of the past two years.

Overwhelmingly, for obvious reasons, it is the native population of Ireland who are the owners of property



and resources, and most of those who have arrived here in the past two decades are not, which means that these additional numbers of illegitimate voters will be able to vote to restrict the property rights of the indigenous population.

While it is true that the Constitution permits the State to expropriate or confiscate private property in certain circumstances, (the 'common good' and 'social justice' are indeed the main qualifiers on such rights as things stand), the idea that the influx of Ukrainian refugees self-evidently fulfils the required criteria is a puerile interpretation based on propaganda. There are many disquieting aspects of what is happening in this context, notwithstanding the continuing corrupt coverage of these matters by the mainstream media. It has already emerged via alternative media that many of those arriving, allegedly from Ukraine, come from multiple other locations. In other words, their claims to refugee status are fraudulent. There is no evidence of any vetting process to offset these abuses. Nor is there any attempt to screen arrivals on the basis that the fighting in Ukraine is overwhelmingly in the east of that country, or to ask why many of these alleged refugees could not be accommodated in the conflict-free western parts. It is furthermore

disquieting that most new arrivals are, as per usual, males of military age.

Moreover, the decision of the Irish Government to accept unlimited numbers of such 'refugees' was taken without reference to the Irish people who stand to be profoundly affected by it. By the end of April, Ireland had already taken in 25,000 'refugees' under this heading, whereas the UK, a significantly larger country and economy, had accepted just 1,200.

The idea that the State already has the power to seize private property in all circumstances is entirely bogus. While the corrupt political establishment of the moment is well capable of theft and fraud, there is no precedent in any of the key legal textbooks for anything remotely like what is being proposed. The premier constitutional guide, J.M. Kelly's *The Irish Constitution*, records no cases of dispute concerning domestic situations — for example, family homes or second homes. Some such properties will undoubtedly have been implicated in CPO (Compulsory Purchase Order) disputes, but the indicators are that these were resolved under the heading of compensation and so did not end up in court. Most of the cases which have arisen under this heading were concerned with planning or business disputes, or technical aspects of related questions: land valuation, rent controls,

taxation, vehicle seizure, pension rights of convicted persons, competition issues, and so forth. Many cases, it is true, related to CPOs sought by State authorities for some planning-related purpose said to be in the public interest, but these did not relate to the dwelling places of citizens, and generally speaking tended to be upheld by the courts. What we face at the present moment is of an entirely more disturbing character.

The typical line coming across in the media is that the Government can do what it pleases, since the Oireachtas has the power, under Article 43, to 'delimit' property rights according to the 'exigencies of the common good' and the imperatives of 'social justice.'

This has never been tested in circumstances such as we now face, where manifestly rank injustice is threatened against the native population — robbing Paddy to house Petruso, or enabling impecunious outsiders to arrive in Ireland and vote to dispossess the natives to enrich themselves.

Leaving aside what terms like 'the common good' and 'social justice' might mean in law (this never appears to have been definitively dealt with or stated by a court) it is clear that there is a difference between 'personal' property rights and the generic, business-related kind with which

the courts tended to deal — cases involving, CPOs, taxation issues, etc. So, while Article 43, as stated, appears to be heavily qualified by social considerations, a primary reference in the personal rights section of Article 40 refers specifically to property rights and requires the State 'by its laws' to protect them 'as best it may from unjust attack and, in the case of injustice done, to vindicate.'

This is the reason the Government is pursuing the precautionary measure of a referendum: It knows that the ground under its feet is not as solid as it tries to suggest.

The legal skills coming out to bat for the Government have unsurprisingly not been going into these complexities or possibilities. The usual spin is that, after a brief period of pro-property thinking in the 1980s/1990s, the courts fell into a more 'common good'-oriented perspective, emphasising the qualifiers in Article 43, which in various cases over the decades resulted in individuals trying to fight CPOs getting short shrift from the courts. These skills do not mention Article 40, and there is no suggestion in anything they say of any degree of differentiation with regard to categories of property rights attracting stronger protection by virtue of this provision.

The above reading of the situation ought certainly offer some reassurance to people who are at present terrified by interventions such as the recent threat by the Minister for 'Justice' that there still exists within the Constitution protection for such as an old person whose home might be adjudged by State agencies to be too large for that person's sole use, and thereby subject to a CPO, with the individual in question carted off to a nursing home. It is conceivable also that such a protection might be extended to a family with a second home which they use intermittently through the year, rendering both properties immune from any expropriation in the claimed interest of 'social justice.'

This window of possible fairness is what the Government will be targeting in its corrupt referendum. The tactics will be to try to browbeat and bamboozle the electorate with moral blackmail and pseudo-legalisms, while at the same time implying that the referendum is a mere technicality that will make no difference, and that Ireland's reputation as 'a compassionate country' is at stake.

These tactics need to be resisted in the most precise, unyielding and comprehensive terms, because the alternative is not simply that the Irish will soon become a minority in their own land (now virtually certain within little more than a decade) but that they will be the actual sole and least regarded dispossessed minority in a country that will belong to everyone but its indigenous population.



# Mask microplastics found deep in lungs

**MICROPLASTIC fibres used in masks have been found deep in the lower lungs of living human beings in almost every person sampled in a recent study by scientists at Hull York Medical School in the UK.**

The study discovered microplastic particles – present in many Covid masks – in the lung tissue of 11 out of 13 patients undergoing surgery.

Polypropylene (“PP”) and polyethylene terephthalate (“PET”) were the most prevalent substances present in the lungs.

Some of the microscopic plastic fragments and fibres discovered – in patients undergoing surgery whose lung tissue they sampled – were two millimetres long.

The research used samples of healthy lung tissue from next to the lung region targeted for surgery. It analysed particles

as small as 0.003mm in size and used spectroscopy to identify plastic types. It also used control samples to account for the level of background contamination.

The plastic dust and microscopic debris comprise the same plastics used to manufacture the ubiquitous surgical masks worn by hundreds of millions of people around the world as mandated by governments to halt the Covid “pandemic.”

The material most commonly used to make these masks is PP. PP fabric is made from a ‘thermoplastic’ polymer, meaning that it’s easy to work with and shape at high temperatures.

Blue surgical masks can also be made of polystyrene, polycarbonate, polyethylene, or polyester, all of which are types of fabrics derived from thermoplastic polymers.

Disposable blue masks continue to litter every street in Ireland as terrified

people continue to wear them.

Microplastics were also detected in human blood in March 2022, showing the particles can travel around the human body and may become embedded in organs. The impact on health is still to be determined.

“Our study is the first indication that we have polymer particles in our blood – it’s a breakthrough result,” said Prof Dick Vethaak, an ecotoxicologist at Vrije Universiteit Amsterdam in the Netherlands. “We also know in general that babies and young children are more vulnerable to chemical and particle exposure,” he said. “That worries me a lot.”

A study from 2020 also found that wearing masks poses microplastic inhalation risk and reusing them increases the danger.

# Freedom of speech - jailed for old Facebook comments

Whereas it is most apparent, that the Multitude of Coffee-Houses of late years set up and kept within this Kingdom . . . have produced very evil and dangerous effects...for that in such Houses, and by occasion of the meetings of such persons therein, diverse False, Malitious and Scandalous Reports are devised and spread abroad, to the Defamation of His Majesties Government

(Proclamation for the Suppression of Coffee-Houses 1676 published in The London Gazette)

After less than 2 weeks the king was forced to retract the proclamation due to the public outcry at this blatant attempt by the government to take

away the right of freedom of speech. Free and unfettered speech is always a danger to governments who infringe on the rights of the people as it is known that open rebellion is never far away when the people become aware of their mistreatment.

As many are aware we are facing a crisis of freedom of speech today all across the world. As well as the social media bans, the hounding of alternative voices from the legacy and failing mainstream media, the lost jobs from those who say the wrong thing, the liberticidal legislation being pushed through parliaments worldwide, we are now seeing worrying examples of people being imprisoned due to so called ‘hate speech’.

On Friday 14th January 2022 Tahra Ahmed was convicted of ‘incitement to stir up racial hatred’ at the Old Bailey in London. Dominic Kennedy writing for The Times newspaper brought to light 2 Facebook comments from 2017 that Tahra made. On the basis of said comments the campaign against antisemitism brought the charge to the court. This being the first case of its kind in the court, which is normally concerned with the crimes of murder and rape, it was assumed by many that the case would be

thrown out. Indeed, two doctors’ letters had been sent to the judge explaining that Tahra was not fit to stand trial as she was suffering from post-traumatic stress disorder on account of the tortuous actions she had faced from the Metropolitan Police during her 6-day long unlawful detention. Due to the pain of her ribcage being crushed when police had held up her handcuffed hands behind her back she had blacked out and awoken to the smell of her own vomit and with policemen and women laughing at her predicament. Yet these letters were ignored by the judge and the sham trial went ahead. On 11th February 2022 she received concurrent custodial sentences of 11 months and 6 months.

At the time of writing (7.4.22) Tahra is currently confined at HMP Downview, having served over 6 weeks of her sentence at another site: HMP Bronefield. Tahra has been surprised to find that one inmate convicted of selling drugs is serving a smaller sentence with a strong chance of early release; something Tahra is not eligible for as she is considered a ‘danger to the public...?’ Such is the state of justice in Great Britain in 2022.

The precedent which has been set should be of concern to all that live in the UK. How many comedians could potentially be brought to court over thought crimes such as this one?

This is not the first time the campaign against antisemitism has caused a stir. It was this very same group who made efforts to bring down Jeremy Corbyn and many of his socialist allies in the Labour Party in 2017/18. Despite the inconvenient fact that many of the prominent Labour voices had made no anti-semitic statements the mainstream media plastered their columns for months with opinion pieces claiming Corbyn and his allies were anti-semitic racists and the damage was done. Could this be due to Corbyn’s interest in the rights of the Palestinians? This is an issue that Tahra Ahmed also feels strongly about. It is an issue that will never be given the attention it deserves.

Is there a future for freedom of speech in the UK? It seems that many politicians, journalists and commentators have not understood the difference between agreeing with what someone says and defending their right to say it. The removal of freedom of speech is one of the first steps which has always marked the beginning of historical authoritarian regimes. Now more than ever, it is incumbent upon and informed citizenry to speak out against this encroaching authoritarianism.

But what about anti-semitism? Having experienced this myself (I am in fact a London-born Jew) anti-semitism is indeed nasty and difficult to face. But how will we deal with it?

Suppress it and push it underground? Or face it head on? The beauty of freedom of speech is that it incorrect ideas to be challenged. If it were somehow to be ‘the Jews’ who were behind the Great Reset scam, why then are the Israeli population one of the most vaccinated, sick and oppressed nations today? Points such as this are what will begin to help those with prejudiced minds to re-consider their viewpoint.

Whatever your thoughts on the concept of freedom of speech, the evidence that this is a political stitch up is compelling. In 2020 and 2021 Tahra confronted senior police constables and explained that she would hold any policeman or woman personally liable in a court of law for any unlawful behaviour against freedom protesters. **I HAVE spent over thirty years working in or studying the logistics industry and all I can really say is that we do live in interesting times.**

As you might have noticed, there appears to be a concentrated effort to disrupt the supply chain in all areas of commerce.

Though the price of fuel in the UK is at record levels, the real shocks are still to come. Talking to a local arable farmer the other evening, he casually mentioned that his main tractor used to cost just under £600 to fill two months ago; it is now over a £1000. That increase in costs is going to be passed onto the consumer. He is confidently predicting a £5 loaf of bread by the end of the summer.

Russia has deemed the UK a hostile nation so do you think we are going to be first in the queue for anything? Russia supplies a third of the UK daily diesel usage. In retaliation we are stopping the export of luxury cars to Russia. That will get Putin's tanks back in the shed.

I don't need to remind the reader that Russia and the Ukraine are responsible for 25 per cent of the world's grain exports. Currently there are no cargo ships collecting anything from the Black Sea ports. Russia is also a major producer of fertiliser products and one of its major customers is Brazil, another major exporter of grain-based products.

In just the last week the main Taiwan food distribution hub caught fire, as did a major hub for Walmart and dozens of other meat processing plants in the U.S.

We all know there is shortage of semiconductors on the market; Ukraine is a major supplier of the gases that are used in the manufacture of those chips.

Closer to home, the Spanish truck drivers' strike is growing in intensity and has been in effect for a week (Sunday 20/3/22). This is closing down horticulture, fishing and industry across Spain.

In France, the Gilets Jaunes are blockading targeted fuel depots. Then to cap an interesting week in European

Poland is restricting diesel sales to hauliers. A UK haulier had to send trucks back to Germany to fuel, due to the lack of diesel in Poland.

So, in just one week the UK supply chain for all products from Europe is compromised and fresh food is especially compromised. As Ian Fleming once wrote 'once is unfortunate, twice is a coincidence, three times is enemy action...'

So what can be done? A return to common sense and everything calms down but after two years of the Corona Crazyness that is extremely unlikely to happen.

We take off our tinfoil hats and think 'oh bothers, we were right' and wish we had been wrong and go back to moaning on social media and sending witty memes to each other.

Now the American version of this is essentially Band-Aids, beans and

bullets. While the British version now seems to be booze, sausage rolls and bog rolls.

Once you have that what else? How do you plan for a complete breakdown of the existing supply chain? Is it even possible you can make a plan for such a series of events?

Well maybe some parts of it that

which had been very well stocked throughout the Corona Carry-On, now has gardening items on the food shelves, slug pellets and lawn feed.

*Then analyse.*

Do I have enough of X to ensure Y? Quite simply, think of items other than food and water.

Can I service my car/van next

might help lessen the impact.

*In all problems, observe.*

Look at supply-chain blogs, free logistics newsletters and see where real problems are. See what the industry is complaining about and what it is short of.

Use maritime trackers to see which ports are congested. Use aircraft trackers to see where the actual no-fly zones are and how air freight is being disrupted.

All this information is freely available on the internet and in real time. Once you have this data, apply it in your local area. What's missing in the supermarket? How much stock is on the shelves? How long until that item could be replenished? Who is complaining about local shortages of raw materials? Why is that factory not producing x, y, or z, etc.?

A local discount store this week

year? Are the tyres better than minimum? Do I have a spare inner tube for my pushbike? Do I have a spare wheel for it when it buckles? A lot of the components for bicycles are manufactured in China. Do not rely on next-day availability from the internet to keep yourself mobile or your home viable.

Do I have space to create a garden? If no space outside, a window ledge with leafy greens or a small indoor potato grow kit will do.

One of the things I am helping promote locally is a version of Guerrilla Gardening where those with spare garden space, usually due to age, can be put in touch with those with enthusiasm but no garden space and personal, local agreements made to create vegetable gardens which benefit both parties.

Find local suppliers to main

supermarkets, major retailers and use these local suppliers as much as finances and practicality allow.

Is it possible to do jobs for next winter now? Obtain next winter's fuel at today's prices and store it safely?

Chop some wood if you are lucky enough to have a real fire or a log burner this spring for next winter.

Do you have some seeds that you could garden with in spring 2023?

At the end of this summer plant some winter crops for winter 2022 – 23.

Please remember, before the internet we had books, find some how to guides now, especially in charity shops.

What alternative energy can you use? Even if you live in a flat a camping solar panel can power a light or a phone.

*Then implement your plan*

Doing something is positive; even half a plan is better than no plan.

Watching the world this week was quite soul-destroying. So, I cleaned up some Brussel sprouts and turnips, parboiled them, cooled and then put in the freezer for soup next winter. Changed nothing in the world but my mood.

However, do expect Russia and China to create a new currency backed by commodities, and not a fiat-based system. Saudi Arabia is selling oil to China for Chinese Yuan and not the American Dollar. Russia and China are already trading in oil and gas and as have Iran been for many years.

Russia has already concluded trade and defence deals with Saudi Arabia, Nigeria and India. In my opinion, the petro-dollar has begun its decline as a reserve currency for the rest of the world.

In the last week, India has announced it is looking at the finer details of the new Russia-China currency.

# World Health Organisation plans worldwide power grab

Proposed WHO framework would deny everyone in the world bodily autonomy

**BACK in December 2021, the World Health Assembly (WHA) adopted a decision entitled ‘The World Together: Establishment of an intergovernmental negotiating body to strengthen pandemic prevention, preparedness and response’.**

According to the EU, the proposed ‘Pandemic Treaty’ is a ‘legally-binding framework, aiming to ensure that the world can better respond to global health threats in the future.’ The WHA is the main governing body of the World Health Organisation, comprised of 194 member states including the UK and Ireland.

Lotte Knudsen, EU ambassador to the UN, claimed such a Treaty would allow countries to respond ‘collectively, effectively and immediately’ to future pandemics, and those words may send a chill through anyone who is aware of encroaching globalisation and potential impending loss of individual power.

The adoption of a WHO worldwide pandemic treaty would be an unprecedented step towards a centralisation of authority. This would inevitably lead to authoritarian approaches with private ‘interests’ involved, damaging not only to health but also to our democratic freedoms and values. German MEP Christine Anderson has spoken out against the WHO Pandemic Treaty which she accurately sums up as ‘a direct attack on the rule of the people by the people’.

The Pandemic Treaty would be tied into the WHO’s QR Verification Code project, intent upon creating a global digital data bank of eight billion people and currently under design by T-Systems, a company previously tainted by involvement in a corruption scandal in 2011.

This technocratic treaty will be put to the next World Health Assembly in Geneva in 2023, and voted on in 2024 - with the WHO themselves having stated that they ‘could accelerate this timescale if a new health emergency is declared’.

Countries such as Ireland and Germany have indicated they will sign up for this, but in one example of a strike back, the sovereign people of Ireland have begun a popular online campaign for a referendum (you can visit Lawyers for Justice Ireland on Facebook for more information). Unsurprisingly, Russia and Brazil have been the only two countries to express “scepticism”. Readers may be well advised to help or create pressure groups opposing this treaty as it is an attack on freedom of movement, bodily autonomy, sovereignty of our land, our digital and personal data and so much more.

Essentially, the threat will tie us all into the ‘data twin’ in a digitally controlled world, for which the infrastructure is already taking shape at speed. It leaves us open to having our rights stolen at the touch of a ‘covid’ or other hyperbole-themed button. Personal rejection of our own digitalisation and refusal to download apps or even own a smartphone are continuing actions to take to slow the speed of these technocratic control systems.

We are living in a situation where the Director General of the WHO recently thanked Bill Gates for sending a copy of his new book and openly claimed that he fully agrees ‘we must act on covid-19’s lessons so that we can deliver swift, equitable health solutions to prevent the next pandemic’. The Bill and Melinda Gates Foundation is the second largest donator to the WHO and the largest private contributor, donating to the tune of \$1 billion last year. It is no longer seen as a conspiracy theory to deduce that the New World Order is indeed working through the guise of the pandemic, with covid-19 as a tool to oppress freedom on every level.

The WHO treaty will tie all nations into obeying whenever a pandemic is arbitrarily declared - meaning lockdowns, enforced vaccination (WHO states a target of a minimum 70 per cent of the total population) and the censoring of

information that can be declared as disinformation if it goes against the programme.

In the UK, we lived through the pain and economic hits when the fake pandemic was declared and we watched as many succumbed to ‘following orders’ as politicians assured them it was ‘to save lives’, using behavioural psychology

models to hypnotise a major section of the population.

Covid-19 emergency legislation was implemented but as of the publication of this article, a Freedom of Information request on what remains law has not yet been answered.

What is clear is that across the world, countries have operated in tandem. It is difficult not to argue that the nation state is no longer in control and that almost all nations are following a protocol to usher in world governmental rule (even when some seem to be playing as a rogue state). Although individual countries such as Australia, New Zealand, Israel and of course China implemented even more draconian rules than the UK, we would surely be under an extremely rigid pressure from a legally binding international treaty as currently proposed by the WHA/WHO.

The WHO opened a public participation portal for feedback, but they, ‘our government’ and the media have done little to publicise it. Their website was flooded with traffic despite the covert nature of the launch, and Canadian journalist Kean Bexte tweeted that the

site crashed due to the volume of submissions by concerned people. The consultation quietly closed on April 13, and it never asked the people if they wanted a treaty, but instead simply enquired as to what they believed it should contain.

That’s why it’s so important right now to research further on this matter, start spreading the word and lobbying. It would appear that the UK is not at this moment pursuing a covid agenda, and has switched the focus and the minds of the masses to the Ukraine and Boris Johnson’s Prime Ministerial tenure; in the background the wheels of totalitarianism are still turning.

Do we want to give up further freedoms without a fight? When the world of full digital ID and the total control of individual countries by the WHO/WHA is looming, what will you tell your children if you don’t oppose it? The planned Great Reset must become our Great Resist and for that we need a Great Awakening.

# Ukrainian president causes uproar in Greece over Neo-Nazi fighter appearance

**Ukrainian President Volodymyr Zelensky's recent address to the Greek Parliament was overshadowed and darkened by the presence of members of the controversial Azov regiment.**

President Zelensky has been regularly addressing globalist leaders and institutions in seeking support for the complex situation in Ukraine. The leader of Ukraine has also bizarrely spoken via video link at the recent Grammy music awards.

In a video address to the Greek Parliament, Zelensky allowed a video message from two ethnic-Greek Ukrainians who are members of the ultra-nationalist Azov Battalion.

Syriza leader and former Prime Minister Alexis Tsipras reacted on Facebook by stating: "The speech by members of the neo-Nazi Azov Battalion in the Greek Parliament is a provocation. But the Nazis cannot have a say in our Parliament."

Former Foreign Affairs Minister, Nikos Kotzias, was also angered by seeing members of the Azov Battalion and said: "The Greek government irresponsibly undermined the struggle of the Ukrainian people, by giving the



floor to a Nazi. The responsibilities are heavy. The government should publish a detailed report of the preparation and contacts for the event."

Recently in March, Zelensky banned eleven main opposition political parties in Ukraine including the second-most popular party, the Opposition Platform for Life party (OPZZh). In the 2019 Ukrainian elections, the OPZZh won 13% of the national vote. In 2021, Zelensky signed decrees banning

opposition media and TV outlets with pro-Russian stances.

Links to a questionable militia group and banning opposition political parties and media outlets is not the picture of a free and democratic country that Ukraine and global leaders like to continually portray to the world through their lackey media mouthpieces.

## New Zealand

**HIGH Court in New Zealand rules against vaccine mandates for police and defence staff.**

Police staff and defence forces in New Zealand have bravely stood up to a draconian government order requiring them to have two covid jabs by March 1, or face losing their jobs.

Three courageous unvaccinated staff, supported by 37 colleagues, challenged the order and sought a judicial review based on the right to decline a medical procedure and the right to religious freedom. Written affidavits were submitted to the High Court.

The High Court rightfully overturned the discriminatory mandate and deemed it unlawful. Justice Francis Cooke said: "The order limits the right to be free to refuse medical treatment recognised by the *New Zealand Bill of Rights Act* (including because of its limitation on people's right to remain employed), and it limits the right to manifest religious

beliefs for those who decline to be vaccinated because the vaccine has been tested on cells derived from a human foetus which is contrary to their religious beliefs."

The *New Zealand Herald* reported: "The lawyer for the police and Defence staff at the centre of the claim is now calling for the suspended workers to return to their jobs immediately, saying many have given decades of service to their community and are still committed to their jobs."

Like a lot of world leaders, New Zealand Prime Minister and World Economic Forum plant, Jacinda Ardern, does not respect the will of the people and the law. The government in New Zealand have now filed an appeal against the High Court decision.

Ardern may have had a stranglehold on New Zealanders for a long time, but it is refreshing to see some Kiwis take back control from her dictatorship.



## Scotland Loch Ness

Loch Ness monster considered an 'anti-Scottish' imperialistic symbol according to new school curriculum

My advice to teachers is to use the Nessie Plan itself as an example of how bias is used by educators."

Local tourism business owner, Willie Cameron, also affectionately known as 'Mr Loch Ness', optimistically told the *Inverness Courier* newspaper: "There is no such thing as bad publicity as far as Loch Ness is concerned. # MEPs roast Trudeau on visit to Brussels

**TWO Members of the European Parliament (MEPs) from Germany and Croatia gave a frosty reception to Canadian Prime Minister Justin Trudeau over his disgraceful and unforgivable handling of the freedom loving truckers' protest in Ottawa.**

accounts of single parents so they can't even pay for their children's education and medicine. So that they can't pay utilities or mortgages for their homes."

Kolakusic finished by stating: "To you, these may be liberal methods. But for many citizens of the world, it is a dictatorship of the worst kind. Rest assured that citizens of the world united can stop any regime that wants to destroy the freedom of citizens, either by bombs or harmful pharmaceutical products."

German MEP, Christine Anderson, from the AFD group in the Parliament also grilled Trudeau on his blatant hypocrisy: "Based on article 195, I would like to point out that it would have been appropriate for Mr Trudeau, Prime Minister of Canada, to address this house, according to article 144. An article which was specifically designed to debate the violations of human rights, democracy, and the rule of law which is clearly the case with Mr Trudeau.

"Then again, a Prime Minister, who openly admires the Chinese 'basic dictatorship', who tramples on fundamental rights by persecuting and criminalising his own citizens as terrorists, just because they dared to stand up to his perverted concept of democracy, should not be allowed to speak in this House at all."

Anderson concluded by saying, "Mr Trudeau, you are a disgrace for any democracy. Please spare us your presence. Thank you."

Both MEPs received a rapturous applause from some parliamentarians in the chamber after their takedown of Trudeau. The days of smug Trudeau holding court on a world stage and getting a warm reception everywhere he goes are now thankfully long gone.

# Kiev is the globalists' key

**BACK in February, as Russian tanks rolled into Ukraine, I asserted in a live interview on Unity News Network that this was a contrived conflict in pursuance of the climate change agenda.**

After the people who really run the world exploited a coronavirus to create a digital surveillance system for totalitarian control of the people, Ukraine is being used to advance control of resources. It's another great stride towards technocracy.

Of course, there was actual tension between Russia and Ukraine. The fighting that failed to materialise in February (when the Russian army surrounded Kiev) soon became very real in the Donbas area, where there had already been eight years of civil war between the Ukrainian military and ethnic Russian separatists. But this is merely a believable context for the bigger plan, just as we were primed to expect a killer virus erupting from the overcrowded cities of the Far East.

Two articles this week reinforce my argument on the underlying motive for war. For decades, the globalist strategy has been the engineering of emergencies: not only ensuring that no crisis goes to waste, but ensuring that no opportunity for a useful crisis is missed.

'A global energy crisis escalates', a front-page commentary in the New York Times (28 April 2022), warns of severe fuel shortages around the world following Putin's invasion. Helen Thompson, professor of political economy at the University of Cambridge, asked: "What does this mean for the most existential issue of all – climate change?" Thompson can hardly hide her enthusiasm for the oil shock, as she predicts a gaining momentum in the shift from fossil fuels to renewables.

"For the green transition, the renewed public awareness that the supply of hydrocarbons does not take care of itself, even as Western governments promise to curtail their use, is – paradoxically – a step forward."

Unfortunately, the West cannot simply convert from carbon

combustion to wind power in one fell swoop. Thompson sees Joe Biden in a bind: he cannot survive electorally if he repeats the words of past President, Jimmy Carter, who told Americans to 'wear a sweater' to reduce their fuel consumption. Necessarily, Biden is taking the short-term approach of releasing millions of barrels from the federal oil reserve to curb pump prices. Inflation in the USA is nearing ten per cent.

But, as Thompson noted,



the Democrat constituency is also populated by professional-bureaucratic metropolitans, who demand progress to a zero-carbon economy. She refers to the slump in shale gas supplies, but the reservoirs are vast. The reason is purely political: and to the detriment of the ordinary people. Since the success of Al Gore's scientifically dubious but massively influential book and film *An Inconvenient Truth*, the Democrats have become climate change zealots.

Thompson is author of another apocalyptic treatise: *Disorder: Hard Times in the 21st Century*. Climate crisis actors will stop at nothing to make life hard and disorderly. This brings me to the second article on saving the Earth by military proxy.

'Operation Thermostat: energy rationing and the pivot from Ukraine to climate' is an alert by Off-Guardian writer Kit Knightly to the coming curtailments on your ability to heat and eat. Italy is the first country to begin fuel rationing

after cutting the flow of Russian oil and gas. For the next twelve months, public buildings are barred from running air conditioning at lower than 25 degrees or heating above 19 degrees. Globalist puppet Prime Minister, Mario Draghi, asked Italians: "Do we want to have peace or do we want to have the air conditioning on?"

We fight Putin by fighting climate change, governments will be telling citizens, like the Dig for Victory messaging in the Second World War. Knightly reminds us that 'lockdowns were marketed as planet-saving almost from the moment they were put in place'. And now the war in Ukraine is a stopcock on fuel lines.

The European Commission is keen on contributing to this important new front of the Great Reset, taking a guilt trip on oil:

"We have profited from it and created enormous wealth at the expense of planet Earth, and, as we realise right now, at the expense of geopolitical imbalances (with dependency on Russia). Both need to be repaired. In order to repair them we need to pay more for energy – and also for food. The two basic needs of life – food and energy – we have paid way too little for in the past 40 years."

So there you have it – the EU wants you to be impoverished. Italy is its testing ground, as Canada is for North America, and Australia for the southern half. The West wants the theatre of Ukraine to continue for as long as it takes to teach people to accept total resource control. Kiev, with its World Economic Forum stooge, Volodymyr Zelensky, is the key to the new world order.

# China builds cheap coal plants while West suffers energy crisis

**CHINA was responsible for more than half of the new coal power station capacity being built across the world last year, with 176 gigawatts of new coal-fired power station projects commenced.**

More coal than ever was burned last year, despite the COP26 agreement for nearly every country to scale back their coal use. As gas and oil become more expensive, it would seem Asian countries are giving themselves the economic advantage Western nations had in the 19th century, but have since been persuaded to drop in favour of wind turbines and solar panels which have no capability to provide sufficient constant power for modern societies.

The number of coal power stations is actually growing in Asia as new constructions more than offset the closure of old plants. India, South Korea and Malaysia also increased their coal capacity in 2021 according to the GLObal

Energy Monitor.

Corporate media outlets such as Nww Scientist and The Guardian are only wringing their hands at the likelihood that all of this natural, cheap energy production will raise the Earth's temperature beyond the 1.5 degree figure agreed at the COP26 summit. Proof that a vague and unproven ideology means more to these publications than the average person's general standard of living, which is clearly declining rapidly through political choice.

"It's a mixed story. Everywhere outside of China, plans for new coal-fired power plants have been scaled back dramatically," says one of the report's authors, Lauri Myllyvirta at the Centre for Research on Energy and Clean Air. "However, Chinese firms have continued to announce new coal-fired power stations and there is very clear government backing for

that. That's a worrying sign."

The Light paper has been publishing articles on the energy crisis for over a year, as many industry experts have been warning about it, horrified at the deliberate political destruction of Britain's once world-leading energy infrastructure.

Those who still place the climate agenda above people's ability to feed and heat themselves have clearly been led to believe so by a decades-long campaign from the establishment to convince them the welfare of the Earth is of more importance than their own individual needs. ## U.S. Army to test drone swarm in Utah desert

**A SWARM of military drones will be launched over the Utah desert as part of an international field training exercise later this month, according to a report published by The War Zone. The swarm will comprise of 30 small drones for a dual air-assault mission.**

"I think what you're going to see is an expansive use of electronic warfare and an expansive use of our interactive drone swarm," Maj. Gen. Walter Rugen, head of the Army's Future Vertical Lift Cross-Functional Team, told The War Zone.

"We feel like we're going to be flying the largest interactive drone swarm ever in partnership with DARPA and our science and technology experts out of Aviation and Missile Command," Rugen said.

The test will occur at the Army's 2022 Experimental Demonstration Gateway Exercise, which runs from April 25 to May 12 at Dugway Proving Ground near Salt Lake City, Utah. The service will use a combination of ALTIUS 600 and Coyote drones by Raytheon.

ALTIUS 600's range is about 276 miles and can operate for four hours. Depending on payloads, the drone weighs 20-27 pounds and can be outfitted with a warhead head for offensive missions. Meanwhile, Coyote drones

provide reconnaissance.

The drones will be launched from an assortment of aircraft and ground vehicles.

"We'll be launching them pretty much, you know, Monster Garage-style, anyway we can," Rugen said. "Which again shows, in my mind, just the flexibility of our air-launched effects initiatives because we can launch it from the air. We can launch it from the ground. We can launch from fixed-wing, rotary-wing, any type of ground vehicle."

The drones will form a swarm where surveillance ones with infrared sensors and electronic warfare payloads will detect and relay intelligence to human operators overseeing the operation. Humans will decide how to engage the enemy targets, whether through suicide drones or other firepower means.

Earlier this month, the Army's Combat Capabilities Development Command Aviation & Missile Center released a short animation of a similar drone swarm scenario.

Judging by the Biden administration's speed in transferring small high-tech drones to Ukraine, these new drone swarms could make their way to the war-torn country in the near term.

with chemicals) foods.

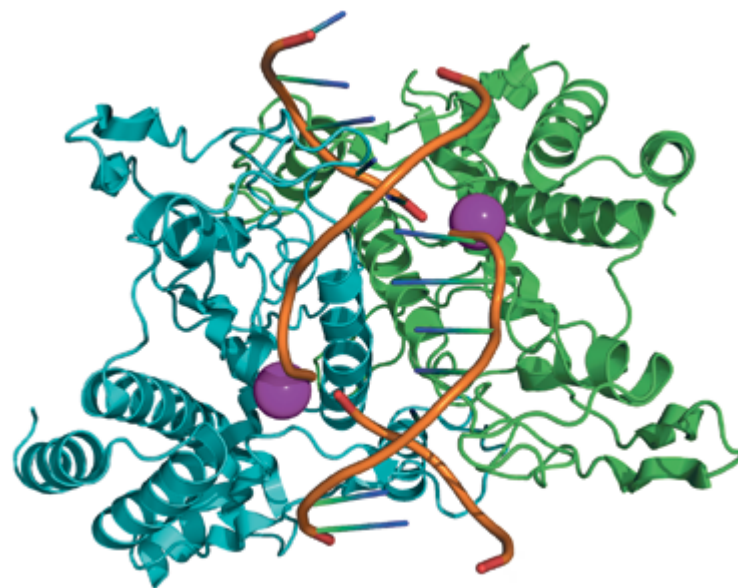
The most important factor in self-repair is the body's ability to manufacture and utilise enzymes.

Enzymes do the work in the body. Vitamin C is technically a co-enzyme; it needs enzymes to allow it to work properly. Enzymes are part of the cleanup crew. A child grazes its knee and will recover without a scar. It would be very different for the elderly. Let's face it, young kids bounce back really well. Toddlers fall flat on their faces all the time and so long as Mum or Dad don't go into a panic, they usually get right up again. Children generally have their full enzyme system working optimally, therefore rapidly repair.

There are many health professionals who believe that as we get older, the single most important element that we need are enzymes and I'd like to explain why.

If I were to get a client who was very elderly that said to me, "Do you know I just don't have the appetite to eat more than a sparrow's portion," the first thing I would propose would be that this person should take digestive enzymes at the beginning of each meal. This would mean that the little food that she is eating is utilised to the maximum. Many health professionals believe that from age 45 there is an increasing need for digestive enzymes. It seems pretty clear that enzymes can extend lifespan and keep us healthy.

Digestive enzymes are made from foods generally speaking. Ones you might know of would be bromelain from pineapple and papain from papaya. In a good digestive enzyme blend, you should find elements to help digest each type of food, from carbohydrates, fats, proteins, dairy and so forth. Many people with digestive problems find digestive enzymes help



them cope with foods that don't agree with them at that time. This can be useful when going out for a meal.

I would like to bring your attention now to proteolytic enzymes. These are enzymes that digest proteins. They can be used to help digest protein-rich foods, however a much more important use is to take it at least 2 hours after eating proteins, in which case it digests scar tissue (fibrosis) both internally and externally, which it sees as foreign protein. One of the worst ingredients is parabens. Scientific studies suggest that parabens can disrupt hormones in the body and harm fertility and reproductive organs, affect birth outcomes, and increase the risk of

Other ingredients in typical name brand products include: Phthalates and Triclosan which are known endocrine system disruptors; aluminium compounds linked with Alzheimer's and cancer; and Propylene glycol, a known neurotoxin which may affect the central nervous system, heart and liver health.

For this reason, I researched the best and easiest alternatives to this chemical concoction, and found the humble lemon to be the most effective, natural odour-repellent.

# GMO safeguards being removed

**IN 2021, the UK Government held a consultation on plans to remove plants and animals created using experimental new GM techniques from the scope of the GMO regulations that protect our food, our farms and the natural environment.**

The public responded with a resounding NO, but the government is pushing on regardless.

A statutory instrument (SI) has just been passed that changes GMO regulations by:

Creating a new class of GMO plants that 'could have occurred naturally' or through a list of techniques that are legally classed as traditional breeding methods.

Allowing these GMOs to be released for any purpose other than 'marketing' without proper safety checks or any measures to prevent escape and contamination.

No criteria were published during the passage of the SI for how to determine which genetic changes could have occurred in other ways. A government committee has now drawn up non-statutory guidelines but GM developers do not have to prove that they are following them. To make matters worse, a recent analysis raises serious concerns about conflicts of interest on this key committee.

The change will only apply in England. Scotland, Wales and Northern Ireland all have much more GM-sceptical governments but that doesn't mean they won't be affected. Pollen and seed don't respect national boundaries any more than they turn left at a roundabout!

Perhaps most worrying of all, Government Ministers have made it clear that they see this change as just the beginning. They want to open the UK's door wide to all forms of genetic engineering and we need to act now to have any hope of stopping them.

Classifying GMOs on the basis of what other ways they might have been created (in a parallel universe?) makes no sense – scientifically or legally. This was very clear in responses to the consultation, in which even organisations that strongly support GMOs criticised this approach.

GMOs can spread easily, contaminating crops growing nearby and getting into the food chain or disrupting the ecosystem.

Details of GMOs released under the new rules will not be made public – farmers could be growing their crops next door to an experimental GM version of the same plant and they would not know about it until

something went wrong.

The government claims that the new law is designed to support field trials but the wording will actually allow anyone to release these types of GMO as long as they don't plan to sell what they grow.

GM Freeze wrote to a House of Lords committee to raise concerns about the SI. They then published a highly critical report on the plans.

We followed the Parliamentary progress of the SI in detail and briefed both MPs and members of the House of Lords. We also helped supporters to write to their own MP at the right time and in the most helpful way. Although we did not manage to stop the SI, MPs and peers made many of our key arguments in Parliament so those are now part of the official record.

Parliamentary processes mean we often have very little notice and need to ask supporters to act quickly so if you would like to help in this way in future, make sure you are signed up to receive our email alerts and action requests. Ministers made some new commitments during the debate on the SI so we will be following up to check that they stick to them. We are also building a network of parliamentarians and others who are willing to speak out against the removal of vital GM safeguards.

We can't do any of this work alone so we are talking to farmers, charities, campaigners and more to help them understand the issues and how their organisation can help. We also have a petition to protect our GM labels and ensure they Don't Hide What's Inside our food.

Political developments like these can move very quickly, without much notice. We will add specific action requests from time to time, but you can always help by donating to GM Freeze. We are one of a handful of organisations working to challenge the use of GM in UK food and farming and we're run on a shoestring so every penny really does count.

# EMF ignored in massive insect population decline

**SEVENTY-five percent of insects have been wiped out since 1989 in tandem with the rise of wireless technologies, such as cell phones, cell towers and more recently WI-FI and the Internet of Things.**

All available data suggests impending extinction of all insect species. The main cause given for the decrease in insect populations is habitat loss due to intensive farming, followed by crop spraying, which started in earnest after World War 2, forty-four years before the surge of insect mortality.

While climate change and invasive species are also posited to contribute to insect decline, electromagnetic pollution is largely ignored by mainstream science and environmental groups. However, radiation is a strong contender according to independent studies. In one study comparing the impact on insects of agrochemicals to electromagnetic frequencies, the latter was found to be the most fatal, destroying three out of four hives.

Birds and insects are particularly vulnerable to electromagnetic fields which damage their reproductive capacity and disrupt their navigational acumen. Magnetite, stored in the beaks of birds and in the abdomen of bees, helps them to navigate. 5G will be deadly to insects, since they absorb far more radiation at mm wavelengths than earlier lower frequencies from 2G, 3G and 4G. This was demonstrated after the installation of a cell tower in Idaho in May 2021, where an entire beehive population at the adjacent farm died within a month.

The earth's electromagnetic field is being shifted by ever-increasing levels of wireless technology, filling the air, earth and presently the sea. Many organisms, including insects, are reliant on the earth's magnetic field for navigation and get disorientated by manmade frequencies, as explained by Dr Ulrich Warnke:

"All magnetic field sensitivity in living organisms, including elasmobranch fishes, is the result of a highly evolved, finely-tuned sensory system based on single-domain, ferro-magnetic crystals. Animals that depend on the natural electrical, magnetic, and electromagnetic fields for their orientation and navigation through earth's atmosphere are confused by the much stronger and constantly changing artificial fields created by technology and fail to navigate back to their home environments."



## The cast of progress needs revision if it bequeathes erasure

Of insects, this has particularly impacted bees, contributing to bee colony collapse disorder. One study showed that it severely disturbed the bee colony and set off the swarming process. There was increased aggression and reduced aversive learning in exposed bees. Studies on fruit flies showed mobile phone radiation at 90Mhz decreases the reproductive capacity of insects by up to 60% through DNA fragmentation and cell death. Similar results were also found with microwave radiation at other frequencies. Other studies evinced abnormal mutation in the mealworm beetle, causing severe deformities in irradiated insect pupae.

Low level Radio Frequency Radiation sizeably influences the insect circadian clock. In one study it slowed down the cockroach rhythm under dim ultraviolet lights according with results on the *Drosophila* circadian clock. "300x weaker RF fields also slowed down the cockroach clock in a near zero static magnetic field, demonstrating the internal clocks of organisms are sensitive to weak RF fields." This confirms the findings of Leif Salford showing that weak electromagnetic fields are just as harmful.

In May 2020, a study was featured in the Times newspaper intriguingly entitled: 'Insects fall prey to diet of junk foods'. Investigating why grasshopper populations fell by nearly 1/3 over two decades in the Konza Prairie, North Eastern Kansas, a study was carried out between 1996-2017 in undisturbed habitats and in 2002-2017 where bison grazed. The article reported that Kasper, leading the

study, said: "In many regions [of the world] the cause of decline was given to be insecticide use and habitat loss." Wireless radiation was not mentioned. As there was no case of habitat loss or insecticide use in the Konza Prairie, they looked at the plants, and found greenhouse gas the main ingredient in the sugars, starches and cellulose of plants, making them less nutritious. Kasper therefore posited that the cause for insect decline could be depleted nitrogen, phosphorous, sodium, zinc and other nutrients in the plants due to rising CO2. He suggested re-greening was redundant, as plants were so nutrient depleted. However, the study ignored the fact that the area is also subject to solar radiation. Weather data is collected by a CR10 data logger accessed every 15 minutes via wireless internet, which monitors air temperature, relative humidity, solar radiation, wind speed and soil temperature.

On assessing the evidence, it is vital to look at the funding source of studies. Measures advocated by mainstream science to stem the tide of extinction do not address what may be the principal cause of insect decline. While a tiny fraction profit from wireless radiation, all pay for ignoring its impact on our fragile, finely tuned ecosystem.

The cast of progress needs revision if it bequeathes erasure. The only real solution is the immediate withdrawal of 4-5G cell towers and mobile phones worldwide, as a matter of urgency.

# The jab, the lies and the truth

Components of the establishment are still refusing to accept the evidence; rejecting their own statistics which show that the covid jabs have already proved to be not just a failure, but a medical disaster

**THE individuals who were foolish enough to accept the covid-19 jabs must now be able to see the consequences of their misplaced trust in the politicians, the media and the medical establishment.**

Those who accepted one or more of the covid-19 jabs are now at risk from a variety of illnesses and are, paradoxically, even more likely to die of covid (the rebranded flu) than those who saw through the lies and rejected the call to be jabbed. The fully vaccinated make up nine out of ten covid-19 deaths in England.

Moreover, there is early evidence that those who have been in close contact with the jabbed may be endangered. The nature and extent of the risk isn't clear yet – after all, we are in the early stages of the world's largest, most unethical and most unjustifiable medical experiment.

Frighteningly, the various components of the establishment are still refusing to accept the evidence; rejecting their own statistics which show that the covid jabs have already proved to be not just a failure, but a medical disaster.

Before I was officially downgraded to conspiracy theorist, I was for 50 years considered an expert on iatrogenesis (disease caused by medical treatment) and drug side effects, and I have steadfastly opposed this indecent jabbing programme.

Back in December 2020, I used evidence from the American Government to warn that the mRNA covid jabs could cause a huge number of serious adverse events – including myocarditis, heart attacks and strokes.

Children, of course, will be more vulnerable because they are more delicate and because they are likely to live longer.

Despite this, the dangerous and ineffective covid-19 jabs were rolled out to billions without doctors having the faintest idea what would happen.

In November 2021, a paper published in the medical journal, *Circulation*,

concluded that the mRNA jabs dramatically increased inflammation on the endothelium and T cell infiltration of cardiac muscle. This linked the jabs to thrombosis, cardiomyopathy and other vascular events.

But the unethical jabbing continued.

And the *Daily Mirror* in the UK said there was now a new miracle jab to save 1000s of lives by preventing heart attacks. Make people ill with one jab and mend them with another.

*ABC7* in Los Angeles reported that doctors had warned that Super Bowl games might trigger heart attacks. The Mayo Clinic in the U.S. said that stress and chaos can cause heart disease (I first pointed that out in 1978 in a book called *Stress Control*. I was widely vilified for saying that. But now it seems stress is running amok). *The Sun* reported that the weather can cause heart attacks. There were claims that the epidemic of heart attacks were caused by people eating too much good food. Vitamin D shortages were also blamed. *Scientific American* said that covid-19 can lead to heart damage among people with no symptoms at all. *National Geographic* warned that covid-19 could cause heart palpitations, chest pain and blood clots.

A drug company argued that 'long covid' increases heart trouble.

Ah, 'Long Covid'!

In early 2022, the UK Government said that there were officially 1.3 million

people in Britain suffering from 'long covid' – and that the figure was rising fast. Two thirds of those individuals were reported to have been off work for a year or more.

Almost before the figure had been published it had been amended and the total was said to be approaching two million. A report from the U.S. suggested that around 12 million Americans were alleged to be off work with 'long covid'.

Covid believers claim that 12% of those who've had covid still have symptoms 12 weeks later.

The media ignored the fact that the biggest and most significant research into 'long covid', involving 26,000 individuals, concluded that 'long covid' is largely a psychological problem.

People who had taken a year off work on full pay didn't want to go back to their offices.

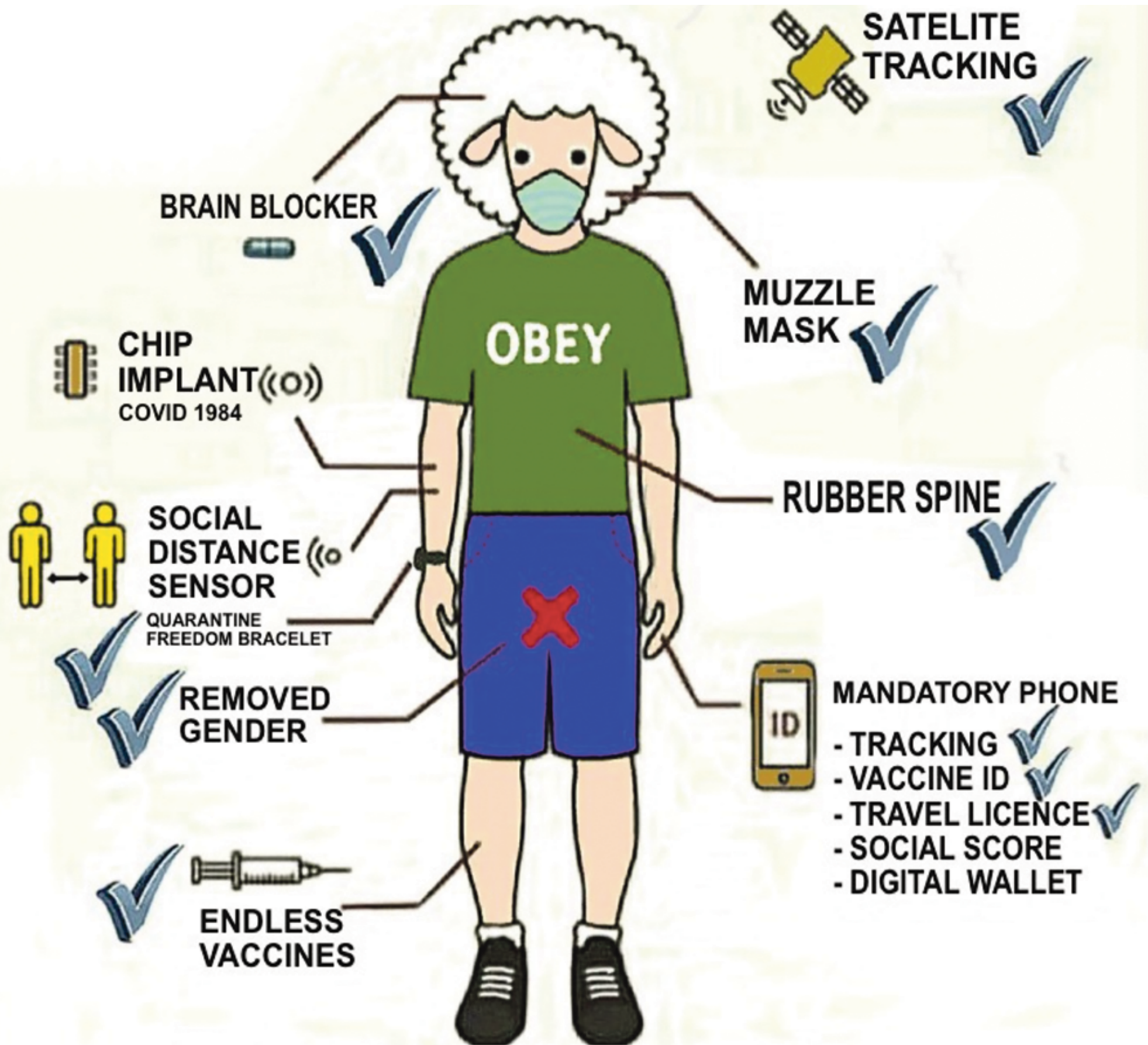

# Warped schools are wrecking children's minds

An Irish teacher describes what life is like in the classroom as the 'woke' Communist agenda permeates every aspect of school life
