## CLOWN COURTS

A FULL 27 months after we compiled and submitted our legal action against the lockdowns, the homecoming chickens are now overhead, circling the runway, and set to land.

Within weeks, it will become obvious that something is drastically wrong in the world, that nothing is as the political class and media have been telling you, and that the world as we know it has been delivered into a state of collapse. This is likely to express itself in various territories as food shortages or famine, fuel restrictions or industrial and business shutdown - all accompanied by public anger at those, including judges, who have been complicit in bringing this down upon the world. And, on top of all this, there will be the escalating die-off of healthy people of all ages from a fake vaccine that was never going to do the good it was purported to, but was instead destined - and predicted by innumerable ignored scientists, and doctors - to inflict immense and irreversible harm. And all this happening under the supervision of the World Economic Forum, whose Camp Commandant Klaus Schwab, boasts that the WEF has now 'penetrated the cabinets' of every government in the Collective West.

The next two to three years will be the most terrifying the world has ever experienced. Everywhere, in political terms, it will amount to the same thing: the disintegration of civilisation as we have understood it, and the - attempted - introduction of new, mainly digital systems of surveillance and control, that will, if they take hold, amount to a monolithic global totalitarianism, the first such that the world has seen.

All this comes from the actions of corrupt politicians, judges and bankers. the determination of the world's richest to ensure that whatever happens, it

strikes lower down the chain.

We went to court in April 2020 in an attempt to prevent this going any further than it had by then gone. The situation was as yet recoverable, and that might be said to have remained relatively true for another six months or so. By the end of 2020, for certain, it was already too late to save Ireland or any other country from the inevitable consequences of what was done. From the outset, we sought to be subtle and restrained in how we presented our facts, making only the most outline case so as to avoid frightening the judicial horses. while at the same time incorporating every detail of available information and every suspected constitutional breach. We hoped that, by the time we got to the judicial review stage, the picture would be clear to even the densest judge. But we did not calculate for the politicised biases of the judges

we encountered from the beginning, or for the utter corruption of the Fourth Estate, which not merely failed to tell its audiences the truth, but offered itself up as a channel for lies, and in addition agreed to become a policing agency to silence and punish anyone seeking to speak truthfully. Thus was constructed a pseudo-reality that obscured from the public the appalling reality unfolding under its feet.

The Chief Justice Donal O'Donnell and the Supreme Court of Ireland have bought into the lies, and now - with the honourable and courageous exception of Mr Justice Gerard Hogan - must take its place in the identity parade of culprits for what is about to happen to our country and the world. We tried to explain, to elucidate, to hint, nudge and warn; we were as courteous as the circumstances permitted us to be. They did not hear. At least six of

the nine judges comprising the total SC complement were sufficiently mesmerised by lies as to be unable to recognise the truth when it was placed before them, and could not hear enough of our warnings to carry out what is their primary function: to protect the citizens of Ireland from dangers of precisely these kinds. The truth is that none of these judges appear to have the faintest idea what has been going on in the world.

That is the benign explanation. The other would be the 'appalling vista' hypothesis which is to suggest that, when hardy come to hardy, the courts will interpret the concept of the separation of powers to defend governmental and state agencies regardless of circumstances: the State, right or wrong. In 1980, the English judge Lord Denning, upholding an appeal by the West Midlands Police

against a civil action brought by the Birmingham Six for injuries they received in custody, said in his judgment that the consequence for the English legal system of accepting that police officers were lying was such an 'appalling vista' that every sensible person would reject further legal action:

If the six men failed it would mean that much time and money and worry would have been expended by many people to no good purpose. If they won, it would mean that the police were guilty of perjury; that they were guilty of violence and threats; that the confessions were involuntary and improperly admitted in evidence; and that the convictions were erroneous... That is such an appalling vista that every sensible person would say, 'It cannot be right that these actions should go any further'.

The men's convictions were overturned in 1991, after it was established beyond doubt that the police had indeed done all the things Denning had listed. He then said that the West Midlands Police force had 'let us all down'. Yes, and he let everyone else down.

If the 'appalling vista' comparison is indeed valid — and there are many signs suggesting that it is — I cannot describe how heartbreaking this is for me at the level of patriotic affection. That our country now stands to be disintegrated, probably irrecoverably, when this remained avoidable, renders me bereft and desolate. That we went in good faith to the courts of the land. asking them to uphold the constitution they are pledged to protect and defend, and came away in effect empty-handed, is not so much a loss for Gemma O'Doherty and me, but a loss for all Irish people, living and yet to be born.

Gemma and I have clear consciences, which is more than can be said for many whose names will stud the history books' accounts of what happened here.

## Defy fuel lockdowns

John Waters on the Government's latest madcap scheme to limit our freedom

LAST month, the Irish Independent carried an 'exclusive' report headlined: 'Return of 'work from home' plan to save fuel in event of crisis caused by Ukraine war.'

This was precisely what the 'conspiracy theorists' had been predicting for two years: that Covid fascism would morph into climate fascism and the entire not-so-merrygo-round start up again from the beginning?

The report began:

'People will be ordered to work from home in the event of a major fuel crisis sparked by the war in Ukraine, under secret Government emergency plans.'

Three years ago, the idea of 'people' - by which is meant the citizens of Ireland - being 'ordered' to do anything by their government would have seemed unthinkable. Any journalist who wrote such a sentence would have been hauled over the editorial coals, and probably ridiculed by colleagues. Now, as a result of public compliance with the unconstitutional and undemocratic diktats of the Tyrannical Trinity of Martin, Varadker and Ryan, it is taken for granted that the Government of Ireland rules rather than leads and manages the country.


From now on we can expect the 'orders' to flow in ever-increasing quantities until the people cry 'Enough'.

The article reported that a 'highlevel,' 'confidential,' 'emergency,' planning exercise had been conducted by multiple participants to explore various 'scenarios' relating to expected drops in fuel supplies in the coming winter

The Rio Times, (Latin America's Voice from Brazil) reported the meeting under the headline: 'Irish Wargames: Country leads the way preparing for fuel crisis and home office mandates.'

That report elaborated:

'Despite there being some prospects for oil extraction off the coast of Ireland, in 2021, Ireland shot itself in the proverbial foot, with the government banning all licenses for new oil and natural gas exploration as part of a plan to hit the mythical netzero carbon emissions mark.'



Precisely. At the time, the relevant minister, Green Party leader Eamon Ryan said: 'The decision we have made today to legislate for a ban on new oil exploration and extraction will send a powerful message, within Ireland and internationally, that Ireland is moving away from fossil fuels towards a renewable future. By keeping fossil fuels in the ground, we will incentivise the transition to renewable energy and put ourselves on a pathway to net-zero by 2050.'

All lies, of course. The government was simply acting upon an instruction issued by its external masters. Just as national sovereignty is now an 'old-fashioned' concept, so is self-sufficiency in any commodity that the external puppeteers of the Irish political class do not approve. All natural resources must be sealed off for the benefit of the 'secret unknowns,' to be exploited when total control has been asserted over Ireland and it's population.

We now move closer to that 'scenario.'

According to the 'leaked' report, participants of the wargame exercise agreed the following measures would need to be taken:

■ The government would impose a work-from-home mandate for 'non-essential' workers

- Travel bans would be imposed on 'non-essential car travel.'
- Speed limits would be imposed on specific roads and road-types;
- Fuel rationing would impose fixed limits on individual purchases
   most likely irrespective of the type or size of vehicle or specific necessity.

This, of course, means, in substance and effect, a return to lockdown, since adjudicating on whether or not a journey is essential is an expertise of the Gestapo, who would evidently be again released on to the highways and byways to torture and harass the public.

But there is more. As the Rio Times puts it:

'A curious "emergency scheme" would be implemented to see people with odd-numbered license plates alternating refuelling days with people with even-numbered plates.'

This measure is to deepen the habit of queuing within the Irish mindset, and bring us closer to the conditions of the USSR - ironic, since Russia is now shucking off the West's pathetic, self-destructive sanctions in conditions of all but total self-sufficiency.

The 'alternate day' fuelling arrangement, interestingly, is described as an 'emergency scheme,' implying that it is temporary and necessitated by some external crisis. Yet, it is only a matter of weeks since the government was informing the public that Ireland did not obtain any of its oil from either Russia or Ukraine. For more than two years, the state has been lying to the courts about the declaration/non declaration of a national emergency in 2020. When this is expedient from a legal viewpoint, they say there was no declaration of an emergency; when it suits to claim there is a 'national emergency' in order to intimidate and control the population, they forget

about the legal niceties - which, theoretically, any Irish government is bound by.

The only 'emergency' here is an emergency of high treason, whereby the Irish government has been deceiving the Irish people concerning the true nature of what is happening. The truth is that the Ukraine was provoked by NATO and the United States, in large part to create alibis for the global criminality represented by the Covid scam. All over the world, for the past 18 months, there have been massive spikes in mortality among young, healthy people, all caused by the lethal poisons masquerading as Covid vaccines. The hyperinflation that currently grips the world economy, and is shortly to rip every country in the world to economic shreds is due entirely to the 'stimulus packages' introduced by central banks to brush the inevitable consequences of lockdown under the rug for a couple of years. It has been obvious and inevitable for more than two years, that all this would end in food and fuel scarcities, rationing, lengthening queues, and - in many places - famine, starvation and deaths from hypothermia and similar afflictions. None of this has anything to do with Putin or Russia, but is the sole doing of Western governments, who now seek to cover up their crimes by pretending that some kind of mysterious 'emergency' has sprung out of nowhere.

The economic crisis in the West is set to escalate though the coming winter, with hyperinflation being followed by layoffs, mass business closures, growing personal indebtedness and rising interest rates. All these were inevitable consequences of lockdown policies, but no media organisation or central bank has done anything to warn the public. On the contrary, reports in state-subsidised media over the past two years have cited central bank spokesperson predicting a 'mini-boom' once the 'pandemic' was over. Unlike what occurred in the much less serious conditions of 2008, no mainstream economists have emerged to criticise any of these disatrous policies or alert the public to their ineluctable consequences.

Ireland is now at the mercy of the venality and incompetence of the donkeys it has elected to lead it, who have handed over not merely the resources that were rightly for the benefit of the Irish people, but also the power to manage and protect their citizens from the ravages arising from global political criminality. This will continue until the people get off their knees and demand their freedom back from the tyrants in government.

## Seven questions to ask about the covid 'vaccines'

1. Why are they referring to a genemanipulating technology as a vaccine?

The term vaccination comes from the 18th century practice of cowpoxing; vacca being the Latin word for cow, and subsequently became the term given to the practice of introducing a minute quantity of a pathogen into the body in order to stimulate an immune response, as a supposed prophylactic measure in the event of exposure to said pathogen at a later stage.

But mRNA interventions do not act to directly induce an immune response. According to their manufacturers, they introduce a set of instructions in the form of a gene sequence, which enters the body's own cells and uses them as factories to produce the S1 spike protein. All this for the secondary benefit, they hope, of building an immune response to a toxin the body is now manufacturing. So the body is set up to attack itself, becoming both the attacker and the defender, which is the very definition of an auto-immune condition.

We are generating auto-immune disease en masse just in order to create a quasi-immunity against a part of a virus. It is hazardous in the extreme, with the short-term effects of disability and death caused by neurological and cardiac damage already manifest, and the medium and long-term effects unknown. As a result of depletion of the body's natural defences, we may well see the activation of many agents which ordinarily lie dormant in the body, such as TB, as well as an eruption of cancer tumours whose cells are otherwise held in check by healthy immune systems; provoking a condition known as VAIDS - vaccineacquired immune deficiency syndrome.

2. How many people would have allowed themselves to be injected had they known the intervention altered part of their DNA?

Humans are not meant to make spike proteins. They are not part of the human genome.

3. Why refer to the mRNA interventions as 'gene-therapy'?

Therapy is a word reserved for the treatment of a condition, disorder or disease. The arrogance of administering therapy to healthy individuals is, at best, an unwarranted



interference, at worst an assault.

4. Why do professions ending in 'ologist' suddenly need studies to declare the obvious, that naturally acquired immunity is far superior to anything artificially stimulated?

The immune system is a multi-faceted, powerful, complex system that has evolved over millennia, and is far from completely understood. What is known is that when the body suffers a disease, it mobilises a battery of defence mechanisms which work in harmony, producing antibodies as a frontline defence to kill pathogens circulating in body fluid or on tissue surfaces, and a T-cell response to deal with pathogens if they manage to enter cells where they can replicate, because antibodies cannot access those cells. Once recovered from a particular infection, the body's T-cells conserve a broad spectrum and lengthy memory, recognising any similar subsequent invader and acting swiftly to overcome

Vaccines that provoke high antibody levels, on the other hand, produce a concomitant reduction in the T-cell response. With T-cell response suppressed, if the pathogen eludes the antibodies, gets into the cells and starts replicating, unlike in an untainted immune system, the tools to combat the microbe are not available, allowing it to establish a persistent, or longer term infection. Furthermore, the

antibodies induced by vaccination are specific, not broad spectrum, which renders them more easily bypassed by a related pathogen.

### 5. What is meant by 'vaccines waning'?

Vaccines of themselves do not confer immunity. They aim to provoke a reaction by the individual's own immune system. How durable and effective that is is an entire area of enquiry. But if the initial perceived immune response vanishes within a short window of time, it signifies the intervention has failed in its purpose. Continued over-soliciting of the body's immune responses by more failed interventions only leads to a weakening of the body's innate protections, rendering it more vulnerable to attacks by toxic agents.

6. Why was it said that the mRNA payload remained in the deltoid muscle, at the site of the injection, or nearby? On what basis was this assumption made?

Professor Michael Palmer gave a video presentation of the pharmacokinetics and toxicity of mRNA injections as part of the Doctors for Covid Ethics' symposium on 30th July 2021, featuring a bio-distribution study of the spike proteins and how they gravitated in particularly high concentrations to the liver, spleen and ovaries.

The mRNA 'packages' containing

the gene sequence are suspended in lipid nanoparticles (LNPs), which are essentially tiny bubbles of fat that are used to deliver genetic material into the cells. But our immune system has all sorts of gate-keeping ways of protecting our cells from invasion, so polyethylene glycol (PEG) is added to promote wide-spread dissemination throughout the body; to deliver a toxin-creating gene sequence into the cells of all our body's systems.

So why the claim that most of the payload stays in the arm muscle?

The above information is provided by Dr. Byram W. Bridle in his article A Moratorium on mRNA 'Vaccines' is Needed. Re-Visiting the Biodistribution of Lipid Nanoparticles, published on Substack on 22nd April 2022 under Covid Chronicles. He also informs us that PEG is the component most associated with causing anaphylactic shock (severe hyper-acute allergic reaction).

7. Why do academics and physicians recommend it be given to the elderly and immunecompromised?

Does it make sense to give individuals with weakened or poor immune systems an intervention which will further damage their ability to ward off everyday infections?

Project Veritas recently released a leaked recording of an AstraZeneca Zoom call of December 2020 in which its CEO, Pascal Soriot, stated that the millions of people with compromised immune systems could not receive a covid vaccine. Jon Rappoport points out that he himself had explained the simple reason for this back in early 2020, which is that a vaccine is supposed to provoke a reaction from the immune system, but if the system is weak and cannot respond, the vaccine functions as a "super-high toxic invader which overwhelms the body."

This did not prevent the European Medicines Agency stating:

'There are limited data on immunecompromised people. But although they may not respond as well to the vaccine, there are no particular safety concerns. Immune-compromised people can still be vaccinated as they may be at higher risk from covid-19.

And, of course, from our own Strategic Advisory Group of Experts on Immunisation (SAGE) came the recommendation that 'severe or moderately immune-compromised persons should be offered an additional dose of vaccine'.

in colder and wetter weather in Europe, worsening food shortages, economic contraction and population migration. In the man-made climate change world, no one's talking about the sun and what it's doing. This climate change theory and the consequent models do not take account of the Sun's activity. ## Web of Corruption

Fabricated evidence, no DNA, phoney witnesses and a litany of Garda lies: Gemma O'Doherty on the framing of Aaron Brady

ON January 25th, 2013, **Detective Adrian Donohoe was** murdered at Lordship Credit Union, north of Dundalk, Co. Louth. In the lead-up to his killing, it had been a wet and frosty week but conditions were calmer when the routine Friday Garda convoy pulled up to escort staff with their cash deposits to a night-safe in Dundalk. Donohoe (41) hadn't been due to work that night but his shift was mysteriously changed at the last minute and he was called in to do the cash run.

It is just one of a litany of oddities about the case which have never been explained by the force to this day. The two detectives were late for the run and two uniformed Gardai had already started the journey which took in other credit unions along the way. One of the gardai was Tony Golden who was shot dead in Omeath, Co Louth in 2015. Rumours about his death also still abound.

An active GAA supporter, Donohoe came from a family of Gardai and was married to one. He had been troubled in the period leading up to his death. Some locals had seen him walking near his home on the Cooley Peninsula in the early hours of the morning seeming distressed.

In the rural hinterland of Lordship, it was well-known that Gardai escorted the cash from the credit union making it an unusual target for raiders. Given the criminal/Garda collusion that has become all too common nationwide, especially in robberies involving cash and drugs, it has been widely speculated that the raid was an inside Garda job coordinated by the force. What made it even more peculiar is that it came after another suspicious robbery at the same credit union 18 months earlier when €22,000 was taken. By the time of the murder 'raid', the escort arrangements had been 'upgraded' to an armed force.

It was approaching 9.30pm when Donohoe and his driver colleague Detective Joe Ryan pulled up at the car park of the credit union in an unmarked car, dressed in civilian clothing and carrying concealed firearms. It was pitch dark in the quiet winter countryside.

According to the Garda story, a navy blue Volkswagen Passat drove suddenly across the road and blocked the entrance after allegedly lying in wait on the hard shoulder. But this aspect of their narrative is just one of many which has been contradicted. The key witness to the incident, a senior credit union employee who was observing from her nearby vehicle, said the raiders' car was silver grey.

Gardai claimed four armed raiders in balaclavas appeared from behind the wall and the fifth - a female - was driving.

In a bizarre, dangerous and inexplicable act, Donohoe got out of the car on his own without his weapon drawn and was immediately shot at close range, effectively walking to his death as the raiders ran towards the Garda vehicle. He died instantly.

Throughout the trial, the state's senior barrister Brendan Grehan - whose behaviour and treatment of the defendant during the trial was often unacceptable - claimed the gang were 'highly sophisticated' and 'slick' and had been 'meticulously' planning the robbery for months. But the facts don't support this in any way. Despite their alleged professionalism, they grabbed a bag worth  $\epsilon 4,000$  but 'mistakenly' left the remaining  $\epsilon 30,000$  behind.

In reality, the key objective of the incident appears to have been nothing to do with stealing cash but killing Adrian Donohoe who was blasted in the face with a shotgun.

His colleague Joe Ryan claimed he was then pinned into the driver's seat

in Crossmaglen, Co Armagh: a rite of passage for many young men living along the border trying to make a living - although it risks a prison sentence.

and told not to move or he too would be killed.

At the time of the murder, Aaron Brady was north of the border laundering diesel near his home Later on, the 22-year-old visited his then girlfriend and her family who lived nearby. They remember him being in good form and laugh at the notion that he could have been on the run after murdering a Garda at close range less than two hours earlier. He showed absolutely no signs of panic or distress and was his usual laidback self.

In the early hours of the morning, he and a friend drove down south over the border and into the Garda cordon that had been set up. At this stage, Aaron had already heard a Garda had been killed. The young men spoke to officers and were flagged on.

Aaron was spending the night in his friend's house, located close to the credit union, about a 30-minute drive from his girlfriend's home.

The following morning, Garda checkpoints surrounded the roads of county Louth - a fact Aaron and his friend were well aware of. As they made their way back over the border to go home, they approached one of the patrols around midday. Not wanting to disclose the fact that he had been cleaning diesel, Aaron told the Gardai he had been at his girlfriend's house the previous evening - a partially true version of his whereabouts that night.

On the day after the Garda murder, Aaron travelled widely around the country spending time in Castleblaney, Co Monaghan, Dundalk and going to the cinema in Belfast that evening. Little did he know that a Garda campaign of harassment and intimidation was about to begin against him: the authorities had chosen the man they were going to frame.

The PSNI paid a visit to his girlfriend's house to confirm his story shortly after his initial Garda encounter. Aaron was concerned she would become embroiled and decided that he would go to the Gardai and explain the full story.

Several days later, he walked into the Dundalk barracks and informed officers exactly where he had been and what he had been doing at the time of murder in the hope that it would alleviate any pressure on his girlfriend. That was the beginning of a long nightmare for the Armagh man which ended in a 40-year prison sentence in 2020.

Despite being unable to produce a shred of concrete evidence - DNA or otherwise - linking him to the scene, the Gardai set about concocting a narrative that they had got their man.

They spread vile rumours about Aaron and claimed that their 'monster Garda killer' had been plotting and planning the robbery for months even though in its immediate aftermath he casually drove back to the location several times knowing it would be crawling with police. A man facing life in prison for capital murder would surely have been on the run, gone into hiding and stayed well away from police checkpoints.


At no time, did Gardai or the PSNI examine the yard in Armagh where Aaron had been on the night of the murder for evidence. They knew from the start they had the wrong man so they set about terrorising him until he was left with no choice but to leave the country. He emigrated to New York in April 2013 barely getting the chance to say goodbye to his family.

There he embarked on a successful career in construction, met his wife and celebrated the birth of his baby boy. He thought the Garda stalking had come to an end but he was wrong.

For several years, Irish officers conspired with rogue Homeland Security staff to identify young Irish illegals who would make suitable candidates to make false claims about Aaron in return for a green card or other favours. It took them more than seven years to concoct their mountain of lies against them which they eventually presented in court.

On August 12th, 2020, Aaron Brady was found guilty of the murder of Adrian Donohoe following one of the longest trials in Irish judicial history.

Judge Michael White faces grave questions over his handling of the trial and his tolerance of the State's deeply flawed case against Aaron who was

convicted on the flimsiest of evidence and statements made by a pair of dubious witnesses via video link from America. This too should never have been permitted and it should have been demanded they attend court in person seeing as they were attempting to have a man sent down for life.

Their bogus testimonies were almost identical in content: they claimed that Aaron had told them on separate occasions 'I shot a cop'.

One of them, Daniel Cahill had been accused of serious crimes including violent assault. An illegal in America, he was involved in an unprovoked machete attack on a young Irish hurler in New York causing him serious harm. He was also a close associate of the so-called Real IRA Ryan gang, which he lied about under oath. Cahill left Dublin in 2013 under mysterious circumstances.

He also committed a vicious attack against Aaron whom he knew through Irish circles in Woodlawn, The Bronx. It involved an alleged falling out over a woman which had nothing to do with Aaron but Cahill gave him a brutal beating and threatened to cut his toes off with a Stanley knife. The attack was confirmed by several others. Under oath, he denied having any knowledge of the incident but proceeded to explain how he was involved in brokering the return of Aaron's phone which was stolen during the assault.

On the day he made false allegations against Aaron he had been detained and caught with marijuana and steroids. An immigration expert who gave evidence during the trial said he should have been sent home on the next flight. Today he works in a pub in Westchester, New York.

Cahill let slip during his testimony

that prior to becoming involved in the Brady case, he had been visited by Homeland Security at his apartment in New York when they were looking for his killer friend Dean Evans. At the time he was on the run for the 2013 murder of dissident Peter Butterly outside The Huntsman Inn in Gormanstown, Co Meath.

That a person of such low moral character with such a sordid past was deemed the State's star witness reflects just how far the Gardai were willing to stoop.

Their second witness was a mentally disturbed young woman of Irish extraction called Molly Staunton.

During her testimony, an unknown male entered the room of her apartment and shouted at her: 'tell them what you're fucking supposed to tell them' and no more testimony' before slamming her laptop down.

At this point, the case should have been dismissed and the jury discharged as it had descended into parody. The following day, it continued regardless with Grehan telling the court the Gardai would not be investigating the Staunton incident.

The idea that Aaron would have gone to the trouble of leaving his home and beloved family because of Garda harassment, started a new life in the US to escape them, but would suddenly start admitting to virtual strangers that he 'shot a cop' has always been utterly implausible.

The Brady family have uncovered evidence that reveals how Gardai colluded with US Homeland Security Officers to blackmail other illegal migrants with green cards in exchange for fabricated statements about Aaron. In one case, a witness said they told him, 'just give us Brady and you'll never hear from us again.'

This was a tactic they deployed in their framing of Ian Bailey. The DPP admitted they gave hash and cash to down-and-outs if they were willing to tell lies about Bailey in the murder of the French film maker Sophie Du Plantier.

Aaron's family have suffered hugely throughout this horrific ordeal and have been threatened by the Gardai on countless occasions for having the temerity to seek justice for and try to free their son.

Their groundbreaking 18-month campaign www.justice4aaronbrady. com has demonstrated clearly that the evidence against him is utterly flawed. It includes distorted CCTV footage used by the state, little more than blobs of light incapable of linking Aaron to the crime.

Some of the timings presented by the Gardai in relation to journeys allegedly made by Aaron and the other 'raiders' on the night of the killing defy logic.

Another absurd claim relates to the height of two of the alleged gunmen. Detective Ryan, who was in the driver's seat of the Garda car, claimed the gunman who shot Donohoe (allegedly Aaron) was between 6ft and 6'1.

He said the raider with the handgun was between 5'6 and 5'7. Aaron is 5'7 inches tall.

Ryan claimed there was a six to seven inch difference in height between the two raiders. If Aaron was the taller of the two, then his colleague would have been under 5ft tall: a virtual midget which would be useful for identification purposes. A detective with over 23 years experience would surely have observed this notable feature.

Ryan, who moved to Spain after the murder, also claimed the killer was of athletic build which was corroborated by one of the Credit Union workers.

At the time, Aaron was slightly overweight and physically unfit.

The Gardai have always said that Aaron was part of a sophisticated and organised gang of raiders but this has yet to be proven. Two of his friends are in custody awaiting trial in relation to the raid but the charges do not relate to capital murder, merely robbery.

The Credit Union employee who witnessed the raid said the driver of the getaway car was a female but this person has been airbrushed from the Garda story. She also said one of the raiders had a Dublin accent while the Garda 'gang' should have had strong local Louth/Armagh accents. Would this woman have any reason to lie?

There is also the mystery hammer that had been left at the scene without a shred of DNA on it, voice recordings of the raiders recorded by a credit union employee car that were tampered with, and unidentified DNA on the inside of the passenger door of the Garda car.

Not one claim by the Brady's campaign has been challenged by the authorities but they have gone to desperate lengths to silence the family including threatening Aaron's legal team with jail following the publication of transcripts from the trial by the campaign, which show the glaring contradictions in the case.

Many people wonder why the Gardai went to such measures to frame an innocent man. The truth lies in the Cooley peninsula where Adrian Donohoe lived. There was a reason he had to be killed and it is more than likely involving collusion between Garda and their criminal drug stooges.

Anyone who has been watching the weekly videos produced by Aaron's father Tony Brady, a respected physiotherapist, knows the Garda case is a farce and that Aaron is an innocent man

Those who must be held to account for their involvement in this travesty of justice are Garda officers Pat Marry, Mark Philips and John Moroney, DPP employee Ray Briscoe, state lawyers Brendan Grehan and Lorcan Staines, and Judge Michael White. Remember their names and that they could do to your son what they have done to Aaron Brady.

The young father is coping well with prison life despite the isolation he has been subjected to since his committal. He is working hard on his 2023 appeal and keeps himself physically and mentally strong despite the horrific ordeal he has been put through for almost a decade. The truth about his innocence is becoming widely known around the country now thanks to the tireless work and devotion of his family. And there is no question the establishment is absolutely terrified of that.







DH: The response from the public has been good and supportive. They're all are in agreement with keeping and using cash. We must talk with and listen to people more: I think more people than we realise understand that what is happening is about control. Our job as activists is to harness this opposition to cashless, before it's too late.

mind-set in the freedom movement to actions to save cash. For me, it is inevitable that the powerful will close in on crypto-currencies. We are in the biggest economic crisis in modern history. The time is now to take actions that the public are receptive to, and make the cashless society just a technocrat's dream – and nothing more!


Labour did not put up a single piece of meaningful opposition to anything covid-related throughout the entirety of the ordeal, other than that measures didn't go far enough.

The shills spew lies with the same enthusiasm as the insane global-warming cultists – the lunatics who fervently claim that if we all live on avocado and bean-shoot salads then we'll save St Paul's Cathedral from drowning.

You can safely ignore them all.

The truth is that human beings are omnivores not carnivores. The sharp

teeth give us a choice not a compulsion. Eating meat is an option not a necessity. You don't need to eat meat any more than you need to eat marzipan or those multi-coloured sprinkles people put on birthday cakes and trifles.

shills say that without meat we won't et enough iron. But there is plenty of iron in green, leafy vegetables, nuts, cereals and beans. Foods rich in vitamin C eaten at the same time as iron-containing food will considerably increase absorption – increasing it by a factor of five. A good, well-balanced vegetarian diet will contain plenty of iron. Although it is true that meat contains iron, the irony is that meat eaters are often more likely to develop iron deficiency anaemia because they tend to eat less fruit and vegetables.

If an animal has cancer when it is killed, meat eaters will eat the cancer. Do you really want to sit down to dinner and eat a large chunk of cancer?

Lifelong vegetarians visit hospital 22% less often than meat eaters – and for shorter stays. Now that we have poorly managed hospitals, long waiting lists and a dead or dying health service, this is incredibly important.

Every minute of every working day thousands of animals are killed in slaughterhouses. Many animals are bled to death. Pain and misery are commonplace. In America alone, 500,000 animals are killed for meat every hour. Animals who die for your dinner table die in terror, in sadness and in pain. The killing is often inhumane. Some religions insist that animals are killed inhumanely by having their throats cut. Conditions in abotheirs are often disquesting.

killing is often inhumane. Some religions insist that animals are killed inhumanely by having their throats cut. Conditions in abattoirs are often disgusting.

Avoiding meat is one of the best and simplest ways to cut down your fat consumption. Modern farm animals are deliberately fattened up to increase profits. Eating fatty meat increases your chances of having a heart attack or developing cancer.

The world's fresh water shortage is being made worse by animal farming. And meat producers are the biggest polluters of water. It takes 2,500 gallons of water to produce one pound of meat. If the meat industry in America wasn't supported by the taxpayer paying a large proportion of its water costs then hamburger meat would cost \$35 a pound. Run-off water from farms does massive damage to rivers and underground water supplies and, therefore, to drinking water supplies.

Vegetarians have 20% lower blood cholesterol levels than meat eaters (I'm not sure how much cholesterol levels really matter – but a naturally lower level won't do you harm.)

Vegetarians are fitter than meat eaters. Many of the world's most successful athletes are vegetarian.

You don't have to eat meat to be strong. The world's strongest animals (elephants, rhinos, gorillas) are vegetarian.

It is much easier to become
— and stay — slim if you are
vegetarian. By 'slim' I do not mean
'abnormally slender' or 'underweight', but
rather, an absence of excess weight.

In a lifetime, the average meat eater will consume 36 pigs, 36 sheep and 750 chickens and turkeys. Do you want that much carnage on your conscience?

There are millions of cases of food poisoning recorded every year. The vast majority of all those cases are caused by eating meat.

If you eat meat you are consuming hormones that were fed to the animals. No one knows what effect those hormones will have on your health. In some parts of the world as many as one in four hamburgers contains growth hormones that were originally given to cattle.

Attempts to outlaw the use of hormones have proved remarkably ineffective.

Some farmers use tranquillisers to keep animals calm. The result is that when you eat meat you are eating the residues of those drugs. And those residues are often very powerful.

African countries export millions of tons of grain to the developed world so that animals can be fattened for the dining tables of the affluent nations. If we all ate the plants we grow — instead of feeding them to animals — the world's food shortage would disappear virtually overnight. One hundred acres of land will produce enough beef for 20 people, but enough wheat to feed 240 people. This year, hundreds of millions will die of starvation in Africa and Asia. Most of those deaths will be unnecessary.

The following diseases have been proved to be commoner among meat eaters: anaemia, appendicitis, arthritis, breast cancer, cancer of the colon, cancer of the prostate, constipation, diabetes, gallstones, gout, high blood pressure, indigestion, obesity, piles, strokes and

feet, rectum and spinal cord of an

animal, and a sausage may contain

ground-up intestines. How can anyone be sure that the intestines are empty when

they are ground up? Do you really want

to eat the contents of a pig's intestines?

indigestion, obesity, piles, strokes and varicose veins. (My book 'Meat causes Cancer and other Food for Thought', which I wrote in 1994, contains extracts from 26 scientific papers beyond argument proving that eating meat causes cancer.)

Considerably more than half of all the antibiotics sold are given by farmers to healthy animals so that they will produce more meat. The percentage of infections resistant to antibiotics such as penicillin has risen dramatically as a result.

Every day tens of millions of one-day-old male chicks are killed because they will not be able to lay eggs. There are no rules about how this mass slaughter takes place. Some are crushed or suffocated to death. Many are used for fertiliser or fed to other animals.

Animals suffer from pain and fear just as much as you do. How would you like to spend your last hours locked in a truck and then cruelly pushed into a blood-soaked death chamber? Animals being transported sometimes spend days packed into two-storey lorries. Some of the animals die of starvation before they reach their destination. The animals on the lower level are subjected to a constant shower of faeces and urine from the animals above them. Anyone who eats meat condones and supports the way animals are treated.

Animals which are a year old are often far more rational — and capable of logical thought — than sixweek-old babies. I once kept four sheep as pets – they were intelligent and sensitive. They knew their names and could pick me out of a crowd. Evidence suggests that pigs and sheep are brighter than dogs and brighter than small children. If you wouldn't eat a dog or a small child then you shouldn't eat a sheep, a pig or a cow.

### So, that's it...

Eat meat if you can't live without the taste or the texture. (And I readily admit that most of the fake meats produced in laboratories don't much taste like the real thing.)

But don't kid yourself that meat will keep you healthy. It won't. All the available evidence proves that eating meat will do tremendous damage to your health. Vegetarians are healthier than meat eaters and they live longer too.

And the argument that we should avoid meat to

save the Earth is manipulative bollocks designed by the conspirators who are behind the Great Reset, the covid fraud and various social credit schemes

Finally, there are two very good, straightforward reasons to avoid eating bits of dead animal.

First, because you like animals, disapprove of the way they are farmed and transported, and would rather be friends with them than eat them. (And animals can make very good friends.) That's why I've been a vegetarian for decades.

Quality meat has all the nutrients we need in the most bioavailable form with zero toxins or antinutrients. There's even enough vitamin C (in the absence of carbohydrates, which compete for the same pathway).

No scurvy among carnivores.

Surprisingly, plants are full of naturally occurring toxins – glutens, salicylates, goitrogens, glycoalkaloids, saponins, oxalates, phytic acid, lectins and many others that build up slowly, affecting multiple organ systems, and can take years to clear. Organic Brussels sprouts contain 136 carcinogens. The least toxic veg has 60. Any nutrients plants have on paper are bound up in indigestible cellulose (fibre) and therefore minimally bioavailable. Plant anti-nutrients even hinder absorption of nutrients in meat eaten alongside them.

Correct study of our digestive system shows we are actually facultative carnivores with a gut structure and pH more like a scavenger such as a hyena – even more acidic than an obligate carnivore such as a lion.

It's not only junk food that's man made. Almost none of the so-called 'essential' modern fruit and veg grow naturally in the wild or even existed 200 years ago. Humans are the only species intelligent enough to make their own food, and stupid enough to eat it.

Bone isotope studies prove what we predominantly ate for millennia was fatty meat from mammoths, aurochs and other large ruminants, which got us through winters and ice ages when no plants were available. See the paper by Dr. Miki Ben Dor in The American Journal of Physical Anthropology.

Many largely or totally carnivorous cultures exist, such as the Inuit, the Sami, the Maasai and the Mongols.
There have been zero plant-based cultures.

It is argued that the low average lifespans of hunter/gatherers are because of meat, but that's actually due to infant mortality and lack of trauma care. The many who do get to old age, often to 100-plus, have none of our modern chronic diseases, which, along with reduced height and skull size, first appeared in skeletal remains about 10,000 years ago when crop farming began.

## Fifth largest life insurance company in the U.S. paid out 163% more for deaths in 2021

LINCOLN National Life Insurance reported a 163% increase in death benefits paid out under its group life insurance policies in 2021.

This is according to the annual statements filed with state insurance departments - statements that were provided exclusively to Crossroads Report in response to public records requests.

The reports show a more extreme situation than the 40% increase in deaths in the third quarter of 2021 that was cited in late December by One America CEO Scott Davison - an increase that he said was industry-wide

and that he described at the time as 'unheard of' and 'huge, huge numbers' and the highest death rates that have ever been seen in the history of the life insurance business.

The annual statements show that the company paid out in death benefits under group life insurance polices a little over \$500 million in 2019, about \$548 million in 2020, and a stunning \$1.4 billion in 2021.

From 2019 to 2020, the year of the covid-19, there was an increase in group death benefits paid out of only 9 percent. But group death benefits in 2021, the year the vaccine was introduced, increased almost 164

percent over 2020.

How many deaths are represented by the 163% increase? It is not possible to determine by the dollar figures on the statements

If the average annual salary of people covered by group life insurance policies in the United States is \$70,000, this may represent 20,647 deaths of working adults. This would represent at least 10,000 more deaths than in a normal year for just this one company.

### Massive protests in Sri Lanka amid total economic collapse

"WE are now facing a far more serious situation beyond mere shortages of fuel, gas, electricity, and food. Our economy has faced a complete collapse," Prime Minister Ranil Wickremesinghe told Parliament on June 22.

"It is no easy task to revive a country with a completely collapsed economy, especially one that is dangerously low on foreign reserves."

Sri Lanka will hold a credit aid conference with India, China, and Japan for loan packages. Wickremesinghe said the goal is to reach a "general consensus" on the lending processes as each country has its own system for granting loans.

Wickremesinghe said that Sri Lanka has received a \$4 billion credit line from India and requested additional loan assistance from the neighbouring country.

Despite these efforts, the Sri Lankan President Rajapaksa and Prime Minister have both announced they will step down due to massive protests which saw tens of thousands of protestors storm the presidential palace on July 9. The president was escorted to safety but announced his intended resignation shortly after.

Parliament Speaker Mahinda
Yapa Abeywardena told the nation
in a televised announcement late
Saturday that Rajapaksa will
resign Wednesday "to ensure a
peaceful transition." The Sri Lankan
constitution says if Rajapaksa and
Wickremesinghe both resign, the
parliament speaker will assume
power for one month.

## Dutch lift cap on coal production amid gas crisis in Europe

DESPITE pledges to fulfil 'carbon reduction targets' for Agenda 2030, the Dutch government have lifted the cap on coal production which had been in place since... and restricted the Netherlands' coal power stations to just 35% of capacity.

Back in May Russia's Gazprom cut off gas supplies to Dutch gas trader GasTerra after it had failed to pay for deliveries in Russian rubles as requested by Russian President Vladimir Putin in March.

That decision means Gazprom will not deliver some 2 billion cubic meters of gas to the Netherlands between now through Oct. 1, when its contract with GasTerra was set to end.

"Because the risk of gas shortages has increased, the cabinet has decided today to withdraw the production limitation for coal-fired power stations for 2022 to 2024 with immediate effect," climate and energy minister Rob Jetten said in a statement announcing the move.

"There are currently no acute gas shortages in the Netherlands, but the declining gas supplies could have consequences," the climate and energy minister said.

The latest decision by the Dutch government comes just a day after Germany's economy minister Robert Habeck said that the country will limit the use of natural gas for electricity production and instead increase coal burning to compensate. The move comes amid decreased supplies from Russia and fears over potential shortages.

## Amish natural farmer fined heavily by U.S. judge for not following government regulations

AMOS Miller and his family has been running Miller's Organic Farm for over a century, providing willing and highly satisfied customers with milk, chicken, beef, and eggs. All of the food coming from Miller's farm is beyond organic, humanely raised in a non-factory setting and the animals treated with dignity as they spend their entire lives naturally and stress-free out on pasture. By any moral standard, Miller's farm is the leading example of what farming in America should look like.

Unfortunately, because Miller uses humane techniques and treats his animals well, this has put a government target on his back. Recently, federal Judge Edward G. Smith, imposed sanctions on his farm, ordering the family farm to pay over \$250,000 in fines or go to jail. Because the Millers don't use the USDA factory farm methods, this makes them non-compliant and thus



an enemy of the state.

According to the USDA, the farm is not complying with USDA regulations on how to label and process their food. But Amos says the methods which they use predate the USDA and the farm and its members have a right to free assembly and the right to choose how their food is processed without the USDA dictating to them on how to do it.

To be clear, not a single one of the farm's customers has filed a complaint. The USDA is unilaterally going after the farm for failing to use their approved slaughter houses which stress and harm the animals before they are killed.

## Austria finally lift mandate on vaccines

AUSTRIA'S health minister announced Thursday that the country is scrapping a dormant coronavirus vaccine mandate, saying the measure risked polarizing society and could even lead to fewer people getting the shot.

The government announced plans last year requiring all people aged 18 and over to get vaccinated against COVID-19, the first country in Europe to do so. The law took effect in February but lawmakers suspended

the mandate before police were due to enforce it in mid-March.

Health Minister Johannes Rauch said the rise of new virus variants had changed citizens' perception of the effectiveness and necessity of a vaccination, even among those willing to get the shot.

This could deter them from voluntarily getting booster shots that will help curb the outbreak in the fall, he said.

"The vaccine mandate hinders some people who are generally willing to get the shot from taking the booster, the idea being: I'm not going to be told what to do," said Rauch.

He said current hardships such as inflation and high energy prices, and fears surrounding the war in Ukraine, had contributed to tensions in society.

"We need every millimeter of solidarity and cohesion to cope with the coming months and years," said Rauch. "And the debate surrounding compulsory vaccination and the hardening of positions over this question tore open rifts and did away with that solidarity."

### Dutch farmers hit boiling point

TENS of thousands of tractordriving Dutch protesters have come out in force to continue demonstrations against the government's radical plan to cut nitrogen emissions by 30% - 70% as part of their 'green' agenda.

Farmers from the world's 5th largest exporter of food are demanding that the Hague immediately reverse course, and have blocked the border between Holland and Germany over the rule which would lead to the closure of dozens of farms and

On Wednesday, dozens of tractors blocked a highway close to the German border, according to traffic authorities.

Organisers are calling on people to action against rules they say will "flatten" the country's agriculture industry.

Concerned farmers and citizens are being called on to organize their own regional actions with the goal of closing all "distribution centers for food supplies and all major polluters" until "the government changes

In 2021, the Netherlands' coalition government proposed slashing livestock numbers in the country by 30 percent to meet nitrogen emissions targets.

The country has already implemented stringent restrictions on new construction with the aim of



curbing nitrogen emissions.

On June 10, the government issued a national and area-specific plan for curbing nitrogen emissions. Those emissions are heavily driven by ammonia from livestock manure.

Some parts of the country would have to slash those emissions by 70 or even 95 percent.

It openly acknowledged that "there

is not a future for all [Dutch] farmers within [this] approach," as reported by the U.S. Department of Agriculture's Foreign Agriculture Service.

The Minister of Nature and Nitrogen Policy expects about a third of the 50,000 Dutch farms to 'disappear' by 2030," the New Zealand Ministry of Foreign Affairs and Trade reported in a June 23

Market Insight Report.

The Netherlands is the world's fifthlargest exporter of food, exceeded only by the United States, Germany, the United Kingdom, and China, according to World Bank statistics

Christianne van der Wal, minister of nature and nitrogen policy, has left open the possibility that the government will expropriate land from farmers who do not comply.

The proposals and resultant protests come amid worldwide fertilizer and food shortages.

United Nations Secretary-General Antonio Guterres warned on June 24 that "there is a real risk that multiple famines will be declared in 2022," adding that "2023 could be even worse:

In Sri Lanka, a ban on chemical fertilizers contributed to an economic crisis that has destabilized the government.

The country recently announced a temporary ban on fuel sales to private

The latest round of demonstrations by Dutch farmers comes after a wave of similar protests in 2019 after lawmaker Tjeerd de Groot called for livestock numbers in the Netherlands to be cut by 50 percent.

Demonstrators have burned hay bales alongside highways, blocked roads with tractors, and spread manure to make their anger known.

Protesters have also targeted the homes of Dutch government officials, including Prime Minister Mark Rutte and Nitrogen Minister van der Wal.

Footage circulating on social media shows protesters spraying manure on Dutch law enforcement and ministerial departments.

## How The World Fell Under The Covid Spell

John Waters reviews the most important book of 2022

BELGIAN psychologist, Mattias Desmet, who came to global attention on the web over the past year with his acute analysis of mass formation in the Covid context, has just published a new book, The Psychology of Totalitarianism.

Professor Desmet's observations have led him to conclude that the overwhelming majority of the world's population has fallen under a kind of spell. It is not literally a spell, he stresses, but a 'mass formation', a term first used by Gustave Le Bon, the French philosopher who 126 years ago in The Psychology of Crowds, was the first thinker systematically to outline how herd psychology differs from that of the individual.

The book takes up the baton handed on from Le Bon and Hannah Arendt in the last century, in describing the initial manifestations of, respectively, mass psychology and totalitarianism, bringing the story up to date after the past two years of renewed globalised tyranny.

Desmet is a professor of Clinical Psychology at Ghent University in Belgium. He lectures on Individual psycho-analytics psychotherapy, and the psychology of the crowd, holding a master's degree and PhD in clinical psychology, and a master's in statistics. He has emerged as the clearest and most meticulous voice warning of and describing the dangers of mass formation - which he says is identical to mass hypnosis - and proposing what we need to do to offset them. 

them is important, which results in insensitivity to personal losses, and a willingness to sacrifice everything - education, jobs, homes, romance, health - and to disregard the losses and griefs of others. By offering a strategy to deal with the anxieties imposed by the crisis, the wouldbe totalitarians are able to create a bogus solidarity in a society that has destroyed true solidarity.

The hypnotised members of a mass formation are enabled to close out everything but that which the hypnotist tells them is important. They acquire not just an indifference to the losses of others, but an insensitivity to personal losses of their own. They become willing to sacrifice everything under the attrition of the collective injunction - in this case, at least initially, the project of 'saving lives'. People do not see the consequences of the lockdown, nor to feel empathy for the victims, or even seem to care their own losses. Their relief at being freed from their free-floating anxieties is enough to have them cleave to the newly-formed mob.

The symptoms he diagnoses and describes are manifesting now, perhaps as never before, in our once free Western world, as a collective psychological response to the unrelenting, single-focus campaign of fear to which we have all been subjected for tow and a half years. Indeed, we may now have reached a stage in this process that even Le Bon did not anticipate, for now the mesmerisers have available to them tech and techniques he could scarcely have envisaged. By the use of electronic technologies, it is infinitely easier to convert the individual to the collective mindset than if he were a member of an actual physical crowd. The advent of social media has made the present situation not merely possible, but possibly inevitable.

Desmet's new book takes us further into this toxic new territory, delving into questions concerning the increasing mechanisation of society and the malign influence of hyper-rationalist scientism on public understandings and discussions. His analysis extends into an updating of the territory mapped out in the 1950s by Jacques Ellul - the mechanistic worldview, scientism, groupthink, propaganda - moving inexorably towards the spectre of transhumanism, the New Big Thing. The book is especially interesting and groundbreaking on the symbiotic relationship between the 'elites' and the 'masses', whereby, as Desmet argues, the former are in a sense as much the ideological captives of the latter as the other way around. The book is also excellent on the given irrationality of everything, arguing that the mechanistic viewpoint is not

merely bad, but wrong. Professor Desmet's prescription for how we deal with the problem of hyperrational scientism at times seems indistinguishable from a religious view of reality, though he doesn't advocate a religious viewpoint as

Here's a sample from The Psychology of Totalitarianism:

'Most are of the opinion that science consists of making dry, logical connections between 'objectively' observable facts. However, science is, in fact, characterised by empathy, a resonant affinity between the observer and the phenomenon under investigation. As such, science stumbles upon an unknowable and mysterious essence that escapes logical explanation and which can be described only in the language of poetry and metaphor. Encounters with that essence often result in what we might describe as the seminal religious experience a religious experience that precedes and is untainted by religious institutions or dogma. Max Planck testified to that experience. in perhaps the most direct and vulnerable way: Science eventually arrives where religion once started, in a personal contact with the Unnameable.

Professor Desmet says that a mass formation can only be combated by an insistence by those who acquire an immunity to it upon telling the truth at all costs. This is because the continued presence of alternative voices serves to curb the viciousness of the rulers and constrains the mob in its excesses for long enough for the hypnosis to weaken. He says that, in spite of the growing menace of the times, we have to continue to share intelligent counter-arguments, in the hope of breaking the contrived link of free-floating anxiety to the 'virus', which he describes as a kind of welded joint created at the highest level of anxiety. Warning people of the dangers of a totalitarian state - itself a possible new object of anxiety - might cause this joint to be broken and a new one formed.



# Foundations of virology fundamentally flawed

No virus has ever been isolated or proven to cause disease

AN alleged outbreak of disease in Wuhan, China in late December 2019 was quickly reported as having developed into an 'epidemic' and on the 11th March 2020 the WHO declared it to be a 'pandemic'.

In quick succession, countries around the world were 'locked down' in an apparent effort to contain the disease; the phrase 'flatten the curve' was used to suggest that the numbers of cases were dramatically increasing to form a steeply inclining curve on graphs produced by various authorities. These 'lock downs' were claimed to be able to stop the spread of the allegedly dangerous SARS-CoV2 coronavirus.

In the months that followed, people were urged to be tested, to wear masks and to 'socially distance' by keeping 6 feet apart from each other. Reports stated that efforts were being made to produce a vaccine and that we could not return to 'normal' until we had all been vaccinated and therefore 'protected' from this allegedly dangerous pathogenic coronavirus. Amazingly, various companies within the pharmaceutical industry were able to produce a number of vaccines in record time and, as soon as they were made available to the public, people began to get their jabs.

This is obviously an extremely brief overview of the events that have occurred in these unprecedented times in which we are currently living. We are certainly all under threat, but the real threat we face is not the result of any 'infection' by a new and deadly 'virus'.

There are clearly many aspects to this whole COVID story, but the aim of this article is to focus on the core issue, which is encapsulated by the simple statement:

"No virus has ever been proven to cause any disease; therefore, there is no such disease as covid-19 caused by a virus called SARS-CoV2".

However, we realise that more clarification is required to help people understand the extent of the lies we are told, the draconian nature of the

measures we are being subjected to and the reasons for their imposition.

Viruses are defined as particles comprised of genetic material in a protein coating. These particles, which are non-living, have never been isolated and their genetic constitution has never been characterised. This in turn means that scientists have no knowledge of the actual identity of any specific so-called 'viral particle'. Furthermore, and most importantly, no 'viral particle' has been proven to be the cause of any disease – ever!

All experiments that are conducted in the belief that they will produce 'isolation of a virus' are based on the experiments conducted by John Enders and Thomas Peebles in the 1950s and reported in their seminal paper entitled Propagation in Tissue Cultures of Cytopathogenic Agents from Patients with Measles that was published in 1954. The experiments they performed are claimed to have proved that a particular 'virus' was the cause of measles; but a careful reading of the actual paper demonstrates that this is not the case.

In his article in the 4/2020 edition of his Wissenschafftplus magazine, Dr Stefan Lanka PD states that,

"Enders, his colleagues and all virologists overlooked...that the death of the cells in the laboratory is not caused by a virus, but because the cells are unintentionally and unnoticed but systematically killed in

the laboratory."

This means that all experiments since 1954 that claim to have proved a viral cause of a disease merely demonstrate cytopathic effects that are the result of the experimental procedures that involve the use of toxic substances; they are not the result of any 'virus'.

In fact, the particles that have been labelled 'viruses' have never been proven to be anything other than cell/tissue debris; as Stefan Lanka clearly states in his article,

"Virologists report typical artifacts of dying tissue / cells and typical structures...as viruses or viral components."

In other words, all particles that have been labelled 'viruses' are simply dead or dying cell/tissue debris.

If everyone were to become aware of this fundamental fact, then this false 'pandemic' would immediately come to an end.

It may therefore be wondered why has this 'pandemic' occurred if viruses do not cause disease? The simple answer to this question is: "to gain control over all aspects of our lives". Although a full explanation is beyond the scope of this short article, certain key points can be identified.

The first clue can be seen from 'Event 201', a conference held in the US in October 2019 to discuss the responses required for a potential scenario in which there was a

Problems can only be solved by correctly identifying their root causes so that measures can be taken to mitigate or even eliminate those causal factors. The medical establishment does not function from a correct understanding of the functions of the human body or of the real nature and causes of disease; it is for this reason that the current medical system can never solve the problem of human disease.

A paradigm shift is clearly needed. We owe it to ourselves and to all future generations to take responsibility for our lives and our health; the alternative – a life of complete servitude – is unthinkable.

## Rest In Peace Germ Theory?

IN the 1800s, the nascent medical industry postulated that diseases were caused by invisible, infectious particles attacking the body. Some of these diseases turned out to be vitamin deficiencies such as scurvy, beriberi and pellagra. Others turned out to be caused by poor sanitation and toxins. For example; by the time the vaccine to fight the so-called measles particles was introduced, improvements in hygiene had already lowered the death rate to nearly zero.

The vaccine for smallpox was also useless and many were killed by it. The method until 1895 was to take scabs and pus (expelled dead cells, bacteria and toxins), add them to water and rub the mixture into cuts made into the arms of babies and children. Alfred Wallace wrote in 1898 how incredulous it was that so many educated specialists could be deceived into accepting that vaccines were effective, when there was no proof. The same could be said today.

The electron microscope was not in use until the 1930's so no-one had actually seen any invisible particles. However even today SARS2 has not been observed in a sample as there is apparently never enough.

Has SARS2 been observed by the indirect method of 'isolation'? If isolation means separation, then no, it hasn't. Crude samples from sick patients are added to abnormal monkey kidney cells, antibiotics are added and the cells starved. Toxic effects seen in the cells is called isolation and the effects of adding proteases is called viral activity. However, as control cultures treated in the same way are not done, these claims must be totally

disregarded.

How was a genome mapped out if the virus had not been seen or separated? A patient who lived and worked in Wuhan, one of the most heavily polluted cities in the world, presented with symptoms of fever, chest tightness, unproductive cough, pain and weakness. This collection of symptoms, commonly used by the body to expel toxins, was inexplicably declared to be a new and distinct disease. Fan Wu et al analysed an unpurified lung sample from the patient, which contained his stressed, dead and dying cells (we know that stressing cells can produce novel genetic sequences and novel proteins), as well as mucus and bacteria, and detected 56,565,928 short fragments of RNA. These nucleotides were fed into a computer which made 384,096 overlapping sequences, from which one was chosen. This was further rearranged to make 30,474 nucleotides that resembled a previously guessed at sequence from bat poo. There was no evidence that the computer nucleotide sequence represented a genome coding for an actual external entity and was not just parts of the genetic material of the patient.

No attempt was made to show correlation between the presence of this nucleotide sequence and the presentation of the same symptoms in any other patients, nor to show its absence in healthy people (indeed it seems that half the people it's detected in have no symptoms), nor that it could transmit symptoms to others. It was simply declared to be the genome of a virus that was the cause of common symptoms, and which was able to replicate and infect others. This is utter

interests might say.

We do not need lockdowns, social distancing or masks. Transmission of disease has not been shown with the 'highly infectious' Spanish flu, a disease state that occurred after millions were bombed, shot at, separated from families, malnourished and terrified. In 1918 62 healthy volunteers were exposed to the fetid air of very sick patients, who repeatedly

coughed in their faces. Much to the authors surprise, not one developed any influenza like illness.

Many lessons could have been learnt from AIDS; a collection of symptoms caused by oxidation, poppers, drugs, malnutrition and poverty, and not by 'HIV'. AIDS cannot be sexually transmitted by 'HIV' as it is only correlated with frequency of receptive anal sex: semen

is highly oxidising and the anus is very thin.

The AIDS test detects proteins present in many conditions including pregnancy and health, so a diagnosis is given on patient history; blood transfusions, or being a Black African or a gay male. Seeing positive results only where one expects to see them. This is so far beyond the scientific method as to beggar belief. Many who tested positive took their own lives and many more were killed by the toxic 'cure' of AZT.

What about bacteria and fungi? These proliferate in disease states, though they seem to helping by breaking down and clearing toxins and dead cells. We cannot survive without the microbiome which protects the lining of our skin, gut, kidneys and brain and nourishes cells among many other things.

## Social Credit system: Nightmare on your street

### Social credit means a dystopian, digital world where you can forget about privacy, freedom or rights

Social credit is leading us straight into the sort of world predicted by Orwell and Huxley

YOUR body, your mind, your spirit and everything you once thought you owned will belong to the conspirators and their world state. Social credit, promoted by the WEF, the UN, the WHO and a bunch of independent, unelected billionaires, is the finale.

A few years ago, in a book called 'The Game's Afoot' I wrote that the Chinese Government was giving people marks according to behaviour. It was, I wrote, called 'social credit', and citizens were being ranked and rated.

'The Government,' I warned,
'will measure people's behaviour in
order to decide what services they
are entitled to access.'

And so it has come to pass.

'I don't know what all the fuss is about,' said a politician. 'If you behave yourself it will be a good thing.'

Social credit is a scheme designed to enable governments to control their citizens. Every new law and rule ties into the social credit system. It's communism.

Look at how social credit has operated in China since 2014. Social credit ratings are measured with a simple points system. Citizens start off with 1,000 points and then lose points if they 'misbehave'.

Information about every individual is collected together from all possible sources – schools, workplaces, banks, doctors' surgeries, hospitals, police, courts, libraries, supermarkets, internet platforms, travel companies and closed circuit television camera.

Supermarket cameras and credit card computers watch to see how much you spend on alcohol, cigarettes, sweets and fatty foods.

The goal is to provide the Government with a general assessment of each individual citizen's trustworthiness.

'Good' citizens are allowed to travel, use a public library, rent bicycles, borrow money, send their by **Dr VERNON COLEMAN** MB ChB DSc

children to better schools, obtain better quality of health care and get better jobs.

Buying green vegetables, sensible clothing and nappies will boost a citizen's rating. Buy sensible work shoes with good soles and your rating will rise. Those who praise the Government will see their rating improve.

'Bad' citizens, who are rebellious, deceitful or disobedient are denied access to travel, hotels, restaurants, good schools, good hospitals and good jobs. 'Bad' citizens may be banned from entering shopping malls or food stores and denied access to food

Buying chocolates, alcohol or frivolous clothing will damage your rating as will playing games on the internet.

Citizens who fail to visit their parents regularly are punished as are jaywalkers, those who smoke in nonsmoking zones and those who walk a dog without putting it on a lead. Not sorting your personal waste properly is a sin as is swearing in public. Reporting friends, relatives and neighbours for using bad language will win you points. All internet data (including searches) is used to compile social credit ratings. Players who cheat in online video games are punished. If you miss recommended tests or jabs you'll be punished.

By 2019, 23 million people in China had been blacklisted from travelling by train or aeroplane because they had low social credit ratings. Students are prevented from attending schools or universities if one parent has a poor score. Employers are encouraged to consult blacklists before hiring new employees or handing out contracts.

Some years ago I wrote a weekly column in a large circulation Chinese newspaper. One week I wrote a column criticising vaccination. I was sacked within hours of the column appearing. And a couple of days later I received an email from my Chinese publisher telling me that my books (several of which were long-term best-sellers) had been banned. No other publisher in China was allowed to publish any of my books.

The Chinese social credit system requires citizens to carry smart phones which are equipped with

Apps connecting them to a central bureaucracy.

Smart TVs, computers, iPads, cell phones and so on also collect data by recording conversations, movements and user activity. Video games use facial recognition software.

Social credit schemes are now being developed worldwide.

New Zealanders who go to Australia are entitled to live and work there for life unless they fail a 'good character' test in which case they will be deported. The good character test is decided entirely at the discretion of officials.

In Bologna, Italy, the authorities have introduced a 'smart citizens' wallet'. Holders receive digital points to obtain discounts for virtuous behaviour.

Ukraine has set up a social credit App combining universal basic income, digital ID and a vaccine passport in a single App.

In France, President Macron introduced a Digital Identity Guarantee.

In Canada, the Government has a new advisory group to enforce censorship and to regulate what they decide is harmful content. The Government has sole authority to decide what can be regarded as a conspiracy theory. Sequestration powers enable the Government to take your money out of your bank account.

In Vienna, Austria, every citizen will be offered an App which will reward good behaviour with 'Vienna Tokens'. The plan is to turn Vienna into a smart city with data replacing money as the city's currency. In future all decisions will be made by artificial intelligence so that there will be no need for elections.

In Germany, citizens have a SCHUFA score which is necessary for buying or renting a house or receiving goods on credit. The system tracks each citizen's entire credit history. Someone who lives in a poor area, or has low scoring neighbours, will find that their score is lowered.

In Russia, by 2025, four out of five Russians will have been given a 'personal development trajectory – a digital file which will contain every achievement in a person's life – 'the misses, mistakes, big projects'. The aim is to digitalise the Russian economy.

In Zimbabwe, 'people who peddle information deemed false by the

Government face up to 20 years in prison, a hefty fine or both.' In Thailand, the Government warned that 'anybody joking about the virus could face up to five years prison time'.

In Holland, a bank links customer spending habits with their CO2 emissions.

In Ireland, the Government has stated that The State 'shall delimit the right to private property where it is necessary to ensure the common good'.

Iran has introduced digital food rationing based on biometric IDs.

In Wales, selected citizens will be given £20,000 a year. They will be allowed to keep the money on top of anything they choose to earn. This is a generous version of Universal Basic Income.

India has a program known as 'Aadhaar' which means that each resident has a 12 digit number. Each individual has their fingerprints and iris scans stored.

International Monetary Fund researchers want internet search history to be tied to credit scores.

In the UK, the Government has a 'nudge unit' to create fear and shame and promote group think. Councils warn homeowners that 'failing to register (to vote) can have a negative impact on your credit score'. The UK Digital Identity and Attitudes Trust Framework, part of the nationwide digital ID push, enables citizens to prove their ID using digital methods.

The UK Government has a new App to monitor shopping habits and encourage healthy eating. Cinemas are planning digital ID cards for children

In 2020, when most people were wondering if they dared nip out to the shop to buy a can of beans, and wondering if it would be legal to buy a loaf of bread as well, the UK Government quietly published 'Evidence and Scenarios for Global Data Systems – the Future of Citizens Data Systems'.

Your local council checks your recycling. Owners of old cars are fined or denied access to city centres.

Life for the 'good citizens' will be just like life in the USSR and China. It will be like life in a giant prison camp. 'Good' citizens will be entitled to buy cheap food, rent cheap apartments, take cheap holidays and get jobs with light

work. They will be entitled to free education for their children and free medical care too.

The world of social credit gets absolutely everywhere; it's more intrusive and tougher to remove than hogweed. You probably think I'm making this up. I wish I were but I'm not.

The old and the sick and the overweight will lose points. Eating on public transport, missing a medical appointment and parking in the wrong place will lose you points.

This is the technocratic state in full flow

There are public loos in China which won't let you in without first checking your face and identifying you. Only then will the machine dispense the small quantity of loo paper you are allowed.

Social credit means a dystopian, digital world where you can forget about privacy, freedom or rights. Good behaviour will be rewarded and bad behaviour punished. But who defines what is good and what is bad?

## Assange verdict: British courts and media GUILTY!

THE months-long extradition hearings of Julian Assange, a trial that will forever define modern journalism, have been shamelessly whitewashed by British media. Too few news agencies reported on the utter abrogation of judicial Due Process and The Rule of Law exhibited in a British courtroom against an innocent fellow journalist.

This sham trial exposed a fundamental British truth: That the UK courts and its press are really America's concubines, willing to fellate any U.S. interest on command.

With the number of courtroom seats set at only sixteen, the few in attendance at Westminster Magistrate's Court provided the only reporting from the trial to the world. Former UK ambassador to Uzbekistan, Craig Murray reported daily the courtroom torture of Julian Assange. However, world media quashed the story!

Wrote Murray in outrage:
"I simply cannot believe the blatant abuse of process that is unfolding before my eyes in this courtroom.... A complicit mainstream media has ensured those of us who know what is happening are very few."

Extradition effectively began after Assange was dragged from the Ecuadorian Embassy on April 11, 2019, and sentenced on May 1 to fifty weeks in jail for jumping bail for the safety offered by thenpresident Rafael Correa. The bell tolled when incoming president Lenin Moreno rescinded his asylum due to U.S. pressure.

The judge for the extradition was Vanessa Baraitser, who was selected by Chief Magistrate Lady Arbuthnot whose husband James has substantial interests with UK and U.S. defence and security contractors and has condemned Assange publicly.

The travesty of justice began at Baraitser's opening gavel when she first denied bail and ordered Assange to be placed each day in a plexiglass box with one bailiff on each side of him at the back of the courtroom where he could not communicate with his attorneys. Baraitser's order brought defence councils QC Edward Fitzgerald and QC Mark Summers together with prosecutor QC James Lewis in stipulating to allow Assange to sit, as normal, with

his council. Baraitser denied the request.

Assange was punished before and during the hearings. Always handcuffed, he was moved between five isolation cells on his way to a plastic box. In Belmarsh Prison he has not been allowed proper medical attention, denied his books, writing supplies and access to his court documents, while being kept in solitary confinement.

When Trump became U.S. president his Attorney General Jeff Sessions stated that it was suddenly "a priority for the Justice Department" to arrest Julian Assange. Later William Barr as AG, in May 2019 issued a new superseding indictment -sealed and ignored since 2013- that added seventeen counts related to the 1917 Espionage Act. This had been an abandoned attempt by Obama AG, Eric Holder who refused to indict Assange using the Espionage Act. Yet the allegations were the same in 2018 as they had been in 2013.

Assange's fate may have been sealed, however, when in the last weeks of the Trump/Clinton presidential Wikileaks provided to the American voter documentary emails that plainly showed that the Democratic National Committee (DNC) led by Donna Brazile, John Podesta, and Amy Wasserman Schultz were not promoting democracy at all, but instead a two-year conspiracy to elect only Hillary Clinton regardless of rising national support for Bernie Sanders. Days later...Hillary lost.

Abuse of process by the

prosecution gave many reasons for an impartial judge to summarily dismiss the extradition request. Baraitser's court ignored the wiretap of Assange's embassy office and of his privileged conversations with his attorneys, the U.S. discussion of having him assassinated and that much of the evidence produced by the prosecution was false and that OC Lewis knew it.

extradition request was first in question because the 2004 U.S./UK extradition treaty provided a specific exemption for Political Prisoners. A separate UK treaty, not specific to the U.S./UK treaty however, did not contain this prohibition. Baraitser ultimately favoured the prosecution, ignoring the exemption for political dissidents.

The defence produced experts

Wikileaks was to keep the Manning tranche safe while redacting. When Assange got word of Harding and Leigh's treachery he alerted US officials. Yet, quietly the Guardian failed to comment. Publicly they let Assange swing instead of Harding or Leigh.

On June 26, 2021, the man the FBI used as its main informant in Iceland regarding Assange helping Manning break the non-existent password, Sigurdur IngiThordarson recanted his testimony saying it was coerced. His claim is bolstered by Iceland's expulsion of the FBI because it was fostering Thordarson to frame Assange.

After the many weeks in court, as expected Baraitser ignored virtually the entire defence and ruled that the U.S./UK treaty prohibition did not apply, Assange was not a journalist, nor a political refugee, he did help Manning access a code that did not exist, and he had not redacted national security information.

Unfathomably, Baraitser next ruled that Assange could not be extradited since incarceration American-style would likely force his eventual suicide.

Any celebration was momentary. Baraitser remanded Assange back into custody pending a U.S. appeal. In Appeals, the UK High Court on Dec 10, 2021, ruled that renewed American "assurances" regarding Assange's treatment in U.S. prison could legally negate Baraitser's inconvenient decision otherwise.

Assange next appealed to the UK Supreme Court but they refused him standing, leaving Home Secretary Pritti Patel to twist the knife and approve Assange's extradition on Lyne 16

The extradition, a Kangaroo court 12 years in the making will now return before the High Court in a last desperate appeal for abuse of process. But first, the Union Jack will be dutifully lowered again from sight, in favour of the Stars and Stripes.

Baraitser on many days brought a laptop from which she read an obviously prepared ruling at the end of the day's proceedings.

QC David Lewis spoke for the American interests while a team of four unknown Americans sat behind him each day passing him notes. The prosecution's case hung on four main points: Assange was not a journalist nor protected by Free Speech or Political Prisoner statutes; Assange had committed crimes when he allegedly helped Chelsea Manning obtain a password for her leaked classified material; that Wikileaks put lives at risk by failing to redact important names when publishing the 2010 leak; and that Assange would certainly receive fair treatment in the U.S. and after being found guilty.

For testimony, the prosecution relied substantially on the written affidavit of U.S. Assistant Attorney Gordon Kromberg who was the man who crafted the 2018 U.S. superseding indictment against Assange. Kromberg provided many assurances of Assange's guilty.

For the defence, QC Edward Fitzgerald and QC Mark Summers countered every allegation using expert witnesses with impeccable credentials. Baraitser again knee-capped the defence by not allowing more than thirty minutes to introduce each expert and their statements to the court. Conversely, she allowed QC Lewis four and one-half hours for each of his cross-examinations.

The very legality of the U.S.

with knowledge with working knowledge of Alexandria City Jail, and the Florence, CO SuperMax-Assange's fate. 23 hours a day in isolation with one hour of exercise per day while shackled, two phone calls and one family visit a month and restricted access to his attorneys. Gordon Kromberg by affidavit, "assured" the court that Assange would not likely suffer these conditions.

With the hearing already underway, on June 20, 2020, the prosecution suddenly announced that it was introducing a brand new subsequent indictment. Evidence showed that the U.S. prosecution had planned this move for months despite the defence's preparations. Bariatser gave the defence a mere six weeks to prepare to challenge the new allegations that the US had kept secret from the court and the defence for months.

Regarding the allegations of Assange helping Manning gain a password for access to classified information the defence and its witnesses showed that no password was required to gain access; that a journalist aiding a source is constitutionally protected and that Assange had gone to great lengths to redact sensitive information and that Wikileaks had worked directly with U.S. officials to do so.

As to the Manning leak becoming public, the defence showed that it was two journalists from The Guardian newspaper, Luke Harding and David Leigh, who published the security code in their tell-all book,

## Medicine in the matrix

Why do good clinicians remain loyal to the system?

A LARGE majority of patients have been educated to believe that healthcare is concerned with health. Why would anyone think differently? In reality, healthcare is a business and all businesses need customers. There is no money in healthy or dead patients, so the best business model is to have the largest number of unwell patients.

Once an individual has surrendered the management of their health to a clinician, they have become disempowered and are dependent on the system. They keep coming back to the system expecting solutions to the problems that are increasingly being created by the system.

Why do so many clinicians in the healthcare system seem unable to see what is obvious to many people who are outside the healthcare system? The truth is that healthcare is a designed system. A system where the truth can be hidden in plain sight, and individuals can be controlled whilst believing they are free. To understand the behaviours of the clinicians in the healthcare system, we need take a broader view of human behaviour in *The Matrix*:

As a young pharmacist I believed that everyone always acted in the best interests of society and for the greater good of humanity. I was frequently disappointed and confused by what I saw in the healthcare system. I came to understand that my idealism was never going to be a match for the system. I now accept that the healthcare system has been very carefully designed for the benefit of those that designed it, and not for the benefit of patients.

I still believe that almost all clinicians join the healthcare system to help patients. I also believe that the majority of clinicians think they are providing high-quality evidence-based services for patients. Sadly, this is not the case today, as few healthcare systems are capable of demonstrating that they are achieving good outcomes for their patients. There are many reasons why good clinicians remain in a system that can be easily shown

to be adversely affecting a significant proportion of patients over the last two years.

The Western allopathic healthcare system thrives on the division of the practice of medicine into specialisms and sub-specialisms. Whilst this may seem logical, as humans are very complex biological organisms, the result is often the management of illness as a dysfunction of a single organ or tissue, with little attention being paid to the whole human.

Models of healthcare that have

evolved over thousands of years that take a more holistic and environmental approach to managing illness are often described as quackery by allopathic doctors. This is a learned response, often coming from a position of little or no knowledge of alternative treatments, and quickly closes the door to therapies which may be effective but do not involve a drug.

Doctors are trained to diagnose illness, but few invest their time in trying to address the behavioural or other factors that are causing

the illnesses in their patients. The system is designed to produce clinical diagnosis codes that match the symptoms the doctor has observed. The next step is usually to prescribe a drug, or refer a patient to hospital for further investigations that can result in surgery and other interventional procedures, such as radiotherapy.

The medical education system is very effective at producing individuals who believe what they are taught and do not challenge what they are taught. By the time doctors qualify and start treating patients, they have been very effectively conditioned to perform as intended by the system. Medical education also seems to be very effective at removing the ability of intelligent people to think for themselves.

During their training, medical students are worked extremely hard and soon learn to reproduce what they have been taught, and not to challenge the system. Heavy workloads and an intolerance of challenges to authority produces doctors that are too busy or not inclined to do their own research. Most practicing doctors believe the information they are provided with by health authorities, and follow the guidance that they have been given.

Status, power and money are corrupting influences on clinicians. The fear of losing them certainly has a very strong influence on clinical behaviour. Even when an individual clinician wants to follow a different treatment course, the system often makes this difficult or even impossible. Individuals learn to conform with the clinical practice of their colleagues and conform with the system. There is a very strong human survival instinct to conform with your tribe, even when you may have a different belief.

Fear itself has a very powerful influence on behaviour, and reduces, or even removes, objective thought and critical thinking amongst clinicians. This has been particularly evident during the recent 'pandemic', where the fear of death has become very real for clinicians of all ages.

When doctors are busy and stressed, they come to rely on pattern recognition to decide how to manage patients. A collection of symptoms and test results that fit a previously observed pattern can be used to diagnose an illness and then prescribe the appropriate treatment. In a busy healthcare environment, pattern recognition can lead to an incomplete understanding of the condition of the patient, and can result in harm or much worse.

So, where do we go from here? Sadly, my experience has taught me that the existing healthcare system cannot be changed into one which is designed to put patients first.

It is now time to stop conforming and to start reforming.

We must place our energies and actions into building a true healthcare system that is designed within our communities. The future of health lies outside the system - beyond the matrix!

# Does an apple a day really keep the doctor away?

ZOOKEEPERS keep their animals healthy by feeding them exactly the right foods, the foods that they would have eaten in the wild. The pandas will have just the right type of bamboo.

The carnivores, the monkeys, the penguins, the anteaters, will each be given exactly what they need. If an animal suddenly gets ill, the first thing we'd ask the zookeeper is "what's wrong with their food?"

Many years ago, farmers worked out what minerals or nutritional elements their animals lacked as they observed that the animals would self-medicate if they could. By observing what rocks they licked, what plants they chose to graze on along with the study of nutritional elements, the farmers, scientists and vets worked out what mineral deficiencies caused which diseases in sheep, chickens and cattle and what minerals and nutrients would remedy them. This vastly cut down the expense of pharmaceutical drugs.

Many nutrient deficiency diseases in animals are the same for humans. It's a great shame that this knowledge has not been applied by medical doctors to people.

Most people are eating food that quite frankly has been poisoned. When you go into a food shop, the food that's been grown naturally should just describe itself as a peach or as bread or milk. The other 95% should have 'Poisoned' written on them. Yes, you could sub-divide for clarity into 'highly poisoned', 'partly poisoned' and 'hardly poisoned' to help the consumers. Which one would you choose?

Let's look at modern food. Some years ago, I spoke to a farmer, and I asked him how he'd grown his apples this year and I mentioned that I had had a small farm myself at one time. He was delighted to tell me everything he'd done to get such perfect-looking apples. He explained what chemicals he'd sprayed on and how he had then sprayed on wax to stop the rain washing the chemicals off. He was very proud of his perfect apples. The question is, with food in general, how much of the pesticides, herbicides, larvicides, insecticides, fungicides still remain on and in the foods that we are told are safe?

What qualities does an apple have? Apples, especially the vitamin B17 rich pips, are very powerful on a nutritional level.

Now let's look at vitamin C in the apple and its importance as an antioxidant. When the apple is fresh and whole it is crisp and delicious. As it ages it begins to wither and die and its vitamins are lost. When the apple is exposed to air it begins to oxidise and go brown, just like metal rusting. ## Stakeholder capitalism - how corporations will rule the world

Covid-19 being used as catalyst to bring about Schwab's vision

THE declaration of the covid-19 pandemic in the spring of 2020 brought the world's economic systems to a near-standstill, decimating small and independent businesses and creating catastrophic hardships on working people everywhere.

In June of 2020, the World Economic Forum (WEF) - an elite think tank representing global corporations, government officials, academia, the media, and social policy influencers - in partnership with the United Nations, announced a plan to address the systemic economic and social injustices that the pandemic revealed or magnified.

Issues like 'gaps' in access to goods and services, the fragility of supply chains, and the environmental impact of daily activities such as driving to work were raised.

'The Great Reset' as the plan is called, aspires to 'seize something good' from the crisis by using it as the 'golden opportunity' to implement 'stakeholder capitalism' on a global scale. Executive chairman and CEO of the WEF, Klaus Schwab, has long argued for a new global socioeconomic order that is equitable, inclusive, resilient, and sustainable - "a new social contract that honours the dignity of every human being".

In order to accomplish this, Schwab argues businesses and corporations must adopt the governance principle (i.e. a framework establishing a corporation's strategic operations toward a mission or purpose) known as Stakeholder Capitalism.

Schwab claims that the realities of life in the 21st century - especially factors associated with The Fourth Industrial Revolution, or 4IR, such as automation, robotics, digital technologies, globalisation, nanotechnology and bioengineering - reveal the fundamental interconnectedness of people and environment.

He says this demonstrates the need to move beyond the outdated paradigm of prioritising the self over the community. Harmony among people and with the Earth that we by JULIANNE ROMANELLO

share is possible if we can set aside our attachment to individualism and individual rights. These must be tempered by reference to the 'common good', which looks toward the needs and preferences of the public as a whole. Schwab's reflection on the mentality guiding Germany's post-WWII recovery captures the heart of Stakeholder Capitalism, i.e. that "one person or entity could only do well if the whole community and economy functioned."

Stakeholder Capitalism is distinguished from two familiar economic models, both of which have a narrow vision of whose interest corporations are to serve:

- 1) Shareholder Capitalism, the standard model for most Western businesses, which sets profit maximisation for corporate shareholders (i.e. equity investors) as its primary criterion of economic success.
- 2) State Capitalism, a system in which the state dictates the structure and direction of the economy as a whole and requires individual corporations to conform to it. The primary example of this model is China

Where shareholder capitalism prioritises the economic success of individual corporations and their investors - oftentimes at the expense of the economic success of the community as a whole, state capitalism seeks to maximise the economic benefits to the community as a whole - even if that leads to diminished returns for the corporate entities that drive the economy.

By contrast, Stakeholder Capitalism seeks to harmonise the interests of the individual and the interests of the community. This 'third way' is accomplished by evaluating competing interests through a forward-looking or long-term moral perspective that envisions people and planetary balance as the ultimate economic goal. Or, in other words, sustainable development.

That is the core of stakeholder capitalism: it is a form of capitalism in which companies do not only optimise short-term profits for shareholders, but seek long-term value creation, by taking into account the needs of all their stakeholders, and society at large.

In an article in TIME Magazine Schwab explains that as "stakeholders of our global future", government, The Great

that: "stakeholder capitalism...
positions private corporations as
trustees of society, and is clearly
the best response to today's social
and environmental challenges". In
this model, private corporations,
which are able to optimise operations
in response to pressing 'global'
problems, assume the place and
powers heretofore assigned to
representative government.

The Great Reset plan attempts to reconfigure almost every feature of society. Its launch of Stakeholder Capitalism, which positions private corporations to assume responsibility for the programs and powers of governments that (in principle, at social contract" is questionable.

But with rising unemployment and decreased consumer spending come lower tax revenues and, subsequently, severe budget deficits that will prevent public agencies from fulfilling their public service obligations - and at a time when more and more people find themselves in need of this assistance. Covid-19 is just the sort of crisis that's needed if one wishes to launch a 'new social contract' quickly and without the hassle of consulting the public. It is indeed a 'golden opportunity'.

As we saw earlier, Stakeholder Capitalism sets up private corporations as 'trustees of the social good'. How well a corporation lives

business, and civil society all "have a shared responsibility to shape the world in collaborative ways".

The "golden opportunity" presented by the declared covid-19 pandemic consists in the revelation of the sub-optimal ability of representative governments to respond effectively to a traumatic and disruptive global crisis. Governments were slow and ineffective in their efforts to contain the spread of the disease and to make timely public health recommendations.

He argued that, by contrast, the private sector - especially technology and pharmaceutical companies - proved its ability to innovate, adapt, and collaborate to deliver a quick and effective solution to an immediate need.

Just a few months prior to the pandemic declaration, Schwab wrote

least) were designed to be accountable to the electorate, is one of the most radical and consequential of its innovations."

The governmental functions to be privatised under Stakeholder Capitalism include the administration and oversight of public services such as health and education services, housing, safety, transportation, and cultural events; and they also include executive, legislative, judicial, and regulatory powers.

In the stakeholder model, these functions are delegated to private or quasi-governmental corporations, often through a public-private partnership, or "P3."

Absent the unprecedented economic devastation caused by close to a year of lockdowns, the likelihood that the people of Western nations would readily adopt the WEF's "new

up to that responsibility will become the basis of its reputation capital score (ESG) - that is, its value as brand and that will be the key to securing a competitive edge in the radicallyaltered 4IR post-Covid economy.

What better way to earn a reputation for social responsibility than to partner with cash-strapped public agencies in order to support public relief efforts with a variety of grants, exptert research and development services, and operational support?

Through these partnerships, private companies - in contrast to the people or their representative government - will acquire the means to drive social progress and to act as guardians of entire 'ecosystems' of people, places, things, and ideas.

## Logos Rising

The overturning of Roe V Wade represents an unprecedented weakening of Jewish control over America, says Dr E Michael Jones

THE media hype surrounding the Supreme Court's overturning of Roe v. Wade brought back memories of my engagement in the almost fifty years of America's abortion wars. Eleanor Smeal, who was then head of the National Organization of Women, had just given a talk on abortion at the University of Notre Dame in what must have been the 1980s. The room was packed with feminists from that university and St. Mary's College, the soi disant Catholic institution which had fired me for being against abortion a few years earlier.

As my attempt to inject some reality into what was obviously a pep rally for what St. Paul referred to as silly women obsessed with their sins, I asked Ms. Smeal during the Q & A "Does the foetus have sex?" Seeing that she was taken aback by the question, I rephrased it: "Is the foetus identifiable as either male or female?" Expecting a realistic answer to the question, I was ready to follow it up with asking how the National Organisation of Women (NOW) justified the murder of unborn women. but what I got was unexpected. "The process of sexual differentiation," the president of NOW opined, "begins at birth." Pondering whether there were any professors of biology in the room who could back up this astounding statement, I started to write down what Ms. Smeal had said, whereupon she screamed at me from across the room, "Don't write that down. You got me crazv."


Roe v. Wade, in other words, had no basis in reality. It was, as Bernard Nathanson pointed out in his memoir, a fantasy concocted by what he termed a bunch of crazy Jews from New York which got imposed upon the United States of America by raw judicial power. Actually, raw judicial power was only part of the story. Abortion got imposed on New York before it got imposed on America by a Jewish newspaper known as The

New York Times at around the same time that this same Jewish newspaper imposed another Jewish narrative, known as the Holocaust, on the country during a period stretching from the late 1960s to the mid-1970s. In both instances, the operative editorial principle at the nation's 'paper of record' was that truth was the opinion of the powerful. In both instances, this principle worked fine until it stopped working, and it stopped working because reality has a way of putting an end to fantasies, which is another way of saving that the repressed always returns, because whatever is being repressed is only being repressed because it is true.

Once it became clear that Jerzy Kozinski was part of the Sulzberger clique which ran the Times. Elie Wiesel certified Kozinski's book The Painted Bird as a Holocaust classic. I used the word book advisedly, because Kozinski played a double game with his publisher and the reading public by claiming that what was a second rate novel was really a memoir which really happened. That fiction fell apart when the Village Voice published an expose which explained not only that what Kozinski said never happened, but also how his memoir had been written by a ghost writer for the princely sum of \$500. So, in addition to being a fraud, the most celebrated Holocaust novelist since Elie Wiesel also turned out to be a cheapskate as well

Something similar happened to Roe v. Wade. The fundamental truth of Roe v. Wade is that truth is the opinion of the powerful. If enough guilt ridden women got together and claimed that the process of sexual differentiation began at birth, then, dammit, that was a true statement, no matter what the biology department had to say to the contrary, because truth was the opinion of the powerful, and if you didn't believe a loudmouth harridan like Ellie Smeal, then the Sulzberger clique at the Jewish paper of record was there to back up whatever she said, no matter how absurd. The result was that this preposterous fiction was kept on life support for almost 50 years, until reality intervened and what seemed like immutable "settled law" disappeared as suddenly as a soap bubble making contact with a thorn bush.

But not before it did a lot of damage. Millions of children died because of this Jewish fantasy. Nothing we can do will bring them back. Instead of going on to lead fulfilling lives, they became martyrs

to the truth, and it was in the end the truth that prevailed, but not before a lot of collateral damage was inflicted on the culture which allowed their murder. Because of Roe v. Wade, the concept of equality before the law was eliminated from our judicial system, to be replaced by a two-tiered system, in which you fit into one of two categories. Everyone was now either a foetus, in which case he had no rights whatsoever, or he was a feminist, in which case he had Jewish privilege and was above the law.

The "Summer of Rage" narrative which has been confected by mainstream Jewish media outlets is very similar to the same narrative that they have confected concerning the war in the Ukraine. Once again, the operative principle is that truth is the opinion of the powerful. And, once again, this fragile fantasy is about to burst like already mentioned soap bubble, as soon as it comes in contact with the category of reality known as the Russian army. The more Russia crushes the Ukrainian Nazis in battle, the more stories we hear extolling Ukrainian President Zelensky as the

latest avatar of Winston Churchill.

In this, coverage of the summer of defeat in Ukraine is similar to coverage of the Summer of Rage in America. In each case, the concoction of Jewish fables serves as a substitute for honest reporting about what is real. Truth, it turns out, isn't the opinion of the powerful after all, because nothing is more powerful than what is real, and what is real is always the correspondence of mind and the thing. It is never the mind in lieu of the thing.

As if admitting that Roe was confected out of thin air and that it was based neither on science or the law, the Jews responded to the leak of Justice Alito's brief by claiming that abortion was "a fundamental Jewish value," and that the Supreme Court, by striking down Roe v. Wade was preventing Jews from practicing their religion.

The Zeitgeist suddenly took a turn in the opposite direction, away from the centralization of power in Washington which was a necessary precondition for projecting imperial power onto the rest of the world

after World War II, back to state legislatures, which have always been more in tune with the will of the people they represent. This meanspace, Ms. Smeal-that "science is real"; the foetus is a little boy or a little girl in the womb and doesn't become one at birth. It also means that that fat Jew in a dress who calls himself "Rachel" Levine isn't a woman no matter how much he mutilates the body God gave him. It also means that Ukraine is losing the war, no matter how many flattering articles the Jewish paper of record writes about the Jewish piano player in the olive drab T-shirt. It means, finally, that the era of Jewish hegemony over our culture is coming to an end.
