# RTÉ Vaccine Fraud

RTÉ's shameful dereliction of duty during the Covid era has guaranteed its inevitable demise

### EDITORIAL

Those who abandoned the channel years ago had observed the creeping narrative which would serve to render Ireland unrecognisable to the country we once knew.

At first the signs were subtle: a touch of political correctness here, a hardline man-hating feminist there, a Catholic-basher in the back row.

Mostly, this was treated by the public with indulgence: 'Political correctness gone mad!' we would proclaim, not realising we were observing the early stages of the capture of our education system followed by the capture of our country. In fact, we were witnessing the early manifestations of Cultural Marxism, an ideology pledged

to create dissension and division within the nations of the West with a view to rendering them amenable to ideological conquest.

Their manic behaviour is an indication that they know the game is up, their lies have been found out and they are cornered rats on a sinking ship.

For decades, RTÉ has been in breach of even its own ethical charter which clearly states that 'all relevant facts and available information should be weighed to provide the most accurate, fair and objective report,' not to 'present factual material in a way that will materially mislead the audience,' and above all to approach its responsibilities in a

spirit of impartiality and 'not unduly favour one perspective over another.'

These undertakings have long since been abandoned. RTÉ no longer exists to serve the public but the interests of puppet politicians, Big Tech/Pharma and other powerful lobby groups and NGOs seeking to embed 'One World' totalitarianism, censorship and the destruction of all the values we associate with the free West.

The channel reached a new low when globalist spin doctor Jon Williams, a Liverpoolian with no understanding of Ireland, was put in charge of News shortly after President Trump was elected in 2016. A former foreign editor at ABC and

# Vaccines have killed thousands in Ireland

**THE staggering death toll from Covid vaccines has surpassed that of the Northern Ireland Troubles, which took 3,500 lives.**

The killer injections are being linked to an extra 500 deaths a month in the Republic or an excess of 16 per day above normal. This represents an increase in mortality rates of approximately 20% for the year so far.

During the summer, deaths in Ireland surged at a time when they should be lowest with an estimated 800 surplus, during the season.

This wave began almost as soon as the vaccine rollout was launched in January. There was an excess of almost 1200 deaths above normal in the first two months of this year.

The horrifying figures come at a time when the genocidal needle is being brutally pushed upon children by the terrorist regime that has taken over the country.

The explosion in deaths tallies with what is happening world-wide.

An analysis of the UK's Office National Statistics reveals 33,000 excess deaths in January and February 2021 alone.

The RIP.ie website is witnessing

an alarming rise in death notices using the terms 'sudden' or 'unexpected'. This usually indicates that the deceased had no known serious illness.

If they were previously unwell, the notice typically reads 'died peacefully' or 'after a long illness'. Likewise, the term 'tragic death' generally indicates events such as motor accidents or suicide.

In comparison to previous years, there has been a very marked increase in the use of terms such as 'died suddenly' in the past year.

A stark parallel can be found in Northern Ireland where the current death rate is running at 25% above normal.

For every death, there are also many casualties and victims of the vaccine who are left permanently disabled. The HPR (Health Products Regulatory Authority) - the vaccine licensing authority in Ireland - has admitted that up to October 26, there have been 90 deaths and 15,705 injuries caused by the vaccine but this is believed to represent just

1% of overall injuries, which more often than not are unreported.

In recent months, hospital A&E's across Ireland have been inundated with 'vaccine' injured patients. In early September during the warm late summer weather there were 460 people on hospital trolleys nationwide one morning.

The inescapable irony is that counties with the highest rates of 'Covid' such as Waterford and Carlow also have the highest rates of vaccination in the country - because vaccine adverse events are being recorded as Covid.

The most heinous aspect of this genocide unfolding before our eyes is the impact of the vaccine on children and youngsters in their 20s who are at much greater risk of injury.

A recent scientific study by University of Ottawa Heart Institute in Canada showed that Covid vaccines have, in just a few months, caused Myocarditis in 1 out of every 1000 children. The condition, which is extremely rare in children, can lead to heart failure and knock years of a child's life expectancy.

Unfortunately, hundreds of

thousands of healthy children over the age of 12 have already been given the experimental injection with the younger children under 12 now being targeted by the State.

The boosters which are currently being offered to elderly and vulnerable people, will, in all likelihood, make the previous death figures look modest. Thousands more will die before the year is out.

# A brief history and the future of money

CBDC's will mean unlimited control over our lives

**FOR thousands of years, money - the conceptual unit of account that we represent with the generally physical, tangible objects we call currency - has been chiefly embodied in the form of coins struck from precious metals.**

The adjective 'precious' - referring to the fundamental limit on availability established by how difficult it was to find and dig up the commodity out of the ground - was important, because, well, everyone cheats: the buyer in the marketplace shaves down his metal coin and saves up the scraps, the seller in the marketplace weighs the metal coin on dishonest scales, and the minter of the coin, who is usually the regent, or the State, dilutes the preciousness of the coin's metal with less valuable materials, to say nothing of other methods.

The history of banking is in many ways the history of this dilution, as governments soon discovered that through mere diktat they could declare that everyone within their borders had to accept that this year's coins were equal to last year's, even if the new coins had less silver and more lead.

In many countries, the penalties for casting doubt on this system, even for pointing out the adulteration, was asset-seizure at best, and at worst hanging, beheading or death by fire.

In Imperial Rome, this currency degradation, which today might be described as 'financial innovation', would go on to fund previously unaffordable policies and forever wars, leading eventually to the Crisis of the Third Century and Diocletian's Edict on Maximum Prices, which outlived the collapse of the Roman economy and the empire itself in an appropriately memorable way.

Tired of carrying around weighty bags of dinar and denarii, post-third-century merchants, particularly travelling merchants, created more symbolic forms of currency, and so created commercial banking - the populist version of royal

Just as America's old paper silver certificate could once be exchanged for a shiny, one-ounce silver dollar, the balance of digital dollars displayed on your phone banking app can today still be redeemed at a commercial bank for one printed green napkin, so long as that bank remains solvent or retains its depository insurance.

your purse, the bank no longer gets to decide, or even know, how and where you use it. Also, the napkin will still work when the power grid fails.

Advocates of Central Bank Digital Currencies (CBDC's) contend that these strictly-centralised currencies are the realisation of a bold new standard - not a gold standard, or a silver standard, or even a blockchain standard, but

'disintermediation', constitute the heart of the matter, and it is notable how reliant the Federal Reserve Board's Christopher Waller is on these terms, whose origins can be found not in capitalist policy, but ironically, in Marxist critique. What they mean is: who or what stands between your money and your intentions for it?

What some economists have lately taken to calling 'decentralised cryptocurrencies' - meaning Bitcoin, Ethereum, and others - are regarded by both central and commercial banks as dangerous disintermediators; precisely because they've been designed to ensure equal protection for all users, with no special privileges extended to the State.

This 'crypto' - whose very technology was primarily created in order to correct the centralisation that now threatens it - was, generally is, and should be constitutionally unconcerned with who possesses it and uses it for what purpose. To traditional banks, however, not to mention states with sovereign currencies, this is unacceptable.

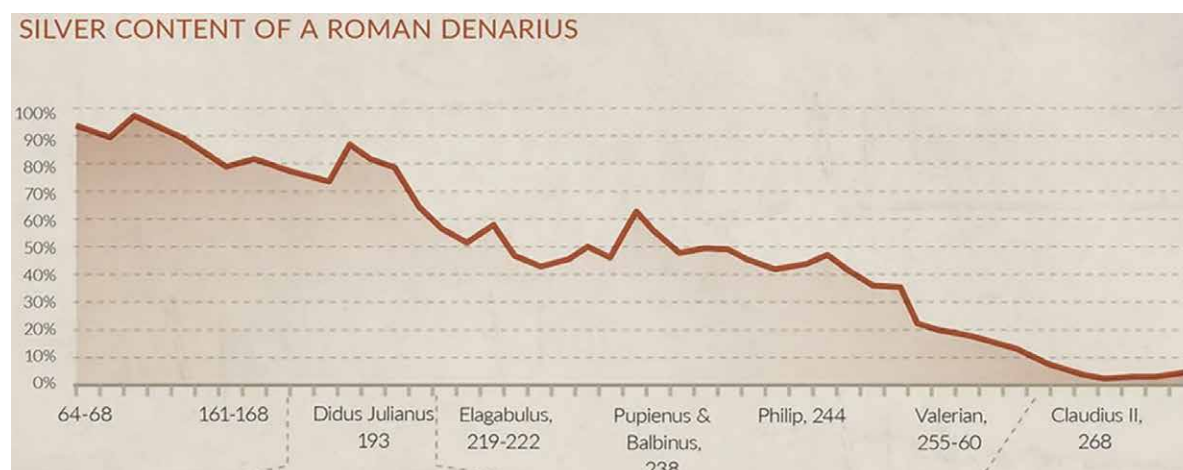
These upstart crypto competitors represent an epochal disruption, promising the possibility of storing and moving verifiable value, independent of state approval, and so placing their users beyond the reach of Rome.

Opposition to such free trade is all too often concealed beneath a veneer of paternalistic concern, with the state claiming that in the absence of its own loving intermediation, the market will inevitably devolve into unlawful gambling dens and fleshpots rife with tax fraud, drug deals, and gun-running.

It is difficult to countenance this claim, however, when according to none other than the Office of Terrorist Financing and Financial Crimes at the U.S. Department of the Treasury: "Although virtual currencies are used for illicit transactions, the volume is small compared to the volume of illicit activity through traditional financial services".

Traditional financial services, of course, being the very face and definition of 'intermediation' - services that seek to extract for themselves a piece of our every exchange.

treasuries - whose most important early instruments were institutional promissory notes, which did not have their own intrinsic value but were 'backed' by a commodity.

They were pieces of parchment and paper that represented the right to be exchanged for some amount of a more-or-less intrinsically valuable coinage.

The regimes that emerged from the fires of Rome extended this concept to establish their own convertible currencies, and tiny shreds of rag circulated within the economy alongside their identical-in-symbolic-value, but distinct-in-intrinsic-value, coin equivalents.

Beginning with an increase in printing paper notes, continuing with the cancellation of the right to exchange them for coinage, and culminating in the zinc-and-copper debasement of the coinage itself, city-states and later enterprising nation-states finally achieved what the Fed would generously describe as 'sovereign currency': a handsome napkin.

Once currency is understood in this way, it is a short hop from napkin to network. The principle is the same: the new digital token circulates alongside the increasingly-

Should that promise-of-redemption seem a cold comfort, you would do well to remember that the napkin in your wallet is still better than what you traded it for: a mere claim on a napkin for your wallet. Also, once that napkin is securely stowed away in

something like a spreadsheet standard, where every central bank-issued dollar is held by a central bank-managed account, recorded in a vast 'ledger-of-state' that can be continuously scrutinised and eternally revised.

CBDC proponents claim that this will make everyday transactions both safer (by removing counterparty risk), and easier to tax (by rendering it impossible to hide money from the government).

CBDC opponents, however, argue that an e-dollar, say, is merely an extension to, or financial manifestation of, the ever-encroaching surveillance state. To these critics, the method by which this proposal eradicates bankruptcy fallout and tax dodgers draws a bright red line under its deadly flaw: these only come at the cost of placing the state, newly privy to the use and custodianship of every dollar, at the centre of monetary interaction.

Look at China, the napkin-clingers cry, where the new ban on Bitcoin, along with the release of the digital yuan, is clearly intended to increase the ability of the state to 'intermediate' - to impose itself in the middle of every last transaction. 'Intermediation', and its opposite

# Invite people to question before making a decision

**I RECENTLY saw a video of a guy standing outside a school with a megaphone saying, "Don't get the vaccine" to a crowd of young people. The school staff were taken aback and told the students to move away.**

One of the many problems with the government's covid vaccine campaign is the active discouragement of everyone, including children, to educate themselves so that they are able to give as well-informed a decision as possible. Instead, the campaigns have a clear message that everyone should take it without thinking about it.

Furthermore, the government has ruled that children aged between 12 and 15 can overrule their parents if they want to have the vaccine and their parents don't consent.

They use the 'Gillick competence' test to determine whether the child is mature enough to make the decision. But how can anyone make an informed choice without information?

The problem with the megaphone guy was that he was once again telling the students what to do instead of encouraging them to think for themselves. Who should they believe? Some random man on a megaphone or their teachers and parents?

We have this bizarre situation now where everyone thinks they know what we all should do. The majority think that everyone should get vaccinated (because they have been pumped with that idea by the corporate media) and a minority think that nobody should get vaccinated, leaving an even smaller minority that think that everyone should make their own minds up, having weighed up the risks and benefits.

To know that everyone should or should not vaccinate would require knowledge of each individual's circumstances and a thorough understanding, not just of virology, epidemiology, vaccines and medicine, but also of political science, logic and economics.

Even if you have weighed up the data and you think that for children the risks outweigh the benefits, there may be some children who are vulnerable or who have become so traumatised by the government

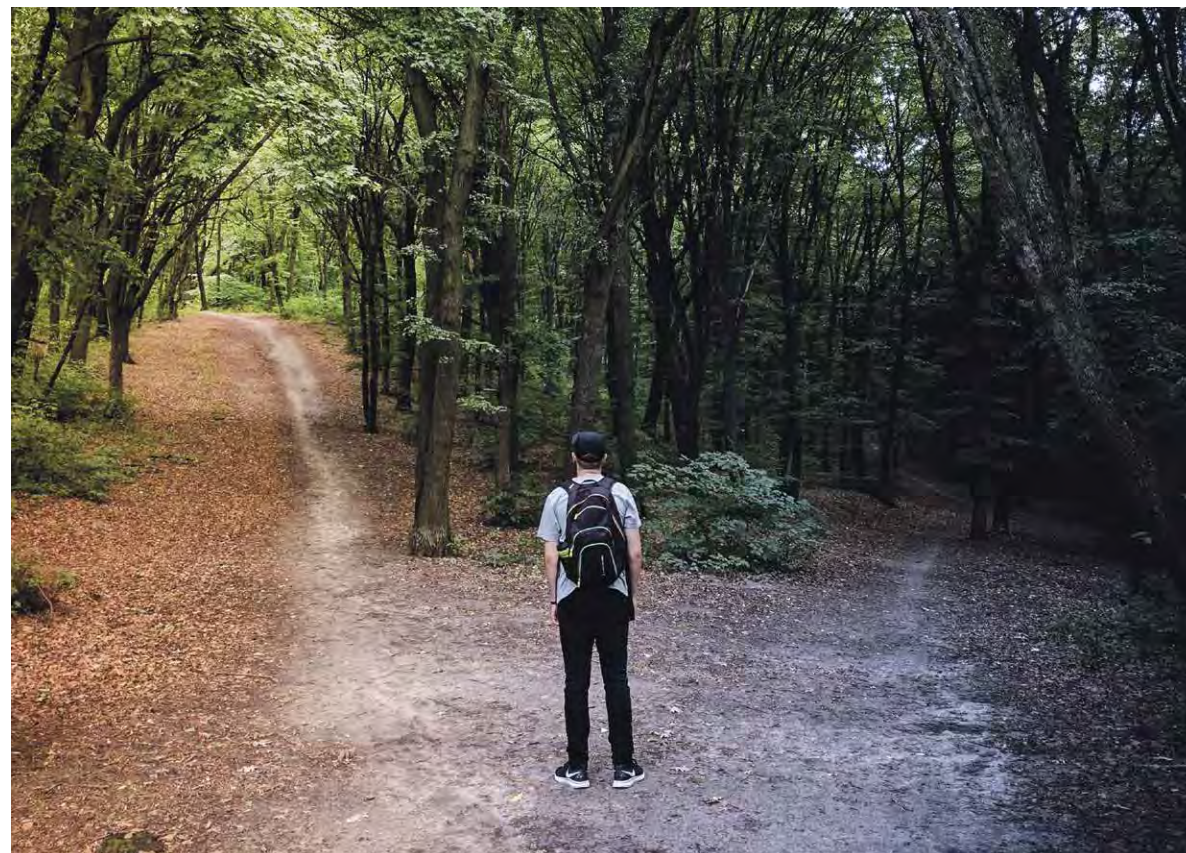

# These policies may be crimes against humanity

**A 'PHYSICIANS Declaration' produced by an international alliance of doctors and medical scientists strongly condemns the worldwide strategy to treat covid.**

It accuses policy-makers of potential 'crimes against humanity' for preventing physicians from providing life-saving treatments for their patients and suppressing open scientific discussion.

The document states that 'one size fits all' treatment recommendations have resulted in needless illness and death.

By the 14th of October, the declaration had garnered more than 12,000 signatures from doctors and scientists across the world.

It was produced by a group of physicians and scientists meeting in Rome for a three-day 'Global Covid Summit' to speak "truth to power about covid pandemic research and treatment".

The summit gave the medical professionals an opportunity to compare studies, and assess the efficacy of the various treatments developed in hospitals, doctors' offices and research labs throughout the world.

The Physicians' Declaration was first read at the Rome Covid Summit, catalysing an explosion of active support from medical scientists and physicians internationally.

These professionals were not expecting career threats, character assassination, papers and research to be censored, social media accounts blocked, search results manipulated, clinical trials and patient observations ignored, and their professional history and accomplishments altered or omitted in academic and mainstream media.

Dr Robert Malone, architect of the mRNA vaccine platform, read the Rome Declaration at the Summit:

"Thousands have died from covid as a result of being denied life-saving early treatment. The declaration is a battle cry from physicians who are daily fighting for the right to treat their patients, and the right of patients to receive those treatments – without fear of interference, retribution or censorship by government, pharmacies, pharmaceutical corporations, and big tech.

## More than 12,000 doctors and scientists sign declaration

"We demand that these groups step aside and honour the sanctity and integrity of the patient-physician relationship, the fundamental maxim 'First Do No Harm', and the freedom of patients and physicians to make informed medical decisions. Lives depend on it.

"We, the physicians of the world, united and loyal to the Hippocratic Oath, recognising the profession of medicine as we know it is at a crossroad, are compelled to declare the following:

"Whereas, it is our utmost responsibility and duty to uphold and restore the dignity, integrity, art and science of medicine;

"Whereas, there is an unprecedented assault on our ability to care for our patients;

"Whereas, public policy makers have chosen to force a 'one size fits

all' treatment strategy, resulting in needless illness and death, rather than upholding fundamental concepts of the individualised, personalised approach to patient care which is proven to be safe and more effective;

"Whereas, physicians and other health-care providers working on the front lines, utilising their knowledge of epidemiology, pathophysiology and pharmacology, are often first to identify new, potentially life-saving treatments;

"Whereas, physicians are increasingly being discouraged from engaging in open professional discourse and the exchange of ideas about new and emerging diseases, not only endangering the essence of the medical profession, but more importantly, more tragically, the lives of our patients;

"Whereas, thousands of

physicians are being prevented from providing treatment to their patients, as a result of barriers put up by pharmacies, hospitals, and public health agencies, rendering the vast majority of healthcare providers helpless to protect their patients in the face of disease.

"Physicians are now advising their patients to simply go home and return when their disease worsens, resulting in hundreds of thousands of unnecessary patient deaths, due to failure-to-treat;

"Whereas, this is not medicine. This is not care. These policies may actually constitute crimes against humanity.

"Now therefore it is:

"Resolved, that the physician-to-patient relationship must be restored. The very heart of medicine is this relationship, which allows physicians

to best understand their patients and their illnesses, to formulate treatments that give the best chance for success, while the patient is an active participant in their care.

"Resolved, that the political intrusion into the practice of medicine and the physician/patient relationship must end. Physicians, and all health-care providers, must be free to practise the art and science of medicine without fear of retribution, censorship, slander, or disciplinary action, including possible loss of licensure and hospital privileges, loss of insurance contracts and interference from government entities and organisations - which further prevent us from caring for patients in need. More than ever, the right and ability to exchange objective scientific findings, which further our understanding of disease, must be protected.

"Resolved, that physicians must defend their right to prescribe treatment, observing the tenet 'First Do No Harm'.

Physicians shall not be restricted from prescribing safe and effective treatments. These restrictions continue to cause unnecessary sickness and death. The rights of patients, after being fully informed about the risks and benefits of each option, must be restored to receive those treatments.

"Resolved, that we invite physicians of the world and all health-care providers to join us in this noble cause as we endeavour to restore trust, integrity and professionalism to the practice of medicine.

"Resolved, that we invite the scientists of the world, who are skilled in biomedical research and uphold the highest ethical and moral standards, to insist on their ability to conduct and publish objective, empirical research without fear of reprisal upon their careers, reputations and livelihoods.

"Resolved, that we invite patients, who believe in the importance of the physician-patient relationship and the ability to be active participants in their care, to demand access to science-based medical care".

# MPs' interests leave the public feeling conflicted

**PERHAPS** the 'year of global opportunities' Chris Whitty was predicting in an interview with Civil Service World in 2020 related to his involvement with Global Health Group, a self-proclaimed specialist supplier of covid-19 medical supplies.

Maybe he was one of their well-placed 'influencers' in the industry, as their website describes how they provide access to 'leading experts' that build bridges between 'top tier buyers, sellers and investors'.

Matt Hancock also had the same entrepreneurial mindset when he was gifted 15% shares in his sister's document-shredding business, Topwood Limited.

This family-owned company, which gained NHS approved status in 2019, recently benefited from £300,000 worth of business from NHS Wales. The company, with assets valued at near £2 million, also claimed up to £20,000 in Coronavirus Job Retention Scheme grants.

Mr Hancock and the Department of Health and Social Care (DHSC) were also scrutinised for their NHS procurement strategy during the pandemic. A High Court judge, Mr Justice Chamberlain, ruled the former health secretary's actions unlawful. This is largely due to failings in publishing the vast majority of £15 billion worth of PPE and services within a 30-day period.

This misuse of public money was highlighted by the procurement consultancy Tussell and challenged in court by the Good Law Project, a not-for-profit organisation bringing legal challenges that show transparency laws are being broken by the government.

Not wanting to be alone in the cronyism, Hancock repeatedly and publicly backed a company for which Dominic Cummings undertook a consultancy role in 2018. Boris Johnson's chief advisor during the pandemic faced conflict of interest accusations over this role for Babylon Health, a government-endorsed healthcare business that introduced the controversial GP at Hand app. Cummings advised Babylon Health on its communications strategy and its senior recruitment, an investigation by The Guardian and the Bureau of Investigative Journalism revealed.

Nadim Zahawi, secretary of state for education, has also sparked controversy with his family links to Warren Health Limited. Although the company never traded, it led to conflict-of-interest questions from the Stratford Herald. The paper argued that the inclusion of the word 'medical' in the new company's name sounded inappropriate, given Mr Zahawi's position at the time, as vaccine minister.

The Department for Health and Social Care responded to questions by the Stratford Herald with an unequivocal 'no conflict of interest' statement. However, how much scrutiny has been placed on Zahawi's other business interests? His wife and twin sons are directors in companies Zahawi & Zahawi Ltd - with assets of £54 million according to confirmation statements, as well as Zahawi Properties Ltd, Zahawi Brierley Ltd and Zahawi Wantage Ltd.

Perhaps Sir Peter Bottomley, the Conservative MP for Worthing West and Father of the House of Commons, was right when he described MPs' pay as 'really grim'? Which could explain their need to look for extra income.

After all, the annual adjustment to MPs' basic pay for 2020-21 was only increased by 3.1%, as recommended by the Independent Parliamentary Standards Authority, bringing the overall salary from £79,468 to £81,932, from April last year.

Chief medical officer, Professor Whitty earns more, at between £205,000 and £210,000, judging by NHS figures published last year.

Former chief adviser Mr Cummings was paid £140,000-£144,999 - up from £95,000-£99,999 the previous year. A cabinet office report revealed the adviser was given a pay rise of around 40% from 2019 to 2020.

MPs can also claim expenses such as travel, office, food, drink and accommodation.

MPs are in the top 5% of earners in the UK when it comes to annual income, judging by HMRC taxpayer data from 2016-17. This does not even take into account their overall wealth, such as fixed assets and business interests.

When you take into account the national average UK wage of around £30,000, and nurses, on an average of £26,000 per year, according to payscale.com, it is hard to believe assertions of poverty from any member of parliament.

Despite the wealth that ministers and their families have amassed, there are no shortages of reports of conflicts of interest during the pandemic, such as UK chief scientific adviser Patrick Vallance having £600,000 of shares in vaccine maker Glaxosmithkline.

There are likely to be many more examples of public office being used for private gain. The apparent prevalence of conflict of interests is alarming. Intriguingly, it is mostly happening in plain sight, right under the taxpayers' noses.

A cursory amount of research on HMRC or the government's own conflicts of interest reports shows that there is still a deep, underlying issue of cronyism. Yet when politicians are quizzed about their seemingly

controversial business interests, there are usually all-too-familiar party lines - 'there is no conflict of interest', and 'no laws were broken'. Which is probably true, which can mean only one thing - the law itself is broken.

There is also theoretical transparency in UK politics to stop this kind of cronyism of the past. That is why we have the National Audit Office, conflict of interest declarations, transparency policy, and above all else, we have parliament. Parliament's job, in their own words, is to scrutinise government so that any decision they make is fair, open, transparent, workable and non-discriminatory. It would appear that parliament has spectacularly failed. The inevitable result of decades of endemic corruption is widespread mediocrity.

Whether any person or company should make a profit from the pandemic is an ethical question. When so many sacrifices were made by the people, giving up freedoms, giving up socialising, wearing masks, getting injected, losing their livelihoods, it does not seem right for someone to make a monetary profit upon that situation.

One question that needs immediate addressing is: should anyone connected to government be able to profit in any way from the pandemic?

When people profit from a crisis their morals are questionable. This is usually associated with wartime profiteering. Henry Ford once said 'Show me who makes a profit from war, and I'll show you how to stop the war'. Replace 'war' with 'pandemic' and we may be seeing history repeat itself.

# Hardy's reminder our souls are rooted in nature

**THERE is an irony, probably forever lost on all but a few, that to really gain insight into what The Fourth Industrial Revolution (4IR) is now forcing upon us, we could do worse than return to the novels and poetry of Thomas Hardy, famed West Country author.**

In his Wessex novels, particularly *Tess*, *The Mayor of Casterbridge*, *Far from the Madding Crowd* and *Jude the Obscure*, we are witness to history in motion, the slow yet inevitable cleaving of people from land; the decimation of a way of life.

The death throes of the 19th century marked the beginning of the end of a bucolic Britain, which existed both as rural idyll and as harsh reality of life on the land, and an even harsher transition to a smoggy industrialisation.

Families were separated (like now), mass production began to kick in and the new mechanical age segregated people from their roots, nature and the life of the soul.

If you research The 4IR (initially a book written by Klaus Schwab of the World Economic Forum, now a proud page on the UK government's website), you will understand that in some ways things have not changed much. The plan is to relocate country dwellers to modern 'smart' high-rise cities, whether they like it or not.

The irony I mentioned earlier is that to properly access the mournful wisdom of Hardy, also a proto-feminist – certainly through the eyes of his heroine *Tess* – you would be advised to read his books.

But as this industrial revolution is about speed not soul, placing virtual reality in your hands, not actual ground beneath your feet, that is unlikely to happen. This is another ending of a way of life – unless we truly and quickly come to our senses – which only its proponents and advocates view as a good thing.

In truth, the digitised/AI agenda is only good for what are called 'stakeholders' in a rather cowardly new world. We can already see who they are: big pharma, big corporations, corporatised governments, in fact anyone willing to sell their soul

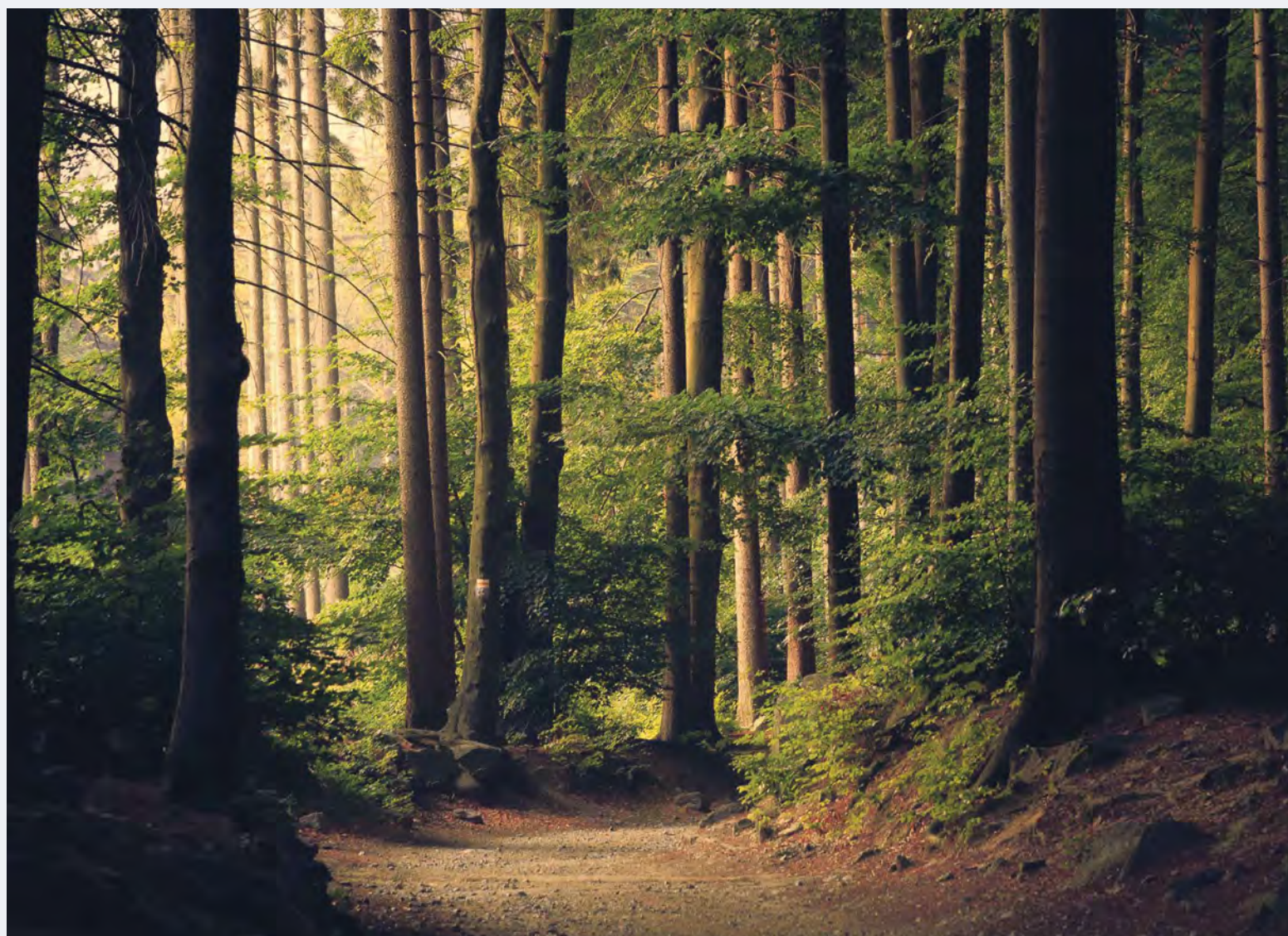

for a buck, and whose blood fits.

The rest of us, whether we realise it yet or not, do not have a place in the New World Order.

Schwab, who also wrote and published 'Covid-19: The Great Reset' as early as July 2020, was both arrogant and bold enough to make it clear that coronavirus was a relatively minor problem but would be the excuse needed to push forward this deadly scheme.

Another irony: it is being sold as a green agenda, so has the sheen of goodness ever to bamboozle the innocent, just as they have been tricked over current medical interventions. 'This may hurt, but it's all for your own good,' is the kind of watchword psychopaths specialise in. The tragedy is that those who grew up with narcissists at the helm

have much sharper insight than those who still naively believe their care-givers would never harm them. It is a belief - a need even - that many will cling to unto death.

The notion of a dire, soulless, malevolent patriarchy is not a new one and Hardy's proto-feminism, the treatment of his heroines, tells us that. The clown that is Boris Johnson suckered millions, his hateful eugenics in no way obvious (his father Stanley wrote a number of books on depopulation and worked for Planned Parenthood when junior was just an unpleasant schoolboy).

As Ray Liotta's narrator in *Goodfellas* tells us, "your killers come with smiles".

As Hardy writes in *Tess*: "The beauty or ugliness of a character lay not only in its achievements,

but in its aims and impulses; its true history lay, not among things done, but among things willed".

Everything feeds the machine, an insatiable, loveless demon erected as demiurge by abused, pitiable boys tragically handed the keys to the kingdom and now bent on revenge.

Yet instead of seeking it among their abusers, they instead target the ordinary man or woman who never did them harm, while keeping the corrupt system alive, including all its horrors of paedophilia and ritual abuse.

What happened to the inquiry into the Westminster child-rape scandal? As Bojo disgustingly put it, why "spaff" all that money up the wall of history?

And yet history is where we might learn our lessons, avoid calamity and the consequent Nuremberg

trials and drag the demons into the light. It is surely no coincidence that those pulling the strings of their government puppets worldwide are hidden from scrutiny.

We may take a guess at who they are, may even be aware of some, yet it seems most stay in the shadows, like vampires awaiting a fresh supply of blood.

In Hardy, the land is all and people are fused with it, as if he had inherited an indigenous bloodline that knew no person can own land. If anything, we belong to it.

As he writes in *Under the Greenwood Tree*: "To dwellers in a wood, almost every species of tree has its voice as well as its feature".

## ‘Hate speech’ pensioner jailed for 32 months

What would George Orwell make of it?

**CORNISH musician and radio host Graham Hart has been sentenced to 32 months in prison for eight counts of ‘hate speech’ at Truro Crown Court.**

The 69-year-old pleaded guilty to ‘producing a programme likely to stir up racial hatred’ but maintains he was just ‘mouthing off’, rather than intending to cause harm to anyone.

Mr Hart started broadcasting back in 2016. He aired his views, chatted with guests about a variety of subjects, questioned significant events throughout history and shared his research findings with listeners around the world.

Central to the prosecution’s case was a dossier compiled by pressure group ‘Campaign Against Anti-Semitism’,

which referenced material from Mr Hart’s radio shows, focusing on a song called ‘The Hoax Train’, which urges people to question the official account of the Holocaust and ‘wake up’.

Police raided his house shortly after the song’s online release. They gathered a ‘Free Palestine’ T-shirt, a German family heirloom and some books, lent to him by friends, as evidence. Arrest followed swiftly once investigators began listening to Mr Hart’s shows. He was denied medication for chronic, painful health conditions while held in custody and lost 11lbs in 10 days.

Mr Hart’s relatives are shocked at the length of his sentence and his treatment. They say he started the radio show from his music studio because he wanted to let off steam. His daughter believes he has been made an example of for being outspoken with his unorthodox views. The family worry about his health and how he

will cope in prison but are reassured that he seems to be doing okay.

In addition to his prison term, Mr Hart is banned from broadcasting for 10 years.

While his opinions may seem radical, surely he is entitled to them? How does it harm anybody else for him to have a different view of history? Can people not decide for themselves whether they will take or leave the information?

A statement on Campaign Against Anti-Semitism’s website said: “Graham Hart, 69, of Penponds, Camborne, was charged earlier this year with five counts of using offending words or behaviour in a programme involving threatening, abusive or insulting visual images or sounds which was included in a programme produced with intent or likely to stir up racial hatred. Three further charges arose from comments that Mr Hart made on another radio show in late December 2020.”

His sentence poses serious questions about censorship and freedom of

speech and is reminiscent of the story of 92-year-old German Holocaust revisionist Ursula Haverbeck, who received multiple sentences from different courts and is now spending time in prison for holding alternative views about the WW2 persecution of Jewish people.

Holocaust denial is illegal in 17 countries. The UK, along with Sweden, Denmark and Italy, has rejected such laws but prosecution is still possible by bringing charges for other related offences. Spain declared genocide denial laws unconstitutional in 2007.

And what of the ‘hate speech’ aspect? Does Muslim and refugee-bashing not become a national pastime when whipped-up by the media? What about the scorn poured on politicians, vegans or those who do not wish to be part of a medical experiment: are not those groups subject to ‘hate speech’? Nobody is in prison for using harsh words against them.

In his much-cited dystopian novel,

1984, Orwell describes ‘thoughtcrime’ as politically controversial or negative thoughts, doubts and beliefs that oppose party dogma. The aim of the government in the prophetic novel is to eradicate individuality and freedom of thought, instead promoting Communism (IngSoc) and mindless obedience as the only acceptable way of life.

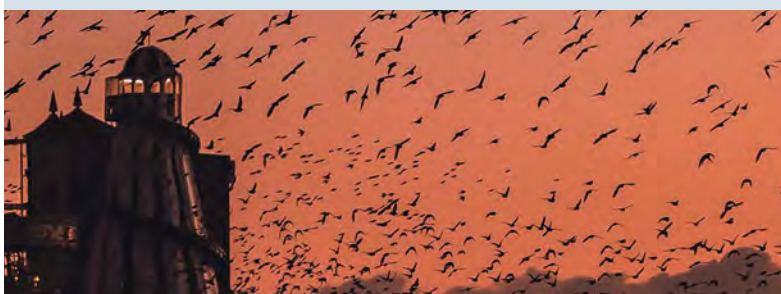
Of course, inciting people to violence in the name of anything is rarely a good idea but Mr Hart insists that his passion for the truth got the better of him and nobody was hurt or harmed by his sharing his opinion with his very niche audience.

The court case following Mr Hart’s trial tried a child molester who had groomed and sexually abused two young sisters. The defendant was given a three-year suspended sentence and returned to the community for treatment. Mr Hart’s daughter remarked that, “the scales of justice are all wrong”.

She also told me that many people are saying they have “not felt right” since being injected against covid, and that they are adamant they will not be taking another shot.

I’m hearing that too.

I pressed Louise on whether she was sure things seemed different.

Yes, she insisted, sudden health issues were popping up more than ever.

Think about it. What is usually the first thing your friendly hairdresser asks when you sit down in front of them?

‘How are you... how have you been... are you well?’

They may well be the perfect barometer for reporting the nation’s health, and based on Louise’s experience the diagnosis is not good.

Now, what she says means nothing unless we know her experience is being mirrored by others like her.

Only then we might be onto something significant.

and fairness, perhaps the mass experimental vaccination programme is not actually the cause or is only part of the possible problem.

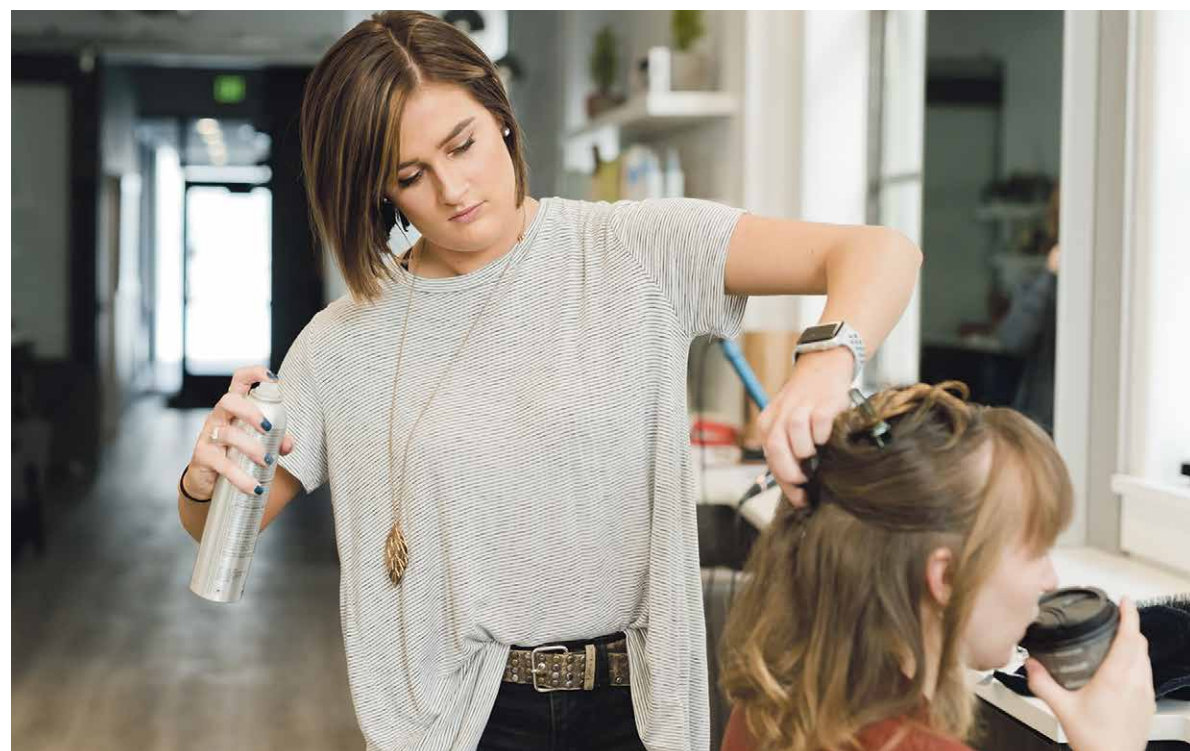

# Government plans for control through a ‘Never Normal’ policy

SAGE professor's report invokes vision of a covid 'Case Finder General'

**‘CASE finders’ and a permanent change in schools, work and public spaces will embed covid permanently in the culture, establishing new routines, norms and identities in the same way that masking changes our relationships.**

Disrupting and reshaping society is at the heart of new research from the Scientific Advisory Group for Emergencies (SAGE) member Professor Susan Michie, just published by the British Psychological Society.

While banks, pharma, social media and the defence sector continue their drive for control - planners show evidence that risk aversion is becoming a universal mindset.

Fear generated among the public is increasingly a projection of spectres that plague the official mind.

The popular theory of outcomes management is driving politicians and otherwise ‘adult’ officials to a Hegelian hysteria as they struggle and fail to meet the unflinching demands of the powers that call the tune.

If you are hoping that getting the covid shot - or even the vaccine passport - will return you to normal life, think again. Governments are planning for Never Normal.

Psychologists are working out how to ‘embed’ population control measures over the long term. The plan is to establish ‘new identities’ and to motivate a broad change in behaviour that will create a new culture.

The proposals were revealed in a report by Prof Michie on August 31. She was widely quoted in a June television interview as saying face coverings and social distancing should become permanent. Now we have proof of the plan.

Interventions are graded as normal, easy, attractive, and routine (NEAR), driven by an array of public and private sector organisations rather than a series of separate interventions. Compliance will be monitored to achieve long-term behaviour change.

Reading between the lines, this suggests that stakeholders - in practice the investors (the military industrial complex, banks, pharma, big tech)

rather than the people - will observe, routinely collect organisational metrics, and monitor and research individuals.

Citizens will be subject to randomised trials, natural experiments and time series studies - perhaps like the pilot programme in South Australia that calls people randomly and demands they supply facial recognition, proof of location and vaccination.



Professor Susan Michie (SAGE)

‘Co-production and extensive stakeholder engagement’ means state-corporatism, aka fascism.

Michie, The University College, London, Professor in Psychology and Language Sciences, is part of the team behind the use of fear to make people yield freedom and submit to control on the pretext of covid, a pandemic that in 2020 killed no more than the seasonal flu.

The minutes of SAGE from March 22, 2020 say: “The perceived level of personal threat needs to be increased among those who

are complacent” by “using hard-hitting emotional messaging”.

Michie’s latest proposals include covid-safe schools, offices and public places while creating the “motivation needed to underpin those behaviours”.

Embedding these into everyday routines will require “education, regulation, communications and social marketing”.

In another television appearance, Michie became angry when asked about her four-decades-long membership of the Communist Party. The Independent newspaper

college closely tied to the military; King’s, London. Her focus was public attitudes to genetic testing and informed choice. She is head of the Human Behaviour-Change Project funded by the Wellcome Trust.

In 2019 she won the British Psychological Society Research Board’s Lifetime Achievement Award for creating a coherent language of behaviour change.

Michie’s party allegiance might be seen in a different light - more technocrat and social-genetic engineer than red flag-waving

will be needed on top of “case finding, supported isolation and border control”. The resonance of the phrase ‘case finding’ is clearly lost on the authors. Perhaps they would not smart at the appointment of a ‘Case Finder General’.

The report says motivations and ‘nudges’ should come at people from multiple directions and sources, and be coordinated and sustained.

The content of the research through Google Scholar is uninspiring and the conclusions are worrying by their apparent superficiality. For example:

“A potentially powerful way of embedding representations of new phenomena is through objectification (Devine-Wright & Devine-Wright, 2009). This involves using a concrete, easily understood metaphor (Wagner, Elejabarrieta & Lahnsteiner, 1995). For instance, the process of aerosol spread can be likened to inhaling someone else’s cigarette smoke and hence generate understanding of the contexts where this is likely and the measures necessary to avoid it.”

Superficial because the measure is not important. Like mandating a mask, it is designed to nudge an outcome.

The desire to prompt behaviour necessitates a simplistic, easily-digestible pretext. You might think that the nudge is the facile tip of a deep and complex policy. Reading Michie’s report you soon realise that it is full of such shallow motivations. Each has a seemingly obvious purpose: you wash hands to keep them clean.

That is the proximate outcome. The aim of that outcome, especially the compounded result of numerous outcomes, is unstated to the population.

Mitigation comes up time and again in the Michie report. Public policy, from education to the workplace, is increasingly concerned with risk avoidance.

Some time in the past decade, German schools celebrated a year in which not a single pupil had drowned. Did they teach them all to swim, a heroic achievement? No. Schools had taught children that water was dangerous: keep away.

The same mindset pervades covid policy. One gets the impression that if there was no deadly virus it would be necessary to invent one.

criticised the presenter’s impertinence, describing Richard Madeley as “a dangerous man”.

This protective attitude towards Michie comes not merely from her status as a government adviser but from her establishment connections.

This communist is no radical outsider. Oxford-educated, her father was a pioneer of artificial intelligence and her mother of in-vitro fertilisation. Her career bears the hallmarks of an insider’s progression between influential positions, for example researching psychology and genetics at a conservative university

champion of the proletariat.

In fairness to Michie, it tells us rather more about the true nature and intent of government that it feels not a flicker of unease about communist affiliation when that person is working towards the same goals of total control of the people.

Michie’s report, ‘Staying covid-safe: Proposals for embedding behaviours that protect against covid-19 transmission in the UK’, written with five others, begins from the assumptive leap that covid is for ever, because of variants.

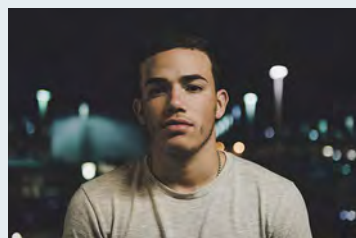

# Scientists warn government over Fluoride

Three British scientists slam statement on fluoridation of drinking water and have written to Boris Johnson

**ACCORDING to three British scientists (Vyvyan Howard, MB, ChB, PhD, Spedding Micklem, PhD, and Paul Connett, PhD) who have followed the debate closely for many years, "This is not a good time for the British government to mislead the public on the dangers posed by the practice of water fluoridation."**

They point to a recent statement from the four chief medical officers of Health for England, Wales, Scotland and Northern Ireland, which was given prominent coverage in the British corporate media. Their statement extols the weak benefits of this practice for teeth but ignores the far stronger evidence that fluoride damages the developing brain.

According to Howard, Micklem and Connett, "The dental lobby has controlled this debate for far too long. You can repair a damaged tooth but early damage to the brain (especially during fetal development and infancy) cannot be repaired or reversed. This is so serious for the future of our country that the matter should not be resolved by the kind of 'sleight of hand' used by those who wrote the script for the CMOs' statement."

This "sleight of hand" occurred in the two short paragraphs that dealt with the risks of the practice. The CMOs write:

"There are adverse associations between much higher levels of natural fluoride in drinking water and the prevalence of dental mottling, referred to as dental fluorosis..."

"There are some weaker studies, which claim an association with hip fracture, Down's syndrome, kidney stones, bladder cancer or osteosarcoma (a cancer of the bone).

However, there is conflicting evidence to support these claims and prevailing public health opinion is now that there is no significant association between water fluoridation and these conditions. [23 September 2021]"

Note that the CMOs failed to mention the many human (over 60) and animal studies that indicate that fluoride is neurotoxic, even though this subject has engaged the serious attention of the National Toxicology Program in the USA for nearly five years. Nor that the U.S. EPA is currently being sued by Food and Water Watch and others in U.S. Federal court to prohibit the deliberate addition of fluoridated chemicals to the public drinking water because of the threat they pose to the developing brain. The judge is expected to issue his ruling in early 2022.

Most significantly, in ignoring these studies on the brain, the CMOs failed to acknowledge the several high-quality U.S. government funded studies published since 2017 (Bashash 2017, 2018; Green, 2019 and Till, 2020) which have found effects on the developing foetus and infant at the very fluoride levels used in artificial water fluoridation schemes. These effects include lowered IQ (between 5 and 9 IQ points reported) and increased ADHD symptoms. These findings make complete nonsense of the CMOs claim that health effects only occur "at much higher levels".

The three British scientists added that, "In our view the way the CMOs treated the health effects posed by fluoridation is a gross dereliction of their duty to protect the health of the British people."

Howard, Micklem and Connett, have explained this alarming new science in an open letter to Boris Johnson calling on him to halt plans to extend water fluoridation to other communities in the UK:

# Canada and New Zealand impose vaccines on public sector staff

**CANADIAN Prime Minister Justin Trudeau has decided to use whatever political capital he gained from his narrow election victory to finally roll out his government's vaccine mandate, which resembles that of its southern neighbour while going a step further in some important respects.**

Trudeau and his government are demanding that all public servants either get vaccinated, or face unpaid leave. This includes all federal workers "in the core public administration" and the Royal Canadian Mounted Police. Federal contractors including cleaning staff must be vaccinated to gain access to government buildings. The government is also asking that all employees in federally regulated air, rail and marine transportation

sectors must establish vaccination policies for their employees that effectively require vaccination.

After October 30, all travellers boarding planes, trains or any marine vessels were required to have their shots. The above-mentioned workers had a few weeks to apply for exemptions - either religious or medical - but otherwise, they will be forced to choose between the job, or losing their job. This travel mandate also applies to everyone over the age of 12.

Anybody hoping to use public transport this holiday season will need to get the jabs. Any Canadians who aren't comfortable with the vaccine won't be able to fly to visit relatives who live outside driving

distance (and they wouldn't be allowed in the U.S., leaving them effectively trapped in their country).

Unvaccinated employees will be barred from going to work, either in person or remotely, and they will be put on administrative leave and denied pay, according to the CBC.

"These travel measures, along with mandatory vaccination for federal employees, are some of the strongest in the world because when it comes to keeping you and your family safe, when it comes to avoiding lockdowns for everyone, this is no time for half measures," Trudeau said.

Employees will be required to sign an 'attestation' form giving their word that they have been vaccinated. Anybody who signs the form can at any time have their vaccine status 'audited' by their managers, who will then seek proof of vaccination.

Bottom line: if you're a federal worker affected by this order, and you decide to lie about your status, definitely don't tell anybody.

One week after Canada adopted mandatory vaccination rules for federal workers and travellers, New Zealand announced its own vaccine mandates for most teachers and health-care workers.

Doctors, nurses and other health-care workers must be fully vaxxed by December 1, while everyone working in education who has contact with students must be vaccinated by January 1.

"We can't leave anything to chance so that's why we are making it mandatory," said covid response minister Chris Hipkins, who is also the country's education minister.

"Vaccination remains our strongest and most effective

tool to protect against infection and disease," Hipkins said.

New Zealand briefly enjoyed covid-free status after the initial global outbreak, but the country's 'drawbridge' strategy was unable to keep out the 'delta variant', imposing a lockdown in Auckland, the country's largest city after confirming just a single case. As cases spread despite the tightening restrictions, the government was forced to finally abandon its 'covid zero' strategy.

Despite this, New Zealand PM Jacinda Ardern said the highly transmissible delta variant had proved a "game-changer" that can't be easily eliminated.

Now, keep in mind, New Zealand has confirmed fewer than 5,000 cases and fewer than 30 deaths.

# Italy rebels against green pass for all workers

"Trieste chiama, l'Italia risponde" - Trieste calls, Italy responds

**MASSIVE demonstrations have erupted throughout Italy as the Italian government pushed further ahead with their 'Green pass'.**

Already used for medical apartheid domestically in Italy since June, all workers across Italy were from the 15th of October 'required' to hold the 'green pass' to work, meaning being forced to be vaccinated or take repeated tests, with workers who fail to comply facing fines of over £1200.

'REMOVE the implementation of the green pass or we WILL bring Italy to a complete standstill'. Freedom is not up for debate is their demand.

Protests ensued in Ancona, Turin, Bologna, Naples, Genoa, Cessena, Vicenza, Bassano Del Grappa, Aosta, Syracuse, Treviso, Livorno, Catania, Bergamo, Sanremo, Belluno, Ravenna, Palermo, Lecco, Udina, Bolzano, Brescia, La Spezia, Cagliari, Verona, Padua, Pisa, Asti, Florence, Modena, Milan and many other cities in Italy, even including Varese - one of the most vaccinated places in Italy at 91%.

Apart from that life was normal. Everything open. I just could not go to my favourite bar to play darts for a month, big deal. Hard for them, but they also got some compensation. My gym, like all

many other things can treat covid, but Japan has not been using it. At least as a matter of policy. I would not be surprised if some doctors prescribed it but generally everyone just toes the line here. There is no dissent from any societal paradigms. So if the government does not say “treat covid with Ivermectin” then I doubt many would.

A full year of a circulating virus, no lockdown, no 100% masking and no treatment protocols like Ivermectin or Hydroxychloroquine. And yet, no pandemic. So why? Two reasons, and no, it is not due to Japanese super-genes.

1. There was no testing. For more than a year it was almost impossible to get a test. You would have to be ill enough with covid symptoms to need hospitalisation. Then you could get a test. No mass testing and what do you know? No virus. Anywhere. Admittedly it has been easier to get tests as time went on but still, there was no test mentality or environment.

I had to take two weeks off school - all paid. Out of all the ‘positives’ every single one was asymptomatic. Not even a sniffle. Some virus.

2. This testing mentality permeated all levels of society, even the health-care system. We had very little of this ‘died with covid’ nonsense. The criteria for a covid ‘death’ were dying with bilateral pneumonia and a positive test. You know, the original expression of the disease before it could kill you from anything from a brain aneurysm to a heart attack? If you died in a car wreck or of cancer, you were not tested for covid. Why would you be?

We have not been immune to the epidemic of fear spread by the corporate media. Japanese media play that game too. But it seems the whole Japanese system has yet to be fully ‘captured’. The reason Japan escaped this plague is due to the absent policy of mass testing; nothing more, nothing less.

here has never been strained. In the city I live in there are 200,000 people and a lot of hospitals. Of these, only one will accept covid patients, of which there has been none in 20 months. Zero.

In some prefectures, they did pass some laws that enabled them to issue fines to businesses that did not comply.

gyms, has remained open. It is half as busy as it was pre-covid.

So how has Japan avoided all those deaths?

Let us first dispel a myth that it is all about the masks. It is true that people wear masks more often here. I would frequently turn up to school in January or February and the whole class would be masked up. Due to an outbreak of influenza. And you are expected to wear a mask if you are ill. That is Japan for you.

However, people do not wear them for no reason. I remember a trip to the mall in August, 2020. I thought I would conduct a super-scientific social experiment. But it took that long.

# Africa appeals to Bill Gates: stop funding the ‘failed’ green revolution



**BILLIONS of dollars in aid and subsidies for industrial agriculture in Africa are harming food security in one of the world’s hungriest regions, according to 200 African organisations.**

Led by the Alliance for Food Sovereignty in Africa, they have asked the Bill and Melinda Gates Foundation, the U.S. Agency for International Development and other donors to stop financing the Alliance for a Green Revolution in Africa (AGRA).

The billion-dollar effort has “unequivocally failed in its mission” and “harmed broader efforts to support African farmers”, the groups said. Donors are asked to switch their funding to African-led efforts and agro-ecology.

Hunger has worsened considerably since the Gates and Rockefeller foundations led a high-profile effort to bring the ‘green revolution’ to Africa in 2006. AGRA’s main focus is transitioning farmers away from traditional seeds and crops to commercial seeds, synthetic fertiliser and other inputs to grow commodity crops for the international market.

African faith groups also appealed to the Gates Foundation in June, with a letter signed by 500 faith leaders asking it to stop:

“There’s somebody keen to kill the African Dream.” – James Shikwati, economist and author said. Kenyan Shikwati believes

that green ideology is not good for developing nations. In ‘The Great Global Warming Swindle’, a 2007 documentary aired on Channel 4, he stated: “One clear thing that emerges from the whole environmental debate is the point that there’s somebody keen to kill the African Dream [of development].”

# Corporation tax is a giant leap towards a one-world government

**LAST month in a triumph for transnationalism, 136 nations including the U.S. agreed to mandate a worldwide corporate income tax for all nations that will not be allowed to fall below 15%.**

“Virtually the entire global economy has decided to end the race to the bottom on corporate taxation”, said U.S. treasury secretary Janet Yellen, who negotiated the pact.

Betraying a nervousness as to how such a minimum corporate tax, dictated by globalists, will be received in Congress, Yellen urged that it be adopted “swiftly”. Yellen is right to be nervous.

The tax proposal is a giant leap towards a globalism that America has rejected, and its defeat should be made a priority of libertarians, conservatives, populists and nationalists alike.

What is this “race to the bottom” that so terrifies Yellen and her globalist allies? Simply the worldwide competition of independent nations to offer lower tax rates to entice successful companies to relocate to their shores and bring their jobs with them.

Yellen’s “race to the bottom” is as American as apple pie.

High tax rates, corporate and personal, in states such as New York, New Jersey, Illinois and California have proven to be incentives to companies to pick up and relocate to low-tax states such as Texas and Florida.

That 15% corporate tax rate is designed to prevent this competitive taxation, the beneficiaries of which

are companies that have moved to countries such as Ireland, which has a corporate tax rate of 12.5%. The Irish corporate tax rate is less than half of the 28% Yellen and President Joe Biden have in mind to impose on the USA.

Why would free-market and free-enterprise Republicans vote to lock into U.S. law a corporate tax rate dictated by agents of the private central-banking cartel?

To sign on to this 15% minimum tax would be to surrender our freedom to set our own tax rates in accordance with the values and beliefs of the party and administration the people vote into power.

Why would a great nation agree to give up its freedom of action and have its surrender written into its national law and ratified by treaty?

Why forfeit a sovereign right to cut corporate taxes when and to whatever level we wish? Why deny ourselves a competitive advantage that can be gained by unilaterally cutting corporate tax rates?

Assume the rest of the world embraces this minimum corporate tax of 15% and the U.S. - to recapture and restore a manufacturing base given away to China - answered the world with a corporate tax rate of 7% or 8%.

Transnational companies would beat a path back to America’s door.

While globalists might be appalled, why would nationalists give up irrevocably the freedom to act?

In the Trump era, a cut in the U.S. corporate tax rate to 21% helped to create one of the great

booms of the modern era, before the pandemic struck in March 2020. Earlier that year, unemployment in all categories was at record lows.

As Ronald Reagan taught, corporations do not pay taxes; they collect them. They get them out of the revenue they receive from the customers who buy their products and services.

The corporate taxes of Ford and General Motors come out of the prices that are charged to buyers of Ford and GM cars and trucks.

And the corporate profits are a primary source of higher wages and salaries, bonuses, and the investment capital companies need to grow and create new jobs.

It is an article of faith among Republicans that lower taxes, personal and corporate, generate greater economic activity and prosperity. And that tax hikes are the ways and means by which rapacious governments consume the seed corn of an economy.

A second provision to which the 136 nations agreed is to have the profits of the world’s largest corporations reallocated to the countries where their goods are sold and services are provided, not to the countries where they are located.

“Under the agreement,” The New York Times writes, “technology giants like Amazon, Facebook and other big global businesses will be required to pay taxes in countries where their goods or services are sold, even if they have no physical presence there.”

Adds the Times: “The separate tax aimed at the technology giants will reallocate more than \$125 billion of profits from the home countries of the 100 most profitable firms in the world to the markets where they operate”.

Why would an America First party inside the USA, home country to more tech giants than any other, sign on to a plan that would transfer tax revenue away from the U.S. treasury into the exchequers of foreign lands?

The GOP should use this moment to re-declare our independence when it comes to internal taxation on individuals and institutions in the United States, and reassert that we will decide the proper rates here, and not be subject to the veto of any other nation. The U.S. is not the EU.

## Blinken: U.S. policy is to ‘oppose the reconstruction of Syria’

The U.S. has ruled out normalising with Syria

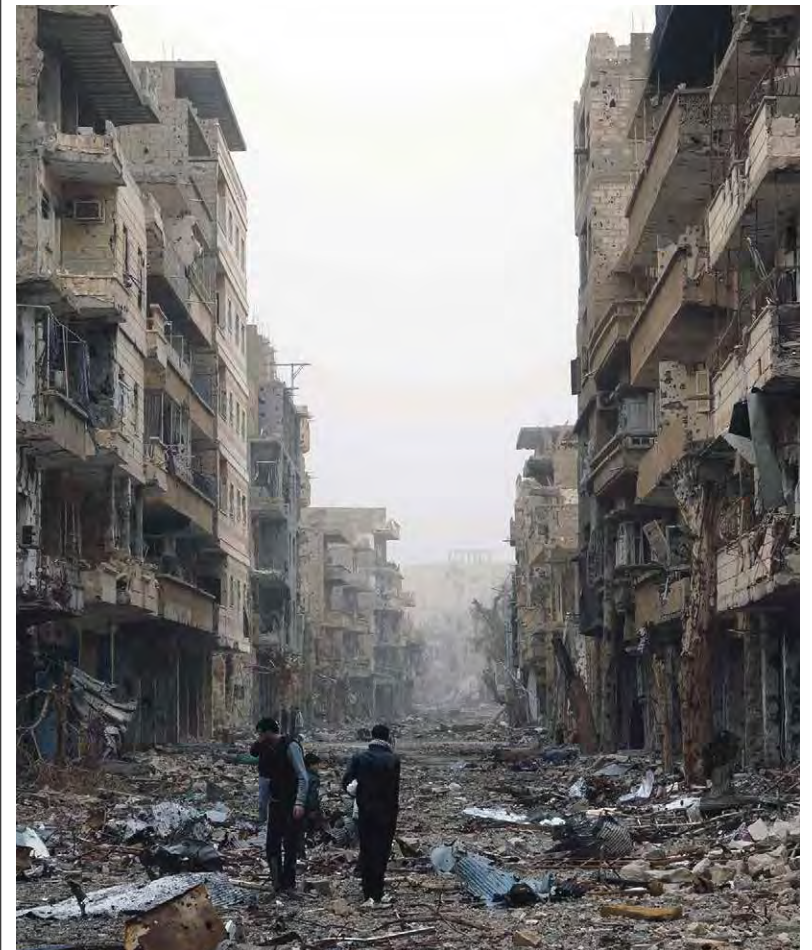

**SECRETARY of State Antony Blinken has said the U.S. position on Syria is to “oppose” the country’s reconstruction and not support any attempts at normalisation with the government of Bashar al-Assad.**

At a joint press conference with his Israeli and UAE counterparts, Blinken said the U.S. has not “changed our position to oppose the reconstruction of Syria until there is irreversible progress toward a political solution”.

U.S. sanctions under the Caesar Act against Syria specifically target the energy and construction sectors to impede the country’s ability to rebuild after 10 brutal years of war. The sanctions can target any person regardless of nationality, discouraging Syria’s neighbours from helping in the reconstruction.

On top of the sanctions, the U.S. also maintains an occupation force of about 900 soldiers in eastern Syria and supports the Kurdish-led Syrian Democratic Forces in the region. This area of Syria is where most of the country’s oil fields are, so the U.S. presence keeps vital



More and more Arab countries are accepting that Assad isn’t going anywhere and have taken steps to normalise, including Jordan, which opened its border with Syria in September. Blinken said the U.S. does not intend to “express any support for efforts to normalise relations or rehabilitate Mr. Assad” or lift a “single sanction” unless there is regime change in Damascus.

resources out of the hands of Damascus.

Washington’s economic warfare against Syria is exacerbating the country’s food shortages. According to the UN, as of February, the number of Syrians that are close to starvation is at 12.4 million, or 60 percent of the population.

# Satan - lost in translation?

**THE image of a devoted Christian at night would be of reading something from the Bible and making prayers, perhaps kneeling at the side of the bed. So what might Satanists do, Luciferians?**

A panicked British broadsheet has been campaigning against ‘conspiracy theories’. For example: “America has been taken over by a Satan worshipping, child-abducting cabal. Like the mythical Beast in Revelations, it has many heads... Hillary Clinton... Bill Gates... George Soros... Oprah Winfrey” (Sunday Telegraph, June 27 2021; book review of *The Storm Is Upon Us* by Mike Rothschild). Such views, it says, make appeal to “people with brain damage”. Well, it would.

But does their Satan really exist? Are world leaders taking orders from empowering satanic forces? A recent YouTube comment says: “Both obama [*sic*] and biden [*sic*] are working for satan and satan’s children.”

In the mythologies of Roman paganism, fictional ‘gods’ conducted evil things among men. Jupiter (also Jove), son of Saturn and Opis, was king of the gods. His Greek equivalent was Zeus.

In the poetical works of Homer, heroes blamed their misdeeds on the ‘gods’. They were the real culprits. Hades, ruler over the dead and the underworld, was cruel and pitiless, silent to any pleading. His realm also was known as Hades. Hermes led dead souls of the wicked to Hades, from where there was no escape.

Jesus had no hesitation in mocking such Hellenistic myths that the priesthood of Jerusalem had swallowed. In his parable of the rich man and Lazarus, Jesus has Abraham say to the rich man: “They have Moses and the prophets. Let them hear those”. (Luke 16/29). In other words, not Hellenistic myths.

When the Bible came to be translated into Latin (c. 390), its editor, Jerome, seeing the Hebrew and Greek words *satan* and *satanas*, rather than translating them as ‘enemy’ or ‘adversary’, merely transliterated them to give the name Satan. Yet they are not the names of anybody.

The same happened with the Greek word *diabolos*, meaning slanderer, not a title of anybody.

At 1 Timothy 3/11 and Titus 2/3 it is clear that *diabolos* makes reference to human slanderers, slandermongers, transgressing, among other things, the ninth

to be regarded as unquestionable orthodoxy. When you say ‘Satan’, you are speaking untranslated Hebrew and Greek words. They need translating. They are not names.

such character. There was no ‘Satan’ in Eden. It just says ‘serpent’.

At 1 Chronicles 21/1 we read: “An adversary [*satan*] stood up against Israel.” The comment on

John Milton’s angel-winged monster, but by ‘an adversary’ (*satan*) and ‘a slanderer’ (*diabolos*). You would imagine being the actual Messiah invoked some psychological battles - it does not say. Jesus though - as the Son of God - would have been instantly alert to Milton’s fallen angel and sent him on his way.

That leaves ‘Lucifer’. It is in the King James Bible just once, at Isaiah 14/12. The doomed King of Babylon is compared in his pomp and his fall to a star, a frequent biblical, astral metaphor. He had been a ‘shining star’.

But for the Hebrew word *balal*, ‘shining star’, the translators turned the King of Babylon into ‘Lucifer’. This was another transliteration from the Latin version. There is no being ‘Lucifer’.

God has declared through the Prophets: “There is no other God but Me”, the Creator.

Translated, rather than lazily transliterated, these narratives are taken out of the realms of myth, and become very human.

Satanism is self-worship. Satanism is an assertion of lusts, an arrogant rebuttal of the beautiful laws of God.

But the elite of the Beast system have no demonic commander other than themselves. Their chantings fall unheard. The power they (the real conspirators) do possess is control of the military, finance, politicians, media, law, medicine, technology, education, arts. They are *kosmokrators*, ‘world rulers’ (Ephesians 6/12) of darkness. Their destruction by Jesus is written: “Kings of the Earth, and the high-ranking, and the military commanders, and the rich, and the mighty men.” (Revelation 6/15, 19/18-21).

Meanwhile, despising us, they attempt their deception and genocide through ‘sorcery’, which is in Greek *pharmakeia* (Revelation 18/23-24, 9/21).

As for “666”, in the numeric values of the Greek alphabet (known as “isopsephy”), the word *παράδοσις* (*paradosis*) has the value of “666”. It means “tradition”, “orthodoxy”.

commandment (Exodus 20/16). The Latin version merely transliterated it as *diabolos*. So English translators put ‘Devil’.

When John Wycliffe made the first complete English translation (1380), he had only that corrupt Latin translation to work from. So he put ‘Satan’, the notion of Satan being long-embedded in the culture, and all English translators followed suit.

The teaching appeared in confessions and commentaries. A 1901 Greek lexicon says of Satan: “The prince of evil spirits, the inveterate adversary of God and of Christ.”

Thus a translation blunder came

These myths came all the way from paganism into evangelical teachings of orthodoxy. Jupiter simply got rebranded.

Mediaeval and later artworks, fictional writings of John Milton’s *Paradise Lost* and *Paradise Regained* (1667, 1671) and CS Lewis’s *Screwtape Letters* (1942), all lionising Satan as the universal tempter of man, help reinforce into the consciousness of orthodoxy the myth of whispering devils.

I have tabulated every occurrence of all biblical words concerning adversaries of God. There is no word or context revealing any monster called ‘Satan’ and ‘the Devil’. The Prophets and Apostles knew of no

that same event at 2 Samuel 24/1 reveals that ‘adversary’ - *satan* - to Israel, to be God Himself! Yet English Bibles have ‘Satan’ at 1 Chronicles 21/1. So what to sloppy translators was ‘Satan’ is actually God. Blasphemy.

Nothing more shows that the Greek forms *satan* and *satanas* do not represent a universal monster than Jesus’ words to Peter, “Get behind me, adversary [*satanas*]!” (Matthew 16/23). Jesus was speaking to Peter, not invoking a mythological monster. Nor would Jesus have called his friend Peter such a name.

When Jesus was tempted in the wilderness he was confronted not by

The global warming fraud is the most immoral confidence trick in history.

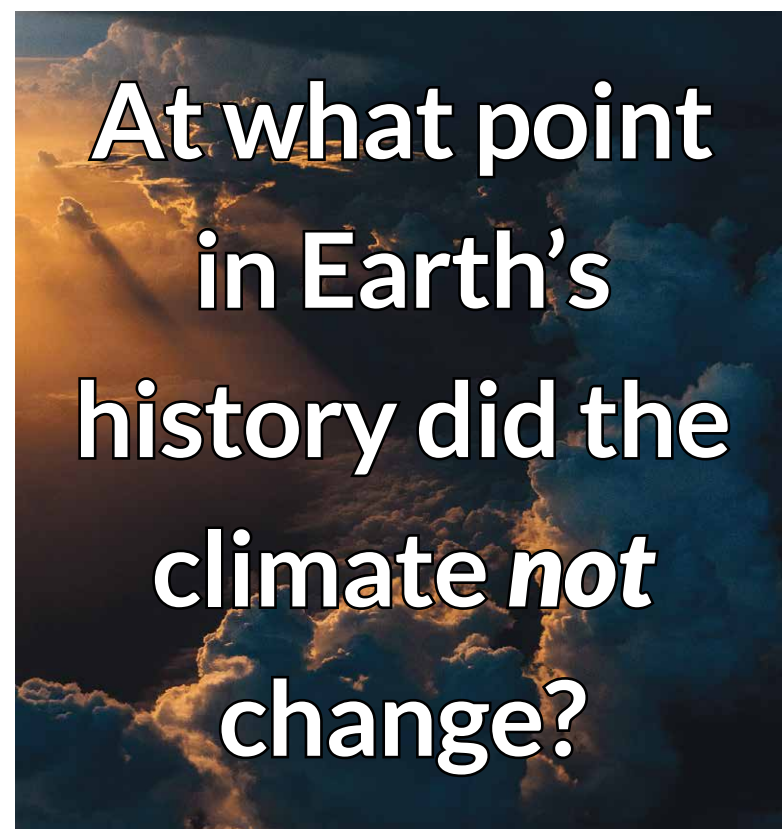

## 'Conspiracy theory' trope killing debate

**I SOMETIMES wonder whether those who routinely deploy the 'conspiracy-theory' (CS) trope remotely have the intelligence to comprehend the irony of their name-calling activities - namely, that in labelling people 'conspiracy theorists', they are themselves guilty of purveying conspiratorial thinking about alleged conspiracy theory.**

'Hoist with one's own self-constructed petard' comes to mind as an apposite metaphor for such thought-challenged individuals.

The deployers of the CS trope clearly want it to be a conversation- and thought-stopping term, from which its recipient is rendered silent and appropriately humiliated. Nothing could be further from the truth.

Those using this abusive term are likely to be so intellectually challenged as to be incapable of entering into the kind of rational, balanced conversation that would facilitate their reflecting on the nature of the term. So we had better do that job for them.

The CS term is routinely deployed and weaponised as a wily way of shutting down any open-minded thinking and discussion about the issue in question. Indeed, it is the overriding reason why the very notion exists - with the CS label strategically used by establishment interests to silence anything that challenges their interests and ideology.

The BBC's promiscuous use of the term is a case in point - not least by their ironically-named 'specialist disinformation reporter' (you really could not make it up), Marianna Spring.

Another irony is that those who robotically play the 'conspiracy theory' card end up closing down critical thinking in exactly the way they claim 'conspiracy theorists' to be doing. Moreover, just because something can be labelled as 'conspiracy theory', it by no means necessarily follows that it is not true.

It is a purely empirical question as to whether something constitutes a conspiracy or

not. History is replete with what we now know to have been real conspiracies; and no doubt the existence of any conspiracy would have been vehemently denied by these conspirators at the time.

But it is also problematic to see conspiracies everywhere – as some people seem to do - sometimes based on the flimsiest of evidence, and seized upon merely because it self-confirmingly serves prejudices. For truth lovers, that is not very helpful either - and can also so easily be the enemy of rational discourse and sober, considered analysis.

I know some people who, because of the fraught and highly controversial nature of the CS terrain, deliberately choose to avoid anything that smacks of CS in order to (they convince themselves) protect their credibility in the face of enemy/establishment attacks, and not because there is assumed to be no truth to such theories and claims.

Such expediency needs to be thought through very carefully, however; and I think French philosopher Michel Foucault's notion of 'fearless speech' is a far more conducive approach when faced with contested and controversial truth-claims.

It could even be argued that if we are genuinely interested in the unrestrained free exchange of ideas, as one of the foundations of a healthy democracy, then we should reject the term 'conspiracy theory' altogether from our lexicon.

The crucial point is that whether a given body of ideas and arguments has any validity is always an empirical question; and to lazily deploy the condemnatory CS trope is anti-science and anti-rationality, as it serves to short-circuit the very work that would be needed in order to ascertain where the truth does actually reside. Which is precisely why the establishment delights in weaponising this squalid term at every opportunity.

# Overgrowing the regime with hemp

Yet, all of this is true. So we established Hempen, a non-profit cooperative that cultivates hemp for the health of people, community and environment. In 2015, we started growing hemp for its seed as a superfood and later discovered the emergent Cannabidiol (CBD) Oil.

Here are just a few of the many practical benefits of hemp:

**Health** - The hemp plant produces one of the most nutritious seeds on Earth. It's an incredible source of protein, containing the optimum balance of omega fatty acids, 21 essential amino acids, minerals and vitamins for great absorption by the human body, and a crispy shell full of fibre too! The green matter holds hundreds of compounds, including

a range of cannabinoids - just one being CBD - that are known to bring our bodies into a state of balance.

**Industry** - Today, BMW make their bodywork from hemp bio-composites that are lighter and stronger than steel. Celebrity architect Kevin Macleod (Grand Designs) claims hemp as one of his favourite ecological building materials. Scientists have even discovered that hemp can be used to make a supercapacitor that outperforms graphene to make eco-batteries.

**Agroecology** - Hemp grows perfectly when cultivated using organic principles. However, the UK doesn't grow enough organic produce in general to meet demand.

Hemp provides a useful crop rotation alternative, as it revitalises the soil and even removes toxins, making it a perfect natural product for bioremediation.

The problem for British farmers is that hemp requires government permission to be grown, even if it is low in the psychoactive compound THC. This is despite the fact that the World Health Organisation has said



that it poses no public health risk and the United Nations claim that it should not be a controlled substance.

Since 2018 only a few farmers have been able to jump through the bureaucratic hoops to get a hemp cultivation licence, so unfortunately there are only about 20 licensed UK growers and their combined hemp growth totals as little as 2000 hectares.

In 2019, we at Hempen were denied the renewal of our licence midway

through a growing season, forcing us to destroy a healthy crop valued at £200,000. This is when the Home Office decided that farmers could no longer cultivate it for CBD use. If we could have harvested the same field for CBD, it would have been worth £2.4 million. Shockingly, all CBD extracts in the UK now have to be imported.

We currently grow in partnership with farms across the British Isles for seed and fibre use, with continued

unclear governmental guidance on hemp cultivation and processing. In fact, we struggle to meet the demand for organic UK-grown hemp, as the government hasn't given enough organic hemp farms their approval.

We've launched 'Overgrow the Regime', a mass direct-action campaign to grow hemp. The time to grow hemp is *now*, with or without a licence. We'll render the licensing regime redundant through the mass civil disobedience of openly growing hemp; in window boxes, allotments and fields, without asking for permission from government ministers with conflicted interests.

Together we will empower anyone who wants to grow hemp and learn about how to harvest it, for its myriad of benefits. A prosecution of one will be defended in court by all, demanding that the government justify its criminalisation of this plant that has so much potential.

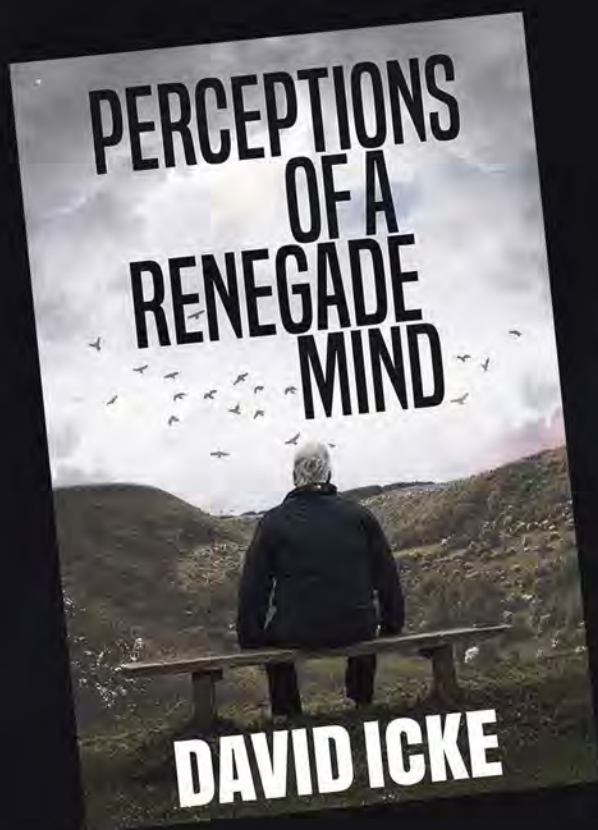
