

Vaccines killing children

The alarming spike in children's deaths in Ireland is being linked to what scientists now call 'the deadliest vaccine ever created.'



EVERY day, RIP.ie reveals countless young faces who died 'unexpectedly', from newborn babies poisoned by their mother's injection to young teenagers in the prime of their lives.

Official figures show there has been almost a doubling of deaths in the 15-24 year age bracket in Ireland during the summer months of 2021 compared to last year when the virus was allegedly raging. But these figures are believed to be a grave underestimation of the real picture.

The experimental mRNA injection turns the body into a spike protein factory - the toxin that makes 'Covid-19' more severe than previous coronavirus (common cold) infections. It has now conclusively been shown to damage all organs in the body including the lungs, heart, brain and kidneys.

The shot does not stop recipients from catching the virus or from transmitting it to other people.

In children and adolescents, the risk of death from the injection is about three times higher than death from Coronavirus, which in under 18s is statistically as rare as being killed by a lightning strike. People in their 20s have a seven times greater risk of dying from the jab than the 'disease'.

Deaths among children have also risen in the UK since they began vaccinating teenagers aged 12 and older, with a 62% increase in 10 to 14-year-olds and a 400% jump in vulnerable children, compared to the last five years. The UK Health Security Agency reported that the number of children who died at the end of October this year was so great, it was considered excess mortality.

Most parents are not aware that a 37-page fact sheet published by Pfizer noted that 79% of Covid vaccinated children should expect side effects. Meanwhile, the first batch of FOIA documents released by the US Food And Drug Administration found that the company reported 1223 deaths in early February 2021 but the rollout was still not stopped. Pfizer has a notorious safety record, paying the biggest criminal fine in history - \$2.3bn for bribing doctors and lying about its drugs.

A study of mice found that if mRNA vaccine gets into a vein, the heart muscle absorbs the mRNA, and starts producing Coronavirus spike protein, gets attacked by the immune system, and develops inflammation and cell damage (i.e. myocarditis).

Scientists believe this is happening in humans too. In every town, village and suburb of Ireland, locals are quietly acknowledging that perfectly healthy people in their parish became very ill and/or died after receiving the vaccine. Few people knew anyone who died of Covid last year, with the vast majority of deaths wrongly attributed to the disease but actually caused by old age, underlying conditions, obesity or accidents. However, there are countless anecdotal accounts coming to light about strokes, clots, heart attacks, convulsions and death in healthy people after they took the shot.

A new British Government study has also shown a sharp jump in hospitalisations and deaths postvaccination with an 'abundance of patients admitted to hospital within seven days of being injected.

As new scientific reports emerge almost weekly linking the vaccine to death and serious illness, the Irish media, government and NPHET are desperately struggling to conceal the devastating injuries and fatalities. There are reports of families of injured loved ones being silenced and paid off.

But even the WHO (World Health Organisation) has been forced to back down on their propaganda, admitting in early December there is no evidence that booster jabs offer greater protection to health.

In a damning new study, the highly regarded heart journal 'Circulation' found the dangers involved in getting

It claims the shots 'dramatically increase inflammation on the endothelium and T cell infiltration of cardiac muscle.'

In March 2021, Israel reported a 'murky wave of heart attacks' and an increase in post-vaccination all-cause mortality. The government confirmed in June that the vaccines may cause heart inflammation (myocarditis) and heart attacks in young people.

In September, a US study showed that healthy male adolescents were five times more likely to suffer from post-vaccination myocarditis than Covid hospitalization. Videos of young vaccinated athletes and football players collapsing and dying on the field have gone viral on social media.

In Ireland, the state's vaccine regulatory authority, the Pharmafunded HPRA (Health Products Regulatory Authority) has reported 195 side effects in 12 to 17-year-olds in Ireland including 83 reports of myocarditis and pericarditis. But this is expected to be just a tiny proportion of young people whose lives have been destroyed by the jab. One can only imagine how they will react in months and years to come when they find out their parents, teachers, government and media led them to their own slaughter and ruined their futures.

Covid Sacrament restrictions 'grave sin': Cardinal

Priests and bishops who deny the sacraments to people using Covid as an excuse are committing grave sin, a German Cardinal has said.

Cardinal Gerhard Müller issued the warning to clerics who 'offer themselves as courtiers to the rulers of this world and make themselves their propagandists.'

In an interview with the National Catholic Register, he said politicians, mainstream media and Big Tech have ruthlessly exploited COVID-19 to promote totalitarian thinking that has led to division within families.

The Prefect Emeritus of the Congregation for the Doctrine of the Faith also said that bishops and priests who close churches or deny the sacraments are in a state of 'grave sin' that goes against their God-given authority.

His words come as Irish Catholics fear they will be shut out of Mass and the sacraments again at Christmas by heretical priests who have followed the diktats of the abortion-providing state.

Many of the faithful have abandoned these 'New World Order' churches who have installed vulgar cash machines beside the altar in line with the 'New Normal' and are now attending the growing number of traditional Masses



where Covid fascism in the form of masks, social distancing and servile obedience is nowhere to be found.

Catholics who remain true to their faith have refused the vaccine on the grounds that it contains aborted foetal cells and is so injurious to health.

The decision to restrict the Sacraments during Covid is 'shocking proof of how far the secularization and de-Christianization of thought has already reached the shepherds of Christ's flock,' the Cardinal said.

The Catholic Church and governments, he added, must 'work towards social cohesion' and avoid divisive rhetoric that labels some as 'conspiracy theorists' or 'sinners against charity.' Those who use such terms are guilty of the very divisive misconduct of which they publicly accuse others.

The cardinal's comments come as various nations in Europe, along with Australia, impose strict vaccine mandates on their citizens. Many governments have lost the public's trust through chaotic measures that have a contradictory logic, he said.

In quite a few cases, regulations have been compromised and contaminated by the financial and political interests of ideological lobbies and pharmaceutical giants. Instead of uniting society in the fight against the pandemic, the powers that be in politics, the mainstream media and Big Tech have ruthlessly exploited the situation to promote the agenda of the "Great Reset," i.e., totalitarian thinking. Right down to families, people are at loggerheads with each other.

'It is, above all, contrary to divine law if access to the means of grace of the Church: the sacraments of Christ, are impaired or forbidden. We bishops should, above all, be guided by the word of Jesus: 'I am the Good Shepherd. A good shepherd lays down his life for the sheep' (John 10:11).

'For the hirelings, like lords of the manor, dispose of the grace of God as they see fit. The bishops, however, as successors of the apostles, are not rulers according to the ways of the world, but ministers of the Word and ministers of the grace of Christ. They cannot justify the refusal of the sacraments for the grace of eternal life must take precedence over temporal goods.

'In times of crisis, places of worship and people's hearts must be wide open so that people may seek refuge in God, from whom all help comes," the Cardinal said.

'No medicine or technical invention can save us from temporal and eternal death. The Bread that Jesus gives is the cure for eternal death and - without an expiration date - the food for eternal life. "Whoever eats this bread will live forever" (John 6:51). And that is why, at the beginning of the second century, the martyr-bishop Ignatius of Antioch, in his 'Letter to the Church of Ephesus' (20:2), was able to call the Eucharist the 'medicine of immortality.

'The task of bishops is to administer the Eucharist to the faithful, not to keep them away from it. Personal devotion at home and virtual co-celebration on screens cannot replace real and physical presence in the assembly of the faithful, for we are bodily and social beings. Therefore, the grace and truth of God is communicated to us through the Incarnation of his Son and is shared with us in the community of the Church. It is his Body. In the Eucharist, Christ is hidden but really present with his divinity and his humanity — in flesh and blood.'

How we win

Marching behind Marxists will cost a higher price in the end, says John Waters

THOUGH it may offer relief to people from the encroaching tyranny to let off steam by attending rallies organised by a front organisation for Marxist Sinn Féin, it is not at all helpful to the project of restoring freedom in our country.

Many who attend are wellintentioned citizens suffering greatly in this unprecedented attack on the Irish people. It is good they are able to meet and mingle with like-minded people, and gain some relief from the tension and stress of the continuing horror of our collective situation, but it is important to consider if this has a price too high.

Some of the speakers at these rallies may well believe they are part of some wave of genuine popular revulsion about vaccines, masks and Covid tyranny. But the telltale signs are there: Why are the organisers of these events allowed to construct large stages outside the GPO and the Dáil when the first wave of protests in the summer of 2020 were beaten off the streets, and banners stating 'No Forced Vaccines' resulted in assaults and jailing by Gardai?

Why are people suddenly permitted to dissent in public when every time real opposition sought to open their mouths in public over the past two years, the Gardai used brute force against them while Soros-terrorists Antifa were allowed to throw missiles at them in full sight of the so-called Guardians Of The Peace? Why do the fake news media condescend to report on these new events when they have either ignored every spontaneous and genuine protest since the summer of 2020 or lied about the nature of those in attendance labelling them 'far right'?

By definition, those who organise these protests are not part of any solution. The clue is in the nature of the speeches, which focus on singleissue elements of the Covid assault - for example the attempt to mask children at school - ignoring the even more grave issues like the escalating deaths from pseudo-vaccines, the continuing inoculation apartheid in Irish GP surgeries, hospitals, shops, bars and restaurants. It is notable also that these speeches contain the same kind of globalist, rainbow, multicultural rhetoric that flows like effluent from the mouths of Government ministers. Vladimir Lenin's advice to fellow our country at the next election, having all but completed its project of duping the electorate into believing it to be different than what it seeks to replace.

Every party and member of the Oireachtas has either colluded with the 'measures' designed to terminate our freedoms, or remained silent in the face of this endeavour. The old axiom applies in spades: Those who are part of the problem simply cannot be part of the solution.

It follows that if we are ever to emerge from the encroaching totalitarian fog, we need to form a collective national resolve that all of those who have been in any way complicit in this tyranny can have no future place in running or serving this Republic. Freedom cannot be freedom if it is restored by those who have wrongfully stolen it, but must be claimed back from such evildoers with single-mindedness and resolve.

Given the abuse of the human mind that has occurred in the past two years, this moment requires reflection and deep communications between citizens, informed from sources that are truthful and reliable with a solid track record in taking on the state. What will occur at the end of such a process will be a solemn and dignified process of reclamation, not a jolly day out in town.

This activity - being honest, sincere, indefatigable and, above all, unmanaged by the Regime - is of infinitely better value than thousands of people being shepherded around Dublin by bought-and-paid-for apparatchiks and covert followers of some of the greatest inspirers of mass murder in human history.

In this way, working alone or in small groups, we shall gradually move closer together, until one day we will realise there are a million of us marching to Dublin in the green, in the green. And that the sum part of all of our individual efforts to bring down the corrupt will have succeeded.
