Court Appeal Reveals Gardai Blackmailed Witnesses To Frame Him

GARDAI ATTACK SPEECH

IT should be remembered that the incursions of 2020 would not have been possible without the assistance of An Garda Síochána, who stood on the roadsides of Ireland interrogating Irish drivers and their passengers as to their business and destinations.

It was members of the alleged 'people's police force' - the 'guardians of the peace' - who dragged people from trains and buses because they were not wearing dangerous synthetic gags over their mouths, and tramped around sacred spaces pursuing the devout and reverent at their prayers. The same alleged guardians of the peace were more than willing to drag elderly ladies off in Paddy wagons for having the temerity to protest about the criminality of the national broadcaster, or stand in solidarity with their friends and colleagues outside the Four Courts while the sole application to contest the lockdown was being heard

It was claimed, on behalf of these individuals, who lent themselves in that episode as hired thugs to do the bidding of the globalist overlords seeking to imprison and dispossess their neighbours, that they did all this reluctantly, that they resented having to treat their own neighbours in this way. If so, why are we still waiting for the apologies? And why, after 43 months in which the deafening silence in this regard has been punctuated by sundry other evidences of the unsuitability of An Garda Síochána to police a free and democratic society, do we now again see the bared fangs of these

quislings as they seek to silence the only newspaper in the country that continues to tell the truth, that is not bought and paid for, that does not do the bidding of the overlords who have the entire Irish establishment in their pockets?

The recent assault by Detective Sergeant Don Griffin from Dun Laoghaire Garda Station on the right of John Waters and Gemma O'Doherty to 'express freely their convictions and opinions' - as it states in Article 40 of the Irish Constitution - is perhaps the most egregious attack on fundamental freedoms that has occurred since the appalling 'lockdowns' of 2020, when people were essentially

subject to house arrest for months on end. We don't know if this is a solo run by Griffin who has previous form in pestering journalists who expose the truth about Garda corruption, as Gemma O'Doherty did in relation to the Raonaid Murray case. He made inappropriate contact with her after she revealed shocking evidence of a Garda cover-up in the 1999 murder of the 17-year-old student in Glenageary. Gemma ignored his veiled attempt to intimidate her then.

Now another intervention has come from Griffin. Last month, we received an email from him in relation to an article I wrote earlier

this year about mass immigration and its damaging impact on Ireland. Griffin has accused us of racism and anti-Semitism and is threatening to prosecute us for the dubious crime of 'hate speech'.

Aside from being the most shocking example of official overreach in many months, his email is also remarkable for its carelessness, highhandedness and presumptuousness, having clearly been knocked off on the basis of the flimsiest intervention (if any) by a members or members of the public, and subject to not the slightest assessment as to the nature of the 'evidence' being proffered, or the legal definitions being employed to issue a potentially chilling

intimidatory threat to two working journalists.

For one thing, the legal instrument being utilised in this opportunistic episode of harassment is the Prohibition of the Incitement to Hatred Act, 1989, which multiple politicians of the present governments have claimed is unfit for purpose, which is why they claim to require 'hate speech' legislation to deal with the supposed problem of hatred in Irish society. Most of the hatred being vented in Ireland comes from 'progressives' seeking to silence those who disagree with their claims. As Senator Michael McDowell noted in his Seanad speech against the 'hate speech' laws in June 2023, some of the most hateful attacks we have witnessed in recent years have been by members of 'minorities' seeking to silence those who sought to question or critique their positions. But we must not be naive. An Garda Síochána is now, under the MI5 agent, an ideological police force. Its job, as it sees matters in this context, is to promote the positions of the crypto-Bolshevik insurgents who seek to dismantle the very roof, walls and foundation of Irish civilisation, while hobbling and gagging those who would seek to prevent this.

The idea of journalists being invited to 'attend' at 'Garda stations' to 'comment' on the capacity of their work to 'offend' achieves a new and breathtaking level of effrontery in someone who is paid to uphold the Irish Constitution, which in this context means to protect freedom in Ireland and bring to justice those seeking to subvert it.

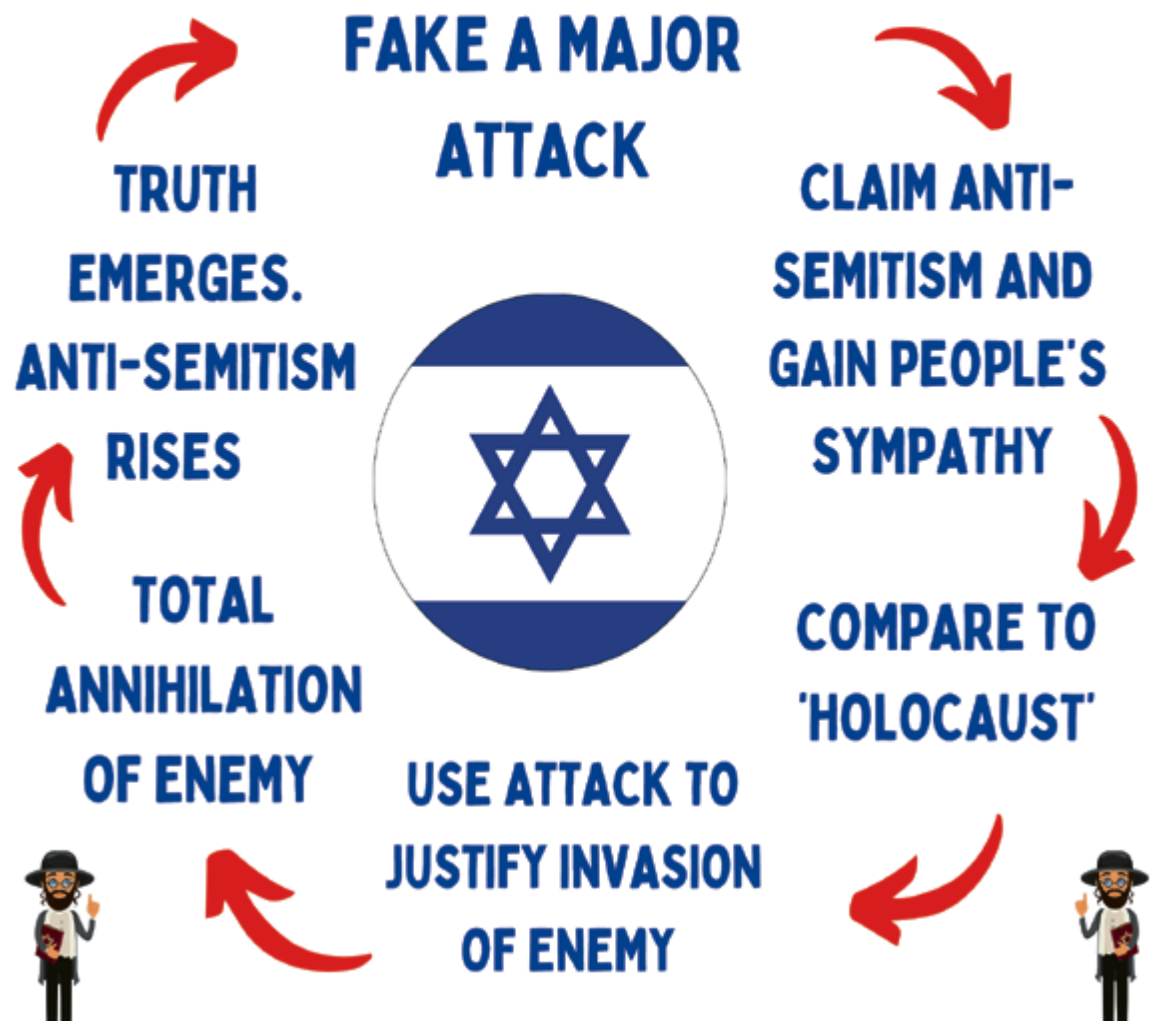

Electric Dreams Up In Flames

ELECTRIC cars are becoming uninsurable due to costs involved in repairing their batteries. Even the mainstream media who have pushed these useless vehicles relentlessly because they are part of the population control agenda have been shamed into publishing this latest embarrassing news.

The Daily Telegraph recently quoted industry experts who say analysts often have a problem putting a figure on the repair price.

A lack of insight and understanding about the cost of repairing damaged batteries is pushing up premiums, said Jonathan Hewett, Chief Executive of Thatcham Research, the motor insurers' automotive research centre in the UK.

"The challenge is that we have no way of understanding whether the battery has been compromised or damaged in any way. This has resulted in some providers declining to provide cover altogether. Analysts often have trouble accurately putting a figure on the repair price.

Electric cars can be expensive to repair, costing around a quarter more to fix, on average, than petrol or diesel vehicles. They are routinely being written off after minor collisions because of the cost and complexity of fixing their batteries.

"The threat of thermal runaway means that a catastrophic fire could take place if the cells of the battery have been damaged in a collision," Mr Hewitt said.

What we're struggling to understand at the moment is how we approach that diagnostic technique. It's like a doctor trying to understand what's wrong with you without any notes or an X-ray."

John Lewis Financial Services stopped providing new and existing customers insurance for electric cars last month to give its underwriter Covéa time to analyse risks and costs. Aviva removed insurance products for the Tesla Model Y earlier this year but restored them several months later.

Vehicle repair costs rose 33 per cent in the first quarter of 2023 compared to the same period last year. This pushed annual premiums to record highs, according to the Association of British Insurers.

Electric cars have turned into nightmares for owners as insurers are increasingly reluctant to deal with them due to the hefty repair costs

Average electric car insurance costs rose 72 per cent in the year to September, compared to 29 per cent for petrol and diesel models, according to Confused.com.

"The battery is an extremely expensive component of an electric vehicle and until we find efficient ways of dealing with it we have the challenge of high premiums for electric vehicles, which nobody wants," said Mr Hewitt.

Some customers have been quoted more than £100 per week to insure electric vehicles and others report that their premiums have doubled or tripled in a year.

The steep rise in the cost of repairing electric cars stems from

recommendations that they should be kept 50ft apart in repair yards over fears they may explode.

In the UK, government guidelines suggest electric vehicles with damaged batteries should be "quarantined" to prevent battery fires, which are typically harder to put out than fires in petrol or diesel cars. The website Tesla-Fire.com lists 25 reports of Teslas catching fire globally since the beginning of this year.

The London Fire Brigade has warned that blazes involving lithium batteries are the fastest growing fire risk in London. It attended 87 e-bike ascooter fires in 2022 alone.

Thatcham Research said insurers would have to spend an extra £900m a year on quarantine facilities for damaged EVs to meet required safety measures by 2035.

The transport operator of Paris has shelved 149 electric buses after two caught fire on separate occasions.

ONE of the most remarkable aspects of green energy is how non-renewable and environmentally dirty it actually is.

Almost no attention goes to the staggering environmental costs that go into making the mammoth wind towers, solar panels and EV lithium-ion batteries. That grave omission is deliberate.

Solar panels and giant wind power arrays require huge amounts of raw materials. A standard engineering evaluation between "renewable" solar and wind versus present nuclear, gas or coal electricity production would begin by comparing bulk materials used such as concrete, steel, aluminium, copper consumed per production of TeraWatt hour (TWh) of electricity.

Wind consumes 5,931 tons of bulk material per TWh, and solar 2,441 tons, both many times higher than coal, gas or nuclear. Building a single wind turbine requires 900 tons of steel, 2,500 tons of concrete and 45

tons of non-recyclable plastic. Solar power farms require even more cement, steel and glass - not to mention other metals. Keep in mind the energy efficiency of wind and solar is dramatically lower than for conventional electricity.

A recent study by the Institute for Sustainable Futures details the impossible demands of mining for not only EV vehicles but also solar and wind farms. The report notes that the raw materials to make solar PV panels or windmills are concentrated in a small number of countries - China, Australia, DR Congo, Chile, Bolivia, Argentina.

The report says: "China is the largest producer of metals used in solar PV and wind technologies, with the largest share of production for aluminium, cadmium, gallium, indium, rare earths, selenium and tellurium.

"In addition, China also has a large influence over the market for cobalt and lithium for batteries. While Australia is the largest producer of lithium...the largest lithium mine, Greenbushes in Western

Australia, is majority owned by a Chinese company."

Not so good when the West is escalating confrontation with China.

The report notes that the DR Congo mines more than half of the world's cobalt. The mining there has led to "heavy metal contamination of air, water and soil... to severe health impacts for miners and surrounding communities in DR Congo, and the cobalt mining area is one of the top ten most polluted places in the world. Around 20% of cobalt from DR Congo is from artisanal and small-scale miners who work in dangerous conditions in hand-dug mines and there is extensive child labor."

Rare earth metals mining and refining is essential for the zero carbon transition in batteries, windmills and solar panels. According to one report by energy specialist Paul Driessen: "Most of the world's rare earth ores are extracted near Baotou, Inner Mongolia, by pumping acid into the ground, then processed using more acids and chemicals.

"Producing one ton of rare earth metals releases up to 420,000 cubic feet of toxic gases, 2,600 cubic feet of acidic wastewater, and a ton of radioactive waste.

"The resulting black sludge is piped into a foul, lifeless lake. Numerous local people suffer from severe skin and respiratory diseases, children are born with soft bones, and cancer rates have soared."

The USA also sends most of its rare earth ores to China for processing since it shut down domestic processing during the Clinton presidency.

Because they are vastly less energy efficient per area, the land used to produce the mandated zero carbon global electric output is staggering. Wind and solar require up to 300 times the land required to produce the same electricity as a typical nuclear plant.

In China 25 square kilometers of a solar farm are required to generate 850 MW of electric power, the amount of power attained at a typical nuclear plant.

Viroliegy Is Not Science

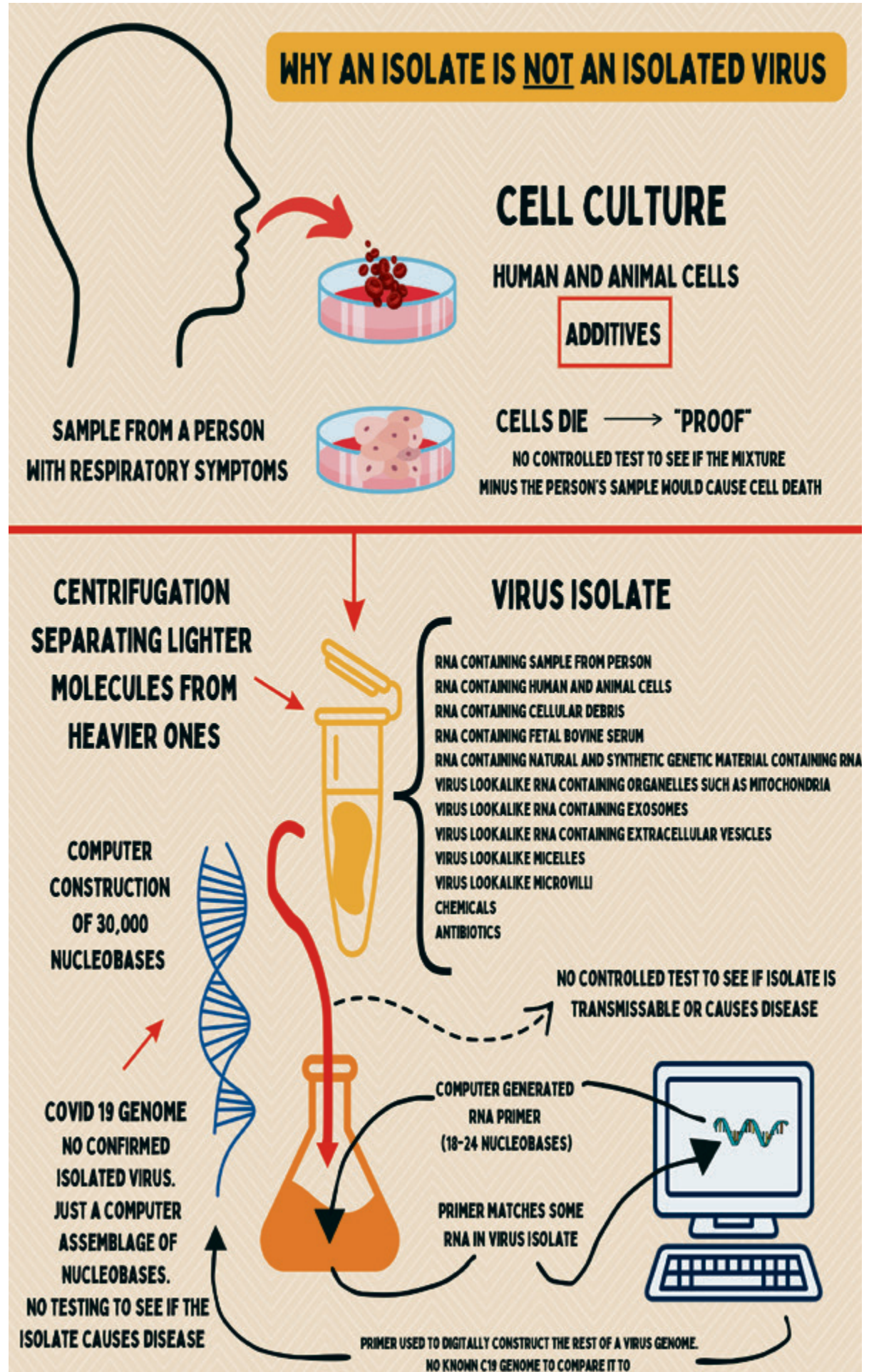

Mobile phones destroying health

“In the mid-eighties, fewer than 3% of all people in most of the countries of the world were using cell phones but if you fast forward to today, almost 100% are using them. By the time they’re 19 or 20 years old, our children will have used the phone for 10 years and we have no idea what kind of risk that’s carrying. We live in an ocean of electromagnetic radiation. It’s all around us, invisible, but we know it’s there. Every time you lift up your mobile phone, you know it’s there. It is very hard to turn the clock back. But we need to be aware of the adverse health effect so that we can have the choice of taking precautions against the exposure.”

ANOTHER chronic symptom of the laid-back approach modern parents take to their children’s health is illustrated by the widespread use of mobile phones among the young. Children may be able to sustain certain levels of radiation when they are young but this poison is building up in their bodies setting them up for cancer and other health conditions in later life.

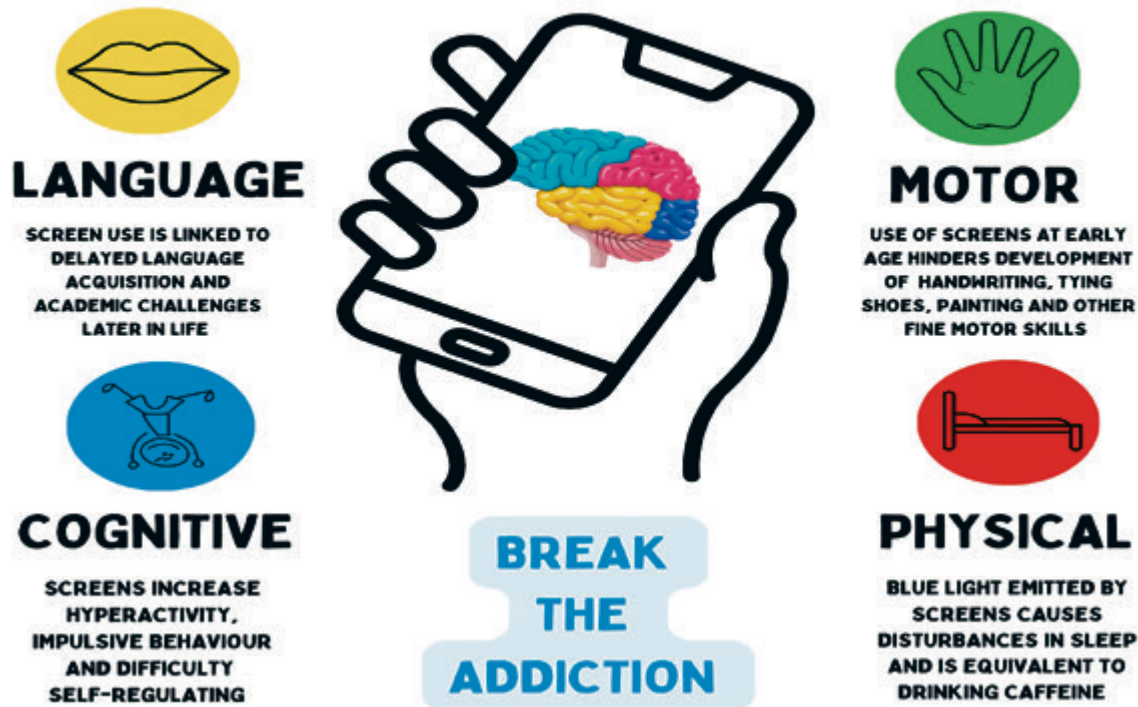
Their small bodies are already being bombarded with heavy metals linked to vaccines, 5G masts, fluoridated tap water and chemical sprays, but handing them a mobile phone before their brains are fully developed is potentially signing their death warrant.

Here are just some of the dangerous effects of using mobile phones

1 All Cell Phones And Wireless Devices Emit Radiation

Every wireless device is a two-way microwave radio that sends and receives a type of non-ionizing electromagnetic radiation called radio frequency radiation RF – EMF. This machine-made radiation is millions of times higher than the natural electromagnetic fields (EMFs) our grandparents were exposed to. Numerous peer-reviewed research studies show that these man-made pulsed electromagnetic frequencies cause adverse biological effects and

are very different to the natural electromagnetic fields that have existed in the environment for years. Research on humans has found an association between cell phone use and serious effects such as brain cancer, headaches, damage to the neurological and immune systems. Studies from Yale found that cellular radiation exposure during pregnancy led to increased hyperactivity and memory problems in offspring.

2. Our Brains And Bodies Are Penetrated By This Radiation

When we hold a cell phone against our head to talk, the radiation from the phone moves into our brain. Likewise, when we use a wireless laptop, the radiation penetrates into our abdominal region, chest area and brain. According to the International Agency for the Research on Cancer: “the average radio frequency radiation energy deposition for children exposed to mobile phone RF is two times higher in the brain and 10 times higher in the bone marrow of the skull, compared with mobile phone use by adults”.

Multiple research studies report cell phone radiation penetrates more deeply into children’s brains (Fernandez-Rodriguez 2015, Fernández 2015, Mohammed 2017) compared to adults.

Research also has found that radiation from tablets penetrates more deeply into children’s brains (Ferreira 2015.) A 2018 study that considered the radiation dose into the brain of teenagers found that teens who used cell phones up to their head had decreased memory performance on researchers’ tests. Harvard doctors have also published research linking electromagnetic fields to autism.

3. Cell Phones And Wireless Devices Emit Radiation Constantly, Even When You’re Not Talking Or Using The Phone

A powered-on cell phone is always “checking in” and maintaining a connection to the nearest cell tower by sending intense bursts of radiation several times per second.

Likewise, a wireless-enabled laptop, tablet or other device is always “checking in” with the nearby router or a network base. These “check-ins” are radiation emissions happening several times per second, whether or not a connection is successfully established.

Concerned doctors, scientists and parents have called on schools to reduce exposure to this radiation but it continues unabated.

4. Every Wireless Device Has Fine Print Instructions Buried In Its User Manual That Specify A Distance Between The Device And User That Should Not Be Surpassed

Most cell phone manuals state the phone should be held at specified distance (often around 5/8th of an inch) from the body. If you look in the user manual for your DECT cordless home phone, wireless laptop or printer, it will state that the device should be at least 20 cm (approximately 8 inches) away from the body to prevent “exceeding FCC radiation exposure limits”. These instructions are in the user manuals because cell phones and wireless devices are tested for user radiation exposures at those specific distances.

5. These Fine Print Instructions DO NOT Protect You From All Health Effects

The instructions buried in your manual are not safe enough. Even if you follow these instructions, you risk your health. Accumulating research now shows a myriad of health effects occur at levels far below (literally tens of thousands times lower than) government regulation limits. Wireless devices were not adequately tested before they came on the market.

6. Research Shows Low Levels Of This Radiation Impact The Brain And Reproductive System

Wireless radiation has been shown to change brain function even at levels hundreds of thousands of times below federal guidelines. In 2011, Dr. Volkow’s NIH research showed that the brain increased glucose metabolism when exposed to cell phone radiation. Dr. Suleyman Kaplan has published multiple research studies showing damaged brain development in the offspring of prenatally exposed test subjects. Significant research shows that wireless exposures decrease and damage sperm and that prenatal exposure can alter testis and ovarian development.

7. Radiation From Cell Phones And Wireless Is Linked To Cancer

In 2011, the World Health Organization’s International Agency for Research on Cancer first classified cell phone and wireless radiation as a “Class 2 B Possible Human Carcinogen” based on these research studies that showed long-term users of cell phones had higher rates of brain cancer on the side of the head where they held the phone. The United States National Toxicology Program completed a \$30M study that found “clear evidence” of cancer in male rats exposed to long-term low-level radio-frequency radiation.

8. As The Evidence Linking Wireless Radiation To Cancer Has Significantly Increased Since 2011, Cell Phone Radiation Is Now Classed As A Human Carcinogen

In 2016, a major US government study found cell phone radiation caused increased cancers (brain and heart nerve) in rats exposed at low levels for two years. The results were stunning because the cancers the rats developed are the same type humans are developing after long-term cell phone use. Due to these findings, several scientists have published that the weight of current peer-reviewed evidence supports the conclusion that radiofrequency radiation should be regarded as a human carcinogen.

Have you had too much to think?

John Waters on the Garda clowns who now monitor our free speech in case it might offend them

THE action or actions purportedly being brought against myself and Gemma O'Doherty will reflect some of the central considerations of the case we took against the lockdown in April 2020, in that among the objectives on that occasion was to demonstrate and dramatise the extent of the corruption of the Irish legal system, and the extent, arising therefrom, of the degeneration of its usefulness for defending truth, reason or justice.

The system failed that test abysmally, and all the way to the very top. One after another, judges stepped out to show their willingness to carry out the will of the overlords seeking to take down the world, to twist the language of the Irish Constitution until it screamed for mercy, and otherwise speak whatever gibberish was put in front of them. The outcome of that constitutional challenge - rejected, finally by the Supreme Court in July 2022, by six votes to one - ought have dismayed every citizen of this Republic to the point of despair, for it meant that the words of our Constitution no longer mean anything except whatever the puppet-masters pulling the strings of our judiciary decide, which is to say that the text of Bunreacht na hÉireann is no longer capable of being understood as meaningful by any literate person with a grasp of either Irish or English.

Similarly with the propositions explicit and implicit in the communications these journalists received from Detective Sergeant Don Griffin of Dun Laoghaire Garda station, which suggest that the meanings of certain words - and by no means just those in the Irish Constitution - have now become so loose and capricious that no reasonable person could be capable of relying upon them to retain their natural and ordinary meanings.

The word 'racism,' for example - which appears in Griffin's diatribe - has long been understood to refer to adverse or discriminatory treatment or speech concerning someone on account of his skin colour or ethnicity. By his redefinition, it appears to mean 'anything a "person of colour" or

alien ethnicity would prefer not to hear.' If this is to be the new definition of 'racism,' then the implications are momentous.

They include that, in future, it will be impossible for a native of Ireland to challenge anything stated or assumed, in any circumstances, by a person who is present in Ireland but not a native, especially if that person's skin is of a particular hue. To challenge any such assertion, however ostensibly presumptuous or unjust, will be, prima facie, 'racist.' To make a joke that leverages any aspect of the personality, background or appearance of a 'person of colour' will be to line up with murderers and paedophiles in the perp-walk of terminal disgrace.

To mouth an argument whatsoever in favour of a native person, against the claims of a non-native, will be among the worst crimes imaginable, deserving of a hefty fine or prison sentence. It goes without saying, by extension, that to utter a disparaging comment about such non-native person, to disagree with his assumptions, to question his demands in any way - all these responses would be 'racist,' and therefore criminal.

Establishing what the law is will become a matter of ideology rather than reason. Ideology is essentially unreasonable opinion, because it is opinion that results from indoctrination rather than adducible principles. In English defamation law, the definition of a 'reasonable' opinion was traditionally vested in 'the man on the Clapham omnibus,' a fabled character capable of arriving at good sense by a process rooted in his experience and capacity to think logically. Such qualities rapidly erode in a society that become excessively ideological, however, which means that, sooner or later, unless this process is arrested, the man on the Clapham omnibus - or the Dart to Greystones - will manifest one dark day as a Woke lunatic, and that will be the end of everything sensible and reasonable.

If you think these assertions to be exaggerations, you have not been paying attention. And all this is part of the intentionality of what Detective Sergeant Griffin is about. What he is essentially saying to Gemma O'Doherty and John Waters is: Stop describing reality and we will leave you alone.

A Movement to Stop the COVID-19 Pandemic

Coincidentally, I went to Dun Laoghaire station in 2015 - the same one which is currently trying to stamp out our free speech - and reported a series of threatening tweets on my safety by the LGBTP mob including one which read: "if you see John Waters, give him a punch from me."

I gathered all the evidence together and presented my complaint but was later visited by two detectives to say there was nothing they could do because the law had 'not yet caught up on that form of harassment.' Very convenient.

DURING the lockdowns of the scamdemic, the Gardai went full tyrant not only on the roads of Ireland but on their social media pages too, using all manner of foul language to bully the Irish people.

This is the Facebook account of one detective who took it upon himself to use obnoxious and threatening language in front of children and the public to dictate to people what their movements should be.

The Constitution clearly states that free expression should not be used to undermine mortality and that the publication of indecent material shall be punishable by law. But debased language is par for the course nowadays in the Gardai whose thuggish antics are witnessed on the streets of Ireland every day. It's no wonder the force is haemorrhaging members. As one resigning officer said in a recent survey about the force: "Leaving the Gardai was like walking away from an abusive relationship."

Gardai Framed Aaron Brady

FOR the last ten years, Aaron Brady and his family have endured a horrific nightmare at the hands of An Garda Siochana. It began in the hours after the murder of Detective Adrian Donohoe on January 25th 2013 at Lordship Credit Union on the Cooley Peninsula north of Dundalk in Co Louth.

A gang of five were lying in wait in what appeared to be a pre-arranged hit on Donohoe who was shot directly in the face. For some reason, the Cavan detective who was not scheduled to work that night was called in at the last minute to escort the Credit Union cash run with his colleague Detective Joe Ryan, who has since moved to France. It was Ryan who identified the killer's height at 6ft 1 to 2. Aaron Brady is only 5'7. That was just one of the many anomalies in a case that will in time be seen as one of the most grotesque miscarriages of justice in the history of the State.

In another bizarre twist, the raiders left the bulk of the cash behind taking just €7,000 but leaving €27,000 behind. Credit union witnesses also said they had Dublin accents, again ruling out Aaron Brady, who has an Armagh lilt.

The gang fled in the direction of the capital in a grey Passat after killing Donohoe, driving erratically. At least one witness we know of saw a similar Passat speeding the wrong way around a major roundabout at Ballymascanlan onto the motorway to Dublin in the minutes after the murder. This happened just minutes from the Credit Union. The killers were long gone by the time the Gardai arrived, who appear to have conveniently protected them by introducing another scenario involving a different car.

Before long, that critical evidence was airbrushed out of the investigation and another narrative was created involving a blue Passat that had been stolen three nights earlier down the coast of Louth in Clogherhead. The Gardai said this was the car involved in the murder, even though it was a different colour to the one described by witnesses, and that Aaron Brady had stolen it and driven it around for three days without removing the number plates. They claimed

the car was taken over the border after the murder and burnt out in a Protestant enclave of rural Armagh. Witnesses in the area contradict the Garda story completely.

At the time of the killing, around 9.30pm, Aaron Brady was about 30 minutes drive away in Cullaville, Co Armagh, laundering diesel in a friend's yard near his home. Later that night, he spent several hours in the nearby home of his then girlfriend and her family before travelling to Dundalk with his close friend James Flynn to stay in his family home for the night. Nobody who saw him that night said there was anything unusual about Aaron's demeanour.

James Flynn was recently acquitted of the robbery at Lordship Credit Union in the Special Criminal Court. Bizarrely, he was never charged with the murder even though the Gardai claimed he was present. CCTV evidence shows him in Northern Ireland at the time.

When Aaron and James arrived in Dundalk in the hours after the murder, there was a ring of steel around the area with Garda checkpoints on every route in and out of the town. If the two men had been involved in such a heinous crime, it's unlikely they would have driven back over the border into the South knowing Dundalk would be crawling with guards and that they would be stopped and asked about their movements.

They were, that night and the following morning after leaving James's family home near Lordship. Not wanting the Gardai

to know about his illegal diesel laundering activities, Aaron told the officers he had arrived at his girlfriend's home earlier than he had. He didn't think any more of it until he discovered that his girlfriend was being quizzed by the authorities about his movements, a situation he did not want to bring upon her.

Aaron made an appointment to see the lead detective in the Donohoe murder, Mark Phillips, in Dundalk Garda Station a few days later and told him where he had been on the night of the murder. He had hoped if there was any confusion, they could visit the site and acquire DNA or whatever may be necessary to vindicate him. But that never happened, and during the trial, Phillips said he forgot that Aaron's statement outlining his admissions had ever been made.

Because Aaron had told one minor lie about his whereabouts on the night, the Gardai believed they had grounds to prosecute him. No DNA. No fingerprints. No weapon. No phone evidence. No CCTV. And a solid alibi. But they went off on a wild goose chase and set about framing an innocent man.

Before long, the media were publishing pictures claiming that an IRA man was responsible using images of Aaron's face. Unlike the key witness for the prosecution, Daniel Cahill, who told preposterous lies under oath, Aaron has never had any connections with any paramilitary organisation. But that didn't stop the campaign of defamation that began against him and his family coordinated by

Mark Phillips and the Gardai.

By April 2013, the harassment had become so intense that Aaron decided to leave home for the US. He went to Boston and got a job in construction. Life was going well. He had an Irish girlfriend who would become his wife and they were expecting a baby when the rumours began again. He knew the Gardai were not going to give up.

Aaron was arrested for the murder of Adrian Donohoe in 2017. He was convicted in August 2020 after a farcical trial that broke numerous rules of evidence, due process and natural justice.

The corrupt trial judge Michael White allowed compromised witnesses against Aaron to give testimony by video link from their bedrooms in New York using Covid as an excuse. They did not even have to come and face the man they were accusing even though they were sending him to prison for life.

The only evidence against Aaron was circumstantial and came from two witnesses who said that Aaron had told him he had 'shot a cop'. This testimony was revealed in his recent appeal to be contaminated, untrue and coming from people who had clearly been blackmailed by the Gardai. As supporters of Aaron looked on in horror, the three judges of the Appeal Court - Tara Burns, Isobel Kennedy and John Edwards - watched a video of one of the witnesses, Irish-American Molly Staunton, being physically assaulted during her testimony and roared at by a man who was in the room with her to

'tell them what you're *ucking supposed to tell them.' He then slammed down her laptop down because she was unwilling to say that Aaron had told her he killed somebody because that was patently untrue.

The second witness Daniel Cahill, a well-known member of Coolock gangland who fled Dublin in 2013, made the same claim. It later became clear that he too was being coerced and had a lot to lose if he didn't go along with the Garda story. Cahill was illegal in the US, in possession of drugs, had been involved in a machete attack on a young man and had a personal vendetta against Aaron whom he knew through the local Irish pub scene in New York.

During the appeal, Aaron's defence barrister Michael O'Higgins played a tape of a US immigration agent unashamedly coercing James Flynn to put Aaron in the frame. This damning piece of evidence proving that the Gardai with Homeland Security were offering inducements to witnesses was withheld from the jury during the initial 2020 trial.

Gardai have plenty of form when it comes to coercing witnesses. The DPP report on the framing of Ian Bailey found that they had offered drug addicts in West Cork cash and hash in exchange for lies about the English journalist who had exposed their corruption in the murder investigation of Sophie Du Plantier.

To date, Aaron has spent six years in prison. His little boy is now seven and has lived almost all of his life without his father's company. He goes to see him in Portlaoise as often as possible and the pair have a unique and close bond. No date has been given as to when the judges of the Appeal Court will give their decision. It's hard to believe they could hold Aaron another day after the week-long appeal given the horrific evidence of Garda criminality that emerged during it. Foreign wars are designed to distract us from the real battle in our midst

“We need a new approach to digital identity”, say the authors of an “Agenda Article” for the World Economic Forum, published on September 28, 2023.

Digital ID has been in the news a lot lately, obscured for a time in the midst of the Israel-Hamas situation.

Last month the United Nations Development Programme published its legal guidelines for digital IDs as well as “mobilizing” global leadership with a \$400m fund to “empower” digital identity programmes in over 100 countries.

Various nations are already making steps in that direction. Multiple US states are either already issuing digital IDs or planning to in the near future, as are Kenya, Somalia, Bhutan and Singapore. Austria’s system is going online in December.

Just last week, Forbes Australia published its guide to what “Australians need to know” about digital IDs, and 9News reported that they could be in place as soon as next year.

Just two days ago, the Journal of Australian Law Society predicted the same thing.

Meanwhile, also in Australia, the world’s 21st largest bank is changing its terms and conditions to allow it to “de-bank” customers.

The National Australian Bank’s “revised” terms and conditions were due to go into force on November 1 and include, in clause 11: “NAB may close your account at any time at its discretion.”

The reasons NAB would consider enforcing clause 11 make for interesting reading.

NAB can take a range of things into account when exercising its rights and discretions. These can include:

* NAB’s public statements, including those relating to protecting vulnerable persons, the environment or sustainability;

* community expectations and any impact on NAB’s reputation;

So - as of November 1 - NAB reserves the right to de-bank you if you get cancelled, or say something they don’t approve of about climate change or “vulnerable people”.

In the UK, just two days ago, it was reported the government is planning to upload every passport photo in their records to a facial recognition database.

Big Brother Watch reports: “At the same time, despite ‘record profits’ for energy

companies last winter, the UK government reports they may need to further increase energy bills to ‘prevent energy companies going bust’.”

And Japan has announced it would be trading carbon credits on its stock exchange, and some Japanese firms are introducing a digital currency specifically for the settlement of “clean energy certificates”.

Meanwhile, India has revealed the launch of trial wholesale digital currency, and the South China Morning Post reported a new “hard-wallet” for SIM-based CBDC payments, a joint project between the Bank of China and Chinese telecommunications giants.

Back to Australia, where it was reported on October 12 that Mastercard and the Reserve

Bank of Australia had “successfully trialled” the interoperability of CBDC systems, whilst ensuring that “the pilot CBDC can be held, used, and redeemed only by authorised parties”.

Mastercard’s report also notes that the benefits of CBDCs are “programmability, transparency, and compliance”.

Oh, and a new study says eating bugs is good for your metabolism.

WHO wants to rule the world

Forced injections, vaccine passports and lockdowns on a permanent basis

THROUGH a series of 307 amendments and a global pandemic treaty, the World Health Organisation is seeking to gain authority over international health decisions of all nations.

These powers would be triggered in the event of another covid-like 'pandemic'.

The WHO would be empowered to tell countries to lock down and close businesses, schools, pubs and churches.

We would be forced to take an injection, whether we want to or not. We would be forced to mask. We would be forced to do whatever it is that they tell us that we have to do.

We have never before seen this level of authority given to an international, unelected body.

Those supporting this authority for the WHO say that it is necessary to protect the world's population, even if it means restricting some of our liberties.

Dr Abdullah Assiri, who co-chairs the Working Group on International Health Regulations (IHR), said: "The world requires a different level of legal mandates, such as the pandemic treaty, to navigate through a particular pandemic, should one occur, and it will.

"Prioritising actions that may restrict individual liberties, mandating and sharing of information, knowledge and resources - pandemic control efforts are all necessary during a pandemic."

Dechen Wangmo, Bhutan's Health Minister agreed: "Let us seize this opportunity to



foster international collaboration, ensure global health security and protect the lives and the well-being of all people beyond boundaries."

And top backers of this United Nations move say speed is of the essence.

U.S. Secretary of Health and Human Services, Xavier Becerra, conveyed the urgency: "I wish to stress from our perspective, the quicker we can come together, the sooner we will all be safe.

"We know that the challenges we face won't be solved by a few leaders or a few countries, but by the world coming together and fighting for what's right."

In the UK, a handful of MPs including Andrew Bridgen, Esther McVey and Sir Christopher Chope have voiced opposition to such undemocratic moves.

But the UN is being underhand by not calling this a treaty, which would require Parliamentary scrutiny, but an 'accord' - so there is no debate about the fact that an unaccountable supra-governmental organisation will be able to order businesses shut and people injected with dangerous products against their will.

This would form a serious constitutional crisis on the nature of people's freedom.

Supporters of the WHO and this planned

'accord' say critics worry too much, and that nations won't really lose sovereignty. It remains to be seen just how powerful the WHO, which started as an advisory body, would become, if these new emergency powers are granted.

Further, the Working Group for amendments (WGIHR) has announced it will not be able to meet the deadline to submit its final draft by January 2024.

Instead of doing the honourable thing by admitting its failure and postponing the consideration of the amendments until the 78th World Health Assembly in 2025, it is plotting to violate the deadline imposed upon its actions by Article 55 of the IHR.

This Article states it must submit a 'package of targeted amendments' at least four months in advance of the 77th World Health Assembly, which is scheduled to be held between May 27 - June 1, 2024.

This means the WGIHR is legally required to submit its final negotiated agreement by the week of January 22-26, 2024, otherwise it will need to wait until 2025.

The four-month period for review of the amendments is mandatory - the language of Article 55 is very clear - but the WGIHR is planning to dishonour itself by ignoring its own legal obligations.

How The Jews Conquered Ireland

“Five Jews came from over sea with gifts to Tairdelbach [King of Munster], and they were sent back again over sea.”

Annals of Inisfallen, 1079 A.D.

“I propose an interrogation of how the Irish nation can become other than white (Christian and settled), by privileging the voices of the racialised, and subverting state immigration, but also integration, policies.”

From racial state to racist state: Ireland on the eve of the citizenship referendum, 2007.

TAIRDELBACH of Munster (Turlough O’Brien 1009 - 86), who was by 1079 effectively the High King of Ireland, probably holds the world record for the fastest expulsion of Jews. He dominated the Irish political scene, had crushed the Viking leadership of Dublin, and possessed ‘the standard of the King of the Saxons.’ Unfortunately, we can only surmise the nuances of the 70-year-old warlord’s reaction to the sudden arrival of a handful of gift-bearing Jews, because the Annals of Inisfallen are thin on detail.

The delegation almost certainly originated in Normandy, where Jews thrived under a symbiotic financial relationship with William the Conqueror. William, of course, had introduced Jews to Anglo-Saxon England thirteen years before the approach to Tairdelbach, leaving open the possibility they could have travelled directly to Ireland from one of these new Jewish enclaves in England. In any event, it is almost certain that they arrived seeking permission to settle in Ireland’s urban centres, forge a relationship with the Irish elite (Tairdelbach himself), and engage in exploitative money-lending among the lower social orders. This was a pattern that had hitherto been witnessed throughout Europe. And yet Tairdelbach’s reaction was to reject the gifts and immediately expel the Jews. They would not be able to form a community in Ireland for several centuries.



It’s probably no coincidence that Tairdelbach was regarded in his lifetime as a good and Christian king. He enjoyed close relationships with the Irish church and was patron to a number of religious figures and scholars. He was almost certainly a literate and educated man, and his decision to expel the Jewish delegation may have been based on a body of knowledge rather than mere instinct.

Historians Aidan Beatty and Dan O’Brien in their book ‘Irish Questions and Jewish Questions’ comment on the expulsion: No-one in Ireland had ever seen a Jewish person prior to this incident, yet the visitors are unambiguously described as “five Jews” (coicer Iudaide) and the Irish people already have a word for Jews, Iudaide, a medieval Gaelic

word that clearly has its roots in the languages of classical antiquity. But more than that paradox, there is also a certain kind of cultural knowledge at work here. The medieval Irish who gave such short shrift to these Jewish guests “know” something about Jews, or more accurately they think some things about Jews: they “know” that Jews are not trustworthy, that Jews bearing gifts are not to be taken into one’s care.

And Jews are not suitable for residence in Ireland – they should be expelled from the country. The impression is therefore that Tairdelbach was a savvy and selfless leader, who sought the good of his people more than the good of his own short-term financial situation.

Jewish revenge, direct or

indirect, occurred a century later, when the glory days of the Gaelic High Kings like Tairdelbach came to an end thanks to the Norman invasion of Ireland by Richard “Strongbow” de Clare. In common with the Norman invasion of England, Strongbow was financed by Jews, in this case an England-based Jewish financier named Josce of Gloucester. After the Norman invasion, the new Norman elite brought a small number of their Jews into Ireland, primarily for financial activities at ports rather than large-scale settlement. A grant dated 28 July 1232 by King Henry III to Peter de Rivel gave him the office of Treasurer and Chancellor of the Irish Exchequer, the king’s ports and coast, and also “the custody of the King’s Judaism in Ireland.” These few nameless Jews would

have been dispensed with after the expulsion from England in 1290, and Jews were absent from Ireland until the time of Cromwell, who also holds a special place of notoriety in Irish history.

By following in the wake of the Normans and the English, the Jews have certainly placed themselves on a dubious historical trajectory in relation to the Irish. But perhaps nothing seen in the past compares with what is seen in the present. Because it is globalism that has now invaded Ireland, and Jewish activists are shaping the thought and policies of the new global-imperial culture.

Mass Migration and Indoctrination

Between 2002 and 2016, the proportion of the Irish population born abroad rose from 5.8% to more than 17%. Given the relatively small population of Ireland, if the current pace of immigration persists, the Irish stand to be overwhelmed in their ancient homeland in the coming years. The biggest increases have come in the form of growing numbers of Pakistanis, Eastern Europeans, Romanian gypsies, Afghans (an increase of 212% on the previous census), and Syrians (an increase of 199%).

Ireland has also become home to a large and rapidly growing African population, which has been mired in “exceptionally high unemployment rates, gang violence, sexual assault and petty crime. African and Muslim cab drivers have also been behind a large and growing number of rapes and sexual assaults. In financial terms, the expanding asylum process is costing the Irish government more than €1 billion every five years, and in the midst of an Irish housing crisis, immigration is putting immense pressure on every aspect of the nation’s infrastructure.

Strangely, the Irish media hasn’t been making much of this aspect of Ireland’s changing complexion. Instead, much discussion has taken place on the fact that Ireland has no real “hate crime” laws with the exception of the Prohibition of Incitement to Hatred Act 1989, which has managed to achieve a grand total of five criminal convictions in the last 30 years. Dr Ali Selim, of the Islamic Cultural Centre in Dublin, has said “there is a desperate need for hate crime legislation.

But, despite the interventions of Dr Selim, the origins of Irish conceptions of “racism” and “hate speech” don’t lie among the growing Muslim population, but among a very small number of influential Jews.

In 1969, some 890 years after Tairdelbach expelled the Norman-Jewish delegation, a young Jewish sociologist arrived in Ireland from Israel. Ronit Lentin was Associate Professor of Sociology in Trinity College Dublin until her retirement in 2014. From 1997 until 2012, Lentin was Head of Sociology, and acted as director of the MPhil program in “Race, Ethnicity, Conflict.” She was also the founder of the Trinity Immigration Initiative from which she advocated an open-door immigration policy for Ireland and opposed all deportations, as well as engaging in activism to liberalise Irish abortion laws. As an academic and “anti-racist” activist, Lentin formulated what would become some of the cardinal facets of Irish self-recrimination on matters of race, beginning with her definition of Ireland as “a biopolitical racist state.” By her own account, before she began her work on stoking Irish race guilt in the early 1990s, “most people were not conscious that Irish racism existed.”

In some senses, Lentin introduced the concept of an Irish racism. Her first step in assuring the Irish that they were indeed racist was to deny their existence as a people. She asserted that the Irish were merely “theorised as homogeneous - white, Christian and settled.”

Quite who had developed this theory of the Irish, and when, was never specified by Lentin, nor did she attempt to show that the white, Christian, and settled status of the vast majority of the Irish population was anything other than a matter of fact and reality. It appears to have sufficed for Lentin simply to assert that Irishness was nothing but a theory, and to leave it at that. She was particularly aggrieved by the fact the Irish, apparently unaware they were a figment of their own imagination, voted (80%) to link citizenship and blood (ending “birth-right citizenship) by constitutionally differentiating between citizen and non-citizen in a June 2004 Citizenship Referendum.

This move was taken primarily in order to stop African “birth tourism” and “anchor babies” by African women, which had become increasingly common by the early 2000s. To Lentin, however, the move was symbolic of the fact “the Irish Republic had consciously and

democratically become a racist state.”

She concludes that any idea of the Irish as historical victims should be dispensed with, and that “Ireland’s new position as heading the Globalisation Index, its status symbol as the locus of “cool” culture, and its privileged position within an ever-expanding European Community calls for re-theorising Irishness as white supremacy.”

So, in Lentin’s worldview, Irishness is not only a fiction, but a racist, white supremacist fiction. Lentin’s advice to the Irish, should they wish to rid themselves of the delusion of peoplehood, is to engage in mass celebrations of “diversity and integration and multiracialism and multiculturalism and interculturalism.”

If Ronit Lentin’s activism can be regarded as cultural sabotage, then that of her Jewish colleague Alan Shatter could be regarded as nothing less than legislative warfare. His impact on Ireland is difficult to exaggerate. His first targets in government were the weakening of legislative controls that helped maintain stability in the family (via the Judicial Separation and Family Law Reform Act 1989), and the gradual erosion of highly conservative Irish laws on contraception (by writing the 1979 satirical tract *Family Planning - Irish Style*, featuring mocking illustrations designed by co-ethnic artist Chaim Factor). He has also been a strident pro-abortion activist since at least 1983, and a very early proponent of homosexual marriage and the adoption of children by homosexuals (he was essentially the author of both bills). Shatter was also central to the founding of the Oireachtas (Parliamentary) Committee on Foreign Affairs, something he then used as a vehicle to pursue Zionist-friendly objectives.

But it was in his efforts in the field of immigration that Shatter demonstrated real revolutionary zeal. Between 2011 and 2014, he utterly transformed the Irish citizenship process, personally granting Irish citizenship to 69,000 foreign nationals. In August 2013 he took steps to expand the Irish asylum process, citing the Syrian Civil War as the reason but later conceding that the highest number of asylum applications was actually coming from Nigerians and Pakistanis. In fact, Shatter was so keen to boost the number of Africans entering Ireland that the rejection rate for African asylum applications dropped from 47% to 3% as soon as he took office.

Many of these asylum seekers, primarily Nigerians, have gone on

to terrorise and assault their hosts, while others have been noted as publicly masturbating in their cabs during rush hour while they wait for customers. In 2013, Shatter proposed a new bill that would grant an amnesty to the thousands of illegal immigrants accumulating in Ireland.

When he was forced to resign in May 2014, it was the incomplete state of his immigration reforms that he told the press was one of his biggest regrets. Although Shatter was forced into early

retirement, much damage had already been done, and his legacy continues. Lentin and Shatter may claim to love Ireland but not the Ireland that was, and has been for millennia, but the Ireland that “is becoming” and is “to be” - the Ireland overwhelmed by globalism, with an international population devoid of the “white supremacy” of Irishness. Perhaps they love the Ireland of gay pride parades, the arid metallic stench of the abortion mills. Perhaps they love the Ireland touched by Nigeria, the one

sprinkled with mosques, and where young Irish homeless mothers hang themselves in despair while asylum seekers are housed and fed mere yards away. Perhaps they do indeed feel some kind of love, and they see what they’ve done, and are doing, as the bringing of gifts to Ireland. But Tairdelbach’s lesson of a thousand years ago is more important than ever: it’s time to give them back.

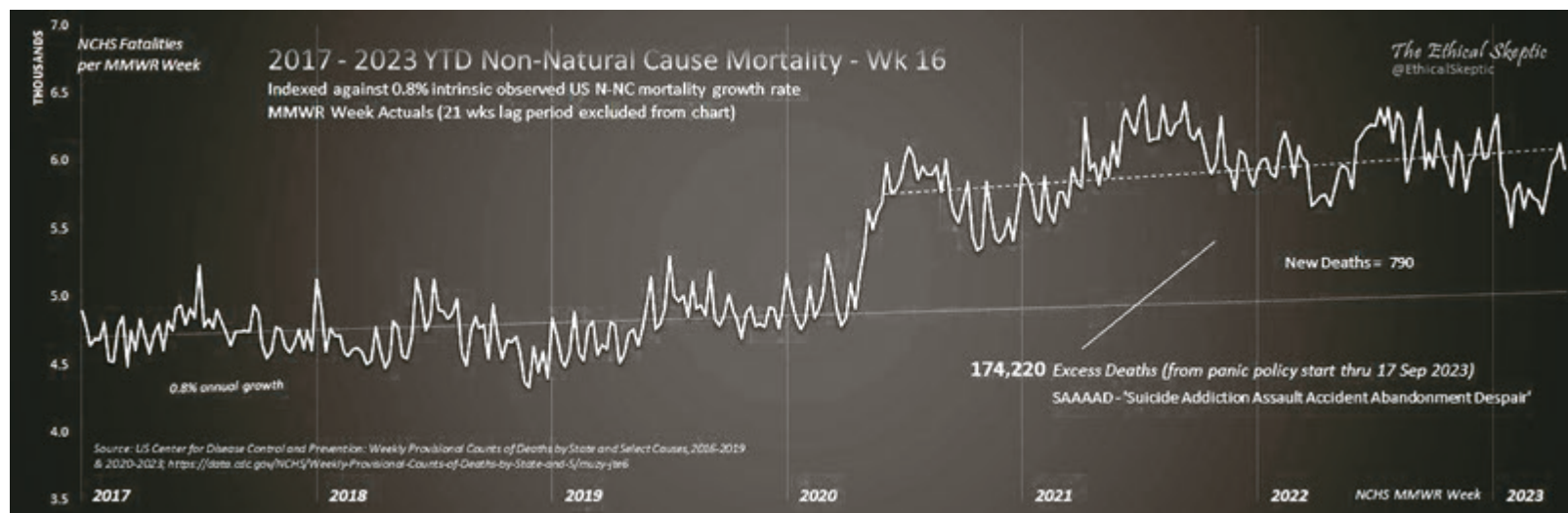
We are currently witnessing an excess in mortality in those countries where the majority of the population has received the so-called “Covid-19 vaccines”. To date, this excess mortality has neither been sufficiently investigated nor studied by national and international health institutions.

The large number of sudden deaths in previously healthy young people who were inoculated with these “vaccines”, is particularly worrying, as is the high incidence of miscarriages and perinatal deaths which have not been investigated.

A large number of adverse side effects, including hospitalisations, permanent disabilities and deaths related to the so-called “Covid-19 vaccines”, have been reported officially.

The registered number has no precedent in world vaccination history.

We know that these numbers just about represent between 1% and 10% of all real events.

Therefore, we consider that we are facing a serious international medical crisis, which must be accepted and treated as critical by all states, health institutions and medical personnel worldwide.

Therefore, the following measures must be undertaken on an urgent basis:

1. A worldwide stop to the national inoculation campaigns with the products known as “Covid-19 vaccines”.
2. Investigation into all sudden deaths of people who were healthy prior to the inoculation.

5. Undertaking analyses of

the composition of vials of Pfizer, Moderna, AstraZeneca, Janssen, Sinovac, Sputnik V and any other products known as “Covid-19 vaccines”, by independent research groups with no affiliation to pharmaceutical companies, nor any conflict of interest.

6. Studies to be conducted on the interactions between the different components of the so-called “Covid-19 vaccines” and their molecular, cellular and biological effects.
7. Implementation of psychological help and compensation programmes for any person that has developed a disease or disability as a consequence of the so-called “Covid-19 vaccines”.
8. Implementation and promotion of help and compensation programmes for the family members of any person who died as a result of having been inoculated with the product known as “Covid-19 vaccines”.

How Kojak would crack Covid

The history of 'pandemics' reveals inconvenient facts

IF the cold case of prior pandemics landed on the desk of a detective like Kojak, he would first review all the evidence collected at the time.

He would instruct forensic teams to look at autopsy and toxicology reports and, if necessary, exhume bodies. He would also look at aerial photography, cell tower data, paramedic reports and profiling analysis.

And he would bring in experts that could shed light on alternative theories as to what caused such apparent sickness that spread so rapidly. He would identify any suppressed or missing evidence. Was it missing for a reason? Was there a conflict of interest?

Were those who gained compromised, bribed, threatened or were they instigators of the events?

If a pathogen is spread from person to person, there must be a patient zero who then passes their illness onto ten other people and so on. But how did patient zero become ill? Not from another person, otherwise they wouldn't be patient zero.

Patient zero could have become ill from stress, or through exposure to multiple sources of toxins, whether in the air, water or food. Likewise, so could everybody else become ill from those same toxins. The person-to-person contagion theory has survived because it doesn't seem counter-intuitive to surmise that people getting sick or showing similar symptoms of an apparent illness, in the same geographical location, caught it from each other.

But they are also drinking from the same water supply, breathing the same air, predominantly using the same food sources and are exposed to the same geographical toxins of industry and common geographical stressors.

Looking at the most recent "pandemic", a detective might wonder why apparent deaths from a pathogen were considered contagious or infectious, when 'Covid' could have been administered (unwittingly or otherwise) via water, food, injection or a swab and where the death could or should have been attributed to other factors.

Then there are the changing parameters of manipulative measurement. During the alleged pandemic, the World Health Organisation added new Covid codes in 2021 including U07.2 - for 'virus not

identified' and estimated to account for 8.4% of 'cases'.

Case data was also unreliable due to the low-threshold definition and the repurposed PCR test whose measurement of 'Covid' could be manipulated by the value of the Cycle Threshold (CT). Worse still, Governments had no knowledge of the CT levels used at any given time, as they outsourced the PCR tests to companies, many of which didn't provide the changing value of CT levels with the PCR results.

President of Tanzania John Magufuli submitted several 'Covid' samples to the World Health Organisation for PCR testing, each given a fake human name to hide its true origin. Car oil tested negative for Covid, jackfruit was inconclusive, a bird and a goat tested positive, as did a pawpaw.

Re-examining older cold case files such as the Russian flu of 1889, a good detective would note that the alleged pandemic, which killed a million

people, had mainly an urban impact, was borne by the European railroads and that contagion in cattle was due to the concerted expansion of the live cattle trade facilitated by the railways. Why settle so readily on a pandemic of contagion when there were alternate parallel factors that might affect human health, such as the electrification of the world - predominantly via towns and railroads?

Arthur Firstenberg's *The Hidden Rainbow* trawls forensically through decades of electrification of Earth and the impact of such electrification on the human condition. The so-called Russian flu of 1889 coincided with the mass rollout of electric railways and electric lighting. The Spanish flu of 1918 coincided with the implementation of radio waves; the Asian flu of 1957 with the first low altitude satellite which sent radio signals back to earth, the Hong Kong flu of 1968 with radiation radar satellites fired up into the Van Allen Radiation Belt, and covid in

2019 with the rollout of 5G.

The Diamond Princess, a ship whose passengers were allegedly hit by 'Covid-19' early on, was not only fitted out with 5G, it was docked at Yokohama where FamilyMart Co. and the Panasonic Corporation had joined forces in April 2019 to launch 'the next generation of convenience store' utilising Internet of Things Technology. Panasonic Connect Co. Ltd was also working on the world's first Beyond 5G technologies for automated driving, which launched in Yokohama in 2022.

On November 11, 2019, Elon Musk's Starlink company launched the first 60 low-Earth satellites to provide high-speed internet to every corner of the Earth. Six days later, the first case of Covid was reported in Wuhan, China.

While there was electrification of the railways in 1980/81 at the start of the AIDS pandemic the consensus was that AIDS was the result of a single green monkey. Newspapers of the time depicted emaciated young men covered in cancerous lesions and Africans dying in their thousands, while a TV commercial had the word AIDS being hammered into a gravestone as a doom-laden voice warned: "Don't die of ignorance." Initially labelled GRID or Gay Related Immune Deficiency, the 'gay plague' soon became known as AIDS or Acquired Immune Deficiency Syndrome when it became clear that the greater the number who believed they could be infected, the larger the investment in looking for a cure.

A detective would begin to see a pattern. As with AIDS, the Covid-era newspapers depicted patients struggling and dying in their thousands. A TV commercial showed masked doctors, nurses and patients staring plaintively into the lens as a doom-laden voice pleads: "Look them in the eye and tell them you're doing all you can." The UK health secretary at the time texted: 'We frighten the pants off everyone.'

What is incontestable is that each 'pandemic' led to the development of new drugs and vaccines, that the drugs and vaccines were part-funded by the taxpayer, that drugs and vaccines make millions not for the taxpayer but for their suppliers and distributors, and that there is no incontrovertible proof that such treatments did more good than harm.

The Truth About Gript

John Waters on establishment stooge John McGuirk whose media platform Gript is just another showcase for government agendas

OF all the long parade of disappointments in the firmament of Irish conservatism, perhaps the most tragic is the case of Gript.ie, which had several excellent journalists and yet has failed miserably to gain traction with the public imagination as a genuinely alternative and independent platform.

The reason for this is not difficult to discern: Its editor, John McGuirk, is a wanna-be establishment groupie who, for that reason makes a less than credible kingpin for a platform that launched four years ago promising to showcase and support 'views which challenge establishment thinking.'

Anyone who doubts this should recall that, on count day following the 2020 general election, McGuirk was employing his Twitter feed to tweet 'congratulations!' to government figures who had scraped back into office. Within a month, these dark creatures were congealing into the most tyrannical government in the history of the State, and Gript.ie was unfortunately unable to challenge them, on account of the cravenness of its fanboy Editor.

What followed was therefore not especially surprising. For three years, Gript under McGuirk was as though the voice of governmental overreach, talking up Covid as a life-threatening disease, justifying lockdowns, defending vaccines long after they were exposed as deadly poisons, and attacking those who sought to advance different accounts of what was happening. Last month, after countless avoidable deaths, McGuirk and Gript finally became converts to the truth. After ridiculing 'anti-vaxxers' for two and a half years, John McGuirk suddenly caught sight of the lights of the oncoming train heading down the tunnel towards him and started tweeting that 'the global scientific community may come to regret the massive amount of its credibility it invested in selling Covid vaccines to the public.'



Well, so might those who placed their trust in Gript, who followed McGuirk's advice and example in taking not one but three shots, and telling people in November 2021: 'I'm not a vaccine sceptic at all, by the way. I took mine am glad I did, and if you want my advice, I think you should take it if offered.' A month later he was declaring, 'I've taken three vaccine doses. I will not take a fourth.'

This is not a cause for gloating. It is a real tragedy for Ireland and Irish people. In the wake of the 2018 referendum, there was a generalised awareness that a new voice was required in Irish society to speak for the silent majority who were being bullied and browbeaten into a new dispensation of dystopian degeneracy masquerading as progressivism. Ireland, it was widely agreed, needed a strong

independent, conservative, traditionalist platform from which to begin a fight-back. Gript fell at the first fence, because of the poor choice made as to editor.

And McGuirk's failures were not merely ones of incompetence or lack of ability - those can be taken for granted. There was also his malevolence, directed at anyone who questioned him, his arrogant pronouncements, business dealings, hypocrisy or establishmentarianism. In July 2022, when the constitutional action against the lockdowns taken by Gemma O'Doherty and myself was finally knocked back by the Supreme Court, McGuirk rang me ostensibly seeking a comment, and left a gloating message on my message minder. Mr McGuirk had a 'scoop' - a first. He had gleaned from the Supreme Court Ruling that

Gemma and I had been offered pro bono legal representation by the court, but had turned this down. He wanted to know if I had any comment on this. I had, but not for the benefit of one of the most repellent creeps ever to decorate the Irish media scene.

This 'scoop' was first ventilated publicly in November of 2021, at the time the Supreme Court agreed to accept our appeal.

The offer was not, as McGuirk's message implied, that the court would pay for our legal representation but that it would choose our legal representatives and have the State - our adversaries in this case - pay for them. This, for obvious reasons, was unacceptable to us, and we made this clear to the court, and publicly, at the time. Our reasoning related to the fact that it is generally preferable in

court proceedings if your lawyers are actually on your side, a factor that could not be guaranteed in a situation where we would have no say over who was selected to represent us, or what their view of the 'pandemic' or lockdowns might be.

Later that day, McGuirk, the purportedly 'objective' editor of an 'alternative' platform, tweeted his view, based on his utter misunderstanding of what had occurred, that our case had been nothing more than 'a campaign for martyrdom.' In other words, Gemma and I had been seeking personal financial ruin so as to gain sympathy from some unspecified quarter. Here, in a nutshell, we perceive why Gript has had virtually zero impact on the media scene.

Over the course of our legal challenge, since April 2020,

McGuirk had used Gript to conduct a sustained campaign of misinformation and mockery against us, but - much worse - had refused to tell Gript's readers anything of the content of our case. Instead, he latched on to anything he could find to attack and denigrate us.

This malevolence had a history going back to the 2020 general election, after which I called him out to other senior Gript management for the dishonesty of his attacks on Gemma O'Doherty, which in my experience of the matter were based on the fact that Gemma had been an assiduous critic of 5G technology, in which McGuirk has a secret interest through his friend Declan Ganley, and a company called Rivada Networks, that had not, at that time, been revealed to the gullible readers of Gript.

My interest in this matter was at the time deeply personal, because it had been agreed with other members of the Gript management that I would join Gript's team of journalists. At that time also, I raised an eyebrow about the fact that McGuirk had, a short time earlier, published a disparaging article on the website about the 'far right' - directed chiefly at Gemma O'Doherty and the Justin Barrett,



then leader of the National Party - written by McGuirk himself, which was of a tone such as one might have expected to find in the

Irish Times or Independent. The members of the Gript management with whom I had been communicating were good people

and conscientious journalists (one of them has since departed the website) but the answer I received was deeply evasive and

unsatisfactory. In my view, either under McGuirk's directions, or nervous of his wrath, they responded to me with a fatuous denial to the effect that Gript had 'never published an article on 5G', which I immediately debunked.

In his attack on the "far right" McGuirk had complained, inter alia, that 'by and large they loathe people like yours truly, who, they say, have done a terrible job advancing conservative causes in Ireland over the past two decades.'

Well, they were right about that anyway! John McGuirk has been, and continues to be, a dismal representative of 'conservative causes.' He is responsible for massive levels of disappointment, division, demoralisation and despair among people who were counting on Gript to make a real difference in Ireland. What it means, in the final analysis, is that Ireland has lost what could have been a decent general platform for alternative, traditional or conservative views. What is refreshing is that many who are awake to the wider agendas are also now awake to McGuirk and Gript and realise they are nothing more than another wing of the controlled mainstream media.

You can't be pro-Aontu and pro-life

ONE of the most disturbing aspects of the scandemic was the manner in which many Catholics obeyed the child-killing corrupt government and rolled up their sleeves to get vaccinated.

Discernment and general lack of trust in government are supposed to be Catholic traits as well as being defiant in the name of the truth. But sadly, many masked up and shut up for the duration, leaving it to the usual handful to take a stand and demand the reopening of Churches and an end to masks. At one stage, his office in Trim even organised buses and lifts to the vaccine centres. Could he have tried any harder to get the poison into people's arms? And yet the pro-life movement every year rallies around him and McGuirk on their token Pro-Life vigil. A very worthy cause but such double standards apply when people know both Gript and Aontu promoted a drug which has killed thousands and is contaminated with aborted products.

Why I went back to the Faith

The story of a young man finding his way back to the true Faith in Ireland, once so Catholic, but today deep in apostasy

GROWING up in the late 1990s and early 2000s in Ireland, things were rapidly changing for the worse. The deconstruction of Ireland's past was already set in motion. As was common for most young men of my age, I was baptised and sent to the local "Catholic" school. But there was never any catechesis, or teaching on the Faith, which is why if you were to ask most children in Ireland who have gone to a "Catholic" school about even the most basic tenets of the Faith, they would not be able to answer.

My return to the Faith has been of an unconventional type. I have always had a hunger for knowledge and I devoured books as a child, but without the proper guidance from authority figures, I was easily led astray by my fallen nature.

In my late teenage years, I read many different types of philosophy, with phases of Marx, Nietzsche, and Camus among others. Somehow, I came across the writings of the old-fashioned Italian philosopher Julius Evola, whose utter hatred and contempt for the modern world struck a chord with me. He never used the word God, as he himself was not Catholic, but he substituted the term with either the 'Absolute' or the 'Transcendent'. However, around the same time as I began to read Evola, I began also looking into Catholicism, more for political than for any spiritual reasons.

The problem arose when I looked at the Church today and compared it with the radical 'Traditionalism' that I was learning from Evola.

I knew some of the issues surrounding Vatican II and was familiar with the SSPX by name, but I knew little about going to Mass or doctrines of the Faith. I read up on how Catholics pray, and I came across the Rosary. I did not understand why Catholics prayed so much to Mary instead of to God, but I was willing to see what all the fuss was about, so I began to say the Rosary. My reversion to the Faith was all happening during the Covid "pandemic", when the



Catholic churches in Ireland were shut for the longest continuous stretch in Europe. I had nowhere to go and could not have availed myself of Communion even if I had wanted to. Thankfully, I had been talking to some Catholics online and one informed me of a priest who was meeting with people to give Confession. I immediately contacted this priest, and my Confession took place in a cemetery. By going to Confession and trying to come back to the Faith, my old atheistic self was in a sense dying, and I was being reborn in the Faith.

Something I have noticed in the Latin Mass communities in Dublin is that the majority of men attending are reverts to the faith, while the women tend to be cradle Catholics. Many of the young men who would describe themselves as traditional Catholics are aware of the 'Jewish Question', but are unsure of what they can do to combat the efforts of the Synagogue of Satan.

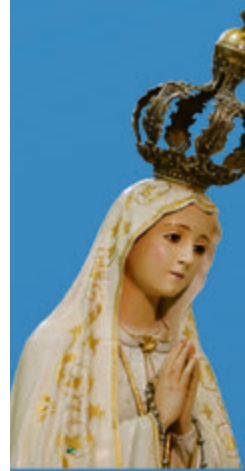
What can we do aside from prayer to actively combat the enemies of the Church?

Papacy of shame

THE proliferation of declarations and behaviours completely foreign to what is expected of a Pope – and indeed in contrast with the Faith and Morality of which the Papacy is the guardian – has led many of the faithful and an increasingly large number of Bishops to take note of something that until some time ago seemed unheard of: the Throne of Peter is occupied by a person who abuses his power, using it for the opposite purpose to that for which Our Lord instituted it.



Some say that Jorge Mario Bergoglio is manifestly heretical in doctrinal questions, others that he is tyrannical in matters of government, still others consider his election invalid because of the multiple anomalies of the resignation of Benedict XVI and the election of the one who took his place.

These opinions – more or less supported by evidence or the result of speculations that cannot always be shared – nevertheless confirm a reality that is now incontestable. And it is this reality, in my opinion, that constitutes a common starting point in trying to remedy the disconcerting, scandalous presence of a Pope who presents himself with ostentatious arrogance as inimicus Ecclesiae, and who acts and speaks as such.

An enemy who, precisely because he occupies the Throne of Peter and abuses papal authority, is capable of inflicting a terrible and disastrous blow, such as no external enemy in the entire history of the Church has ever been able to cause. The worst persecutors of Christians, the fiercest adherents of the Masonic Lodges, and the most unrestrained here siarchs have never before succeeded, in such a short time and with such effectiveness, in devastating the Lord's vineyard, scandalizing the faithful, disgusting the Ministers, discrediting its authority and authoritativeness before the world, and demolishing the Magisterium, Faith, Morals, Liturgy, and discipline.

Inimicus Ecclesiae (hostile to

the Church), not only with respect to the members of the Mystical Body – which he despises, ridicules (he never ceases to launch poisonous epithets against it), persecutes, and strikes; but also with respect to the Head of the Mystical Body, Jesus Christ: whose authority is exercised by Bergoglio no longer in a vicarious way, which would therefore be in necessary and dutiful consistency with the Depositum Fidei, but rather in a self-referential and thus tyrannical way.

The authority of the Roman Pontiff is in fact derived from the Supreme Authority of Christ, in which it participates, always within the boundaries and scope of the goals which the Divine Founder has established once and for all, and which no human power can change.

The evidence of Bergoglio's alienity to the office he holds is certainly a painful and very serious fact; but becoming aware of this reality is the indispensable premise for remedying an unsustainable and disastrous situation.

AGERE SEQUITUR ESSE

(ACTION FOLLOWS BEING)

In these ten years of his "pontificate" we have seen Bergoglio do everything that would never be expected of a Pope, and vice-versa everything that an apostate would do. There have been occasions when these actions have appeared manifestly provocative, as if by his utterances or certain acts of government he

deliberately wanted to arouse the indignation of the ecclesial body and urge priests and faithful to react by giving them the pretext to declare them schismatic. But this typical strategy of the worst Jesuitism is now uncovered, because the whole operation has been conducted with too much arrogance and in areas on which not even moderate Catholics are willing to compromise.

The sexual scandals of the clergy, and in particular the response of the Holy See to the scourge of moral corruption of Cardinals and Bishops, have shown a shameful disparity of treatment between those who belong to Bergoglio's so-called "magic circle" and those he considers adversaries.

The recent case of Marko Rupnik is evidence of one who exercises power like a despot, legibus solutus, who considers himself free to act without being accountable for any of his actions. It often happens that the consequences of the decisions taken personally by the Argentine are then passed on to his subordinates, who find themselves accused and discredited for choices which are not theirs.

I think of the case of the London building in which officials of the Secretariat of State were involved, while the contract of sale bears the august chirograph.

I think of the shameful handling of the Rupnik case, which in addition to having rehabilitated a criminal responsible for

horrendous crimes, in contempt of the numerous victims, has also discredited the former Prefect of the Congregation for the Doctrine of the Faith, Cardinal Ladaria. I am thinking of the McCarrick case, which with the farce of a secret administrative procedure was hastily liquidated without any compensation to the victims, and declared res judicata unappealable.

And the list goes on and on. It remains evident that the unfortunates who willingly or unwillingly collaborate with Bergoglio find themselves thrown overboard as soon as the press discovers the Vatican scandals.

Many are noticing this cynical utilitarian behavior, which in fact brings them to decline appointments and promotions precisely so as not to find themselves in the uncomfortable role of scapegoat. The silence of the Episcopate in the face of the Bergoglian nonsense confirms that the self-referential authoritarianism of the Jesuit Bergoglio has found servile obedience in almost all the Bishops, terrified by the idea of being made the object of the retaliation of the vengeful and despotic satrap of Santa Marta. Some diocesan bishops are beginning to no longer tolerate his devastating action, which undermines the authority and authoritativeness of the whole Church. Bishop Joseph Strickland, for example, has commendably reiterated immutable doctrinal truths that the Synod on Synodality in the coming months is preparing

to demolish.

And Cardinal Gerard Ludwig Müller has rightly recalled that the Lord did not give power to the Pope to "bully" good bishops.

Something therefore is beginning to change: alignments are taking shape and we see on the one hand Bergoglio's "synodal church" – which he emblematically calls "our church" – and on the other hand what remains of the Catholic Church, towards which he does not fail to reiterate his absolute extraneousness.

This situation is humanly irremediable because the forces at play are immense and because the corruption of Authority cannot be healed by those who are subject to it. We must take note that the metastasis of this "pontificate" originates from the conciliar cancer, from that Vatican II which created the ideological, doctrinal, and disciplinary bases that inevitably had to lead to this point. If this passio Ecclesiae is a prelude to the end times, it is our duty to prepare ourselves spiritually for moments of great tribulation and of true and proper persecution. But it will be precisely by retracing the Via Dolorosa of the Cross that the ecclesial body will be able to purify itself from the filth that disfigures it and merit the supernatural help that Providence reserves for the Church in times of trial: where sin abounds, grace abounds all the more.

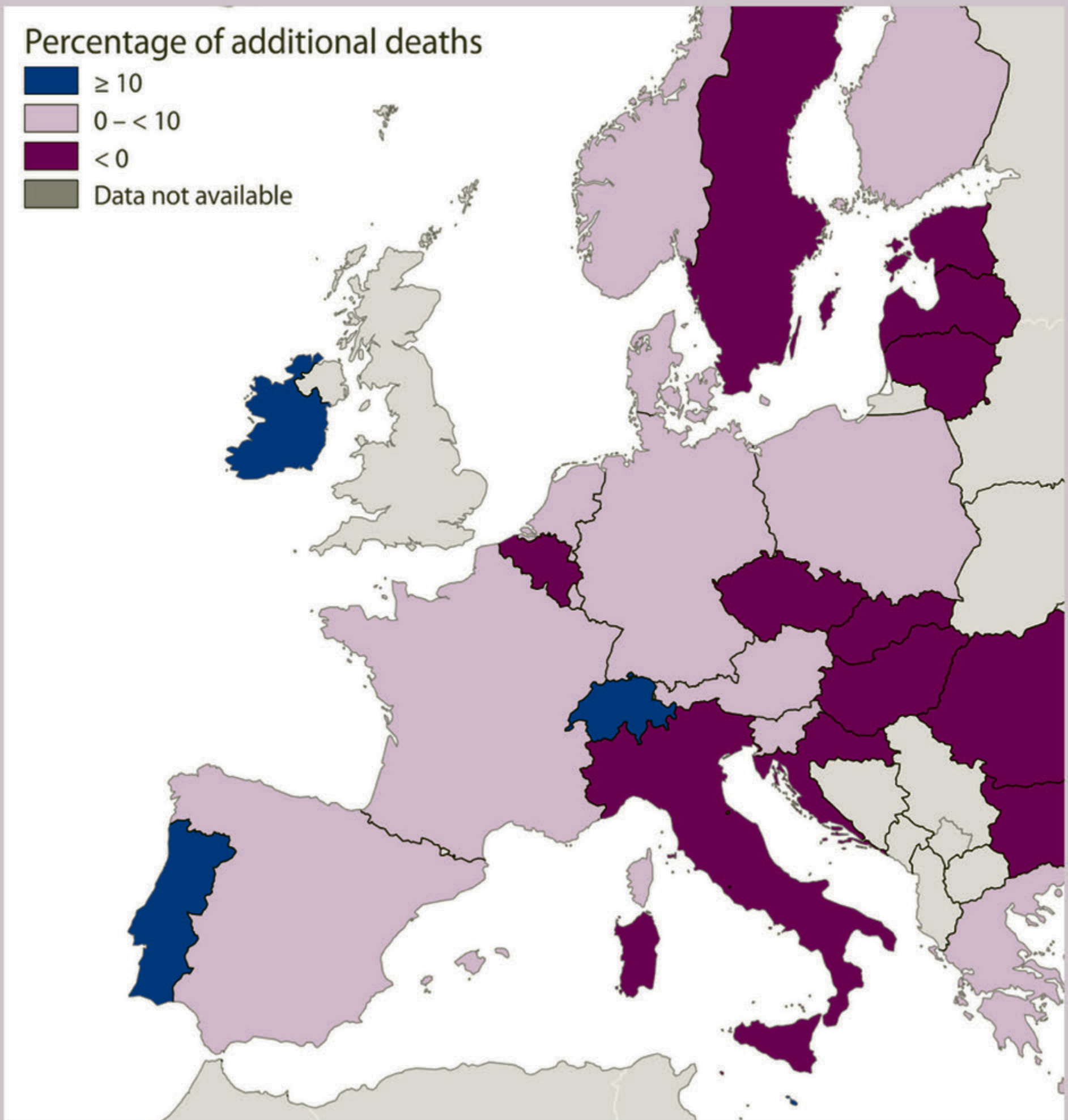
