Migrant Slums Destroying Ireland

John Waters on the new Ballymuns being built for Varadkar's imported slaves

ALL over Ireland now, a building boom is underway. But this is not a boom like any we have known all our lives. It involves not houses but what might loosely be termed 'apartments,' or more accurately 'flats.'

You see them around Dublin and other urban centres and can only wonder at the (large) quantity and (small) scale of them. They can be seen in Cherrywood, south Dublin; in Shanganagh further south (pictured on the right); on Beach Road, Sandymount, in the approach to the toll bridge. They might be termed 'matchbox development,' so small do the individual 'apartments' appear from the grounds, so numerous as to be almost impossible to count, even in a single structure.

These Soviet-style blocks contain the new 'homes' of an utterly changed Ireland, the 'pods' in which the workers of the future will reside, which is to say 'rest' awhile between shifts at the grindstone of the new fascistic economy of Varadkar and Martin, O'Gorman and Donnelly.

And still the ranks of the Irish homeless expand at a steady pace - the official figures 14,000 and counting - without any promise of relief or improvement.

On St Stephen's Day just past, flying back to Ireland after a brief trip to London for Christmas, I noticed that, in a half-full aeroplane cabin, only a handful of passengers - the upper singledigit numbers - could remotely have been Irish people. The rest were evident outsiders, though not 'migrants' in the conventional sense of scammers, spongers and welfare tourists, but more like the kind of people companies like Google and Facebook have brought in to man their surveillance and censorship operations, presumably because Paddy might not take their instructions quite so literally as an alien with no loyalty or affection for Ireland or its people.

There was a time, not so long ago, when a standard element of the RTE Christmas routine was the TV crew dispatched to Dublin or Knock airport to welcome home the returning emigrants and film them bading a tearful farewell by their loved ones. What happened to all of that? No longer an

appropriate part of the narrative, one presumes. Now all of our tears are crocodile one. It has long been common knowledge that the transnational corporations who own and control much of what is laughably termed the 'Irish economy' have little interest in employing Irish people. Although that was the understanding upon which they came here in the first place (to dodge tax likely to be levied in their home fiscal jurisdictions) they found that Irish wage and salary expectations were too high and Paddy was less suited to the drone-style occupations that make up the majority of the jobs in the tech and pharma sectors.

On the face of it, it is as if, unable to feed, clothe and house its own people, the government of Ireland switched to solving the whole world's problems. But it has nothing, of course, to do with altruism. The young people on the flight from Heathrow were the slaves of the new Ireland, a literal fascist state, its government comprising a coalition between a uni-voce political establishment and an externally-rooted and directed corporate sector. The 'pod-living' apartments of the new Ireland have nothing to do with the Irish people. They are the dormitories of the new imported serf class which will operate the wealth-generating apparatus that, on the sand bank of our once proud island, will be the sole remaining residue of the Easter Proclamation's commitment to cherish equally all the children of the nation. In the future, all denizens of Ireland will be treated with equal contempt.

Once the homes of Ireland were commissioned by Irish developers and built by Irish builders. The 'pods' of the new 'hive-cities,' however are built to the instructions of foreign vulture funds, appointed by an 'Irish' government as the new absentee landlord class that will own the roof over the heads of - before long - the entire population.

It is not possible for an ordinary citizen, even an immigrant to Ireland, to buy any of these 'apartments.' They are not for sale, except to 'investors,' most of whom will never set foot in Ireland all the days of their lives. A typical operator within this newly-forged marketplace is the Royalton Group, a UK company with offices now in Malahide, north Dublin, which offers 'assetmanagement' service as well as trading in 'real estate consultancy', student accommodation and hotels. No longer is the property market concerned with providing homes for prospective or existing Irish families, but with tapping into the highly lucrative market of rental to single individuals operating in the 21st century sweatshops of the new allegedly 'progressive' Ireland.

In the summer of 2023, for example, work began on a new development at Beach Road, Sandymount, Dublin 4, by Walls Construction, an Irish company for once, at least. Prospective investors were advised that 'this modern 6-storey development accommodates 112 one and two-bed apartments, each with their own balcony. The scheme also includes shared landscaped gardens, and a large communal space, comprising of a gym, lounge, workspace, bookable room, office and more. This sits above a single-level basement car park with 79 car spaces and 234 bicycle spaces

This is typical of the new developments: one and two-bed 'apartments'; gyms but no creche facilities; and more than three times as many spaces for bicycles as for cars,

It is clear that this complex is not intended for Irish families,

constructed with a view to building a healthy and vibrant nation, but the provision of battery cages for the sweatshop fodder of the next Celtic Tiger. This is the stage of development of the new economics that comes after the peopletrafficking stage. Meanwhile, those responsible for constructing these new ghetto slums blather from the other sides of their mouths about 'equality' and the necessity for environmental sustainability and ecological accountability.

Meanwhile, the words of Thomas Davis echo ghostily through our cityscapes, ricocheting off the walls of the nouveau Ballymuns of the 21st century:

'This country of ours is no sand bank, thrown up by some recent caprice of earth. It is an ancient land, honoured in its archives of civilisation, traceable into antiquity by its piety, its valour, and its sufferings. Every great European race has sent its stream to the river of Irish mind. Long wars, vast organisations, subtle codes, beacon crimes, leading virtues, and self-mighty men were here. If we live influenced by wind and sun and tree, and not by the passions and deeds of the past, we are a thriftless and a hopeless people.'

Irish Second-Class Citizens Once Again

ONE of the psychopath's favourite tricks is triangulation. This is where they use a third party to undermine, demoralise, and shame their victim by attempting to make them feel jealous and worthless. Government's Goalkeepers

John Waters on Ireland's judges and lawyers who operate as a criminal cartel disguised in wigs and gowns abusing the Constitution and Irish citizens daily

IT is no longer widely appreciated that the Government of Ireland has three elements: the Executive (Taoiseach and cabinet), the Oireachtas (Legislature/parliament) and the Judiciary (essentially the Supreme Court). These three elements are intended to operate on a self-regulating basis, whereby the Government proposes new laws which, once passed, it also enforces; the Oireachtas makes the laws; and the courts interpret these laws.

Each of the three elements is supposed to function as a check on both the others; in particular the Oireachtas on the executive and judiciary, with the judiciary returning the compliment by maintaining oversight on laws passed by the political arms to ensure that these are in accordance with the Irish Constitution, which says that all of the power of the State comes from the Irish people.

The constitutional text is also at pains to keep these governmental uses of powers separate, so as to guarantee that there is no imbalance of power between the three elements of the constitutional government. This principle is known as 'The Separation of Powers.'

In as far as it relates to the relationship between politicians and judges, however, this principle, in its application within the system, has become subject to a degree of slippage and erosion of recent times. Once intended as a safeguard against legislative or administrative overreach, it has come to be interpreted by latter-day judges as decreeing that they ought not step on the toes of the politicians. Since the primary function of the judiciary is to maintain oversight on the legislative and administrative conduct of politicians, this modern interpretation has created a dangerously undemocratic situation whereby the courts nowadays are, almost regardless of the facts, inclined to take the side of the government of the day, whenever a conflict arises with citizens concerning the constitutionality (i.e. lawfulness) of any Act of the Oireachtas, or any action of the Executive arising therefrom. In practice, this tends to mean that a litigant coming before the courts finds himself confronted not by an independent forum of adjudication but a star chamber acting as goalkeeper for Government and State.

This has resulted in a situation whereby it is now almost impossible for an ordinary citizen to succeed in a legal action against any legislative foray of the government. This, however, notably does not apply to applicants who issue claims under the

immigration laws, who - this being the latest major cash cow of the legal profession generally encounter a most accommodating response, especially in the higher courts.

For example, whereas a native Irish applicant is likely to be informed that the apparently absolute or near-absolute language whereby rights are expressed within the Constitution (words like 'inalienable,' 'imprescriptible,' and 'indefeasible') is not to be taken literally, migrants have on a number of occasions been told that, where they are concerned, such words mean exactly what it says in the dictionary.

This is merely yet another tendency to be observed in judicial patterns of behaviour suggesting that the modern judiciary sees its principle function as the upholding of governmental decisions and agendas. This follows in a long pattern of such behaviour, whereby any governmental impatience with residual provisions of the Constitution regarded as upholding or defending rights considered politically inconvenient are set upon by judges in the higher courts until they have been reduced to nothing.

This occurred in a series of moves initiating in 1995, whereby the place of Natural Law within the Constitution whereas once regarded as essentially the bedrock of all fundamental rights - was diluted and downplayed by a series of facile but plausible judgements which no lawyer had the courage to challenge. The eventual outcome of this was that the 'inalienable' ('not subject to being taken away') rights of the unborn child (the 'alive though not yet born' human person, as per the Irish wording of Bunreacht na hÉireann: 'beo gan breith') were dismantled and finally carted away to the dumpster in April 2018, a month before the electorate was to vote on whether the article acknowledging this most fundamental right of all children (Article 40.3.3, otherwise 'The Eighth Amendment') should be removed or retained. In actual fact, the electorate, while possessing the right to remove the article, had no right to dissolve the rights it recognised, but the courts had already taken care of that little problem.

These actions of the courts are of a piece with other developments over the years which, because of the deference of the media, and the secrecy imposed in respect of key functions of the courts, have not yet been seen in the context of their underlying patterns, which indicate continuous judicial cooperation with the nefarious demands of the political sector. Going back to the late 1980s, for example, family law courts, which are protected from public scrutiny by the in camera rule, have been trampling upon family rights, destroying parent-child relationships and brutalising individuals who come before these courts in a manner that could be a national scandal were it to happen in open court to common recidivist criminals.

For decades, these episodes, leaking

anecdotally from multiple court hearings and assorted informed sources, were deemed to be simply abuses of power by individual judges; now, however, it is clear that these tendencies were part of a systematic political agenda of undermining family authority and cohesion, in accordance with a longterm plan to undermine marriage, natural parenthood and the nuclear family. For the most part, these agendas are being pushed on Irish society from outside, though with the assistance of sinister and anti-democratic forces operating within the country.

In retrospect, too, it is clear that the political and judicial systems had forged alliances with radical feminist groups seeking to dispossess fathers of all parental rights in situations where they were unmarried or separated/divorced, while clamouring for the purpose of all this viciousness and arbitrariness became clear.

These agendas have latterly entered a new phase. The phenomenon of recent times, whereby dangerous paedophiles are allowed back on the streets with minimal supervision, even on conviction for the most egregious acts against children, may be seen as part of an agenda which seeks the ultimate decriminalisation and whitewashing of paedophila, which is now the next major 'progressive' item on the list of the powersthat-shouldn't-be.

In all this we can observe the corruption of the long but crooked arm of the law as its alleged custodians seek to assist in the radical transformation of society in accordance with a deeply anti-human agenda.

The most egregious aspect of this, at the judicial end of this ever-expanding sewer, is that lawyers and judges who stand on the plinth of a bogus independence seek to deceive the public as to their true natures and intentions, usurping their positions within the legal system - and thereby the powers of the legal system itself - in order to override the democratic process and the will of the people.

Toddlers Sent For Transitioning

The paedophile regime are intent on destroying your children's innocence

AS amazing and impressive as children can be, all right thinking people recognise that they are not the same as adults. Childhood development is a slow process. It takes time for our brains to properly mature.

There is a reason why your average three-year-old girl will struggle to hop on one foot, draw a picture of herself, tie her shoelaces, catch a bounced ball, speak in sentences of more than five words or remember her last name. There is a reason why children do not generally commence primary school until the age of five.

Equally, because of the long process required for full cognitive development, a child's capacity to understand the implications of certain decisions is significantly limited. This is why, as a society, we have minimum age limits for various activities - to prevent our children from coming to undue harm. There is a reason why a 10-year-old cannot open a bank account. There is a reason why a 12-year-old cannot sign up to Facebook. There is a reason why a 15-year-old cannot consent to having sex. There is a reason why a 17-year-old cannot buy a scratch card or drink alcohol in a pub. This is called child safeguarding.

However, in the name of gender ideology, which has managed to infiltrate all areas of our society, we have seemingly thrown everything we know about both child development and child safeguarding out of the window.

Last month, it emerged that 382 children aged six and below were referred to the now defunct Gender Identity Development Service (GIDS) at the Tavistock clinic in London over the past decade. Even more shocking: over 70 of those children were aged just three or four.

Of course, three-year-olds have no real concept of terms like biological sex or gender identity. Nor are they capable of communicating confusions about their 'gender identity' to those around them. Most likely, these children simply showed an interest in toys or clothing that are more commonly associated with the opposite sex. And this led to them being carted off to the Tavistock.

I thought we had moved past the days of regressive gender

We live in a world where Satan has stopped hiding and the world pretends not to see him





stereotyping. It appears not. Nowadays, a young boy who likes the colour pink or a young girl who enjoys playing with Action Man may find themselves in a gender clinic, on the dubious basis that they are 'trapped in the wrong body'.

How these children came to be there may vary. Were they referred by a GP who believes that everyone has a unique gender identity? Did an activist charity scare the parents into believing their child might commit suicide if they do not transition?

Was it a case of Munchausen syndrome by proxy, with the child's parents seeking the positive attention and affirmation that comes with having a child who identifies as trans?

Even so-called social transitioning, when a child adopts a new name and pronouns or wears the clothes of the opposite sex, is not a neutral act. This was made clear back in 2022 in the interim Cass review, an independent British government review into child gender services which ultimately brought about the closure of the Tavistock. Research shows that if a child begins to live as if they are the opposite sex, their discomfort with their actual sex is more likely to persist.

There has been increasing pressure from our institutions to 'affirm' clients, including young children, who are struggling with gender dysphoria and believed themselves to be trapped in the 'wrong body'.

In practice, this means accepting their claims without properly exploring their symptoms. In turn, this means encouraging children who wished to 'medically transition' to take irreversible puberty blockers, cross-sex hormones and to eventually progress to surgical intervention, if that is what they desired.

The 'trans' three-year-olds of today could well become the irreversibly damaged teenagers and young adults of tomorrow, their puberty blocked, fertility extinguished and perfectly healthy body parts chopped off. We have seen it all before. A gender clinic is no place for a three-year-old. We are witnessing the worst medical scandal for a generation. We must put a stop to it.

Was Guerin Paid To Silence Truth?

Five-year campaign of defamation and stalking of a journalist who is seeking justice for his sister

FOR five years, Fingal **Councillor Jimmy Guerin** has been harassing Gemma **O'Doherty in a campaign** of vicious defamation and slander that began the day after she made her views public about the murder of his sister Veronica Guerin on the Naas Road in June 1996. Like many journalists at the time, Gemma was not convinced that Veronica was murdered by the gangland cronies whose lurid antics she frequently revealed in The Sunday Independent in her role as crime reporter.

For many years, Gemma has written about the 1985 murder of Fr Niall Molloy. Her investigation, which revealed a sordid State cover-up involving gardai, judges, politicians and clergy, led to the 'reopening' of the case. Veronica revealed that the Gardai had done a deal with 'The General' Martin Cahill to retrieve the stolen Molloy file from him. The Dublin criminal had broken into the offices of the DPP a year after the priest's murder and stole compromised files which he planned to use to embarrass the State. The night before she published details of this lurid deal between guards and criminals in October 1994, Veronica's home in north county Dublin was attacked by gunfire, narrowly missing her young son Cathal. The timing of this was no coincidence. Veronica was being warned to stay away from State, Garda and judicial corruption and focus on Dublin gangland.

Gemma too paid a heavy price for writing about white collar criminality and lost her 20-year career at the Irish Independent, where she was a senior reporter, because she refused to stop writing

about State corruption - which is the primary and most important function of a journalist. She was forced to take a defamation case against INM and Denis O'Brien and was successful in her action, allowing her to continue her work today.

In August 2018, when Gemma announced she was seeking a nomination for the Presidency, she was giving a talk about corruption in a hall in Waterford. Late in the evening, she answered a question about her thoughts on Veronica Guerin, and in less than a minute, explained her honestly held belief that Veronica was murdered with the assistance of agents working for the State/Gardai because she was getting too close to some of the State's dirtiest secrets.

There is nothing particularly original in Gemma's opinion on this matter. *The London Independent* in the days after Veronica's murder claimed she had been killed as part of a co-ordinated Garda plan. Gemma, having spent her entire career exposing criminality within the force and being threatened by them on countless occasions, did not need much convincing that this may well be the case but did her own independent research on the matter and established it to be a strong possibility.

At the time of her murder, Veronica is believed to have been working on a number of stories regarding judicial wrongdoing including claims that certain judges were on the take from criminals and that they were assisting in the protection of paedophiles. She was also exposing collusion between Gardai and criminals in the drug trade. She was putting her nose into areas where she risked getting burned and upsetting the higher echelons of the political elite. When she was gunned down after a low-key court date for a speeding offence, it was widely believed in journalistic circles that she had ruffled too many feathers and had to be taken down. But very few reporters were willing or allowed to say that publicly at the time.

After Veronica died, her brother Jimmy took control of the narrative surrounding her death, protecting the Gardai at every turn and attacking anyone who ventured off the official story. The day after Gemma expressed her views on the subject in 2018, he went on the airwayes and into the council chamber in Fingal North Dublin and told the most outrageous and slanderous lies about her. Purely because Gemma had stated her honestly held opinion and was seeking justice for Veronica, he accused her of a stream of vile accussations calling her 'poisonous', 'hurtful' and 'capitalising on his sister's murder.' It was an astonishing outburst from a man who should want to know the truth about Veronica's death and indicated to Gemma that Jimmy Guerin's function was to act as a shield in protecting the State and Gardai from awkward reporters who might venture into unofficial waters. The day after her comments, RTE followed Gemma around demanding she withdraw them and apologise. Apologise for what? Expressing truths that needed to be told? Nobody wanted to know the extent of her evidence or why she had come to her conclusions. The whole operation was designed to intimidate Gemma in the hope of silencing her.

Less than a year later, the Guerin harassment began again in the form of a ludicrous and fabricated legal action against Gemma regarding her coverage of the crimes of Martin Guerin, a well-known paedophile in north Dublin and sibling of Jimmy and Veronica. Martin Guerin was tracked down by Interpol in 2014 in possession of hundreds of the most depraved child abuse images, some of them including babies as young as two. (Continued next page)

THE Gardai sat on the information for almost five years, during which time Guerin could have been abusing children. When he was eventually brought before the courts in July 2019, there was public consternation when he was allowed to walk without spending one day in prison. There was widespread coverage across the media, with headlines splashing 'Guerin Brother Convicted Of Child Abuse Imagery; Walks from court.'

Gemma was one of the many journalists who covered the story that day, as part of her longestablished record exposing wellconnected child predators who are treated leniently by judges and the Gardai. Her thesis had been proven once again.

Some months later, she read in an online paper, that Jimmy Guerin was taking a defamation action against her. For several years, the phony case was dragged out ad nauseum in an effort to persecute Gemma and publish defamatory headlines about her. The printing of money is a serious offence and comes with a custodial sentence but where Jimmy Guerin's friends are concerned favours seems to be available, as they were for his brother Martin who is still on the loose in north Dublin. The investigation into the cash find was also a massive Garda cover-up.

Since Veronica's murder, Jimmy Guerin has bullied any journalist who puts their head above the parapet and suggests there may have been State involvement. Why does he want to shut down debate about his own sister's death? Does he not want justice for her? Why does he attack and try to silence those who try to bring her real killers to justice? This is not a normal reaction from a family member.

Either way, Gemma will not be silenced in her work and will continue to expose the facts about Veronica's death, Martin Guerin and his paedophile crimes and the campaign of stalking carried out against her by Councillor Jimmy Guerin.

Guerin and his lawyers who are trying to extort money from her will never receive one cent from her no matter how many judges are in on this futile mission to take her down. All they are doing is drawing more attention to her journalistic work and showing themselves up as vindictive madmen. On January 19th, they go back to court to try to have Gemma jailed for speaking about the case. Feel free to attend. Obviously the State is driving this charade which will ultimately. All vaccines are inherer

SUPPORTERS of vaccination argue that vaccines prevent disease, and cite as evidence a disingenuous correlation between vaccination and the disappearance of diseases such as smallpox, diphtheria, cholera, typhoid, poliomyelitis, tuberculosis and tetanus.

Epidemiological studies repeatedly show that these diseases were already dying out as general sewage networks and treatment stations were built, universal domestic running water and flushing lavatories installed, slums demolished and nutrition improved.

An exhaustive study by CDC (Center for Disease Control and Prevention in the U.S.) and John Hopkins' scientists in 2000, published in Pediatrics, concluded: "Vaccination does not account for the impressive declines in [infectious disease] mortality seen in the first half of the [20th] century... nearly 90 percent of which occurred before 1940 when few antibiotics or vaccines were available."

By the 1960s there was not an epidemic to be found, but the vaccine industry was not to be deterred. It set its sights on the childhood illnesses of measles, mumps and rubella,



despite the fact mortality from measles had naturally declined by 95 percent, and a school of physicians believe these illnesses actually serve to help build and strengthen a child's immune system.

Dr. Tom Cowan in his book, *The Contagion Myth*, writes: "Measles is a process of detoxification, transformation and growth. If thwarted, particularly by an injection that clearly alters our immune response, then only worse things can happen. This is clearly revealed by the many studies showing that children who go through typical childhood illnesses such as measles have fewer chronic diseases throughout the course of their lives."

Vaccine theory is predicated on the assumption that by injecting a trace amount of an attenuated pathogen (an antigen) into the human body, the immune system responds by producing antibodies specific to that pathogen, which will protect the recipient against infection.

However, the presence of antibodies in the bloodstream does not guarantee immunity. These are simply part of the immune system's response to an outside attack, infection or wound, including that inflicted by a needle. Many vaccinated individuals go on to develop the very illness they are supposed to be protected against, and people who die from infection have antibodies in their system. The scientific body which opposes vaccination believes all vaccines damage the immune system, and therefore mass vaccination is one of the greatest contributors to disease. They explain that injecting noxious substances directly into the bloodstream is a form of assault, as it immobilises a part of the immune system whilst it temporarily diverts all resources to this artificial stimulation. In the case of babies and children, whose immune systems are just starting to develop, it is reckless because it can permanently derail the formation of a healthy immune system. Multiple vaccinations cripple several parts of the immune system at the same time and do nothing to restore its balance. Each challenge by vaccination has the potential to deregulate the immune system, and we have no idea what happens when multiple antigens are injected simultaneously, which is increasingly the trend.

The consequences, they believe, are weakened immune systems, far less able to fend off disease, borne out by the exponential rise in immunological and neurological disorders, cancers, asthma, allergies, juvenile diabetes and chronic infections, in direct line with ever-expanding mass vaccination programmes.

After **Merck** developed its chickenpox vaccine in 1995, it was suddenly declared a life-threatening illness. By vaccinating and thereby preventing children from developing natural immunity to chickenpox, we now have



a new epidemic of adult shingles, for which the medical Ponzi scheme has another vaccine.

There are three separate and potentially harmful aspects to vaccination. First, as artificially stimulating one part of the immune system to abnormally produce antibodies inhibits the other part of the system, this throws the entire immunological response out of gear. Second, vaccines are laden with adjuvants such as chemicals, metals, and drugs which act as preservatives and turbo-chargers to enhance their performance, some of which are neurotoxins. In infants, the bloodbrain barrier, which keeps harmful substances from reaching the brain, is not developed as it is in adults, so they are vulnerable to neurological damage from these ingredients. Thirdly, they contain contaminants. The former pharmaceutical R&D executive Sasha Latypova explains how traditional vaccines are always contaminated with plant and animal proteins which hyper-sensitise the body, especially in children, causing allergies. And these are all injected directly into the bloodstream. The biochemist Judy Mikovits

PhD writes in her book, *Plague of* Corruption: "We've been stimulating the immune system of individuals for a century with virtually no monitoring of how their immune system is responding. Each intervention increases the likelihood of an adverse event. Increase the number of interventions/vaccines, and you dramatically raise the likelihood of adverse reactions. Add to that complexity the fact that vaccines contain multiple ingredients, and you realise what a shaky foundation upon which we've built our current medical system."

Vaccines are the only pharmaceutical or medical product that the FDA (Food and Drug Administration in the U.S.) does not require to be rigorously safety tested. The gold standard for safety testing new pharmaceuticals is randomised control trials (RCTs).

Clinical trial participants are divided at random into two groups of similar size where one group takes the product being tested whilst the other, known as the control arm, takes an inert placebo (saline solution) in order to compare the results at the end of the trial period.

In the case of vaccines, either there is no control arm, or the placebo vials contain the same mix of toxic ingredients that go into the vaccine itself, minus the attenuated virus, or something else, as there is no requirement to disclose the ingredients of placebos.

It is important to remember the immune system is a multi-layered, finely balanced, complex system, much of which remains a mystery.

When we encounter pathogens through the normal channels of the nose, throat, skin and the saliva, the body has various lines of defence through which the attacker must travel to be effectively dealt with. Each filter screens the pathogen and mobilises its forces against it. A pathogen must provoke the complete inflammatory and immune response for the body to acquire natural, real and lasting immunity to a particular germ. Attempting to bypass this sophisticated system is not only ineffective but fraught with risk.

Biochemist Dr Judy Mikovits PhD writes: **"We are finding that natural exposure, such as having measles,** not only provides lifelong immunity, but also tunes the system to make it less likely you'll have certain cancers when you're older."

ntly unsafe - here's why

As 'vaccine-mania' surged through the 1970s and 80s, so did the lawsuits filed against manufacturers for injuries and deaths caused by them. A major culprit was the DTaP vaccine (diphtheria, pertussis (whooping cough) and tetanus) as studies linked it to sudden infant death syndrome (SIDS), seizures and more than a dozen neurological and immunological disorders. The vaccine contained thimerosal, which is almost 50 percent mercury, and in infants can pass through the blood-brainbarrier.

Several laboratories were brought close to bankruptcy as insurers withdrew their indemnity cover.

This led Congress in **1986** to pass the National Childhood Vaccine Injury Act which established a special no-blame 'Vaccine Court' to shield vaccine makers from liability, which is funded through a levy on every vaccine dose sold.

The terms of reference of the Vaccine Court are that it only allows parents of vaccine-injured children to bring claims under a specific set of court rules, which are very different from

those which prevail in normal civil liability actions, and their lawyers have to argue against the might of the Department of Justice attorneys (DoJ). The odds are stacked heavily against parents as the vaccine-makers are allowed to keep their formulations and methods secret even while the lawsuit is being contested. In other words, there is no normal discovery process whereby the pharmaceutical companies are required to hand over their documents. This considerably hampers the plaintiff's ability to prove their claim, given the onus to establish a causal link between the vaccine and the injury, illness or death of their child lies squarely on their shoulders.

Despite these hurdles, the court has paid out over four billion dollars in compensation to thousands of parents since its inception in 1988. That year, the U.S. childhood immunisation schedule was expanded, and again in 1991. Cases of autism soared. Notwithstanding, the list continues to bloat.

Thimerosal was ultimately banned from use in paediatric vaccines in the early 2000s.

No vaccine has attracted more litigation than the MMR, and thousands of cases of 'regressive autism' were filed in the early 1990s. Regressive autism is when a child that is meeting its normal developmental milestones develops a fever post vaccination and suddenly regresses.

By 2002, there were around 5,000 autism-related cases awaiting adjudication in the U.S.

In 2006, the Vaccine Court decided to categorise the cases and select a handful as test cases, where evidence of causation could be presented based on three separate hypotheses:

- 1. That a combination of the MMR vaccine and thimerosal caused autism.
- 2. That thimerosal alone caused autism.
- **3.** That the MMR vaccine itself caused autism.

The hearings known as the 'Omnibus Autism Proceedings' began in 2007. Paediatric neurologist Dr Andrew Zimmerman acted for Health & Human Services (HHS) as its primary autism expert. He issued a written opinion in the first test case, Cedillo v. HHS (Health and Human Services), that he did not believe the vaccine had contributed to Michelle Cedillo's autism. This opinion was then applied to other cases.

However, it recently came to light in 2019, through a sworn affidavit issued by **Dr Zimmerman**, that whilst attending proceedings on June 15, 2007, he had taken the Dol's lead attorney, **Vincent Matanoski**, aside to clarify that his written expert opinion in the Cedillo case was case-specific, and not intended to be a blanket statement for all the cases, and that Torsten Engelbrecht Claus Köhnlein

in some children, specifically those with mitochondria dysfunction, vaccination could cause autism.

Dr Zimmerman had been due to testify in the next test case, Hazlehurst v. HHS, on Monday, June 18 but, according to his sworn affidavit, shortly after he clarified his opinions to the DoJ attorneys, he was informed that he would no longer be needed as an expert witness on behalf of HHS.

A former senior vaccine-safety scientist at the CDC, Dr William Thompson told a member of Congress, Bill Posey, under sworn deposition that he had been strongarmed into destroying data showing a link between vaccines and autism, and ordered by CDC bigwigs to publish a fraudulent study dismissing the link. Dr Thompson told Robert F Kennedy Jr. (RFK Jr.) he feels a profound sense of shame.

It was estimated in 2007 that the lifetime care cost for a child with autism was around three million dollars. It was also estimated that the subset of children with vaccine-induced autism based on mitochrondrial dysfunction was between 25 and 40 per cent.

RFK Jr. tells us that in his youth, one child in 10,000 had autism in the U.S. In 1986, it was around one in 2,500, and today it is one in 36.

The War On The Car

It's time to resist Orwellian State interference on the roads before it's too late

IF Net Zero is about control, then car makers are fully on board with legislators. Reducing emissions through the use of technology, such as sophisticated engine management systems, is certainly part of their remit. However, controlling the way drivers make decisions should be regarded as a step too far.

The General Safety Regulation applies to cars made to be sold in the EU from 2022, and ordains that they now come with many extra exciting features, a speed limiter being just one of them. Others include automated emergency braking, electronic data recorders and all-round cameras. The important point is that while these systems are fitted, or capable of being fitted, to all brand new cars from 2022, there is no obligation to activate or use them. The trouble may occur with an automatic speed limiter which prevents exceeding a legal limit.

However, an inability to accelerate and exceed the speed limit in an emergency could be a problem. Especially if the driver is unaware that 'hard-acceleration' may get them out of trouble.

These regulations are not just about speed devices. Manufacturers will also need to equip their vehicles with a 'driver drowsiness and attention loss warning' system, a soupedup version of the existing lanedeparture warning features, which beep and shake the steering wheel at you. Drivers will soon be looking for a way to permanently turn them off. but this is difficult. as so many are default settings when the vehicle is started. Distinguishing between the irritating and the dangerous is sometimes tricky. Emergency Brake Assist is supposed to know better when to slam the anchors on than the driver. Whereas beeping at you because something is ajar or left on is something many can just about cope with.

Rather more controversial is the 'event data recorder' effectively a black box. In theory, it is there to log all the relevant circumstances

of an accident. It is sold to motorists as making their lives simpler, and maybe the insurance cheaper. However, this has already been called out by the 'Ligue de Défense des Conducteurs', a French pro-car action group, who have said that once these devices are installed, the authorities can check driver data in real time, or retrospectively and quite possibly punish them for motoring offences.

The EU clearly can't stop interfering with the way cars are made, operated and used.

There has been little physical resistance to Net Zero. Ordinary people, who will be most affected by the policy, usually continue going about their daily routine to earn a living and look after their families. Nevertheless, it is possible to fight back in this war against the motorist, and the French have shown us the way, donning their high visibility jackets to become the Gilets Jaunes ('Yellow Vests'). Their origins were rooted in principle and rebellion. It all began with a proposed fuel tax rise, again justified by the decarbonisation agenda. The revenue was apparently to be used to finance renewable-energy projects and discourage the use of diesel and petrol cars. Incredibly, the price of diesel had already risen by 23 per cent in the space of a year. Firstly, the price of crude oil rose in October 2018 to just over €80 a barrel, with the cost quickly passed on to consumers. Fuel tax also went up in 2018: diesel by 7.60

cents and petrol by 3.90 cents per litre Then there was the dreaded Carbon Tax. These measures all hit hard at rural dwellers, who rely heavily on their cars. They also hated the cut in the speed limit on rural roads from 90 km/h to 80 km/h. Many believed the policy was just a way to make money from speeding tickets. No wonder then that the Gilets Jaunes targeted the country's speed cameras, taping them up, burning them, and knocking them over. As many as 60% may have been 'retired' in this way. This was the French working class versus their intellectual elite.

More recently, the British caught on. After all the logical arguments against London's ULEZ (Ultra Low Emission Zones) failed and the scheme was implemented, the direct actions of the so-called 'Blade Runners', a group who took to cutting the cables on ANPR (Automatic number plate recognition) cameras, seemed to be more effective.

The loony 'green' regime in Ireland is intent on bringing our cars to a snail's pace with new restrictions in place all over the country which must be resisted and ignored. It is well and truly proven that reducing speed limits to dangerously slow levels does not impact in any way on emissions if anything it increases them - and has no impact on collisions. This is all about control over where you go, what you do and your freedom to travel whenever you want. These absurd rules must be broken at every turn.

MORE CLIMATE FRAUD

Just about all of the media have been peddling the claim that 2023 was the 'Hottest for 125,000 years', which suggests a very concerted effort by the climate establishment to brainwash the masses. The claim is self evident and baseless nonsense for a number of good reasons: There is no such thing as "a global average temperature." Even now we have very sparse coverage of temperature measurements. Prior to satellites, we had virtually no data outside of the US, Europe and a few other built up areas. The temperature record we do have is thoroughly corrupted by UHI (Urban Heat Island) and only dates back to the late 19th century. Natural variations, including volcanic activity can easily cause temperature swings of a degree Celsius from year to year, and decade to decade. But historical proxies don't have the fine resolution to pick these up, they merely give an idea of average temperatures over decades and even centuries. Consequently you cannot compare one year now with the

general climate of, say, 2000 years ago.

But forget about all of these theoretical objections, because the climatic evidence we do have is overwhelming, and it tells us that the climate has been much warmer than now for most of the last 10000 years, since the end of the ice age. Temperatures in Greenland have been much higher than now for most of the last 8000 years. Many other studies confirm that the temperature trends found in Greenland ice cores also exist elsewhere around the Arctic.

A wide selection of proxies in the Canadian Arctic and Greenland identify a long running decline in temperatures over the last 3000 years. The ice sheet has also grown since since that time. Summer temperatures were between 2.5 and 7.0C warmer 7000 years ago in northern Russia: Temperatures in the Baltic were between 1.0 and 3.5C higher 4500 years ago.

And it is equally apparent that this warmer climate was worldwide. Even where there are no proxies, there is still evidence in places like the Sahara, where the lush climate there a few thousands of years ago is indicative of an expansion of the Tropics resulting from a warmer world. Large scale retreats and advances of glaciers don't happen as a result of a few years of weather. Neither do advances of tree lines hundreds of feet up mountainsides. The evidence from these events and the likes of ice cores is irrefutable and clearcut. Throughout, the overall climate was still warmer than the current one. Anybody who claims that last year was the hottest for 125,000 years is a fraud.

Wind farms killing eagles



A French court has ordered the dismantling of a wind farm due to the threat it poses to local ecology including golden eagles in the area.

In a ruling published in December 2023, the Nîmes appeal court upheld a previous decision that demanded the immediate "demolition of all the wind turbines" and restoration of the site within 15 months. Daily fines of €3,000are to be paid by developer Energies Renouvelables du Languedoc-Valeco, a subsidiary of German energy company EnBW, if it does not comply with the demolition order.

The onshore wind farm was commissioned in 2016 and is located near the southern town of Lunas in Languedoc, France. It has been the subject of a series of legal proceedings brought by residents and conservation groups, with the latter arguing that it was directly harmful to wildlife in the area, including golden eagles.

French media reported that the body of a golden eagle deemed to have been killed by a wind turbine blade was found at the wind farm last year. The developer was originally ordered to dismantle the wind farm by a court in Montpellier in 2021 but won an appeal against the ruling. However, this was overturned by the French Court of Cassation earlier this year, a decision that was then upheld by the appeal court in Nîmes on 7 December. A study had found that the wind farm had led to the deaths of more than 1,000 birds and bats.

An earlier judgement also pointed out that the impact assessment submitted in 2013 during the development process for the wind farm was "insufficient", which resulted in its construction in an area where golden eagles were nesting.

It's amazing what can be achieved when neighbours come together to fight these environmental atrocities in our midst. Every single parish in Ireland should be battling to have them removed. They are the greatest crime ever committed against our precious rural landscape.

Crisis actors rolled out to usher in hate laws and police state

IT was only a matter time before the regime that runs Ireland put on a staged mass stabbing event here, followed by fake 'far right' riots. The photograph above which was one of the very few of the 'scene' released by the regime reveals countless errors in the official narrative which give the game away and prompt serious questions as to whether it happened at all. The lack of blood anywhere is an obvious problem. The placing in the forefront of the picture a Helen McEntee lookalike in a tie-dye dress may have been used to give an impression of blood splatters - it is certainly a very unusual dress to be wearing on a freezing November day. It's unusual too that the 'ambulance men' are in their summer uniforms wearing short-sleeve shirts. As for the pair in the window on the left making freemasonic symbols, who knows what they were up to?

It astonishing too how every image and video taken on the day shows no victims - just crowds of emergency staff standing around them almost as if to hide them at all times. Was this because there was nothing to show? This type of shielding operation is common in staged government mass injury events. Pray Your Gay Away

Same-sex marriage serves one purpose only: to ridicule, obscure and annihilate Christ's relationship with his Bride, the Catholic Church

THE message given is: what the Catholic Church has condemned in the past as being mortally sinful, now they're encouraging priests to bless those relationships,'

Father Gerald Murray, a priest and canonist of the Archdiocese of New York, has denounced the newest document of the Vatican, Fiducia Supplicans, for allowing priests to bless the mortal sins of sodomy and adultery. He has been joined by thousands of priests and bishops all over the world in condemning and rejecting Rome's latest bizarre instruction.

Asked whether the proposed 'blessing' of same-sex couples could truly be called a development of the Church's teaching on marriage and blessings, the priest emphatically rejected this,saying the novel practice is a contradiction of the Church's perennial teachings on the matter.

"No, that's a misuse of the word development," he said. "It's accurate to call it innovative because it's an innovation, meaning it's something new that hasn't happened before. And the reason it hasn't happened before is it's a contradiction of the Church's teaching."

Murray explained that, as St. John-Henry Newman, true development requires continuity, not corruption. "A thing becomes more fully itself as an acorn becomes a tree over time with nourishment and sunlight

Likewise, the understanding of the Church – for instance on the papacy, the Holy Eucharist, the other sacraments—it develops over time, because... until someone asks a question an answer's basically implicit, not explicit. So to make explicit what a thing is, is not to change its nature or to corrupt it." Murray denounced the muchtouted attempt to distinguish between liturgical and nonliturgical blessings as nothing less than casuistry seeking to endorse



sodomy and adultery.

"The major problem with this document is its casuistry. Casuistry is basically a deceptive and unfair use of Revelation to try and arrive at a predetermined conclusion. And this basically says there's a difference between a liturgical blessing and a non-liturgical blessing. This is ridiculous. Every blessing in the Church comes from the fact that God blessed us in Jesus Christ, and we primarily, in the Church, as a hierarchical organization, bring those blessings through public ministries. So to say there's something like an unofficial blessing - they compare it to a parent blessing his children, you know, at the dinner table; wait a minute, this has nothing to do with a mum and a dad saying, 'I bless vou Tommy. I bless vou Sally' this is a relationship."

"When two people come forward and say, we just got married at City Hall, two men, and we'd like to bless our relationship, well, what's the relationship? It's a promise to commit immoral acts. Same with people in the second adulterous marriage: we're going to commit adultery even though our former wife or husband, you know, is still living in the same town."

"So it's a dodge to say we bless people without asking questions. Therefore, we shouldn't ask questions the next time two people who are involved in an incestuous relationship come in and say, 'Father, would you bless us? You know, we're brother and sister but we think sex is beyond the restrictions that used to be.' Is a priest supposed to say, well, if you feel it's important maybe I should bless you? Of course not! Everybody would know that's endorsing incest."

"This really for me is one of the most shocking things about this, all of this casuistic reasoning. This is casuistry on the very people who condemn true moral reasoning as being casuistry. So for me the scandal here is that the Pope, and all those who agree with him – they are telling people who are engaging in sodomy and adultery, no problem, the Church agrees that your behavior, while not up to perfection, is something that we can bless. This is unreal.

Meanwhile, a former homosexual has slammed Pope Francis and says he is inviting humanity to join Satan in mocking Christ and His Church. Catholic convert Doug Mainwaring says: "It was just a little over a dozen years ago that Argentine Cardinal Jorge Bergoglio said: Let's not be naive, we're not talking about a simple political battle. The Female Slavery Referendum

John Waters on the latest attempt by the regime to shred the Constitution

THE forthcoming 'homemaker referendum, to be held in March, which canvasses the changing of the provision in Article 41 of the Irish Constitution guaranteeing to protect the right of women to work in the home, if they so wish, is set to become the occasion of non-stop misinformation by the Olympic-standard liars of the Irish Government, as they try to pass off an attempt to confiscate even more of the fundamental rights of Irish people as some kind of demonstration of their progressive and egalitarian instincts.

'We will push back strongly against misinformation [in the coming referendum debates],' the appalling Varadkar told reporters in December, added that those who engage in misinformation or disinformation concerning the referendum are going to be 'called out.'

Perhaps he will begin by ceasing and desisting from trying to mislead the electorate in his presentation of the issues, thus obviating the need for his own lies to be 'called out'in the coming weeks and months? While it is never wise to rule out imbecility in considering any statement or action of an Irish politician, it is hard to believe that no mature person in the Department of Justice has pointed out to those involved that, legally speaking, they are uttering nonsense when they bleat on about the 'outmoded' and 'sexist' tenor of Article 41.2.

Article 41.2 does not, as they imply, confine women to a domestic role. It recognises the significant role played by wives and mothers in the home, which in no way excludes women and mothers from other roles and activities, or restricts them in any way. it offers them 'choice'— a word that should awaken memories of another recent referendum. It is a recognition of the work performed by women in the home, on the basis that it has immense benefit for society.

Announcing the referendum in December, Education Minister Norma Foley spoke about the 'wonderful carers in homes around Ireland include both men and women,' as if she was saying something no-one had ever said before.

'There are families where it is the dad who stays home,' she said, as if she had ever before expressed concern for fathers or their treatment in law or otherwise by the Irish State.'

This is a Government with such contempt for the Irish population that it imagines a scatter of Woke verbiage will be sufficient to cloak every form of deceit and criminality.

Article 41.2 already contains implicit recognition of fathers and other categories of carers in the home. In DT v CT (2002) Murray J. specified that the Article could be interpreted as covering fathers' roles in caring for their children and the home: It is also likely that, had the political thinking of the time not become so ideologically poisonous, this rumination would long since have become hard law, and would have been extended in its interpretation to people of both sexes working in the home to care for the elderly, the sick and the disabled. In a system which was overwhelmingly anti-father, Murray J. was an exceptionally pro-father judge. But had the political system not already been bought off by George Soros, it is likely that, over the past nearly three decades since the introduction of divorce, many more such unenumerated rights would have been identified in judgements of the High Court and Supreme Court.

Another reason why politicians did not favour such interpretations was their fear that they might lead to home carers becoming entitled, in time, to contributory pensions and the like. Indeed, if such a principle were to be established in court, it would stand in the way of the unannounced but already determined plan to introduce euthanasia for the purposes of population reduction and financial savings.

Even a cursory reading of the present Article 41.2, and its proposed replacement, ought to raise loud alarm bells for any sentient person. The existing Article 41, reading from the top, reads:

- 1. The State recognises the Family as the natural primary and fundamental unit group of Society, and as a moral institution possessing inalienable and imprescriptible rights, antecedent and superior to apositive law.
- 2. The State, therefore, guarantees to protect the Family in its constitution and authority, as the necessary basis of social order and as indispensable to the welfare of the Nation and the State.
- 3. In particular, the State recognises that by her life within the home, woman gives to the State a support without which the common good cannot be achieved.
- 4. The State shall, therefore, endeavour to ensure that mothers shall not be obliged by economic necessity to engage in labour to the neglect of their duties in the home.

The change being proposed is the deletion of the last two paragraphs, referring explicitly to 'woman' and 'mothers.' A key phrase to be noted here is 'shall not be obliged,' which any half-literate nine year-old could read as indicating a noncompulsory principle.

The point of the article, taken on its face, is to give women the option to work in the home, if she so desires, and thereby not be required, by material or other circumstances, to work outside the home. Although no case has ever been taken to establish the point in case law, this in time might well have led to a requirement that women working in the home be entitled to some form of explicit payment on account of the support they provide, and 'without which the common good cannot be achieved.' It is possible that, as we are about to enter an era in which the concept of the 'common good' will in other contexts be employed a great deal to remove other kinds of rights, some sharp legal adviser to the political system recognised here a potential source of future bother. In any event, the Fortieth Amendment of the Constitution (Care) Bill 2023 proposes to delete Article 41.2 from the Constitution and insert an Article 42B with the following wording:

The State recognises that the provision of care, by members of a family to one another by reason of the bonds that exist among them, gives to Society a support without which the common good cannot be achieved, and shall strive to support such provision.

It does not require a legal expert to observe that the specific responsibility placed on the State by virtue of the requirement in the existing wording to 'endeavour to ensure that mothers shall not be obliged by economic necessity to engage in (external) labour ... ' is considerably more burdensome than simply requiring ithe State to 'strive to support' the provision of care 'by members of a family to one another by reason of the bonds that exist among them.' What, here, does 'support'mean?

Does this not imply that any raggle-taggle group of people declaring as a 'family' would be entitled to State support without requirement of any biological or formalised connection? Quite clearly, this would be the easiest thing in the world for a court to throw out, and thrown out it would be. It is, in short. a clownish proposal which burlesques the very idea of a constitution.

It is clear that, in the existing wording, a mother who is struggling to rear her family by virtue of remaining working exclusively in the home, would have standing to seek additional financial support from the State, whereas the revised guarantee might at best be interpreted as requiring the provision of occasional home assistance or respite to families struggling to care for their elderly or disabled relatives, which already happens in many cases, and without any requirement of a constitutional provision. This is the true situation that resides behind all the Woke untruths about the necessity to catch up with 'modern social norms' by dispensing with the 'outdated' and 'sexist' language of the present Article 41. The politicians seek to save money, presumably so they can spend it on foreign invaders, and are also anxious to ensure that no constitutional obstacles remain to their future plans for euthanasia, and other 'progressive' developments.

'The current wording seeks to contain women in a very singular role, a role that's completely divorced from the reality of women's lives, of women's careers across our state today,' the appalling Varadkar claimed on announcing the referendum in December. All lies. The best approach in all such matters is to regard with suspicion anything offered by the type of purchased politician we deal with nowadays.
