

# Reject State Control


# Fake Opposition Have No Shame

# Only Fools Put Trust In Government

**PUBLIC trust in government is understandably at an all-time low as more and more people waken up to the Covid scam. 
If I steal, it is theft. If the state steals, it is taxation. If I kill, it is murder. If the state kills, it is warfare. If I force someone to work for me involuntarily, it is slavery. If the state does it, it is conscription. If I confine someone against their will, it is kidnapping. If the state does it, it is incarceration. Nothing has changed but the label. What binds us to the state is the belief that there is a different morality for anything that has been sanctified through the political process.

"Oh, 50%+1 of the population voted for forced vaccinations? Then I guess we have to comply." If you scoff at that sentence, how about if the vote were 100%-1? Would that change the morality of resistance? How about if forced vaccinations were mandated by the constitution? Then would you be compelled to submit?

Does the ballot box transform the unethical into the ethical? Of course not. But I'll tell you what it does do: It makes everyone who casts their ballot a part of the process that legitimizes the murder and violence committed by agents of the state.

No, I am not an efficiency manager for the state. I do not want to help it do its job of inflicting aggression and violence on peaceful people. I want the state to perish, not through violence or bloodshed, but by removing the mystical superstition from the minds of the general public that makes them believe that "government" is anything other than a gang of thugs with a fancy title.

This is the point that I start butting up against a brick wall of incomprehension when talking to the normies in the crowd. They start having mental breakdowns, frothing at the mouth that "votes need to happen." As if voting, elections, positions of responsibility and other things that exist under statism could not exist under



voluntary associations. As if voluntary association itself were such an arcane and bewildering concept that no one could possibly wrap their head around it (let alone, heaven forfend, read a book or two to see if some of their questions on the subject have already been answered).

No, much easier to go back to the comforting political wrestling match. Now that I can get behind!"

## **Don't trust the government with your privacy, digital or otherwise.**

In the more than two decades since 9/11, the global security industrial complex has operated under a permanent state of emergency that, in turn, has given rise to a digital prison that grows more confining and inescapable by the day.

Wall-to-wall surveillance, monitored by AI software and fed to a growing network of fusion centers, render the twin concepts of privacy and anonymity almost void. Every scheme the government is involved in is to get control of you and everything you own. Guard your privacy with your life. Tell them nothing. Keep their snouts out of your life.

## **Don't trust the government with your property.**

If government agents can invade your home, break down your doors, kill your dog, damage your furnishings and terrorize your family, your property is no longer private

and secure—it belongs to the government. Hard-working people are having their homes, farms, cars, electronics and cash seized under the assumption that they have allegedly been associated with some criminal scheme. Many of these people have been targeted simply because they objected to the Covid scam. Keep the government out of your domestic affairs. Remember you have a right to the peaceful enjoyment of your private property. But you have to guard that right if you want to retain it.

## **Don't trust the government with your finances.**

The national debt in Ireland is EU240 billion and growing. Ireland is a banana republic run by tin-pot dictators. 



**The Communist plan to ‘march through the institutions’ is complete in Irish education**



# How Dissent Is Always Controlled

## FLUORIDATION LOWERS CHILDREN'S IQ, US COURT RULES

The link between water fluoridation and low IQ in children has been known about by governments for years. In the same way they have been vaccinating newborns with toxins that they know cause autism and other neurological conditions, so too were they well aware when they started putting industrial by-products into tap water that it was dangerous. Every action taken by government be it introducing abortion or sexualising children is designed to harm future generations. That is the fundamental tenet of population control and how better to do it than through the water supply.

A recent court case taken by the Fluoride Action Network in the US has resulted in a federal ruling confirming that fluoridation in water does indeed lower IQ in children. The California judge said that the Environmental Protection Agency must take action. Many cities have already halted the practice.

"In all, there is substantial and scientifically credible evidence that fluoride poses a risk to human health: it is associated with a reduction in the IQ of children and is hazardous at dosages that are far too close to fluoride levels in the drinking water of the US." Like in Ireland, the authorities have been well aware of this for decades. It is unknown now why they have decided to act - possibly because they can no longer get away with it. The new ruling cites a review by the National Institutes of Health toxicology programme which concludes that higher levels of fluoride is linked to lower IQ in children. Sadly, some people need to hear obvious truths like this from so-called official sources before they believe it but it turns out the conspiracy theorists were right once again.

For almost 30 years, the editor of this newspaper has been writing about the health impact of water fluoridation and how Ireland is one of just a handful of countries where it is mandated by law.



Because they cannot see the toxins that are pumped into their tap water, parents blithely give it to their children in the same way they do vaccines. If they visited a fluoridation plant and saw the protective measures required by workers who add this poison to our most important natural resource they would surely think twice.

Why are the Irish people forced in law to take this neurotoxin? Were they asked? Why do they go along with it? Have they done the research that shows it causes harm? Or are they also damaged by the effects of fluoridation and do not care that the government is hurting them. Following the Covid scamdem, it would appear the latter is the case. It is a case of classic cognitive dissonance that is often associated with the Irish. They uncritically endorse the massive dumping of fluoride into the nation's water supply.

The recent court case in the US referenced more than 2,500 pages of scientific documentation detailing the risks of water fluoridation to human health, including more than 180 published studies showing that it is linked to reduced IQ and neurotoxic harm. Do you ever stop and wonder why we have so many children in Ireland whose brains are simply not working in the way they should? As an expert witness at the US case confirmed:

'If you are a pregnant woman, if you are the parent of an infant, this is where the science is showing it's happening by women consuming fluoride. It gets into the foetus and this is where the brain damage happens.'

Water fluoridation is a violation of our most fundamental rights. The government is medicating the population without permission. The truth is that fluoridation was never about preventing cavities in teeth because it does not protect them either. Why is it that 98% of western Europe rejects fluoridation but the Irish government continues to push it. When the editor of this newspaper first exposed the dangers of this toxin to Irish people in 2002, then Minister for Health Micheal Martin set up a forum of lobbyists to look into the matter. The forum was completely compromised and failed to examine the real harm. A decision was made to keep the practice in place. Martin is fully aware of the dangers.

Research dating back to the 70s revealed a link between cancer and water fluoridation, particularly bone cancer. Throughout the 80s, the evidence started piling up indicating a wide range of harmful effects, particularly arthritis. The Lancet reported in 2006 that fluoride is a neurotoxic substance that causes brain damage and lowers children's IQ. The same year, the National Research Council reported that fluoride is an endocrine disruptor which can interfere with the normal function of the thyroid and pineal glands. Fluoride has long been recognised as one of the most toxic elements found in the earth's crust. Fluorides are by-products of many industrial processes - especially the aluminium industry. When the State gets involved in medicating the population, people should take notice. What do fluoridation, pasteurisation and vaccination have in common? They are all biopolitical programmes related to the management of the population. People who question their health benefits are immediately labelled cranks by establishment media. That is all the more reason why we should question these practices.

Common household water filters do not remove fluoride, and unlike chlorine which steams off when water is boiled, fluoride becomes more concentrated. Perhaps the saddest thing about the Irish people is that they do not even take the time to ask what the government is putting into the water supply, not even on behalf of their innocent children who are more susceptible to the dangers than adults.

Out of 196 nations, only 24 have water fluoridation including Ireland. France, Germany, Belgium, the Netherlands, Denmark, Norway and Sweden have all banned the practice, many citing the ethical problem of putting any drug in drinking water. You have been warned.

# Make Cash Your Currency

## Push back against cashless whenever you can

**THE watermelon brigade (green on the outside, red on the inside) have reached that point in the climate deception that they have to bribe the public to 'save the planet'.**

We all know it's nothing to do with protecting the environment but gaining control over the masses. Few countries have shown themselves to be so subservient in this regard as Denmark who began the 'world's first climate-related social rewards scheme' this summer.

Only the Marxist stronghold of Copenhagen could come up with such wokery. It's called "CopenPay" and operates by giving gullible tourists who perform 'green actions' free rewards such as a vegan meal or a trip down the city's ski slope built on top of a dump. What else.

The official website describes the purpose of the scheme as follows:

...to encourage sustainable behaviour and enrich the cultural experience of visitors and residents in Copenhagen by transforming green actions into currency for cultural experiences. Our friends in Off-Guardian were quick off the mark noting: 'this is climate change based behavioural modification. This is a social credit system. For now, it's optional and only for tourists. They are testing the waters. Barring a catastrophic failure it won't stay that way for long. They likely won't ever make it mandatory to take part, rather – like bank accounts and cellphones – opting out will simply be too difficult for most people to bother with. Eventually "rewarding green actions" will segue into "punishing non-green actions". The currency of "cultural experiences" replaced with actual currency.

This isn't guesswork. We don't have to guess where this leads, because we know. They told us. They laid out the world they want to build, and this is just one of the first bricks.' (See [www.off-guardian.org](http://www.off-guardian.org) for more). Here in Ireland, we have to be extra vigilant about the creeping cashless society. Businesses and

services who refuse cash should be boycotted, and named and shamed on social media. The squeaky wheel gets the oil. You'll be surprised how quickly they will act if you simply refuse to use your card. You might also like to remind them it is against the law to refuse legal tender.

On a happier front, in Norway, new laws are being introduced to ensure customers can continue to pay with cash. At least 600,000 people there do not use digital payments and the government says they must be protected. What? A government actually on the side of the people for once? A spokesperson said: "We believe these groups must have the same opportunity to pay as everyone else and have therefore ensured that the right to pay with cash is strengthened,"

The proposals to strengthen the Financial Agreements Act were adopted by Norway's parliament this summer and entered into force on October 1st. New rules will make the situations in which customers have the right to pay with cash clearer.

The move to unstaffed tills in supermarkets isn't going so well either. Even the BBC have had to admit that it's a failed experiment: It's a common sight at many retail stores: a queue of people, waiting to use a self-checkout kiosk, doing their best to remain patient as a lone store worker attends to multiple malfunctioning machines. The frustration mounts while a dozen darkened, roped-off and cashier-less tills sit in the background. For shoppers, self-checkout was supposed to provide convenience and speed. Retailers hoped it would usher in a new age of cost savings. Their thinking: why pay six employees when you could pay one to oversee customers at self-service registers, as they do their own labour of scanning and bagging for free?

While self-checkout technology has its theoretical selling points for both consumers and businesses, it mostly isn't living up to expectations. Customers are still queueing. They need store employees to help clear kiosk errors or check their identifications for age-restricted items. Stores still need to have workers on-hand to help them, and to service the machines.

The technology is more trouble than it's worth.


*I was on holiday in Copenhagen last month and can confirm that the CopenPay scheme was indeed advertised to tourists.*

# Transmania hits new low

LGBT media is responsible for all manner of hostility from transgender activists

**PINKNEWS** bills itself as “the world’s largest and most influential LGBTQ+ led media brand,” and boasts that their allegedly “multi-award winning content leads the cultural zeitgeist, created through a uniquely inclusive lens.”

In reality, the website is the most extreme propaganda arm of the LGBT movement, and its “journalists” serve as attack dogs for delusional and increasingly violent transgender activists.

Consider their lead “story” from September 23: “Medical experts have warned that “tens of thousands” of trans people in England could be missing out on vital cancer screenings. The World Cancer Congress in Geneva, which took place from 17 to 19 September, highlighted the importance of regular cervical and breast cancer screenings for the trans community. However, transgender men are not currently offered breast or cervical screenings. And trans women whose GP details do not align with their gender, are not offered breast screenings, despite the NHS acknowledging that the use of combined HRT (a drug with oestrogen and progesterone) can slightly increase the chances of breast cancer.”

Now why, might you ask, are “transgender men” – that is, women – missing out on “regular cervical and breast cancer screenings”? Because they are identifying as men, and thus physicians understandably do not broach the subject. You see, men don’t have cervixes, and thus are not generally offered cervical screenings, just as women are not checked for testicular cancer. In other words, there is no discrimination or “transphobia” or any other fictitious injustices going on here. When medical professionals believe they are serving a man, they do not think to inquire about their cervixes.

It is essential, apparently, that people not simply be asked to provide this information to their physicians: “Putting the burden on the individual to approach the GP compounds existing healthcare inequalities for trans patients.”

Pink News added: “A recent study revealed that homophobia or transphobia can indirectly increase the chances of queer



people developing cancer and worsen health outcomes for those who do.”

To sum up: according to trans activists and PinkNews, trans-identifying people run the risk of cancer because doctors don’t realize they are trans-identifying, and this demands that we come up with any solution but asking trans-identifying people to provide this information, which would make them feel terrible. Not as terrible as severe illness, presumably, but bad enough that some trans activists think it’s worth running the risk.

Interestingly, for a website that bills itself as covering all things “LGBTQ+,” PinkNews seems to miss quite a bit. Like this story, for example: “Transgender Muslim ‘Wannabe Firefighter’ Requests Court Allow Him To Be Euthanized After Being Charged With Making Terroristic Threats.” Or perhaps this story, out of France: “Trans Activists Set Off Explosion in Attempt to Sabotage Conference Critical of Gender Ideology.”

Of course, that story would highlight a dangerous and growing trend – the radicalism and violence of trans activists, who are increasingly willing to use street-level violence to enforce their ideology, usually against women. Indeed, Andrew Doyle made this point in a September 23 column titled “Violence has become normalised within trans activism.” Doyle lays out the damning evidence, noting:

The violence we have seen over the past few years from trans activists is undeniable.

Virtually all protests of this kind involve some kind of demonstration of aggression, whether that be placards bearing phrases such as “Kill JK Rowling” or “Punch TERFs” or actual instances of physical hostility. Such rhetoric is now so commonplace that two SNP politicians were photographed next to an activist holding a placard with the slogan “Decapitate TERFs,” along with an image of a guillotine, and they didn’t even notice.

One oncologist suggested that to rectify this problem, trans-identifying patients have both their sex as well as their current identity plugged into the system, due to the fact that “we have busy lives” and “rely on these vital systems to remind us to access screenings” – but that “these screenings can be dysphoric for trans people.”

If it bleeds, it leads, the old media slogan goes. For PinkNews, that’s only true if it isn’t trans activists drawing the blood – and it generally is.

# COVID: THE TRUTH THEY

## SYMPTOMS

1. 'Covid19' and the flu have IDENTICAL symptoms. There are no symptoms or collections of symptoms unique or specific to 'Covid' and only 'Covid'. All 'Covid' symptoms are common to many other diseases and conditions, including the collection of common respiratory infections colloquially known as 'the flu'. This is readily admitted by mainstream sources and 'experts', who routinely describe 'Covid' symptoms as 'flu-like'. According to the US Center for Disease Control's own website comparing 'Covid' and the flu. You cannot tell the difference between flu and COVID-19 just by looking at the symptoms alone because they have some of the same symptoms. While the UK's NHS states: The symptoms [of Covid] are very similar to symptoms of other illnesses, such as colds and flu.

2. Early in the 'pandemic', it was reported that medical imaging revealed what they call 'ground glass opacity' in the lungs of suspected 'Covid' cases and that this was being used to diagnose patients, but ground glass anomalies are not unique to 'Covid'. According to a German paper published in the Radiologie journal in 2010: Ground glass opacity (GGO) is defined as diffuse pulmonary infiltration which can be caused by edema, airspace and interstitial pneumonia non-infectious pneumonitis as well as tumour manifestations. Physiological processes, such as poor ventilation of dependent lung areas and effects of expiration can also present as ground glass opacity. In 2022, the Lancet published a case study from an Indian doctor literally titled 'Ground glass opacities are not always COVID-19'. Another article, published by Health.com in May 2022, underlines that: Ground-glass opacities (GGOs) aren't specific to COVID-19- they can show up due to other conditions and infections. In short, GGOs are a common presentation of pulmonary illness or injury, and are associated with pneumonia and many other conditions.

3. A loss of smell and taste is NOT unique to 'covid'. It has been widely reported that a loss of the sense of taste and sense of smell is the telltale sign of 'Covid', but that is a known symptom of many upper respiratory infections. According to a 2001 article published on the website of the University of Connecticut School of Medicine: In adults, the two most common causes of smell problems that we see at our Clinic are: (1) Smell loss due to an ongoing process in the nose and/or sinuses such as nasal allergies and (2) smell loss due to injury of the specialized nerve tissue at the top of the nose (or possibly the higher smell pathways in the brain) from a previous viral upper respiratory infection. Changes in sense of smell are most often caused by a cold or flu, sinusitis (sinus infection) or allergies (like hay fever).



## DIAGNOSIS AND PCR TESTS



4. It is not possible to clinically diagnose 'Covid19'. Clinical diagnosis is the practice of diagnosing a disease based on a unique symptom or collection of symptoms. Since 'Covid19' has no unique symptomatic profile and since ALL major symptoms of 'Covid' can potentially apply to literally every common respiratory infection, it is impossible to diagnose 'Covid19' based on symptoms.

5. The most frequently used 'self-test' for 'Covid' were Lateral Flow Tests (LFTs). These tests are highly unreliable, and known to return positive test results from household liquids such as fruit juice and soda. Children frequently 'broke' their LFTs using vinegar or coca-cola in order to create false-positive tests and get a few days off school. The official position is that LFTs produce false negative results AND false positive results. Further, it is acknowledged that LFT and PCR results will often contradict one another. Meaning you can test positive on one, but not the other. Lateral flow tests are of almost no diagnostic value whatsoever.

6. PCR tests were not designed to diagnose illness. The Reverse-Transcriptase Polymerase Chain Reaction (RT-PCR) test is described in the media as the 'gold standard' for 'Covid' diagnosis. But Kary Mullis, the Nobel Prize-winning inventor of the process, never intended it to be used as a diagnostic tool and said so publicly: 'PCR is just a process that allows you to make a whole lot of something out of something. It doesn't tell you that you are sick, or that the thing that you ended up with was going to hurt you or anything like that.'

7. PCR Tests have a history of being inaccurate and unreliable. A Chinese study found the same patient could get two different results from the same test on the same day. Some tests in the US even reacted to the negative control sample. The late President of Tanzania, John Magufuli, submitted samples of goat, pawpaw, and motor oil for PCR testing; all came back positive. As early as February of 2020 experts were admitting the test was unreliable. Dr Wang Cheng, president of the Chinese Academy of Medical Sciences told Chinese state television 'The accuracy of the tests is only 30-50%'. The Australian government's own website claimed 'There is limited evidence available to assess the accuracy and clinical utility of available COVID-19 tests.' And a Portuguese court ruled that PCR tests were 'unreliable' and should not be used for diagnosis. The unreliability of PCR tests is not unique to 'Covid', either. A 2006 study found PCR tests for one virus responded to other viruses too. In 2007, reliance on PCR tests resulted in an 'outbreak' of Whooping Cough that never actually existed.

8. PCR tests are run in cycles: the number of cycles you use to get your result is known as your 'cycle threshold' or CT value. Kary Mullis said, 'If you have to go more than 40 cycles, there is something seriously wrong with your PCR.' Dr Fauci himself even admitted anything over 35 cycles is almost never culturable. The CDC's own data suggests no sample over 35 cycles could be cultured and Germany's Robert Koch Institute says nothing over 30 cycles is likely to be infectious. Despite this, it is known almost all the labs run their tests at least 37 cycles and sometimes as high as 45. The HSE 'standard operating procedure' for PCR tests rules set the limit at 40 cycles. Based on what we know about the CT values, the majority of PCR test results are at best questionable.



9. The scientific basis for ALL 'Covid' tests is questionable. The genome of the Sars-Cov-2 virus was supposedly sequenced by Chinese scientists in December 2019, then published on January 10th 2020. Less than two weeks later, German virologists (Christian Drosten et al.) had allegedly used the genome to create assays for PCR tests. They wrote a paper, Detection of 2019 novel coronavirus (2019-nCoV) by real-time RT-PCR, which was submitted for publication on January 21st 2020, and then accepted on January 22nd. Meaning the paper was allegedly 'peer-reviewed' in less than 24 hours. This process typically takes weeks. Since then, a consortium of over forty life scientists has petitioned for the withdrawal of the paper, writing a lengthy report detailing 10 major errors in the paper's methodology. They also requested the release of the journal's peer-review report, to prove the paper really did pass through the peer-review process. The journal has yet to comply. The Corman-Drosten assays are the root of every 'Covid' PCR test in the world. If the paper is questionable, every PCR test is also questionable.



10. The World Health Organization twice admitted PCR tests produced false positives. In December 2020, WHO put out a briefing memo on the PCR process instructing labs to be wary of high CT values causing false positive results: when specimens return a high Ct value, it means that many cycles were required to detect virus. Then, in January 2021, the WHO released another memo, this time warning that 'asymptomatic' positive PCR tests should be re-tested because they might be false positives. Where test results do not correspond with the clinical presentation, a new specimen should be taken and retested using the same or different technology. These announcements coincided with the initial launch of the 'covid vaccines'.

## CASES AND DEATHS

11. Huge numbers of 'Covid cases' are 'asymptomatic'. Early in the 'pandemic' it was reported that the majority of 'Covid cases' never exhibited any symptoms. In March 2020, studies done in Italy were suggesting 50-75% of positive Covid tests had no symptoms. Another UK study from August 2020 found as much as 86% of 'Covid patients' experienced no viral symptoms at all. A Chinese paper from March 2020 found over 80% of 'asymptomatic cases' were actually false positive test results. In short, the vast majority of 'cases' during the first year of the 'pandemic' were people who never got sick at all.



12. 'Covid case' numbers are inherently meaningless. From the onset of the 'pandemic', a 'Covid case' has been defined in terms guaranteed to artificially inflate statistics. The World Health Organization's definition of a 'confirmed case' is anyone who gets a positive PCR result, regardless of symptoms or personal history. Further, it is known that many health agencies around the world include 'probable cases' in their statistics. The WHO defines a 'probable case' as anyone who meets the 'clinical criteria' (ie has flu-like symptoms) and has been in contact either a 'confirmed case' OR another 'probable case'. As established above, PCR tests do not work and produce false positives. Lateral flow tests also produce false positives. It is known these tests may even give contradictory results for the same person at the same time. 'Covid19' also lacks a unique symptom profile, ruling out clinical diagnosis. If you cannot reliably test for the disease in a lab, and cannot identify it via a unique symptom profile, and many 'cases' are recognised as 'asymptomatic', then 'Covid19' becomes a label with no meaning. Absent any kind of reliable diagnostic method, case statistics for any disease are inherently meaningless.



13. 'Covid deaths' were created by statistical manipulation. Since 'Covid' case statistics are inflated, it naturally follows that 'Covid' death statistics would be likewise unreliable. In fact it was noted from the very beginning of the 'pandemic' that 'Covid death' counts were being artificially inflated. The WHO defined a 'Covid death' in the following terms: A COVID-19 death is defined for surveillance purposes as a death resulting from a clinically compatible illness in a probable or confirmed COVID-19 case, unless there is a clear alternative cause of death that cannot be related to COVID-19 disease (eg. trauma). Throughout the 'pandemic', many countries including Ireland went even further and defined a 'Covid death' as a 'death by any cause within 28/30/60 days of a positive test'. Considering the huge percentage of 'asymptomatic Covid infections', the well-known prevalence of serious comorbidities and the fact all 'Covid tests' are entirely unreliable, this renders the 'Covid' death numbers a completely meaningless statistic.



## LOCKDOWNS



14. Lockdowns kill people. Dr David Nabarro, World Health Organization special envoy for Covid-19 described lockdowns as a 'global catastrophe' in October 2020. 'We in the World Health Organization do not advocate lockdowns as the primary means of control of the virus - it seems we may have a doubling of world poverty by next year. We may well have at least a doubling of child malnutrition. This is a terrible, ghastly global catastrophe.' A UN report from April 2020 warned of 100,000s of children being killed by the economic impact of lockdown. Unemployment, poverty, suicide, alcoholism, drug use and other social/mental health crises are spiking all over the world. As of January 2023, healthcare services the world over are still experiencing chaotic backlogs in treatment and diagnosis. The knock-on effects of lockdown will likely hurt public health for years.

15. Lockdowns do not prevent the spread of disease. There is little to no evidence lockdowns have any impact on limiting 'Covid' deaths. If you compare regions that locked down to regions that did not, you can see no pattern at all.

16. Babies born during lockdown have lower IQs. A study done at Brown University found that children born after March 2020 had, on average, IQs 21 points lower than previous generations. This mirrors reports in older children (aged 4-5) of stunted development of social skills and inability to read facial cues.

17. Hospitals were never unusually overburdened. The main argument used to defend lockdowns is that 'flattening the curve' would prevent a rapid influx of cases and protect healthcare systems from collapse. In March 2020, it was reported that hospitals in Spain and Italy were overflowing with patients, but this happens every flu season as it does in Ireland. During an alleged deadly pandemic, they actually reduced the maximum occupancy of hospitals. Despite this the HSE never felt any pressure beyond the typical flu season.

18. There was a massive increase in the use of 'unlawful' DNRs. Watchdogs and government agencies reported huge increases in the use of Do Not Resuscitate Orders (DNRs) in the years 2020-2021. As early as March 2020, when the 'pandemic' was still in its early stages, there were already papers appearing in mainstream journals predicting 'unilateral' DNR usage, something which had 'rarely had a role prior to Covid'; clinicians in some health care settings may unilaterally decide to write a DNR order. This latter approach is not uniformly accepted and, prior to COVID-19, it rarely had a role. A study done by Sheffield University found over one-third of all 'suspected' Covid patients had a DNR attached to their file within 24 hours of hospital admission.

## VENTILATORS



19. Ventilation is NOT a treatment for respiratory infections. Mechanical ventilation is not, and never has been, recommended treatment for respiratory infection of any kind. In the early days of the pandemic, many doctors came forward questioning the use of ventilators to treat 'Covid'. Writing in The Spectator, Dr Matt Strauss stated: Ventilators do not cure any disease. They can fill your lungs with air when you find yourself unable to do so yourself. They are associated with lung disease in the public's consciousness, but this is not in fact their most common or most appropriate application. German Pulmonologist Dr Thomas Voisard, chairman of the Association of Pneumotology Clinics said: When we read the first studies and reports from China and Italy, we immediately asked ourselves why intubation was so common there. This contradicted our clinical experience with viral pneumonia. Despite this, the WHO, CDC, ECDC and NHS all 'recommended' Covid patients be ventilated instead of using non-invasive methods. This was not a medical policy designed to best treat the patients, but rather to reduce the hypothetical spread of Covid by preventing patients from exhaling aerosol droplets, this was made clear in officially published guidelines.

20. Ventilators kill people. Putting someone on a ventilator who is suffering from influenza, pneumonia, chronic obstructive pulmonary disease, or any other condition which restricts breathing or affects the lungs, will not alleviate any of those symptoms. In fact, it will almost certainly make it worse, and will kill many of them. Intubation tubes are a potential source of an infection known as 'ventilator-associated pneumonia', which studies show affects up to 28% of all people put on ventilators, and kills 20-55% of those infected. Mechanical ventilation is also damaging to the physical structure of the lungs, resulting in 'ventilator-induced lung injury', which can dramatically impact quality of life, and even result in death. Experts estimate 40-50% of ventilated patients die, regardless of their disease. Around the world, between 66 and 86% of all 'Covid patients' put on ventilators died. According to the 'undercover nurse', ventilators were being used so improperly in New York, they were destroying patients' lungs.



# KEPT HIDDEN FROM YOU



## MASKS



21. Masks don't work. At least a dozen scientific studies have shown that masks do nothing to stop the spread of respiratory viruses. One meta-analysis published by the CDC in May 2020 found "no significant reduction in influenza transmission with the use of face masks". A Canadian review from July 2020 found "limited evidence that the use of masks might reduce the risk of viral respiratory infections". Another study with over 8000 subjects found masks "did not seem to be effective against respiratory infections nor against clinical respiratory infection." Dr Denis Rancourt cites studies from 2009, 2010, 2012, 2016, 2017 and 2019, none of which found any significant benefit at all from wearing a mask. And, most tellingly, in their own report on influenza from 2019, the WHO itself noted that: there is no evidence that [masks are] effective in reducing transmission.

22. Masks are bad for your health. Wearing a mask for long periods, wearing the same mask more than once, and other aspects of cloth masks can be very dangerous. A long study on the detrimental effects of mask-wearing was published by the International Journal of Environmental Research and Public Health. Dr. James Meehan reported in August 2020 he was seeing increases in bacterial pneumonia, fungal infections, and facial rashes. Masks are also known to contain plastic microfibers, which damage the lungs when inhaled and may be potentially carcinogenic. Children wearing masks encourages mouth-breathing, which results in facial deformities. People around the world passed out due to CO2 poisoning while wearing their masks, and some children even suffered sudden cardiac arrest. Moreover, masks may actually increase the likelihood of respiratory disease. Moisture retention, reuse of cloth masks and poor filtration may result in an increased risk of infection. While a new study published in July 2022 found that masks, especially those worn more than once, were breeding grounds for both bacteria and fungal microbes.

23. Masks are bad for the planet. Millions upon millions of disposable masks have been used per month for over a year. A report from the UN found the Covid19 pandemic will likely result in plastic waste more than doubling in the next few years and the vast majority of that is face masks. The report goes on to warn these masks (and other medical waste) will clog sewage and irrigation systems, which will have knock-on effects on public health, irrigation and agriculture. A study from the University of Swansea found "heavy metals and plastic fibres were released when throw-away masks were submerged in water." These materials are toxic to both people and wildlife.

24. Covid "vaccines" are totally unprecedented. Before 2020 no successful vaccine against a human coronavirus had ever been developed. Following the advent of "Covid", we allegedly made over 20 of them in 18 months. Scientists have been trying to develop a SARS and MERS vaccine for years with little success. Whereas the theory behind traditional vaccines is that exposing the body to a weakened strain of a microorganism will trigger an immune response (which is also bogus), many of these new Covid "vaccines" are mRNA vaccines. mRNA (messenger ribonucleic acid) vaccines theoretically work by injecting viral mRNA into the body, where it replicates inside your cells and encourages your body to recognise, and make antigens for, the "spike proteins" of the virus. mRNA vaccines have been the subject of research since the 1990s, but before 2020 no mRNA vaccine was ever approved for use on humans. Yet, following the advent of Covid, two different companies made two supposedly "safe and effective" mRNA vaccines within weeks of each other.

## VACCINES

25. "Covid vaccines" do not confer immunity or prevent transmission. It is readily admitted that Covid "vaccines" do not confer immunity from infection and do not prevent you from passing the disease onto others. Vaccine trials were not designed to even try and assess if the vaccines limited transmission. The vaccine manufacturers themselves, upon releasing the vaccines, were quite clear their product's "efficacy" was based on "reducing the severity of symptoms". In October 2022, Pfizer executive Janine Small, testifying in front of the EU parliament, admitted that Pfizer never even tested if their vaccine prevented transmission of "Covid" prior to its release to the public.

26. The vaccines were rushed and have unknown long-term effects. Vaccine development is a slow, laborious process. Usually, from development through testing and finally being approved for public use takes many years. The various vaccines for Covid were all developed and approved in less than a year. Moderna's own website admits "it normally takes 10-15 years to develop a vaccine", but boasts of producing their SpikeVax "within 2 months". Obviously, there can be no long-term safety data on chemicals that are less than a year old. Pfizer admits this is true in the leaked supply contract between the pharmaceutical giant, and the government of Albania: the long-term effects and efficacy of the Vaccine are not currently known and that there may be adverse effects of the Vaccine that are not currently known. Further, none of the vaccines have been subject to proper trials. Many of them skipped early-stage trials entirely, and the late-stage human trials have either not been peer-reviewed, not been released or were abandoned after "severe adverse effects". 27. Vaccine manufacturers have been granted legal indemnity in Ireland should they cause harm. The EU's product licensing law does the same, and there are reports of confidential liability clauses in the contracts the EU signed with vaccine manufacturers. The leaked Albanian contract suggests that Pfizer, at least, made this indemnity a standard demand of supplying Covid vaccines. Purchaser hereby agrees to indemnify, defend and hold harmless Pfizer from and against any and all suits, claims, actions, demands, losses, damages, liabilities, settlements, penalties, fines, costs and expenses.

28. Covid "vaccines" carry a significant risk of adverse side effects. The experimental injections have potentially caused thousands of deaths in Ireland and severe conditions in countless people. These include myocarditis (especially in young males) blood clots, allergic reactions, skin conditions, Bell's Palsy, menstrual irregularities and more. The US CDC's Vaccine Adverse Event Reporting System (VAERS) has received twice as many reports since the covid vaccine rollout than all previous years combined.



## MORTALITY DATA



29. The survival rate of "Covid" is over 99%. A global review of Covid data, published in October 2022 by Stanford epidemiologist John Ioannidis (et al) found a median fatality rate of just 0.07% in people younger than 70 years old. Almost all antibody studies on the infection-fatality ratio (IFR) of Covid have returned results between 0.04% and 0.5%. Meaning, assuming for a moment that "Covid" ever existed as a discrete disease at all, which it has never been proven to, its survival rate was at least 99.5%.

31. Average age of "Covid death" is greater than the average life expectancy. The average age of a "Covid death" in Ireland is 82 years. In Italy, it's 86. Germany, 83. Switzerland, 86. Canada, 86. The US, 78. Australia, 82. In almost all cases the median age of a "Covid death" is higher than the national life expectancy. Research from March 2021 found that, across the eight studied countries, more than 64% of all "Covid deaths" occurred in people over the national life expectancy. As such, for most of the world, the "pandemic" had little-to-no impact on life expectancy.

30. The vast majority of "covid deaths" have serious comorbidities. In March 2020, the Italian government published statistics showing 99.2% of their "Covid deaths" had at least one serious comorbidity. These included cancer, heart disease, dementia, Alzheimer's, kidney failure and diabetes. Over 50% of them had three or more serious pre-existing conditions. This pattern has held up in all other countries over the course of the "pandemic". An October 2020 FOIA request in the UK revealed less than 10% of the official "Covid death" count at that time had Covid as the sole cause of death. In summary, the vast majority of "Covid deaths" were very frail people. This was interpreted by the press as old age or infirmity being "risk factors" for "Covid". However, it could be more accurately said the number one risk factor for "dying of covid" was already dying of something else.

32. Covid mortality exactly mirrors the natural mortality curve. The risk of death "from Covid" follows, almost exactly, your background risk of death in general. The small increase for some of the older age groups can be accounted for by other factors.

33. There has been NO unusual excess mortality. The global death toll of "Covid", even with exaggerated statistics was never high enough to justify the draconian responses we saw from most world governments. In three years of "covid", there have been roughly 6.8 million "Covid deaths", or 2.3 million per year. That's 0.03% of the global population. For comparison's sake, the Spanish Flu of 1918 killed 25-100 million people in two years, or between 0.7 and 2.8% of the global population per year. The press has called 2020 the UK's "deadliest year since world war two", but this is misleading because it ignores the massive increase in the population since that time. 2020 isn't even the worst year for mortality since 2000. In fact, since 1943 only 9 years have been better than 2020.



## PLANNING AND DECEPTION



34. The EU was preparing "vaccine passports" at least a YEAR before the pandemic began. Proposed COVID countermeasures, presented to the public as improvised emergency measures, have existed since before the emergence of the disease. Two EU documents published in 2018, the "2018 State of Vaccine Confidence" and a technical report titled "Designing and implementing an immunisation information system" discussed the plausibility of an EU-wide vaccination monitoring system. In fact, vaccination and immunisation programs have been recognised as "an entry point for digital identity" since at least 2018. Founded in 2016, ID2020 is a corporate-governmental "alliance" dedicated to "providing digital identity to all". In March 2018, the ID2020 published an article headlined: "Immunization: an entry point for digital identity", in which the author argues: immunisation poses a huge opportunity to scale digital identity. ID2020 was founded jointly by Microsoft, the Rockefeller Foundation and GAVI the Vaccine Alliance. Its "partners" include Facebook, and the UN.

35. A "training exercise" predicted the pandemic just weeks before it started. In October 2019 the World Economic Forum and Johns Hopkins University held Event 201. This was a training exercise based on a zoonotic coronavirus starting a worldwide pandemic. The exercise was sponsored by the Bill and Melinda Gates Foundation and GAVI the vaccine alliance. The exercise published its findings and recommendations in November 2019 as a "call to action". One month later, China recorded their first case of "Covid".

36. Covid-sceptic world leaders "died suddenly". Multiple political leaders who opposed the World Health Organization's Covid policies died unexpectedly, only to see their anti-WHO covid policies reversed immediately by their successors. On the 3rd of May 2020, President Pierre Nkurunziza of Burundi dismissed Covid as "a hoax". Three days later the Council on Foreign Relations warned of "dangerous trends in Burundi's democracy". On May 14th 2020 Nkurunziza formally expelled the WHO representatives from Burundi. Less than a month later, he died "of a sudden illness". His successor labelled Covid "our biggest enemy", and invited the WHO back. There was an almost identical situation in Tanzania, where Covid-sceptic president John Magufuli questioned the accuracy of the PCR tests and banned the use of Covid vaccines in his country. In March 2021, Magufuli disappeared from public view for weeks. Again, the Council on Foreign Relations published an article calling for his removal, and again it was reported he had died suddenly. His successor reversed course on Covid immediately, enforcing quarantines, social distancing and mask-wearing, as well as signing Tanzania up to the WHO's vaccine program and jabbing 10 million of her citizens.

37. During the "Covid pandemic", the Flu almost completely "disappeared". In April of 2021, Scientific American published an article headlined: Flu Has Disappeared for More Than a Year. The explanation given is that anti-Covid measures - eg, masks and lockdowns - stopped flu spreading. But we have established that masks and lockdowns do not halt the spread of respiratory illnesses. In short, globally, the flu almost completely disappeared throughout 2020 and 2021, and that cannot be explained by anti-Covid measures. Meanwhile, a new disease called "Covid", which has identical symptoms and a similar mortality rate to influenza, was apparently affecting all the people normally affected by the flu.

38. The Covid pandemic advanced a pre-existing political agenda. From its earliest days, Covid was used as an excuse to push through reforms of food, identity and monetary systems, as well as advance "green" agendas that centralise both global and national power. As early as March 2020, former UK Prime Minister Gordon Brown was calling for a "global government" to tackle the pandemic. The pandemic also saw an increase in censorship and surveillance powers. In September 2018, the important role of "digital identity" in the future "social contract" was a major talking point at Davos. By December 2020, The Economist reported that "Covid-19 spurs national plans to give citizens digital identities". In January 2019, it was reported the Bank of International Settlements and 70 central banks around the world were involved in research on central bank digital currencies (CBDCs). In July 2021 FinTech times reported that the pandemic had "accelerated the development of Central Bank Digital Currencies by up to five years". Throughout 2019, articles and papers called for a "radical transformation" of the global food system. By 2021 Deloitte was reporting that "Covid" had "accelerated food transformation". Finally, the pandemic opened the door for sweeping globalist changes to public health policies in the form of the proposed "Pandemic Treaty".

39. Corporations saw MASSIVE profits due to Covid. Companies in multiple sectors saw huge profits due to the "pandemic", most of which arose from increases in government spending putting public money in private hands. The global market for facemasks, for example, expanded by over 15000%, from \$1.4 billion in 2019 to \$225 billion in 2020. And that's just facemasks, not other forms of personal protective equipment (PPE) which all saw massive increases in both personal and government spending. Rubber gloves and hand sanitizers also saw huge upticks in their market thanks to government spending. Amazon saw its profits double thanks to covid, and streaming platforms added millions of new users thanks to lockdowns. However, the biggest profits were seen in the vaccine sector. Since the vaccine rollout, pharmaceutical companies have made roughly \$1000 a second. In late 2019, Pfizer's revenues were the lowest they had been since 2010, two years later they had increased by 150%, and were the highest they had ever been. Within months of the vaccine rollout, 9 vaccine manufacturers had become billionaires. By May of 2022, that number had risen to 45.

40. The elite have made fortunes during the pandemic. It is not just pharmaceutical companies that have profited from Covid, since the beginning of lockdown the wealthiest people have become significantly wealthier. In October 2020, Business Insider reported that "billionaires saw their net worth increase by half a trillion dollars" in just the first six months of the pandemic. By April 2021 Forbes was reporting that 40 new billionaires have been created "fighting the coronavirus". That process has only accelerated. As of May 2022, the number of new billionaires created by the pandemic stood at 545. Or roughly one every 30 hours for the previous two years. That includes 40 new billionaires in the pharmaceutical sector alone. Meanwhile, the share of the world's wealth held by billionaires has increased from 10% in 2019 to 14% in 2022, a greater increase than the previous 16 years combined. Altogether, the richest people in the world increased their collective wealth by over five trillion dollars in the past three years, all thanks to Covid.

# YOU CAN'T CATCH A COLD

They're laughing at you as you traipse to your recycling depot laden down with plastic bottles to get your 'deposit' back on bottles



The Re-turn company is non profit (appears to be making a killing currently but alas) but its members are all large drink manufacturers. The only real impact the scheme has had on them is to ensure they all use standardised plastics. What has been introduced needlessly, is the requirement for Irish market specific packaging labels (the Re-turn logo). Anecdotally, I've noticed rather significant price increases in drinks since the scheme was introduced, on top of the deposit. Whatever about the intention of the scheme at the outset, we let the drinks producers create a scheme that benefits them and inconveniences and costs us, and let them take the credit for being 'green'. The companies who are addicted to cheap, oil based plastics should be facing upheaval, but instead their position is better than ever huge barrier compared to other markets, and thus reduced choice for Irish consumers.

Well said! Best way to avoid scams like this? Stop buying plastic bottles - most of what they contain is bad for your health.


The labels 'biodegradable' and 'compostable' are also marketing scams. It just means they break down marginally faster and usually into microplastics which get into our food and water supply.

# Chemo Is The Killer Not Cancer


Understanding the cause of illness is at the heart of groundbreaking German New Medicine

**IN 1997, I read a book that outlined the discoveries of Dr Ryke Geert Hamer, the inventor of New German Medicine (Germanische Heilkunde or GHK). This was the first time I learned something about medicine and biology that I could actually understand, rather than just having to believe in. Since then, GHK has played a significant role in my life.**

Every organ, every tissue, and every cell in our body has its specific task and function. If a biological conflict shock arises in this task, our brain activates a special biological programme that effectively helps us to resolve this conflict. Depending on where this tissue belongs, the conflict results in either cell growth, cell degradation, or loss of function. This cell change changes or improves the organ function in such a way that we can better resolve our conflict shock in real terms.

New German Medicine classifies the Five Biological Laws Of Nature. The 1st Biological Law describes the causes of diseases that arise by themselves, such as cancer, chronic diseases, allergies, and psychoses. It does not apply to poisoning, injury, and extreme malnutrition. The 2nd Biological Law states that every SBS (Sensible Biological Special Programme) has a healing phase, provided that a conflict resolution occurs. This healing phase usually lasts as long as the conflict is active. The 3rd Biological Law states that an SBS controlled by the old brain (brainstem + midbrain + cerebellum) makes cell proliferation in the active phase. An SBS that is controlled by the new brain (cerebral medulla + cerebral cortex) causes cell loss (necrosis, ulcers) in the active phase. The 4th Biological Law describes how microbes, without exception, act as nature's surgeons by breaking down the old-brain-controlled tumours tuberculously during the healing phase while microbes replenish the new-brain-controlled necroses through swelling. At the end of the healing phase, the microbes withdraw again. The 5th Biological Law describes the biological purpose of every special programme. A mother enters the garden and sees her child lying motionless under a tree. She suffers a DHS (Dirk Hamer Syndrome named after Dr Hamer's son who was fatally wounded in a bizarre shooting incident resulting in the onset of his father's testicular cancer), described as an unexpected, highly acute, and isolating conflict shock that occurs simultaneously in the psyche, the brain, and on the corresponding organ) a mother/child worry conflict.

From this moment on, the mammary glands of her left breast begin to divide (if she is right-handed). The biological purpose of this SBS is to provide the injured child with more milk for better recovery. As long



as this DHS (conflict shock) has not been resolved, the mammary glands divide, and the lump can be palpated after two weeks. Only when the mother receives the message from the hospital that the child will soon be well again, will she resolve this conflict in real terms. The tumour that has grown up to this point is now being broken down again by the fungal bacteria in a tuberculous decomposition manner. (Healing phase)

The biological meaning was to provide the child with more milk for better recovery. This may not always be necessary in our modern world, but these biological special programmes (SBS) have been programmed into us for thousands of years. The idea of a "conflict shock" or DHS is central to German New Medicine.

The DHS (Dirk Hamer Syndrome) is the linchpin of every special programme (SBS) commonly referred to as "disease". Except for environmental poisoning and accidents, the DHS is the cause of our symptoms. Finding the DHS and resolving it in real terms is the "therapy" of Germanische Heilkunde. Only when the conflict can be resolved, will our body switch to the vagotonic healing phase and reverse the cell changes of the previous active phase. At the end of the healing phase, we are healthy again.

Dr. Hamer's research involved brain scans and their correlation with diseases. Our brain directly controls every organ and its function. If a conflict shock (DHS) arises, we always have a change on three levels.

In the psyche, we have obsessive thinking. The unresolved conflict shock (DHS) haunts us into our dreams and keeps us awake at night. Thus, our psyche forces us to seek a quick and real solution to the conflict. From the second of the DHS, a HH (Hamer Focus) is present in the relevant relay in the brain and can be photographed with a computer tomograph (CT scan). This Hamer Focus looks similar to an onion; regardless of the angle one cuts through, one can

see the ring-shaped structure. These ring structures (HH) can be seen with the naked eye during open brain surgery, and we can see the corresponding tissue changes or loss of function in the organ. With conflict resolution, these rings become blurred and retain edema. Therefore, we can tell from the brain CT whether a conflict is active, already resolved, or in the hanging healing process (chronic disease, allergy).

One hundred fifty years ago, Louis Pasteur claimed that microbes make us ill. Although he revised this opinion on his deathbed, a global and very lucrative business concept had already been developed based on this statement. What we call illness is usually the vagotonic healing phase. The microbes are our healing phase optimisers, our body's own surgeons, which, depending on the tissue ("germ layer"), either break down tissue that is no longer needed (tumour) in a tuberculous manner (fungi and fungal bacteria), or rebuild necroses (cell loss) from the active phase (bacteria).

The virus is always claimed to be present in the healing phase of the squamous epithelium, but yet has never been seen by the human eye. There is no instance in which a microbe is the cause of our healing phase symptoms. However, this is what conventional medicine leads us to believe. The conventional doctor's war in our bodies against microbes—our faithful helpers and healing phase optimizers—is one we pay for, if we're lucky, only with money. In Germanische Heilkunde, we no longer use the word cancer. The term is laden with fear, and the diagnosis of "cancer" alone almost always causes new conflict shocks such as "fear of death conflict" (lung cancer) and many others. If I suffer a scent conflict with the nasal mucosa and resolve it after a few seconds, I will sneeze once in the crisis, and that's it. There will be no further symptoms. However, if I only resolve the same scent conflict after a week, I will have a cold in the healing phase. But if I need three months to resolve the same conflict,

conventional medicine then will then speak of nasal mucosal cancer. If I see that my dog has blood in his stool, and I stroke him with pity and tell him: "You poor thing, you have bowel cancer!" What will the dog do? He will wag his tail and be happy that his owner is taking notice of him. He will lie down in a quiet corner and wait patiently until his body has completed the healing phase. But when a doctor tells his patient that he has cancer, the word pulls the ground from under the patient's feet, and the patient usually suffers several subsequent conflicts. For example, one may experience a fear of death conflict, and only two weeks later, one can already see the first shadows on the lung X-ray, which seemingly confirms the doctor's initial diagnosis brilliantly.

But the cause of this lung cancer is the fear of death conflict that the poor patient has received from the doctor.

No researcher or doctor has ever found evidence of alleged "cancer cells" in the blood. They pretend that these cancer cells exist in the blood or lymphatic system because otherwise, the metastases could not be explained, but there is no evidence of them, except in the case of leukemia. The absurd assertion that, for example, a bone cancer cell (which makes holes in the bone) is supposed to transform into a lung cell on its way to the periphery to cause a lung tumour in the lungs has not yet been explained by any doctor, not even theoretically.

There are around 1000 different branches of medicine worldwide. Conventional medicine, homeopathy, Chinese etc. They all have one thing in common. They do not know the cause of disease and focus exclusively on getting rid of the symptoms. The only difference is the method. The most brutal of all is conventional medicine. It poisons (chemo), burns (radiation), and cuts away (scalpel), but the physicians don't know the cause of any symptom, nor are they interested in the cause. But if I cut away the symptom without solving the cause, the symptom will return. The definition of the term "experimental therapy" is the therapy of any symptom whose cause is unknown. They do human experiments with us. They poison us with chemo, cut out parts of our brains, and bet on how long we will still be walking around. Chemo is a cytostatic (Latin: cell stop) - it's a derivative of mustard gas. According to the Geneva Convention of 1925, using poison gas in war to kill enemy soldiers is a war crime. However, if this poison gas is injected into the patient's body, it's called "therapy." The result remains the same: poison gas will always do what it was made to do.

# The Patrick Nugent Murder

The 1984 murder of Patrick Nugent has been covered up by the Gardai and media for decades. The question is why

**IN February of 1984, a party was held at the Folk Park near Bunratty Castle in Co. Clare. Over 60 people attended. When the party was over, there were less than a dozen people left behind and the function manager, Patrick Nugent, was dead aged just 23.**

There is evidence to suggest that a car accident had something to do with his death. But nobody on the night admitted publicly to seeing what happened. William Ryan was afterwards charged with manslaughter but was subsequently acquitted on all counts. There are still many unanswered questions about the death of Patrick Nugent. The fact that two gardai who were at the party tried to cover up the initial garda investigation fostered suspicion about the circumstances in which Patrick (pictured above) died. In recent weeks, the gardai have been engaged in a PR exercise surrounding the murder - brought about in no small part by the efforts of Patrick Nugent's family who continue to seek justice for him. His body has been exhumed in what appears to be a stunt to delude the public that the gardai intend to tell them what really happened that evening 40 years ago. Given the guards' track record in exposing internal corruption, we are unlikely to find out. This article was published by investigative journalist Derek Dunne in 1985 and was one of the more forensic pieces about the mysterious death.

## The party took place on a Friday night

Patrick drove his Datsun Cherry from his home at Sixmilebridge, Clare, to Bunratty Castle. He was the function manager and started to arrange the food for the guests. Pat's job was to make sure the entire affair ran smoothly.

The party was organised by William and Chrissie Ryan saw him. Ryan had worked as a chef in Shannon for thirty-five years. It was his 40th wedding anniversary.

It was 7.15pm when the couple arrived at Bunratty. Ryan parked his car in front of the reception area. Detective Garda Eugene Quinlan and his wife Alison were the first



guests to arrive. He had been a garda for 21 years and was a neighbour of the Ryans. Drink was served liberally at the party and the meal finished around 11pm. All the left over food was cleared, put into a van and locked away. The guests were given anniversary cake. William Ryan told some of his guests at the end of his speech that they were welcome to take home left over food if they wished. People danced as the band played on, finishing with the national anthem at around 3am.

Patrick Nugent was in and out of the function room as the guests began to leave. Ashtrays, bottles, candles and glasses were all being cleared away. Around 4am, there were no more than a dozen people left. William Ryan and his wife decided to leave. Patrick Nugent left the function room. Shortly afterwards, a crash was heard, then roaring. Those who rushed out to the reception area, where the noise had come from, were later to give different accounts of what they had seen. Patrick was holding his stomach in obvious pain, collapsed on the ground. Outside the reception area, William Ryan's car appeared to have hit a car belonging to another guest, Garda Jim Cummins. It was agreed that the two men would fix the matter up between themselves. Ryan was encouraged to go home. He had no knowledge of seeing or hitting Patrick Nugent.

The two gardai claimed they tried to revive Patrick when he became unconscious. An observer heard Patrick say before he

died, "He clocked me." He said it three times. A doctor and ambulance arrived and Patrick was taken to Barringtons Hospital in Limerick. He was pronounced dead at 5.15am.

William Ryan gave three statements to the gardai. He was then charged with manslaughter, dangerous driving and failing to keep his vehicle at the scene of an accident. When the case came to trial, the manslaughter charge was withdrawn by the State. The jury found William Ryan 'not guilty' on the other two counts.

At the relatively young age of 23, Patrick Nugent had 'made good'. When he was fifteen, he left school and worked at Bunratty, cooking for the banquets that catered mainly for American tourists. He was a hard and diligent worker. William Ryan was a chef there and he picked out Patrick to train. He made a lot of money for the company in banquets. He was finally promoted to function manager. He was planning to get married and travel to England and Australia to visit relatives. At the time, Bunratty attracted more than 70,000 visitors a year. They either came to the Castle, or to one of the functions in the nearby barns.

Chef William Ryan was forty years married, and had worked for thirty-five years at Shannon. He was going to invite about sixty people to a party at the Folk Park to celebrate. All the food and drink would be supplied by the company and he would pick up the bill. It was going to be special. People he had known for decades, friends, relatives, and a few executives from

Shannon would be there. He knew that Patrick would do a good job. He asked him to take charge of the party. Patrick agreed. When Patrick was killed, rumours of cover up emerged immediately. It was implied that he had been killed and that somehow William Ryan had been "set up".

The pathologist who carried out the post mortem on Patrick found a bruise on his left cheekbone, a linear bruise on his right arm and bruises on the back, just above the hips. The liver was ruptured and the right lobe was minutely fragmented. There was also bruising of the right kidney, pancreas and adrenaaline gland. Eight ribs were fractured. The apex of the heart was bruised. In Dr Bennett's opinion, the death was consistent with a crushing injury and being struck by a car. Failure of heart and lungs was the cause of death. However, he also said that Patrick was not erect when he was hit. He was in a "crouching" position or lying on the ground. But in order for this to happen, Patrick would have had to be in a position about eighteen inches off the ground without bending his knees. Otherwise, there would have been damage to his legs. There were no injuries on Nugent's arms, indicating that he had not put out his arms in a reflex action to protect himself against an oncoming car. Dr Michael Flynn had made a cursory examination of the body and had found small scratches on the small of the back.

# Another Garda Cover-Up

**ON the balance of probability, Patrick was lying on the ground when he was struck. No-one knows how he came to be lying on the ground. This lack of knowledge was compounded by an attempted cover-up by the two gardai who had been at the party.**

Suggestions were made that Eugene Quinlan and another guest Gerard O'Connor were having a fight and Patrick went over to break it up. Both men denied in court that they had any row during the night. William Ryan said that he saw a "ferocious argument" going on between two men. A barman at the party said he thought the two men were also having a disagreement earlier on in the night.

Two Gardai arrived at the Folk Park shortly after the ambulance left at 5.15am. Garda John Talty asked what had happened but no-one was willing to answer. Jim Cummins said something about Patrick Nugent getting a heart attack. Talty went outside and Eugene Quinlan told him that there wasn't a mark on the body. At one stage, Jim Cummins put his two wrists together and said "you're coming for me lads." "Come on lads. What the f\*\*\* happened here? Do you think we're idiots," Garda Talty told the two men. He then asked Cummins what had happened to his car. Cummins replied that William Ryan had hit it and that they were going to fix it up between themselves. Quinlan called Talty aside into a small room and again told him that there wasn't a mark on the body. Patrick Crowe came into the room and was asked to leave. He was keyholder for the Folk Park and had been called to the area by the gardai. The alarm had been set off when the ambulance was called. When Crowe left the room, Quinlan told Talty to "do the best you can for Jim's sake." Garda Talty admitted in court that he did not enquire what "you're coming for me lads" or "do the best you can for Jim's sake" meant.

Around 7am, the gardai called to Joe Nugent at Sixmilebridge. He was told that his son had died of a heart attack. To Joe Nugent's best knowledge, his son had never attended a doctor in his life. He was then asked if anyone had it in for him. The circumstances surrounding the killing were such as to breed rumours locally. The head of the Investigation Section of the Technical Bureau in Dublin, Detective Superintendent John Courtney, took charge of the investigation after five days. A week later, he arranged for William Ryan to be brought to the garda station. He indicated to him that the forensic report showed that his car was involved in the incident which caused injuries to Patrick Nugent and eventually led to his death. Ryan made a third statement to the gardai. Even

though he said that he had no recollection of hitting Patrick Nugent, he accepted that this must be so because of the evidence. He was then charged with manslaughter, dangerous driving and failing to keep his vehicle at the scene of an accident. Notice to prosecute had previously been served on Ryan. It had also been served on Jim Cummins. No charges were preferred against Cummins.

The gardai had also been told by Pat Crowe that Declan O'Neill had said that Nugent's last words were "he clocked me". Declan had started work at 3pm that afternoon. He had worked in the kitchen until midnight. Around 4am, Patrick Nugent told him to go and clear up the kitchen. He was there about five minutes when he heard roaring. He went out to the Function Room and then into the reception area. Patrick was lying inside the main door on his back. There was no-one else there apart from Alison Quinlan, Eugene Quinlan's wife. Patrick was holding his stomach and said "my stomach" twice. He then said "he clocked me", twice. Declan O'Neill tried to pick him up. Patrick said again "he clocked me". O'Neill looked to his right and saw Detective Quinlan standing there. According to O'Neill, Quinlan did not come from outside, and neither did he come from inside. Jim Cummins then came along and told him to leave Patrick alone. O'Neill looked out into the courtyard and saw William Ryan and his wife sitting in his car. There were two crashed cars including Ryan's. The second belonged to Garda Cummins.

Both Detective Quinlan and Garda Cummins said that they tried to revive Patrick when he seemed to pass out. They removed his tie and opened his shirt. Quinlan tried artificial respiration and thought that Nugent's eyes opened and that he was breathing. Garda Cummins had slapped Nugent on the face a couple of times when he realised that he was unconscious. There is some conflict about where the cars of the two gardai, Quinlan and Cummins, were parked and at what times. What is clear is that at 4am the cars of Quinlan, Cummins and William Ryan were parked outside the reception area. Cummins said he parked his car there, having brought it in from the car park, at 3am. Quinlan says he parked his car there between 3.30am and 3.45am. However, three witnesses, Edward Quish, Mrs Titley and Con Ford, all said that when they left at 3.45am only William Ryan's car was parked at reception. Quinlan and Cummins were at various times going and coming from the kitchen, getting food. They were, they said, transferring the food to their cars just outside the reception area.

What is significant about whether or not the cars were brought in from the car

park earlier is that William Ryan said in statements to the gardai that when he got into his car and started it, it jumped forward (it is an automatic). When he struck Cummins' car, he said, it "came out of nowhere" and he thought it was being driven at the time. Jim Cummins denied this in court. Eugene Quinlan also denied being outside at a time close to 4am.

There is a major conflict of evidence between those that remained at the party as to where various people were when the noise was heard first. Detective Garda Eugene Quinlan says he was in the kitchen looking for something to eat, went back into the function room, and from there went to the reception area where there was a crowd gathered.

In answering Inspector Drudy shortly after the killing, he said he was sitting at the table in the function room with Garda Jim Cummins when all the commotion started. When it was pointed out to him that his wife had said he wasn't in the room, he then changed his story. Detective Quinlan declined to make a formal statement to the gardai and contacted his solicitor. Senior Counsel Patrick McEntee was also engaged. It was over two weeks before he made his formal statement.

Teresa and Jim Cummins and Gerard O'Connor say that Quinlan was in the function room when the commotion started. Both the Quinlans agree now that he was not.

Gerard O'Connor says he was in the function room at the bar when the noise occurred. In a statement on the day of the incident, he said that he was going home when he saw Patrick Nugent stretched out on the floor. Two days later, he said he was standing at the bar in the function room with the Quinlans and the Cummins. When it was put to him on this occasion that he was outside at the time, he agreed that he might have been. He had difficulty remembering anything when he had drink taken. Almost three weeks later, in yet another statement, he said he was in the function room with both the Quinlans and Cummins. Teresa Quinlan says he was not at the table. In statements afterwards, she said that O'Connor appeared in the doorway. According to her, he was already there or just appeared.

At the trial, she said that he was at the door between the function and reception rooms. Teresa and Jim Cummins both agree that O'Connor had left when the commotion started. Gerard O'Connor insists that he was at the bar when the crash occurred. Both Cummins and Alison Quinlan disagree with that.

Garda Jim Cummins says that he was getting ready to leave when he heard the crash. In a statement after the incident, he

said he was actually leaving the function room at the time. He also said that Eugene Quinlan was with him. In an interview with the gardai, it was put to him that there was a question of the body being moved. He denied this. What he did move was his car. He initially told the gardai that he moved it to make way for the ambulance: He did not, however, move his car until after the ambulance had left. He had, it appears, a problem with his car insurance and following a conversation with Eugene Quinlan moved his car into the public car park.

Eugene Quinlan denied an allegation by Chrissie Ryan that he, Jim Cummins and Gerard O'Connor had carried the body of Patrick Nugent across the courtyard into the reception area where it was found. It was also denied that there had been a row between Eugene Quinlan and Gerard O'Connor over membership of a golf club. Any suggestions raised at the trial about the party-goers "cleaning the place out" were also denied. A week after the incident, William and Chrissie Ryan were brought to Ennis garda station. Gerard O'Connor came into the room. Chrissie Ryan told him that she saw him taking a body over the door of the reception area to the function room. He denied this and said that it must have been Jim Cummins. Chrissie Ryan said that it was himself and Eugene Quinlan. Gerard O'Connor told her that she must have been mistaken. Inspector Drudy recreated the scene and was satisfied that it would have been possible for Chrissie Ryan to see what she alleged. The gardai attempted to have Chrissie Ryan meet Eugene Quinlan and Jim Cummins. The two gardai declined the offer.

No satisfactory explanation has been forthcoming to explain why Patrick Nugent was on the ground when hit by the car. The explanations given as to where different people were at the time of the incident are less than clear, but understandable, given the length and nature of the party. What is undoubtedly true is the fact that the two gardai at the party, Detective Garda Eugene Quinlan and Garda Jim Cummins were less than forthcoming to the two gardai who initially investigated the occurrence. Detective Quinlan then waited a considerable time, and engaged a solicitor and senior counsel, before he made a formal statement about the matter.

The family of Patrick Nugent believe he was murdered. It is clear that the gardai have been involved in a cover-up of his death. But the reality is they are never going to arrest the suspects. And like many other cases, this violent death will likely remain unpunished to protect the institution as usual, above justice and accountability.

# Europeans Reject Net Zero Scam

The public are voting with their feet and walking away from useless and expensive 'green' technology

**ALL** across Europe, consumer confidence is plummeting in so-called green technology as householders return to tried and trusted traditional methods of transport and heating.

In the first half of the year alone, sales of heat pumps fell by 47% Europe-wide - a firm rejection by the public who are unwilling to give up their reliable clean gas boilers.

Here in Ireland, a new survey has found that more than 61% of households will not install a heat pump because they are too costly. The research by *Fuels for Ireland* and *the Alliance for Zero Carbon Heating* found two thirds of homes have no plan to install one, rising to 75% in rural areas. Sensible consumers who are not deluded by the climate scam are making wise decisions and holding onto open fires which provide real heat and comfort at an affordable price.

The government has a fantasy target to install 400,000 heat pumps in existing Irish homes by 2030, with an interim target of 45,000 by 2025. Most new builds come with heat pumps - another reason to be very wary of buying a new home. But according to the *Fuels for Ireland* survey, 33% of people are satisfied with their current heating arrangements and see no benefit in changing.

According to their research, other obstacles to installing a heat pump include disruption during installation (23%) and a lack of confidence in the technology (17%). In 2022, the EU set a target of installing at least 10 million more heat pumps by 2027 as part of efforts to lessen its dependence on Russian gas but a subsequent boom in sales is now over.

Homeowners in countries such as Germany rebelled against government drives to install more of the green technology, which is expensive to set up, during the cost of living crisis. Chancellor Olaf Scholz's under-fire coalition has since watered down its proposals to make heat pumps compulsory from 2024 in the face of public anger.

The Green Party in Germany suffered a catastrophic collapse in recent elections resulting in the resignation of the entire leadership. Climate communism has run out of steam in the once most industrial nation in Europe which has been brought to its knees by green tyranny.

The country has seen a spectacular drop in electric car sales with new purchases falling by nearly 70%.

In France, the EU's second largest market for battery electric vehicles after Germany, deliveries fell by 33%.

The dramatic fall in both countries meant that only 92,627 battery electric vehicles were registered across Europe last month,



a fall of 43.9pc compared to a year earlier. This drove a wider 18pc drop in new car sales across the EU. The collapse in sales comes amid concerns about their range, high prices and the lack of charging infrastructure across the EU.

Earlier this month, Volkswagen warned it may have to close factories in Germany for the first time in the face of slumping sales. The car maker has also scrapped a decades-old promise to protect workers' jobs, with fears as many as 15,000 roles could be at risk. The EV sales crisis prompted a call for "urgent action" to address new EU net zero car sales rules that will leave European electric car manufacturers at risk of hefty fines.

The European Commission, which creates and enforces EU law, is preparing to introduce new rules for car and van makers designed to slash carbon emissions and encourage the adoption of electric vehicles.

The new rules require all new European cars to produce no more than 93.6g of CO<sub>2</sub> per kilometre. Brands will be fined €95 for each gram of CO<sub>2</sub> per kilometre over the limit, multiplied by the number of cars sold.

Top carmakers including Volkswagen, BMW and Renault have already suggested pushing back the targets, which would see companies fined for failing to comply.

Meanwhile, Italy urged the EU to pause its "absurd" plans to ban petrol cars by 2035 amid concerns the policy risks triggering the automotive industry's collapse. That is of course the intention behind these insane policies directed at getting


rid of petrol and diesel cars. EVs are a fundamental part of the control grid and can be managed remotely by governments and intelligence agencies intent of restricting public movement into the future - the Covid lockdowns were a trial run. In Ireland, climate hoaxers say they are 'very worried' about the sharp decline in electric car sales.

The latest figures from the Central Statistics Office show that 12,765 EVs were licensed in Ireland between January and July of this year, a decline of nearly 25% compared with the same period last year. The total number of electric vehicles (EVs) on Irish roads is now around 125,000.

However, the target outlined in the Government's Climate Action Plan is to have 845,000 electric vehicles by 2030. Some chance.

Once people get a taste of electric cars, they rarely want to keep them because of the charging and maintenance nightmare involved, but because they have no resale value, they are stuck and have no choice but to hold onto them. The most sensible people on the roads of Ireland today are those driving petrol/diesel cars older than five years and more that can be picked up for a couple of grand and are the most economical to run and maintain. Because they have fewer electrics on board, they are less prone to expensive repairs. The older the car, the better made it is likely to be and give a lot less trouble. That's why the second-hand car market is on the up as people wake up to the truth about EVs.

Most people with half a brain are waking up to the madness of electric cars and have worked out that they are no cleaner than petrol or diesel cars because they are powered by batteries that are charged by coal plants and diesel generators. Soaring electricity bills are a reminder that so-called green electricity is anything but cheap, as promised. The Irish public are reaching their limit when it comes to outrageous electricity prices which are almost the highest in Europe, largely because they are paying to subsidise unreliable costly renewables.

# Trump Shooting Staged Event

**LET me preface this by stating I am not partisan. I hate both parties and candidates in the US election about equally. Both parties are “deep state” and neither has any intention of cleaning any swamp, so it is best to admit it. You won’t clean any swamp by voting or by putting signs in your yard. This is a problem far older and deeper than that.**

Politics as usual will never clean anything, since it is intrinsically dirty, but telling the truth and acting on it will. Truth is the most powerful weapon against corruption. So although I have zero desire to see another four years of the Dems, I would never pretend I believed this assassination attempt was genuine.

Our logical and default assumption for any new highly promoted event should be that it is fake. Before we get into it, let me just state the obvious: in that “iconic” photo, Trump is not saying “fight”, he is saying “f\*ck”. Everybody knows that, so let’s just be honest. That will help get us in.

Another clue is that, technically, the flag is upside down in that photo. Then we have the bad moulage job, where some make-up girl was hiding behind the podium and smeared some fake blood on Trump when he kneeled down. It isn’t convincing at all, since the straight lines of blood look like they were drawn on with a moulage marker. The moulage doesn’t run down the face like real blood since it is impossible to match the fluidity and viscosity of blood. You should know that: you have bled before. Then there is some red goop on his ear, but she didn’t have time to make that look real, either. All she did is make the whole ear red. But where is the bullet hole? We seem to be missing a bullet hole.

Trump’s doctor released a report claiming a 2cm wide wound from the bullet - 2cm is almost one inch. Do you see a one-inch loss to Trump’s outer ear? That’s the width of your thumb. I don’t see anything, period. All I see is a tiny white fleck the size of a piece of dandruff. One thing it certainly is NOT: a one-inch loss from a rifle bullet. If a bullet had taken off even a centimeter of the edge of Trump’s ear, it would be bleeding profusely, and we would see blood dripping from his earlobe down onto his shirt and jacket. Then there’s the little problem about allowing him to stand up and do his little dance, gesturing to the crowd and so on. They had to get the picture for the papers. But if this had been real they would have kept him down. He would never have been allowed to stand back up almost immediately, making himself a target again. That was against all protocol and logic. Next we come to the fact that the Secret Service acted nothing like the Secret Service. Their strange (in)action indicate either a stand down OR a faked event. So why is no one in the mainstream or



alternative press on either side allowed to point that out?

Any real investigation would start by proving the event happened. These are Hollywood people, after all. Trump is an actor and has worked on TV and with WWE, both masters of fakery. It’s clear the event was allowed to happen, but not because SS wanted Trump dead. It was allowed to happen because it was staged.

The mainstream admitted SS had previously tagged the rooftop where the shooter was perched as dangerous, so it should not only have been restricted, it should have had an agent physically on it. Snipers on adjacent buildings could see him and had already spotted him, but allegedly weren’t allowed first shot. Yeah. If you believe that you will believe anything. That’s why the snipers were there in the first place: to prevent a first shot on a former President.

People in the crowd had also seen the shooter and warned SS about it, but were ignored. Besides, even if SS wasn’t allowed first shot, that still doesn’t explain anything here. Are we to believe SS was required to wait until after the eighth shot?

At that shutter speed, how far would the bullet move? Since this was an AR15, the bullet would have slowed to about 2000fps. So we just multiply. The bullet should have traveled  $\frac{1}{4}$  foot, or three inches. Is that track 3 inches?

No, it is about a foot, which is four times too long. Obviously, the bullet would need to be moving 8000 fps to make a track one foot long on a film open for 1/8000s. Anyone can do that math.  $8000/8000 = 1$ .

The NYT photographer Doug Mills who allegedly took that photo is also covered in red flags. He has won two Pulitzers, one for coverage of the Monica Lewinsky scandal, which I have shown was also staged. He appears to be a plant from Intel.

Then there is the reaction of the crowd behind Trump, which allegedly had eight bullets whizzing past them, or into their neighbors. They sit and stand there like idiots, many not running or even ducking.

Some are filming on their cellphones. Most just continue to watch, as if it is on TV. That’s because they know the bangs are just blanks.

One of the guys interviewed afterwards admitted it sounded like fireworks behind the stage, not an AR15 more than 100 yards in front of the stage. Whoops! He is being paid to sell the hits on the crowd, but he goes off script badly, as these crisis actors always do. I think you could tell the difference between pops behind or under the stage and a high-powered rifle 500 feet away.

We should also hear the bullets whizzing, and as in the Las Vegas fake, we don’t. Even more ridiculous, perhaps, is that they paid these people on stage to stay there and cheer when he raised his fist.

No one knows all shooters have been killed at that point, how could they, but not only have they not run or tried to hide, they sit there calmly and then stand up and cheer when Trump does his “fight” act. This is fake event staging at its worst.

You will say one of those people was killed. Corey Comperatore. Unfortunately, his story

doesn’t add up, either. We are being told he was an ex-fire chief in Buffalo Township. But his LinkedIn profile doesn’t mention being a firefighter. It says he has worked at JSP in Butler for 30 years. Plus, this dead guy is still posting at LinkedIn as of today.

Then there’s the alleged shooter Thomas Matthew Crooks who appeared in a Blackrock commercial from last year. For some reason not given, Blackrock shot their commercial at Bethel Park Highschool, where Crooks was

a student. Blackrock has now admitted that is him, removing the commercial from any future rotation. That is being sold as some sort of wild coincidence, but it isn’t. Any student appearing in this

commercial would be handpicked by the directors. They don’t just shoot randomly and then ask students to sign a release.

My guess is Crooks is related to someone high up at Blackrock, and this was his first foot-wetting for his career. What career? CIA, of course. His fake death in this event is the perfect entry into CIA, since he now has cover. The best cover available: a faked death. It has since come out that Blackrock also owned the building that Crooks shot from. Of course

Blackrock owns almost everything now, so that doesn’t narrow it down much. They probably owned the store where he bought the gun and the ladder, too. # Telltale Signs Of Fake Terror

To this day, there isn't a shred of evidence to prove that any child was harmed in the event. There was no blood at the scene - there would have been a lot given that it was supposedly a mass stabbing. And the people they used to claim that the event happened like crisis actor Anto Boyle really gave the game away.


The staged 'far right' riot that was put on later that night in Dublin was a pantomime of fakery with empty garda cars with open doors strategically positioned beside cardboard boxes in flames. A combination of Antifa actors and inner city hooligans took up their roles in the controlled mob scenes and destruction of property. It was one of the worst examples of manufactured chaos we have seen in a long time. The public were then subjected to several weeks of puppeticians and Drew Harrass whining on about the antics of the so-called nationalist movement - which in Ireland does not exist. And what they might do to curtail people's speech and fundamental rights to deal with it. A classic Problem, Reaction, Solution.

Here are some of the signs that a scare event has been staged:

## 1. **No blood, no bodies, no photographs:**

Imagine the scene in a crowded Dublin street where there are hundreds of people milling around with their phones and in cars and buses yet nobody managed to get a picture of the wounded, blood on the ground or anything resembling a mass stabbing incident. Inconceivable.

From Sandy Hook to the Boston Marathon and the Manchester Arena event in 2017, key evidence is missing from the storylines and photography produced highlights countless flaws in the media narrative. For example, one of



the actors in the Manchester event - Ruth Murrell claimed a bolt of shrapnel had gone through her leg. But Murrell was spotted walking through the arena after the bomb in high heels showing no signs of discomfort - if she had endured an injury like that she would not have been able to stand not to mind walk.

## 2. **Go Fund Me accounts set up within 24 hours:**

Crisis actors have to be paid. So typically within a few hours of a staged event, you will see the fund set up and the money pouring in - usually from anonymous sources ie MI5/CIA/Mossad. No genuine person caught up in mass murder would give a second thought about money. So it's a sure sign of a set-up and a great way to launder cash. The actor can then go and retire off the proceeds until such time as they are given a new role and disguise to carry out their next job. Thousands of such operatives were used in 9/11. The government were carrying



out a drill on the same day in Manhattan in which they admitted they would use large numbers of personnel in role play situations.

## 3. **Practice drill on the same day or shortly before:**

Invariably in a staged terror event, a drill is held in the hours before. This is when they get the footage of the event and release it as a live event shortly afterwards when they are happy it has gone to plan. In the London Tube psyop of 2005, MI5 admitted they were doing a drill at the exact same time as the real 'attack' using the exact same scenario involving Muslims with explosive-filled rucksacks at the exact same train stations. What are the chances? Zero. They said they had to go from 'fictional to real'. Governments use these staged events to justify war (more money laundering and people trafficking) in foreign countries as they did in the case of 9/11 and London, not to mention

## 4. **Bad actors:**

One of the giveaway signs of a staged fear operation is always the crisis actors. They either start laughing at the start of their scripted interviews, forget their lines or say something off-script that calls the whole event into question. One of the most infamous crisis actors is 'Robbie Parker' - a father of one of the fictional victims of Sandy Hook, the 2017 school shooting event in Connecticut that has been thoroughly debunked. Parker started laughing just before his media appearance even though he had allegedly just lost his six-year-old daughter. The Sandy 'Crook' hoax convinced so many Americans and people around the world that staged events were being used to manipulate the public that a fake trial was set up against CIA asset Alex Jones to convince them otherwise. It didn't work.

## 5. **Non-stop media coverage:**

In order for the psyop to have maximum impact, the mainstream media have to prop it up with constant updates to give it credibility. In the case of the Parnell psyop, we have seen the media go back to it every few months to reinforce that it is real even though no detail is ever provided. There is no reason to return to stories like this unless they have a bigger agenda and are being used to change the law. These are media stories and nothing more than that. The press lies to you every single day. They lied to you for four years during the Covid scam - that was their bread and butter. They were paid by big corporations and governments to keep the scam going.

## 6. **Migrants used in central casting:**
